1 **[~~AMENDED PROPOSED~~] ORDER**

2 Having reviewed Plaintiff's Motion to Modify the Final Approval Order, and for good cause
3 shown, the Court ORDERS that the Court's Order Granting Motion for Final Approval of Class Action
4 Settlement entered on August 31, 2023 shall be modified as follows:

- 5 1. The Court hereby:
- 6 a. Awards **\$68,958.33** in attorneys' fees to Class Counsel (which is one-third of \$206,875);
- 7 b. Awards **\$72,644.59** in reimbursement of litigation costs to Class Counsel;
- 8 c. Approves payment of **\$18,750** (75% of \$25,000 PAGA penalty) to the LWDA;
- 9 d. Approves payment of **\$7,250** (25% of \$25,000 PAGA penalty) to the Aggrieved

10 Employees;

11 e. Awards **\$7,559.90** in settlement administration costs to Simpluris, Inc.;

12 f. Awards **\$1,750** to Plaintiff Yazmin Gonzalez as a service award;

13 g. Orders that the remainder of the Settlement Fund in the amount of **\$29,962.18** be

14 distributed to the class members in accordance with the terms of the Settlement Agreement; and
15 The deadline for filing the declaration of final distribution is August 31, 2026.

16 2. A Non-Appearance Case Review re: Final Report re: Distribution of Settlement Funds is
17 set for September 8, 2026 at 8:30 a.m. ~~August 30, 2026, at 8:30 a.m., or _____~~. The Final Report is to be filed
18 ~~five court days in advance~~. If there is unpaid residue or unclaimed or abandoned class member funds
19 and/or interest thereon to be distributed to Public Citizen Foundation, Plaintiff's counsel shall also submit
20 an Amended Judgment pursuant to Cal. Code of Civ. Pro. § 384.
