## DECLARATION OF JAKE FINKEL

I, Jake Finkel, say and declare, as follows:

1. I am an attorney at law, duly licensed to practice before all the Courts of the State of California and I am the principal of The Finkel Firm, co-counsel with Mehrdad Bokhour of Bokhour Law Group, P.C., as attorneys of record for Plaintiff Margarita Sandoval Mendoza and the Aggrieved Employees.

2. As such, I am familiar with the file in this matter, and if called as a witness, I could and would competently testify to the following facts of my own personal knowledge.

3. The Finkel Firm possesses considerable expertise in litigating complex litigation matters. I graduated from the University of California at Irvine in 2009, received my Juris Doctorate from UCLA School of Law in 2013, and became a member of the California State Bar in 2013. I established my own law practice shortly after becoming a member of the California State Bar and have grown the practice, which currently employs four attorneys and 12 support staff.

4. I am a member of the California Employment Lawyers Association and the Consumer Attorneys Association of Los Angeles.

5. I have been a member, in good standing, of the State Bar of California since 2013. I am admitted to practice before all California state courts and the United States District Court of California for the Central District, Eastern District, and Southern District and have litigated class action and Private Attorneys General Act (“PAGA”) representative action cases in various courts in California.

6. In addition to the instant case, I have served as class counsel in various wage and hour class actions. I have developed extensive litigation experience in complex employment litigation matters, particularly in California wage and hour class actions representing employees.

7. My firm has the experience, resources, and means necessary to allow us to provide adequate representation as Plaintiff's Counsel to the class in this litigation. Currently, my firm serves as counsel in at least fifteen wage-and-hour class actions and co-counsel in at least ten others.

8. I am experienced and qualified to evaluate the class and PAGA claims and the viability of the defenses. I have extensive experience in prosecuting employment litigation and

1 have focused my practice primarily on cases regarding wage and hour class actions and  
2 representative PAGA actions.

3 9. Based on my experience and after factoring in the risks explained below, I believe  
4 the proposed settlement is fair and reasonable. As such, and for the reasons set forth below, I believe  
5 that the PAGA Settlement Agreement should be approved.

6 10. PAGA Counsel are respected members of the California Bar with strong records of  
7 vigorous and effective advocacy of their clients, and they are experienced in handling complex  
8 class action litigation. Counsel and the Plaintiff were prepared to litigate the claims in this action,  
9 but they strongly and unequivocally support the proposed Settlement as being in the best interest  
10 of the Settlement Class based on the circumstances referenced herein. Through a contested but  
11 productive mediation, the Parties entered into a PAGA Settlement Agreement resolving the wage and  
12 hour claims of the Class.

13 11. My office has performed considerable work and diligently investigated and  
14 prosecuted this case to a successful conclusion. Our work has resulted in the creation of a significant  
15 Settlement Amount for the benefit of the aggrieved employees and the state of California. We  
16 communicated and exchanged information informally with Defense counsel, enabling the Parties  
17 to successfully settle the case at mediation before the Hon. Carl J. West (Ret.). Because of the risks  
18 involved in litigating the case and the contested legal and factual issues, Plaintiff's counsel believes  
19 this Settlement to be fair, reasonable, and adequate.

20 12. Because the Settlement is fair and reasonable and was negotiated at arm's length by  
21 experienced counsel and an experienced mediator following a sufficient exchange of information and  
22 documents in advance of mediation, it should be approved.

23 13. It is our experience that attorneys' fee awards of one-third of a common fund  
24 settlement are the standard in California.

25 14. The actual aggregated lodestar between the attorneys who worked on this case is  
26 \$136,790. This results in a negative multiplier, demonstrating that the requested fee is justified,  
27 reasonable, and appropriate. The total lodestar is summarized in the following table:

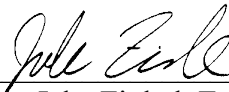
15. Attached hereto as **Exhibit “A”** is a true and correct copy of my firm’s time entries associated with this matter.

These expenses included but were not limited to court filings, mediator fees, and other incidental expenses directly related to this action. Defendant does not oppose this request for costs. Through final approval, my office incurred \$6,376.71 in litigation costs.

17. Attached as **Exhibit “B”** is the itemized litigation costs (actually incurred), including invoices, for the above-referenced matter.

18. For the foregoing reasons, it is respectfully requested that the Court grant approval of the Settlement as being fair, reasonable, and in the best interests of the state of California and aggrieved employees, as well as approve the requested attorneys’ fees and costs, and service award to the named plaintiff and settlement administration costs..
