1. On May 13, 2025, this Court entered an Order Granting Plaintiff Blanca Catano's Motion for Final Approval of Class Action and PAGA Settlement and a Judgment.

2. The Settlement Administrator has reported that 167 settlement checks totaling \$32,099.32 remained uncashed after the April 29, 2026 check cashing deadline.

3. Pursuant to Code of Civil Procedure § 384(b), the Court hereby AMENDS the Judgment entered on May 13, 2025 as follows:

a. The Court hereby directs the Settlement Administrator to transmit the uncashed funds totaling \$32,099.32 to the California State Controller's Office Unclaimed Property Fund in the name of each respective class member to whom the uncashed checks were payable.

b. Within ten (10) calendar days after the Court's entry of the Amended Judgment, the Settlement Administrator shall post notice of this Amended Judgment on the website (www.cptgroupcaseinfo.com/compassfoodsaction) the Settlement Administrator established for purposes of settlement administration.

c. Plaintiff shall submit a copy of this Amended Judgment to the Labor and Workforce Development Agency within ten (10) calendar days of the Court's entry of this Amended Judgment.
