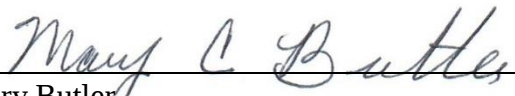

NET SETTLEMENT AMOUNT	\$637,250.00

As of this date, the *highest* Individual Settlement Payment to be paid is approximately \$2,251.20 and the *average* Individual Settlement Payment to be paid is approximately \$637.25. As of this date, the *highest* Individual PAGA Payment to be paid is approximately \$102.95 and the *average* Individual PAGA Payment to be paid is approximately \$24.98.

ADMINISTRATION COSTS

13. Simpluris' total costs for services in connection with the administration of this Settlement, including fees incurred and anticipated future costs for completion of the administration, are \$10,250.00. Simpluris' work in connection with this matter will continue with the calculation of the Settlement checks, issuance and mailing of those Settlement checks, etc., and the necessary tax reporting on such payments.
