

AMENDMENT TO STIPULATION OF SETTLEMENT

This Amendment to Stipulation of Settlement seeks to amend the Stipulation of Settlement in the matter of *Anthony Lopez v. Revline, LLC*, et al., Case No. CVRI2102037 (hereinafter "Lawsuit.") The Stipulation of Settlement was executed by Plaintiff Anthony Lopez and Jacob Fraleigh, individually and on behalf of Revline, LLC.

The "Gross Settlement Amount" described in Paragraph 3 of the Stipulation of Settlement remains unchanged. However, the calculation for the payout of the \$16,000 to the 37 putative class members, described in Paragraph 4, will change. Instead of a flat payment of \$432.43 per putative class member, the putative class members will be paid the \$16,000 based on the number of workweeks he/she worked. Each putative class member will be paid \$19.77 per workweek that he/she worked for Revline, based on Revline's records. Revline's records indicate that 809 workweeks were worked by the 37 employees during the class period.

The PAGA Settlement amount described in Paragraph 4 is amended as follows: the \$5,000 total for the PAGA settlement will be paid based on pay periods worked during the PAGA period, which is between 3/16/2020 and 12/1/2023. Revline's records indicated that this is approximately 194 pay periods, which amounts to \$25.77 per pay period worked. 75% of the \$5,000 PAGA settlement must be paid to the LWDA, leaving \$1,250 to the "Aggrieved Employees," which amounts to \$6.44 per pay period for the employees.

Paragraph 4 of the Stipulation of Settlement refers to a "claim form." The claim will be substantially in the appearance of Exhibit C, attached hereto. The claim form will have a self-addressed stamped envelope (addressed to Revline, LLC, which is administering the settlement).

Paragraph 9 of the Stipulation of Settlement refers to the "Notice Packet" that will be mailed to the class members "within (10) business days after entry of an order preliminarily approving this settlement" will also include the claim form. Class members will also have forty-five (45) calendar days of the date of the initial mailing of the Notice Packets to sign and return the Claim Form.

Payment to Class Members (who submitted the Claim Form) of Settlement Funds will be paid within 45 days of the Court's Order granting final approval.

Paragraph 2 of the Stipulation of Settlement is amended to state that the "Released Parties" only include the Defendants named in the Third Amended Complaint, including Jacob Fraleigh and Revline, LLC, as well as Revline, LLC's officers, directors, employees and agents.

Since Anthony Lopez has passed away, his surviving heir and successor-in-interest Amanda Lopez will be entitled to the Class Representative Award of \$4,500 and will receive that payment from Revline within 45 days of the Court's final approval of the settlement.

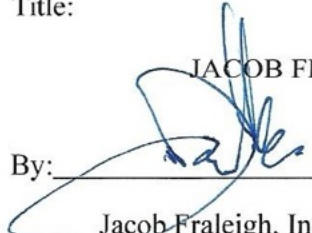
