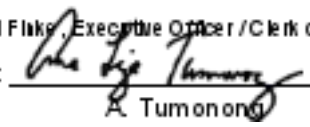

2 the Class and PAGA Action Settlement reached in this action. Pursuant to the Court's Order, the
3 funds from any uncashed checks would be forwarded to Legal Aid At Work. The compliance

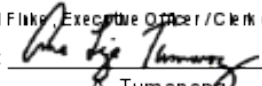

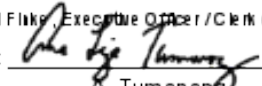

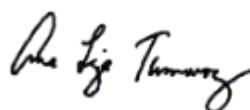
