PLEASE TAKE NOTICE that on July 17, 2026, at 8:30 a.m., in Department B of the above-entitled Court, located at 825 Maple Avenue, Torrance, California, 90503, Plaintiff Joana Flores (“Plaintiff” or “Class Representative”) will and hereby does move for an order granting final approval of:

1. Making final the Court’s previous preliminary certification of the class for settlement purposes, and approving the Amended Class Action and PAGA Settlement Agreement (“Settlement,” “Agreement,” or “Settlement Agreement”), on the grounds that the Settlement is fair, adequate, and reasonable because, *inter alia*:

- A Net Settlement Amount of approximately **\$1,302,638.39** will be fully distributed to the Class Members who do not submit a timely and valid Request for Exclusion (“Participating Class Member”); and
- **No Objections** were submitted to the settlement administrator, Simpluris Inc. (“Simpluris Inc.” or “Settlement Administrator”).

2. Awarding payment in the amount of **\$835,014.00** to Lawyers for Justice, PC (“Class Counsel”), representing thirty-five percent (35%) of the Gross Settlement Amount,¹ for attorneys’ fees, which is reasonable and justified on a percentage-basis and also based on a lodestar cross-check;

3. Awarding payment in the amount of **\$20,541.66** to Class Counsel for reimbursement of litigation costs and expenses;

4. Awarding payment in the amount of **\$17,558.00** to the Settlement Administrator for Administration Expenses;

5. Awarding payment in the amount of **\$10,000.00** to Plaintiff Joana Flores, as a Class Representative Service Payment; and

6. Approving the allocation of the penalties under the Private Attorneys General Act of 2004, California Labor Code § 2698, et seq. (“PAGA”), in the amount of **\$200,000.00** (“PAGA Penalties”), of which 75%, or **\$150,000.00**, will be paid to the California Labor and Workforce Development Agency (“LWDA”) (“LWDA PAGA Payment”) and 25%, or

1 **\$50,000.00** will be distributed to Aggrieved Employees on a pro rata basis, based on PAGA Pay
2 Periods during the PAGA Period (“Individual PAGA Payment”).

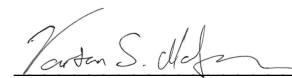
3 This motion is made pursuant to Rules 3.764, 3.769, and 3.1113(e) of the California Rules of
4 Court, which, respectively, require that a memorandum in support of class certification not exceed 20
5 pages, require approval by the Court of a class action settlement, and permit the Court to extend the page
6 limit for memoranda, and California Labor Code section 2699(l)(2), which requires approval by the Court
7 of a PAGA settlement. Unless otherwise specified, all citations and references to the PAGA
8 statute that are contained within this motion and supporting papers are to the former version of
9 the PAGA statute prior to the recent amendment effective July 1, 2024; the amended PAGA
10 statute does not apply to the above-captioned action and the Settlement pursuant to California
11 Labor Code § 2699, subd. (v), as amended, because the above-captioned action was filed prior to
12 June 19, 2024.

13 This motion is based upon the following Memorandum of Points and Authorities; the
14 Declarations of Class Counsel (Vartan Madoyan), Class Representative (Joana Flores), and Settlement
15 Administrator (Bentley Conn of Simpluris Inc.) in support thereof; the pleadings and other records on file
16 with the Court in this matter; and such evidence and oral argument as may be presented at the hearing on
17 this motion.

MEMORANDUM OF POINTS AND AUTHORITIES

I. SUMMARY OF MOTION

Plaintiff Joana Flores (“Plaintiff” or “Class Representative”) seeks final approval of: (1) the settlement reached between Plaintiff and Defendant Alliance Ground International LLC, now referred to as AGI Cargo, LLC (“Defendant”) (together with Plaintiff, the “Parties”) which provides for Defendant’s payment of a Gross Settlement Amount of \$2,385,752.35;² (2) attorneys’ fees in the amount of \$835,014.00, which is thirty-five percent (35%) of the Gross Settlement Amount, and reimbursement of litigation costs and expenses in the amount of \$20,541.66 (together, referred to as the “Attorneys Fees and Expenses” and “Class Counsel Litigation Expenses”) to Lawyers for Justice, PC (“Class Counsel”); (3) payment in the amount of \$17,558.00 to Simpluris Inc. (“Administration Expenses”); (4) payment in the amount of \$10,000.00 to Plaintiff Joana Flores (“Class Representative Service Payment”); and (5) allocation of \$200,000.00 for penalties under the Private Attorneys General Act of 2004, California Labor Code § 2698, et seq. (“PAGA Penalties”).

Plaintiff requests that the Court make final its preliminary certification of the class for settlement purposes. The Settlement resolves the Released Class Claims and provides relief to a class consisting of the following individuals: all current and former hourly-paid or non-exempt employees who worked for Defendant in the State of California at any time during the Settlement Class Period (i.e., the time period of January 27, 2019 through December 31, 2024) (“Class” or “Class Members”).³

The Settlement also resolves the Released PAGA Claims pertaining to the employment of the following alleged aggrieved employees: all current and former hourly-paid or non-exempt employees who worked for Defendant in the state of California at any time during the PAGA Period (i.e., the time period of April 5, 2020 through December 31, 2024) (“Aggrieved Employees”).⁴

This matter involved, and the settlement is the product of meaningful and extensive investigations, and review and analysis of a large volume of information, documents, and data exchanged

1 by the Parties in the course of litigation and mediation and settlement negotiations (which involved a full
2 day mediation conducted by Eve Wagner, Esq.).⁵

3 This case has required 498.60 hours of attorney time by Class Counsel.⁶ As will be demonstrated
4 herein, the request for attorneys' fees, which represents thirty-five percent (35%) of the Gross Settlement
5 Amount, is fully supported by the use of the percentage-fee method. Courts have historically awarded
6 fees of up to fifty percent (50%) of the recovery. The requested attorneys' fees are also supported under
7 the lodestar cross-check method.⁷

8 The requests for Class Counsel Fees Payment and Class Counsel Litigation Expenses
9 Payment, Class Representative Service Payment, Administration Expenses, and allocation for the
10 PAGA Penalties were fully disclosed in the Court Approved Notice of Class Action Settlement
11 ("Class Notice") that was mailed to the Class Members. Most importantly, as of the date of this Motion,
12 *no Class Member has objected to the Settlement or to the contemplated Class Counsel Fees Payment and*
13 *Class Counsel Litigation Expenses, Class Representative Service Payment, Administration Expenses,*
14 *or allocation for PAGA Penalties.*

15 The Settlement is fair, adequate, and reasonable, and is the product of arm's-length, good-faith
16 negotiations by experienced counsel presided over by a highly-regarded mediator who is experienced in
17 mediating employment class action lawsuits. Accordingly, the Court should grant final approval of the
18 Settlement, and award the Class Counsel Fees Payment, Class Counsel Litigation Expenses Payment,
19 Class Representative Service Payment, Administration Expenses, and allocation for the PAGA
20 Penalties in the full amounts requested herein.

21 In order to efficiently present the Court with adequate information to determine whether to grant
22 final approval of the Settlement, and award Class Counsel Fees Payment, Class Counsel Litigation
23 Expenses Payment, Class Representative Service Payment, Administration Expenses, and allocation
24 for the PAGA Penalties, Plaintiff also moves for an order permitting the filing of this single
25 consolidated memorandum, although it exceeds the page limit established by California Rules of Court,
26 Rule 3.764, instead of filing several separate motions.

**II. RELEVANT PROCEDURAL HISTORY AND FACTUAL BACKGROUND SINCE
PRELIMINARY APPROVAL**

For a discussion of relevant procedural history and facts regarding this matter since preliminary approval was granted, please see the Declaration of Vartan Madoyan at paragraphs 2 to 4.

III. THE CLASS SHOULD BE CERTIFIED FOR SETTLEMENT PURPOSES

For the reasons previously addressed by way of Plaintiff's moving and supporting papers for the Motion for Preliminary Approval of Class Action Settlement (namely, that the relevant class certification factors are satisfied, i.e., ascertainability, numerosity, community of interest, typicality, adequacy of representation, superiority, and manageability), as well as the reasons discussed herein regarding the completion of the due process notice procedure, the Court is requested to now make final its preliminary certification of the class for settlement purposes.

**IV. SUMMARY OF THE SETTLEMENT TERMS, NOTICE PROCESS, AND PLAN OF
DISTRIBUTION**

Under the terms of the Settlement Agreement, Defendant has agreed to pay a Gross Settlement Amount of \$2,385,752.35 on a non-reversionary basis,⁸ and separately the amounts necessary to pay its Employer Taxes, via two (2) installment payments of \$1,192,876.18 ("First Installment") plus Employer Taxes, and a second payment of the remaining \$1,192,876.18 of the Gross Settlement Amount ("Second Installment").⁹ Within sixty-one (61) calendar days of the Effective Date, Defendant shall provide the Settlement Administrator with the First Installment and the Employer Taxes.¹⁰ No later than six (6) months after the Effective Date, Defendant shall provide the Settlement Administrator with the Second Installment.¹¹ Subject to approval by the Court, the Net Settlement Amount will be calculated by deducting the Class Counsel Fees Payment, Class Counsel Litigation Expenses, Class Representative Service Payment, Administration Expenses, and LWDA PAGA Payment.¹² The Net Settlement Amount, which is estimated to be \$1,302,638.39, will be fully distributed to Participating Class Members in accordance with the Settlement Agreement.¹³ The PAGA Penalties of \$200,000.00 will be

distributed to the Labor and Workforce Development Agency ("LWDA") (in the amount of \$150,000.00) and to the Aggrieved Employees (in the amount of \$50,000.00) in accordance with the Settlement Agreement.¹⁴

Simpluris Inc. ("Settlement Administrator" or "Simpluris Inc.") will determine each Participating Class Member's (i.e., Class Members who did not timely opt out of the Class Settlement) *pro rata* share of the Net Settlement Amount ("Individual Class Payment(s)")¹⁵, according to the following methodology: the Settlement Administrator will divide the final Net Settlement Amount by the Workweeks of all Participating Class Member during the Class Period to yield the "Final Workweek Value," and multiply each Participating Class Member's individual Workweeks during the Class Period by the Final Workweek Value to yield his or her Individual Settlement Share.¹⁶

The Administrator will calculate each individual PAGA Payment by (a) dividing the amount of the Aggrieved Employees 25% share of PAGA Penalties by the total number of PAGA Pay Periods worked by all Aggrieved Employees during the PAGA Period and (b) multiplying the result by each Aggrieved Employee's PAGA Pay Periods.¹⁷

Class Members had sixty (60) calendar days from the initial mailing of the Class Notice ("Response Deadline") to dispute the number of Workweeks and/or the PAGA Pay Periods credited to each of them, opt out of the Class Settlement, and/or object to the Settlement.¹⁸ The Response Deadline was May 4, 2026, and the extended Response Deadline was May 18, 2026, for Class Members who were re-mailed the Class Notice.¹⁹ ***As of the date of this motion, the Settlement Administrator has received three (3) written requests for exclusion from the Class Settlement ("Request for Exclusion") and zero (0) written objections to the Class Settlement ("Objection") from Class Members.***²⁰

Each Individual Class Payment will be allocated as follows: twenty-five percent (25%) as wages which will be reported on an IRS Form W-2; and the remaining seventy five percent (75%) as interest, penalties, and non-wage damages, which will be reported on an IRS Form 1099.²¹ The Settlement

Administrator will withhold the employee's share of taxes and withholdings with respect to the wages portion of the Individual Class Payment, and issue checks to Participating Class Members for their Individual Settlement Payments (i.e., payment of their Individual Class Payment net of these taxes and withholdings).²² Defendant will pay the employer's share of payroll taxes and contributions with respect to the wage portion of Individual Class Payments ("Employer Taxes") in addition to the Gross Settlement Amount.²³ The Individual PAGA Payments will be allocated as one hundred percent (100%) penalties, and will be reported on an IRS Form-1099, by the Settlement Administrator.²⁴

The Settlement Administrator shall distribute the following payments: Within fourteen (14) calendar days of the funding of the Gross Settlement Amount: Class Representative Service Payment to Plaintiff, Individual Settlement Payment to Participating Class Members, Individual PAGA Payment checks to Aggrieved Employees, the LWDA PAGA Payment to the LWDA, Administration Expenses to itself, Class Counsel Expenses, and Class Counsel Litigation Expenses to Class Counsel.²⁵

Individual Settlement Payment and Individual PAGA Payment checks will be valid and negotiable for one hundred eighty (180) calendar days from the date the checks are mailed, and thereafter, shall be canceled.²⁶ The funds associated with such canceled checks will be distributed by the Settlement Administrator to the California Controller's Unclaimed Property Fund in the name of the individuals to whom the checks had originally been issued.²⁷ All Participating Class Member and Aggrieved Employees shall be bound by the terms and conditions of this Settlement Agreement regardless of whether or not they cash or otherwise negotiate their Individual Settlement Payment and/or Individual PAGA Payment checks.²⁸

V. THE SETTLEMENT ADMINISTRATION PROCESS

The Court directed Simpluris Inc. to administer and effectuate the notice and settlement administration process, as set forth in the Court's August 1, 2024, Preliminary Approval Order – which

1 was modified after the Court granted preliminary approval of the modified settlement on January 20,
2 2026. On February 9, 2026, Simpluris Inc. received a mailing list from Defendant's counsel that
3 contained each Class Members' and Aggrieved Employees' full name, last known mailing address,
4 Social Security Number, and number of Class Period Workweeks, and PAGA Pay Periods. (collectively,
5 "Class Data").²⁹

6 The Class Data contained information for 3,137 individuals identified as Class Members.³⁰ The
7 mailing addresses contained in the Class Data were processed and updated utilizing the U.S. Postal
8 Service's National Change of Address Database ("NCOA").³¹

9 On February 23, 2026, Simpluris Inc. mailed the Class Notice via U.S. first class mail to all
10 3,137 individuals identified as Class Members in the Class Data.³²

11 A total of 292 Class Notices were returned as undeliverable, and after Simpluris Inc. performed a
12 skip-trace search, 276 of the Class Notices were re-mailed through the skip-trace search and USPS
13 forwarding addresses received. There are 274 mailed Class Notices that remain undeliverable.³³

14 The Settlement Administrator has received zero (0) Objections and three (3) Request for
15 Exclusion from Class Members by the Response Deadline of May 4, 2026, or the extended Response
16 Deadline of May 18, 2026, for those Class Notices that were re-mailed.³⁴

17 To date, there are 3,134 Class Members who did not submit a timely and valid Request for
18 Exclusion ("Participating Class Members"), and who will be paid their portion of the Net Settlement
19 Amount. The Net Settlement Amount of approximately \$1,302,638.39 and the PAGA Penalties of
20 \$150,000.00 will be distributed in accordance with the terms of the Settlement.³⁵

21 **VI. THE COURT SHOULD GRANT FINAL APPROVAL OF THE CLASS ACTION**
22 **SETTLEMENT.**

23 In reviewing a class settlement, the court need not reach any ultimate conclusions on the issues of
24 fact and law that underlie the merits of the dispute. *7-Eleven Owners for Fair Franchising v. Southland*

Corp. (2000) 85 Cal.App.4th 1135, 1146. The inquiry is not whether the settlement agreement is the best one that class members could have possibly obtained, but whether the settlement, taken as a whole, is “fair, adequate, and reasonable”—and the trial court has broad discretion to determine this. *Chavez v. Netflix, Inc.* (2008) 162 Cal.App.4th 43, 52-55. A settlement need not obtain 100 percent of the damages sought in order to be fair, reasonable, and ultimately, meaningful. *Wershba v. Apple Computer, Inc.* (2001) 91 Cal.App.4th 224, 251. Even if the proposed settlement affords relief that is substantially narrower than it would be if the case were to be successfully litigated, that is no bar to a class settlement because the public interest may indeed be served by a voluntary settlement in which each side gives ground in the interest of avoiding prolonged litigation. *Id.*

To determine whether the settlement is fair and reasonable, relevant factors to consider are:

the strength of plaintiffs’ case, the risk, expense, complexity and likely duration of further litigation, the risk of maintaining class action status through trial, the amount offered in settlement, the extent of discovery completed and the stage of the proceedings, the experience and views of counsel, the presence of a governmental participant, and the reaction of the class members to the proposed settlement.

Dunk v. Ford Motor Co. (1996) 48 Cal.App.4th 1794, 1801. The list of factors is not exclusive and the court can consider different factors based on the circumstances of each case.” *Wershba* at 245. At the final approval stage, a presumption of fairness exists where, as here:

“(1) the settlement is reached through arm’s-length bargaining; (2) investigation and discovery are sufficient to allow counsel and the court to act intelligently; (3) counsel is experienced in similar litigation; and (4) the percentage of objectors is small.”

Id. at 1802. “Due regard should be given to what is otherwise a private consensual agreement between the parties.” *Dunk* at 1801.

A. The Settlement Resulted from Arm’s-Length Negotiations Based Upon Extensive Investigation and Formal and Informal Discovery.

The Parties actively litigated the cases since the initial complaint was filed on June 10, 2021. Class Counsel conducted significant investigation, and extensive formal and informal discovery into the facts of the case, to assess the veracity, strength, and scope of the claims, and was preparing for class certification and trial prior to reaching the Settlement.³⁶

1 The Parties informally exchanged a volume of information, documents, and data throughout the
2 course of the litigation and in connection with the mediations and settlement negotiations.³⁷ Class
3 Counsel informally exchanged a large volume of information, documents, and data obtained from
4 Plaintiff, Defendant, and other sources, including: employment records of Plaintiff, a detailed sampling of
5 Plaintiffs, Class Members, and aggrieved employees timekeeping and payroll data, Multiple Iterations of
6 Defendant's Employee Handbook(s) and wage and hour policies (including, but not limited to,
7 Defendant's California Meal Periods Policy and Rest Periods Policy, Overtime Policy, and Timekeeping
8 Policy), earning statements, company policy acknowledgments and forms (including, but not limited to,
9 Defendant's Handbook/Policy Employee Acknowledgment, Employee Acknowledgement of Receipt of
10 the Meal Periods Policy and Rest Periods Policy, Employee Acknowledgement of Receipt of the
11 Timekeeping Policy, and Meal Period Waiver Form), internal memorandum, job descriptions, and other
12 operations and employment policies, practices, and procedures documents, among other information and
13 documents.³⁸ Class Counsel had the opportunity to interview Plaintiff and other percipient witnesses.³⁹
14 Class Counsel developed liability, damages, and penalties valuation models in the course of litigation and
15 in connection with the mediation and settlement negotiations, and met and conferred with Defendant's
16 counsel on numerous occasions, e.g., to discuss issues relating to the pleadings, case management, motion
17 practice, and production of information, documents, and data in the course of litigation and in connection
18 with the mediation and settlement negotiations, and settlement.⁴⁰ The Parties also engaged in
19 significant law and motion practice including motions to compel arbitration and dismiss claims, and
20 Plaintiff's appeal to the California Court of Appeals. Other work performed by Class Counsel included,
21 and was not limited to, case strategy and analysis; legal research; drafting, reviewing, and revising the
22 pleadings, motion-related papers, mediation briefing and supporting materials, and settlement-related
23 papers; and preparing for and attending court proceedings, settlement negotiations, and the mediation,
24 among other tasks.⁴¹

The Parties participated in a formal, full-day mediation conducted by Eve Wagner, Esq., who is well-regarded mediator experienced in mediating employment matters.⁴² In the course of mediation and the settlement negotiations following mediation, the Parties exchanged extensive information, documents, and data and discussed all aspects of the case, including and not limited to, the risks and delays of further litigation, the risks and expenses to the Parties of proceeding with class certification, representative adjudication, the law relating to class certification, off-the-clock theory, meal and rest periods (including *inter alia*, on premises breaks), representative PAGA claims and penalties, and wage-and-hour law and enforcement; Plaintiff's claims and allegations, and Defendant's defenses thereto; as well as the evidence produced and analyzed; and the possibility of appeals, among other things.⁴³ During all settlement discussions, the Parties conducted their negotiations at arm's length in an adversarial position.⁴⁴ Arriving at a settlement that was acceptable to the Parties was not easy.⁴⁵ Defendant and its counsel felt very strongly about Defendant's ability to prevail on the merits and to avoid class certification and representative adjudication and prevail on the merits, while, Plaintiff and Class Counsel believed that they would be able to obtain class certification and prevail at trial.⁴⁶ After conducting significant formal and informal discovery and investigations, extensive settlement negotiations, and with the aid of the mediator's evaluation, the Parties agreed that this matter was well-suited for settlement given the legal issues relating to Plaintiff's principal claims, as well as the costs and risks to the Parties that would attend further litigation.⁴⁷

The Settlement takes into account the strengths and weaknesses of each side's position and the uncertainty of how this matter might have concluded at certification, trial, and/or appeals (and, indeed, Plaintiff had earlier filed an appeal in this matter).⁴⁸ The Settlement was based on a large volume of facts, evidence, and investigation.⁴⁹ Additionally, Class Counsel has extensive experience in handling complex wage-and-hour actions, including significant experience in employment class action litigation.⁵⁰

1 **B. The Risks Inherent in Continued Litigation Favor Final Approval of the**
2 **Settlement.**

3 The risks inherent in litigating the claims through certification proceedings, trial, and/or appeals,
4 favor resolving this matter for a Gross Settlement Amount of \$2,385,752.35.⁵¹ The Settlement was
5 calculated using information and data uncovered through extensive case investigation, formal and
6 informal discovery, and the exchange of information in the context of litigation mediation, and ongoing
7 settlement negotiations.⁵² Had the action not settled, Defendant would have continued to vigorously
8 challenged class certification, liability, and damages. Defendant contended that individualized questions
9 of fact predominated over any common issues, and these issues would pose challenges to certification
10 and representative adjudication. Defendant would have likely argued again at trial, if any, that
11 Plaintiff's claims were not appropriate for class-wide and/or representative adjudication. On the other
12 hand, Defendant also faced the risk of the Court certifying a class and allowing a jury to decide Plaintiff's
13 claims on a class-wide or representative basis. Also, preparation for trial would have been expensive
14 for all Parties.

15 It is preferable to reach an early resolution of a dispute because such resolutions save time and
16 money that would otherwise go to litigation. If this matter had settled after further litigation, the
17 settlement amount would have taken into account the additional costs incurred, and there might have been
18 less money available for Class Members, Aggrieved Employees, and the State of California after all
19 was said and done. This is not just an abstract contention. The risks and expenses of further litigation
20 outweighed any benefit that might have been gained otherwise. These risks of further litigation include a
21 determination that the claims were unsuitable for class treatment and/or representative adjudication,
22 failure to obtain certification, class de-certification after certification of a class, allowing a jury to decide
23 the claims asserted in this matter, and the real possibility of no recovery after years of litigation.
24 Additionally, the Parties were moving into the phase of the litigation where they would have to conduct a
25 significant amount of additional discovery, including and not limited to, additional depositions of
26 Defendant's Person Most Knowledgeable designees, expert witnesses, and percipient witnesses, such as

managers, supervisors, and other current and former employees throughout the State of California. Additional discovery would have certainly arisen, which would have cost the Parties additional time and money. In contrast, the Settlement provides real and significant benefits for the Class, Aggrieved Employees, and the State of California here and now, while avoiding the further expenses, risks, and delay of prolonged litigation with only the possibility of recovery.

It would be grossly inefficient for such a large class of current and former employees to bring individual actions to recover from Defendant for the alleged violations of wage-and-hour laws. Moreover, the potential individual recovery that could be obtained by a Class Member would not be significant enough to provide him or her with the incentive to sue. By granting final approval of the Settlement, the Court can approve a resolution that provides a certain and substantial recovery for Class Members, Aggrieved Employees, and the State of California.

C. The Settlement Is Fair, Reasonable, and Adequate.

The Settlement, which provides for a Gross Settlement Amount of \$2,385,752.35, represents a fair, reasonable, and adequate resolution of this matter. The Settlement was calculated using information and data uncovered through extensive case investigation, formal and informal discovery, and the exchange of information in the context of litigation, mediation, and extensive settlement negotiations. The Settlement takes into account the potential risks and rewards inherent in any case and, in particular, in this matter. Moreover, considering the facts in this matter, the Gross Settlement Amount represents a considerable recovery.

The Gross Settlement Amount will be fully paid out, in accordance with the terms of the Settlement. As discussed above, each Participating Class Member will be paid a *pro rata* share of the Net Settlement Amount (which is currently estimated to be \$1,302,638.39, based on the number of Workweeks credited to them and each Aggrieved Employee will be paid a pro rata share of the 25% share of the PAGA Penalties, based on the number of PAGA Pay Periods during the PAGA Period credited to them.⁵³ The highest Individual Settlement Payment to a Participating Class Member

is currently estimated to be \$1,809.88 and the average Individual Settlement Payment is currently estimated to be \$415.25.⁵⁴ The highest Individual PAGA Payment to an Aggrieved Employee is current estimated to be \$71.79 and the average Individual PAGA Payment is currently estimated to be \$17.54.⁵⁵ These are significant individual recoveries, particularly in light of the risks of litigation.

Class Counsel believes that the Settlement as a whole is fair, reasonable, and adequate.⁵⁶ Although Class Counsel's recommendations are not conclusive, the Court can properly take the recommendations into account, particularly if Class Counsel appears to be competent, has experience with this type of litigation, and significant discovery and investigation have been completed, as is the case here. Conte & Newberg, *Newberg on Class Actions* (4th Ed., 2002) § 11.47. Accordingly, the Court should grant final approval of the Settlement.

D. The Class Was Represented by Competent Counsel.

Class Counsel has extensive experience in employment class action law and complex wage-and-hour litigation.⁵⁷ Lawyers for Justice, PC has been appointed class counsel in numerous complex wage-and-hour cases, and has recovered millions of dollars for individuals in California.⁵⁸ Both Parties' counsel were capable of assessing the strengths and weaknesses of the Class Members' claims against Defendant and the benefits of the Settlement under the circumstances of the lawsuits and in the context of a private, consensual settlement agreement.

E. There Are No Written Objections to the Class Settlement.

The Settlement has been well received by the Class – *not a single Class Member objected to the Settlement*.⁵⁹ Specifically, no objections have been made as to the Gross Settlement Amount or contemplated Class Counsel Fees Payment and Class Counsel Litigation Expenses, Class Representative Service Payment, Administration Expenses, and allocation for the PAGA Penalties. California courts have consistently found that a small number of objectors indicates support for a settlement and strongly favors final approval.⁶⁰

Here, the lack of any objections speaks volumes about the fairness, reasonableness, and adequacy of this Settlement. Accordingly, the Settlement as a whole is presumed to be fair, reasonable, and adequate, and the Court should grant final approval of the Settlement in its entirety. *Dunk*, 48 Cal.App.4th at 1802.

VII. THE ATTORNEYS' FEES REQUESTED SHOULD BE APPROVED.

A. A Fee Award of a Percentage of the Entire Fund Is Appropriate.

Under the terms of the Settlement Agreement, Defendant will pay a Gross Settlement Amount of \$2,385,752.35.⁶¹ The requested attorneys' fees are thirty-five percent (35%) of the total value of the monetary settlement.⁶² In light of Class Counsel's successful prosecution and resolution of this matter, the requested attorneys' fees are appropriate and reasonable.

Where the amount of a settlement is a "certain easily calculable sum of money," California courts may calculate attorneys' fees as a reasonable percentage of the settlement. Weil and Brown, *California Practice Guide, Civil Procedure Before Trial*, Chapter 14, § 14:145; *In re Bluetooth Headset Prods. Liab. Litig.* (9th Cir. 2011) 654 F.3d 935, 942 (The percentage method is particularly appropriate where a monetary settlement has been recovered and "the benefit [recovered can be] easily quantified."); see also *Laffitte v. Robert Half Int'l Inc.* (2016) 1 Cal.5th 480, 503; *Dunk* at 1808. Courts may calculate and award attorneys' fees as a percentage of a monetary fund that has, by litigation, been preserved or recovered for the benefit of others. *Laffitte* at 486 & 506. Trial courts "retain the discretion to forgo a lodestar cross-check and [may] use other means to evaluate the reasonableness of a requested percentage fee." *Id.* (internal quotes omitted); see also *Wershba, supra*, 91 Cal.App.4th at 253.

Courts award fees as an economic incentive for lawyers to pursue litigation that will enhance and facilitate access to the judicial system for meritorious claims, deter wrongdoing, and address multiple similar alleged wrongs that would not be economically feasible to pursue individually, such as here. See A. Conte, *Attorney Fee Awards* (2d ed. 1993) 104, at 6.

The percentage fee method is preferred in representative actions because "it better approximates the workings of the marketplace than the lodestar approach." *Lealao v. Beneficial Cal., Inc.* (2000) 82 Cal.App.4th 19, 49. California law provides that the award for attorneys' fees should be equivalent to

fees freely negotiated in the legal marketplace and paid in comparable litigation based on the result achieved and risk incurred. *Id.* at 47-50; *Laffitte* at 503. In cases where the settlement agreement provides that the defendant will pay the plaintiff's attorneys a percentage of the fund created by the settlement, use of that percentage method is appropriate. *Lealao* at 32. Fee awards that are too small will "chill the private enforcement essential to the vindication of many legal rights and obstruct the representative actions that often relieve the courts of the need to separately adjudicate numerous claims." *Id.* at 53. Therefore, fees in representative actions should approximate the probable terms of a contingent fee contract negotiated by a sophisticated attorney and client in comparable litigation. *Id.* at 48. "The ultimate goal . . . is the award of a 'reasonable' fee to compensate counsel for their efforts, irrespective of the method of calculation." *Consumer Privacy Cases* (2009) 175 Cal.App.4th 545, 557-58 (quoting *Apple Computer, Inc. v. Superior Court* (2005) 126 Cal.App.4th, 1253, 1270).

Class Counsel's application for attorneys' fees in light of the facts and circumstances surrounding the case is well-within the range of reasonableness. Courts have awarded fees as high as 50% of the settlement in complex actions, depending on the circumstances of the case.⁶³

Class Counsel has performed significant work in this matter, as discussed in the Declaration of Vartan Madoyan with the very real possibility of an unsuccessful outcome and no fee recovery of any kind.⁶⁴ In the present matter, Class Counsel has borne all of the risks and costs of litigation and will not receive any compensation until recovery is obtained.⁶⁵ Class Counsel is experienced in complex wage-and-hour litigation and used that experience to obtain a significant settlement recovery for Plaintiff, the Class, and the State of California.⁶⁶ Considering the amount of fees requested, work performed, risks incurred, results obtained, and experience of Class Counsel in handling similar matters, Plaintiff maintains that the requested attorneys' fees are reasonable and should be awarded.

Compensating class counsel in class litigation on a percentage basis, as requested herein, makes good sense because: (1) it is consistent with the private marketplace where contingent fee attorneys are customarily compensated on such a basis; (2) it aligns the interests of class counsel and absent class

members in achieving the maximum possible resolution of the case; and (3) it encourages the most efficient and expeditious resolution of the litigation by providing an incentive for early, yet reasonable, settlement. The attorney fee request here satisfies all of these factors and should be approved on a percentage basis.

The percentage method is consistent with, and is intended to mirror, the practice in the private marketplace where contingent-fee attorneys typically negotiate percentage-fee arrangements with their clients. The named plaintiff's agreement to pay a contingent fee is powerful evidence of a reasonable fee. One of the best ways to demonstrate the value of counsel's work to the class is to review the consideration agreed to be paid by the named plaintiff. If the named plaintiff has employed counsel on a contingency-fee basis, it would indeed be inequitable for the members of the class, who will enjoy the benefits of the settlement without incurring the risks of bringing the claim, to pay less than the named plaintiff. In this case, Plaintiff has agreed to a contingency fee agreement of at least thirty-five percent (35%) of the recovery.⁶⁷

Class Counsel has obtained a substantial recovery on behalf of Plaintiff, the Class, and the State of California and the results achieved justify an attorneys' fees award that is the equivalent of the standard market fee and that is consistent with the contingency-fee agreement entered into by and between Plaintiff and Class Counsel. Thus, the requested attorneys' fees are appropriate.

B. The Attorneys' Fees Requested Are Reasonable Based on the Factors Considered in Determination of Fee Awards.

The factors which courts consider in determining whether fee awards are reasonable, all of which support the fee award requested by Class Counsel, are: the time and labor required; the novelty and difficulty of the questions involved; the skill requisite to perform the legal services properly; the preclusion of other employment by the attorney due to the acceptance of the case; the customary fee; whether the fee is fixed or contingent; the time limitation imposed by the client or the circumstances; the amount involved and results obtained; the experience, reputation, and ability of the attorney; the undesirability of the case; the nature and length of the professional relationship with the client; and awards

3 The award of attorneys’ fees in the amount of \$835,014.00 (which is 35% of the Gross
4 Settlement Amount) is commensurate with the time, effort, and expense dedicated to this matter, the
5 contingent nature of Class Counsel’s fee recovery and the risks taken, the skill and determination
6 required, the results that Class Counsel has achieved, and the value of the settlement that Class Counsel
7 has obtained in this matter.

8 ***1. Time & Labor.***

9 Class Counsel used its experience and skills, and dedicated the full extent of resources, to litigate
10 and bring this matter to a successful conclusion.⁶⁸

11 As outlined in the Declaration of Vartan Madoyan, Class Counsel has fully and actively
12 participated in litigation of this matter.⁶⁹ Prior to commencing the lawsuits, Class Counsel had conducted
13 a significant amount of investigation into the factual and legal issues, Defendant’s business and its
14 operations, and employment policies, practices, and procedures.⁷⁰ During the litigation of this matter,
15 Class Counsel had interviewed Plaintiff and numerous other class members, aggrieved employees, and
16 percipient witnesses; reviewed and analyzed of a large volume of information, documents and data
17 obtained from Defendant, Plaintiff, and other sources; and prepared liability, damages, penalties, and
18 valuation calculations.⁷¹ The Parties also engaged in significant motion practice and Plaintiff filed an
19 appeal with the California Court of Appeals. Class Counsel also met and conferred with Defendant’s
20 counsel on numerous occasions e.g., to discuss issues relating to the pleadings, case management, motion
21 practice, informal discovery, and the production of information, documents and data among other things,
22 and prepared for and attended court proceedings, mediation, and settlement negotiations.⁷²

23 Counsel has dedicated staffing and monetary resources necessary to prosecute this matter
24 diligently and with maximum efficiency and has fully and actively participated in the litigation
25 process.⁷³ The Attorney Task and Time Chart, which is attached as “EXHIBIT A” to the

1 accompanying Declaration of Vartan Madoyan, sets forth in detail the hours that attorneys at Lawyers for
2 Justice, PC have spent performing tasks in this matter.⁷⁴ Class Counsel has spent **498.60** hours
3 performing tasks and to obtain a significant recovery in this matter.⁷⁵ These hours were required to bring
4 this matter to its successful conclusion. In light of the value of Class Counsel's work and the carrying of
5 costs involved in litigating this matter, the requested attorneys' fees are fair, adequate, and reasonable.

6 **2. The Skill Required to Perform Legal Services Properly.**

7 The skill required to properly litigate this matter is evident from the results achieved, the steps
8 necessary to reach those results, and that Defendant retained well-respected counsel to represent it.

9 Class Counsel exercised its skill to perform significant investigation, analysis, and research prior
10 to filing the cases, during the litigation, and prior to and during the mediation and settlement negotiations.
11 Class Counsel took steps to prepare the matter for class certification and representative adjudication
12 and had every intention of taking this matter to trial on a class-wide basis if Defendant did not offer an
13 appropriate class-wide settlement. Despite all of the obstacles that had to be overcome, as demonstrated
14 in the Declaration of Vartan Madoyan, Class Counsel used its extensive experience in the handling of
15 class actions and complex wage-and-hour matters in order to obtain the Settlement with maximum
16 efficiency.⁷⁶

17 **3. Whether the Fee Is Fixed or Contingent.**

18 Plaintiff entered into a contingency fee agreement with Class Counsel, and the representation of
19 the Class provided by Class Counsel has been wholly contingent.⁷⁷ Class Counsel has invested **498.60**
20 hours of time to obtain relief on behalf of Plaintiff, the Class, and the State of California.⁷⁸ Class
21 Counsel has also incurred litigation costs and expenses in the amount of \$20,541.66.⁷⁹ Thus, Class
22 Counsel has borne all of the risks and costs of litigation and will not receive any compensation until
23 recovery is obtained.⁸⁰

1 In determining the reasonableness of a fee award in a class action settlement, whether or not
2 representation is provided on a contingency basis is an important factor:

3 A contingent fee must be higher than a fee for the same legal services paid as they are
4 performed. The contingent fee compensates the lawyer not only for the legal services he
5 renders but for the loan of those services. A lawyer who both bears the risk of not being
6 paid and provides legal services is not receiving the fair market value of his work if he is
7 paid only for the second of these functions. If he is paid no more, competent counsel will
8 be reluctant to accept fee award cases.

9 *Cates v. Chiang* (2013) 213 Cal.App.4th 791, 823 (internal quotes and citations omitted). Class Counsel
10 litigated this matter on a contingent basis with all of the concomitant risk factors inherent in such an
11 uncertain undertaking. Had Class Counsel not been successful, the time that Class Counsel has devoted
12 to litigating this matter would have been for naught, and would not have produced any fee or any
13 reimbursement of costs or expenses. See *Vizcaino v. Microsoft* (9th Cir. 2002) 290 F.3d 1043, 1048-49
14 (discussing the risks of engaging in litigation without certainty of compensation).

15 **4. The Amount Involved and the Results Achieved.**

16 The Settlement represents an excellent resolution of this matter, given the risks inherent in
17 litigating the matter through class certification proceedings, trial, and/or appeals. Had this matter not
18 settled, Defendant would have vigorously challenged certifiability, and liability. Defendant, however,
19 faced risks if the Court certified a class and allowed a jury to decide the claims. Additionally, preparing
20 this matter for trial would have been expensive for the Parties. The Settlement at this stage is preferred
21 over continued litigation because such resolutions save time and money that would otherwise go to
22 litigation. The risks and expenses of further litigation outweighed any benefit that might have been gained
23 otherwise. The Settlement provides an immediate recovery, as opposed to an uncertain result in the future
24 after costly, risk, and prolonged litigation involving expert discovery, trial preparation, class certification
25 proceedings, and appellate review of those proceedings.

26 The results achieved, in light of the difficulties inherent in similar cases and the specific
27 difficulties faced in this matter, are considerable.⁸¹ Class Counsel obtained a significant settlement of
28 \$2,385,752.35.⁸² The Settlement has yielded a positive response from the Class Members—no Class

Members objected to the Class Settlement.⁸³ Thus, these facts weigh in favor of granting the requested fees.

5. The Reputation and Ability of the Attorneys.

Lawyers for Justice, PC is a recognized class action law firm that employed its attorneys' knowledge, skills, and experience in bringing this case to a successful conclusion.⁸⁴ Class Counsel has years of complex and class action litigation experience, has recovered millions of dollars on behalf of thousands of individuals in California, and has successfully handled numerous significant wage-and-hour class action and complex cases.⁸⁵

C. The Lodestar Methodology Also Justifies Approval of the Requested Fees.

While the percentage-of-the-benefit approach is endorsed as the better approximation of the workings of the marketplace than the lodestar approach, courts may also use the lodestar method to "cross-check" the results of the other.⁸⁶ The lodestar is calculated based on reasonable hours at reasonable prevailing hourly rates for the attorneys, and counsel is entitled to compensation for every hour reasonably spent on the matter. *Ketchum v. Moses* (2001) 24 Cal.4th 1122, 1131-33. The reasonableness of hours is assessed by "the entire course of the litigation, including pretrial matters, settlement negotiations, discovery, litigation tactics, and the trial itself[.]" *Vo v. Las Virgenes Municipal Water Dist.* (2000) 79 Cal.App.4th 440, 447.

As discussed above and in the Declaration of Vartan Madoyan, Class Counsel expended significant time and labor in this highly contested matter.⁸⁷ Class Counsel has been actively involved in the prosecution of this case (including appeals), and the work performed in said case has precluded other employment.⁸⁸ Class Counsel bore the risk that, despite all of its efforts and skills employed, there may be no recovery.⁸⁹ Ultimately, Class Counsel was successful in reaching a sizable settlement of

1 \$2,385,752.35.⁹⁰ The Attorney Task and Time Chart sets forth in detail the numerous tasks that Class
2 Counsel performed in this matter, and the time required for completing those tasks.⁹¹ The chart
3 demonstrates that Class Counsel has spent a total of **498.60** hours litigating this matter and finalizing the
4 Settlement.⁹² In light of the facts and circumstances of this matter, as well as the results that Class
5 Counsel has achieved, Class Counsel has spent a reasonable number of hours performing work on this
6 matter. In addition, Class Counsel will continue to perform work on this matter through the date of final
7 approval and in connection with the implementation of the Settlement.

8 As set forth in the Declaration of Vartan Madoyan, the professional background and experience
9 of Class Counsel support a reasonable rate of compensation of at least \$850 per hour for services
10 provided by Class Counsel.⁹³ Lawyers for Justice, PC has been awarded attorneys' fees, compensating
11 the firm at the blended rate of at least \$850 per hour for legal service performed, by courts of this state.⁹⁴
12 While the circumstances of every case are unique, the fact remains that the work performed by Class
13 Counsel in this matter justify the requested attorneys' fees.

14 Applying the rate of \$850 per hour to 498.60 hours worked by Class Counsel, would place a
15 base lodestar value of \$423,810.00 on the services provided by Class Counsel. However, courts also
16 generally apply a multiplier in consideration for risk, efficiency, and/or obtaining a substantial result, to
17 enhance the lodestar for purpose of cross-check. *See Ketchum* at 1133-34 (holding that a risk multiplier
18 may be applied to compensate contingency fee attorneys at a fair market rate).⁹⁵ The risks involved, skill
19 required, complexity of the matter, and results obtained warrant upward enhancement of the lodestar.⁹⁶

In determining whether or not to enhance the lodestar, California courts take into account multiple factors, many of which were specifically addressed above. See, *Cates* at 822-23. Multiple factors warrant enhancement of the lodestar in this case, including the following: the time and labor required; the skill requisite to perform the legal services properly; the preclusion of other employment by the attorney due to the acceptance of these cases; the contingent nature of the fee; the amount involved and results obtained; the experience, reputation, and ability of the attorney; and awards in similar cases. *Ketchum* at 1134. Therefore, a multiplier of 1.98 should be applied. Applying the rate of \$850 per hour to 498.60 hours for services provided by Class Counsel results in a base lodestar value of \$423,810.00 for the work performed by Class Counsel, and applying a modest multiplier of 1.98⁹⁷, the total enhanced lodestar fees are \$839,143.80.

The lodestar method as a cross-check to the percentage award sought herein, strongly supports the reasonableness of the requested attorneys' fees. The nature of the work performed, skill exercised, and the outcome in this matter—which involves an outstanding monetary recovery involving a Gross Settlement Amount of \$2,385,752.35 (with a Net Settlement Amount of approximately at least \$1,302,638.39 to be paid to Participating Class Member (with gross Individual Settlement Payments averaging approximately more than \$415.25), payment of \$50,000.00 to Aggrieved Employees, and payment of \$150,000.00 to the State of California)—support the percentage fee sought. Accordingly, the Court is respectfully requested to award attorneys' fees in the amount of \$835,014.00 to Class Counsel.

VIII. REIMBURSEMENT OF CLASS COUNSEL'S LITIGATION COSTS AND EXPENSES SHOULD BE APPROVED.

The Settlement provides for reimbursement of litigation costs and expenses of up to \$25,000.00. As set forth in the Declaration of Vartan Madoyan, Class Counsel only seeks reimbursement of

\$20,541.66 in litigation costs and expenses incurred in this matter.⁹⁸ This amount was reasonable and necessary in the prosecution of this matter and to obtain the Settlement, and is less than the maximum amount allocated under the Settlement Agreement.⁹⁹ The cost savings of \$4,458.34 will be part of the Net Settlement Amount, which will be distributed to Participating Class Members in accordance with the Settlement.¹⁰⁰ Accordingly, Plaintiff requests that the Court award litigation costs and expenses in the amount of \$20,541.66 to Class Counsel.

IX. THE SETTLEMENT ADMINISTRATION EXPENSES SHOULD BE APPROVED.

As set forth in the accompanying Simpluris Inc. Declaration, the total costs incurred and to be incurred by Simpluris Inc. for the notice and settlement administration process are \$17,558.00.¹⁰¹ The costs incurred and to be incurred include, but are not limited to, establishing and maintaining a settlement fund account; establishing and maintaining a calendar of administrative deadlines and responsibilities; processing, issuing, and transmitting settlement payments; distributing notice of the Settlement to the Class; receiving and validating Request for Exclusions, Objections, or Workweeks Disputes submitted by Class Members; calculating Employer Taxes and providing appropriate forms and calculations to Defendant; providing counsel with weekly reports; and other tasks as the Parties mutually agree or the Court orders Simpluris Inc. to perform.¹⁰²

Accordingly, the Court should grant final approval of payment to Simpluris Inc., a necessary third-party for its handling of the notice and settlement process, in the amount of \$17,558.00.

X. THE CLASS REPRESENTATIVE SERVICE PAYMENT SHOULD BE APPROVED.

Plaintiff requests a Service Payment, in the amount of \$10,000.00 to herself, for her efforts and work spearheading the prosecution of this matter and serving as the Class Representative, as well as her broader individual waiver and release of claims with a California Civil Code Section 1542 waiver. Such enhancement awards are common, and the one requested here is reasonable.¹⁰³

Plaintiff spent a substantial amount of time and effort providing the facts and evidence necessary to support the prosecution of the claims.¹⁰⁴ Plaintiff was available whenever Class Counsel needed her and actively tried to obtain, and gave, information to support the pursuit of this matter.¹⁰⁵

Accordingly, it is appropriate and just for Plaintiff Joana Flores to receive \$10,000.00 as a reasonable Class Representative Service Payment, in addition to her Individual Settlement Payment.

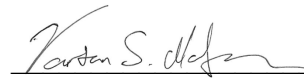
XI. CONCLUSION
