1. I am over 18 years of age and a resident of California. I am one of the named plaintiffs in the above-captioned case. I have personal knowledge of the facts and statements set forth in this declaration, and if called upon to testify, I could and would competently testify thereto.

3. I have spent over **7 hours** communicating with my attorneys regarding the case and fulfilling my responsibilities as a class representative, which has included gathering documents concerning my employment with Clinica Sierra Vista, reviewing documents with my attorneys and answering their questions, providing information regarding the duties of other hourly-paid employees and helping develop a strategy as to what documents and information to obtain from Clinica Sierra Vista. I routinely checked in with my attorneys and their staff to make sure that they had all of my most current information and any additional information that I had obtained.

4. I was available to answer any questions my attorneys had, and available to speak and meet with my attorneys whenever they needed me. I responded to them as quickly as possible and gave them as much information and identified as many documents as I could. I spent at least **2 additional hours** speaking with my attorneys about the case, identifying

1 potential witnesses, providing my attorneys with documents and information concerning the
2 case, and also describing policies, practices, and procedures of Clinica Sierra Vista.

3 5. As far as the settlement is concerned, I spent about **1 hour** reviewing the
4 settlement agreement and asking questions and discussing the potential settlement with my
5 attorneys before signing the settlement agreement.

6 6. I believe that I have done everything that my attorneys have asked of me and have
7 tried, to the best of my ability, to represent the class. I think my efforts helped to get the result
8 obtained in this case, and as a class representative, I respectfully request that the Court award me
9 an incentive award in the amount of \$7,500.00 for my active participation in this case. Taking
10 into consideration the time that I have dedicated to this case, I believe that this amount is
11 reasonable.

12 7. I am not related to anyone associated with Lawyers *for* Justice, PC.

13 8. I have not entered into any undisclosed agreements, nor have I received any
14 undisclosed compensation in this case. The only compensation I will receive is whatever amount
15 the Court awards as an enhancement payment, as well as my share of the settlement as a class
16 member.
