On February 26, 2025, this Court issued an Order Granting Approval of PAGA Settlement and Final Judgment ("Order and Judgment"), approving the settlement between Plaintiff Jordan Andrew Pitt ("Plaintiff") and Defendant The Brigantine, Inc. ("Defendant") resolving the Private Attorneys General Act ("PAGA") claims in this matter (the "Settlement"). Pursuant to the Settlement and the Order and Judgment, the funds from any uncashed checks would be forwarded to Breakthrough T1D. On August 6, 2025, the Court ordered the transmission of recovered settlement funds of \$3,098.36, in addition to any unclaimed funds, to Breakthrough T1D. Concurrent with the submission of the instant Amended Order and Judgment, Plaintiff submitted the Declaration of Amanda Howard of ILYM Group, Inc. Regarding Disbursement of Settlement Funds confirming that the total residual funds, including funds from uncashed checks, amount to \$50,551.47.

IT IS HEREBY ORDERED, ADJUDGED AND DECREED AS FOLLOWS:

1. The Order and Judgment is amended to provide that the residual funds from the Settlement, in the total amount of \$50,551.47, shall be released to Breakthrough T1D.
