[PROPOSED] ORDER

The Motion for Approval of Representative Action Settlement (“Motion”) came before this Court, the Honorable Danielle Douglas, presiding. The Court, having considered the papers submitted in support of the motion of the parties, **HEREBY ORDERS THE FOLLOWING:**

Having considered Plaintiffs’ Motion, and all legal authorities and documents submitted in support thereof, including the PAGA Settlement Agreement (“Agreement”), attached to the Declaration of Kelsey M. Szamet as Exhibit “1”, and good cause appearing, IT IS HEREBY ORDERED that Plaintiffs’ Motion is GRANTED, subject to the following findings and orders:

1. The Court finds the Settlement fair and reasonable.
2. The Court approves the Gross Settlement Amount of \$140,000.00.
3. The Court approves the PAGA Penalties in the amount of \$50,451.34.
4. The Court approves 75% of the PAGA Penalties being allocated to the LWDA in the amount of \$37,838.51.
5. The Court directs that the remaining 25% of the PAGA Penalties, in the amount of \$12,612.84 shall be allocated to the Aggrieved Employees.
6. The Court approves PAGA Counsel’s request for reimbursement of case costs in the amount of \$25,881.99 and attorneys’ fees in the amount of \$46,666.67.
7. The Court approves the settlement administration costs of \$7,000.00.
8. The Court approves the enhancement award for Plaintiffs, in the amount of \$10,000.00, to Plaintiffs MONICA ARMSTRONG and KENDRA L. MCGHEE.
9. Pursuant to C.C.P §664.6, the Court shall have and retain continuing jurisdiction over this action and the Parties and the Aggrieved Employees including after the entry of this Order, to the fullest extent necessary to interpret, enforce and effectuate the terms and intent of the Agreement and this Order.

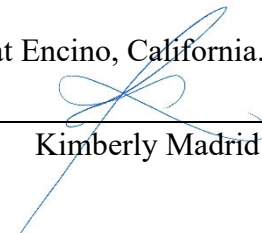
