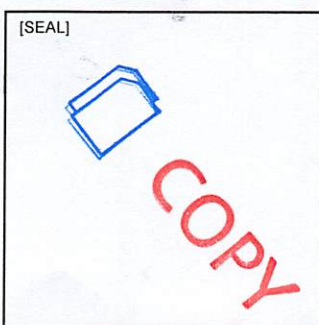

DEMAND FOR JURY TRIAL

Plaintiff TYLOR JOHNSEN ("Plaintiff"), on behalf of herself and other "aggrieved
employees" complains of Defendants as follows:

I. INTRODUCTION

1. This is a Representation Action, pursuant to Labor Code § 2698, 2699 et seq., on
behalf of Plaintiff and certain individuals who are employed by, or were formerly employed by
Restif Cleaning Service Cooperative, Inc. and any subsidiaries or affiliated companies (hereinafter
collectively referred to as "Defendants") within California.

2. For at least one (1) year prior to the filing of this action and continuing to the present
(the "liability period"), Defendants have had a consistent policy of failing to pay all final wages due
at termination or within seventy-two (72) hours after separation to all employees in California, and
failing to provide employees with accurately itemized wage statements.

1 3. Defendants further failed to pay premium wages to Plaintiff and all other aggrieved
2 employees who were denied meal and rest breaks. Plaintiff and Defendant's California employees
3 were routinely unable, and not authorized to take their ten (10) minute rest periods and were also
4 unable to take an uninterrupted thirty (30) minute meal break for every shift they worked.
5 Specifically, Plaintiff and Defendant's California employees were forced to continue working
6 through their meal and rest breaks in order to assist Defendant's needs. Because of this, Plaintiff
7 and Defendant's California employees were unable to take their required meal and rest breaks.
8 Moreover, Defendants failed to pay premium wages of one hour's pay for each missed meal and
9 rest break to Plaintiff and Defendants' California employees who were denied timely meal and rest
10 breaks, in violation of Labor Code §§ 226.7, 512, and 558, and IWC Order No. 5-2001, Section 12.

11 4. Plaintiff and all other California employees of Defendants also claims that
12 Defendants have failed to pay all overtime wages due to non-exempt employees. As a result,
13 employees are not properly compensated for work performance in excess of eight (8) hours in a
14 workday and work performed in excess of forty (40) hours in a workweek at a rate of no less than
15 one and one-half times the regular rate of pay. Employees of Defendants regularly work in excess
16 of eight (8) hours in a day or more than forty (40) hours per week and do not receive overtime
17 compensation at a rate of one and one half of their regular rate. Plaintiff and Defendant's California
18 employees were forced to work overtime and were not paid for all hours worked including all
19 straight time wages, and overtime wages. These failures to pay all overtime wages constitute
20 violations of Labor Code §§ 510, 1194, 1194.2.

21 5. Defendants failed to issue Plaintiff and Defendant's California employees accurately
22 itemized wage statements. As Defendants failed to compensate Plaintiff and Defendants' California
23 employees with all wages due, as detailed above, their wage statements failed to accurately state all
24 gross wages earned, in violation of Labor Code § 226(a)(1), total hours worked, in violation of
25 Labor Code § 226(a)(2), and net wages earned, in violation of Labor Code § 226(a)(5). Moreover,
26 Plaintiff and the California employees wage statements' failed to accurately state all applicable
27 hourly rates during the pay period and the corresponding number of hours worked, in violation of
28 Labor Code § 226(a)(9), as a result of Defendant's failure to pay all overtime wages due. These
violations also violate Labor Code §§ 226(e) and 226.3 with respect to Plaintiff and Defendant's
California employees.

6. Plaintiff further alleges that Defendant paid her and other of its non-exempt California employees their final wages beyond the time frames set forth in Labor Code §§ 201 and 202. As they were not paid all wages due and owing throughout the course of their employment as a result of Defendant's failure to pay all premium wages as detailed above, at the time of their separation, they were not paid all final wages due and owing for the entirety of their employment. This violates Labor Code §§ 201-203.

7. Defendant pays Plaintiff and it's California employees on a bi-monthly basis and has failed to comply with Labor Code § 204(a) which holds that wages earned on a bi-monthly basis must be paid no later than ten calendar days following the close of the payroll period. Due to the violations described above, Plaintiff and Defendant's California employees did not receive all of their wages earned in a timely manner as required by Labor Code § 204(a)(b).

8. Defendant failed to reimburse Plaintiff and Defendant's California employees for the equipment they purchased to perform work for Defendant. Labor Code section 2802 provides that "[a]n employer shall indemnify his or her employee for all necessary expenditures or losses incurred by the employee in direct consequence of the discharge of his or her duties." Defendant also failed to reimburse Plaintiff and Defendant's California employees for use of their cell phone when performing their tasks for Defendant. Plaintiff and Defendant's California employees have incurred reasonable and necessary expenses in the course of their job duties, which were not reimbursed by Defendant, in violation of Labor Code § 2802.

9. Plaintiff, on behalf of herself and all other aggrieved employees, brings this action pursuant to Labor Code §§ 226.7, 512, 558, 510, 1194, 1194.2, 226(a)(e), 201-203, 204(a)(b).

10. Venue as to each Defendant is proper in this judicial district, pursuant to Code of Civil Procedure § 395. Defendants operate within the State of California. The unlawful acts alleged herein took place in Samoa, California.

II. PARTIES

A. PLAINTIFF

11. Plaintiff TYLOR JOHNSEN is a resident of Eureka, California. At all times relevant herein, she was employed by Defendants in Humboldt County, California. Plaintiff was employed by Defendants as a non-exempt, hourly employee in California, including in and around the city of

1 Samoa, County of Humboldt. During Plaintiff's employment:

- 2 A. Plaintiff did not receive final wages at the time of her termination.
- 3 B. Plaintiff was required to work without meal and rest periods, nor compensation in lieu
- 4 thereof, as required by the Labor Code and relevant Wage Orders.
- 5 C. Plaintiff was required to work either in excess of eight hours per workday or in excess of
- 6 forty hours per workweek without receiving compensation at a rate of one and one half
- 7 the regular rate of pay.
- 8 D. Plaintiff was forced to receive inaccurately itemized and deficient wage statements, in
- 9 violation of Labor Code § 226(a).
- 10 E. Plaintiff did not receive his compensation in accordance with Labor Code § 204 in that
- 11 Defendants failed to issues wages to its employees within ten (10) calendar days after the
- 12 pay period ended.
- 13 F. Plaintiff was not paid in a timely manner pertaining to the waiting time penalties in
- 14 accordance with Labor Code §§ 201-203.

15 **B. DEFENDANTS**

16 12. Defendant RESTIF CLEANING SERVICE COOPERATIVE, INC., is a California

17 Corporation doing business in Samoa, California. It operates within the State of California.

18 Defendant employed Plaintiff and similarly situated employees within California. The violations

19 alleged herein arose in Samoa, California.

20 13. As used herein, the term "AGGRIEVED EMPLOYEES," and "DEFENDANTS'

21 CALIFORNIA EMPLOYEES," shall mean Defendant RESTIF CLEANING SERVICE

22 COOPERATIVE, INC.'S non-exempt employees.

23 14. The true names and capacities, whether individual, corporate, associate, or otherwise,

24 of Defendants sued herein as DOES 1 to 10, inclusive, are currently unknown to Plaintiff, who

25 therefore sues Defendants by such fictitious names under Code of Civil Procedure § 474. Plaintiff is

26 informed and believes, and based thereon alleges, that each of the Defendants designated herein as a

27 DOE is legally responsible in some manner for the unlawful acts referred to herein. Plaintiff will

28 seek leave of court to amend this Complaint to reflect the true names and capacities of the

Defendants designated hereinafter as DOES when such identities become known.

15 15. Plaintiff is informed and believes, and based thereon alleges, that each Defendant

16 acted in all respects pertinent to this action as the agent of the other Defendants, carried out a joint

1 scheme, business plan or policy in all respects pertinent hereto, and the acts of each Defendant are
2 legally attributable to the other Defendants. Furthermore, Defendants in all respects acted as the
3 employer and/or joint employer of Plaintiff and all other aggrieved employees.

4 **FACTUAL ALLEGATIONS**

5 16. Plaintiff and Defendant's California employees were routinely unable, and not
6 authorized to take their ten (10) minute rest periods and were also unable to take an
7 uninterrupted thirty (30) minute meal break for every shift they worked. Specifically, Plaintiff
8 and Defendant's California employees were forced to continue working through their meal and
9 rest breaks in order to assist Defendant's needs. Because of this, Plaintiff and Defendant's
10 California employees were unable to take their required meal and rest breaks. Moreover,
11 Defendants failed to pay premium wages of one hour's pay for each missed meal and rest break
12 to Plaintiff and Defendants' California employees who were denied timely meal and rest
13 breaks, in violation of Labor Code §§ 226.7, 512, and 558, and IWC Order No. 5-2001, Section
14 12.

15 17. Plaintiff and all other California employees of Defendants also claims that
16 Defendants have failed to pay all overtime wages due to non-exempt employees. As a result,
17 employees are not properly compensated for work performance in excess of eight (8) hours in a
18 workday and work performed in excess of forty (40) hours in a workweek at a rate of no less
19 than one and one-half times the regular rate of pay. Employees of Defendants regularly work in
20 excess of eight (8) hours in a day or more than forty (40) hours per week and do not receive
21 overtime compensation at a rate of one and one half of their regular rate. Plaintiff and
22 Defendant's California employees were forced to work overtime and were not paid for all hours
23 worked including all straight time wages, and overtime wages. These failures to pay all
24 overtime wages constitute violations of Labor Code §§ 510, 1194, 1194.2.

25 18. Defendants failed to issue Plaintiff and Defendant's California employees
26 accurately itemized wage statements. As Defendants failed to compensate Plaintiff and
27 Defendants' California employees with all wages due, as detailed above, their wage statements
28 failed to accurately state all gross wages earned, in violation of Labor Code § 226(a)(1), total
hours worked, in violation of Labor Code § 226(a)(2), and net wages earned, in violation of
Labor Code § 226(a)(5). Moreover, Plaintiff and the California employees wage statements'
failed to accurately state all applicable hourly rates during the pay period and the

1 corresponding number of hours worked, in violation of Labor Code § 226(a)(9), as a result of
2 Defendant's failure to pay all overtime wages due. These violations also violate Labor Code
3 §§ 226(e) and 226.3 with respect to Plaintiff and Defendant's California employees.

4 19. Plaintiff further alleges that Defendants paid her and Defendant's California
5 employees their final wages beyond the time frames set forth in Labor Code §§ 201 and 202.
6 As they were not paid all wages due and owing throughout the course of their employment as a
7 result of Defendant's failure to pay all premium wages as detailed above, at the time of their
8 separation, they were not paid all final wages due and owing for the entirety of their
9 employment. This violates Labor Code §§ 201-203.

10 20. Defendant pays Plaintiff and it's California employees on a bi-monthly basis
11 and has failed to comply with Labor Code § 204(a) which holds that wages earned on a bi-
12 monthly basis must be paid no later than ten calendar days following the close of the payroll
13 period. Due to the violations described above, Plaintiff and Defendant's California employees
14 did not receive all of their wages earned in a timely manner as required by Labor Code §
15 204(a)(b).

16 **CAUSES OF ACTION**

17 **FIRST CAUSE OF ACTION**

18 **PENALTIES PURSUANT TO LABOR CODE § 2699(f) FOR VIOLATIONS OF LABOR 19 CODE §§ 226.7, 512, 558, 510, 1194, 1194.2, 226(a), (e), 201-203, 204(a)(b)**

20 21. Plaintiff incorporates all preceding paragraphs of this Complaint as though fully set
21 forth herein.

22 22. As a result of the acts alleged herein, Plaintiff seeks penalties under Labor Code §
23 2698 *et seq.* because of Defendants' violations of Labor Code §§ 226.7, 512, 558, 510, 1194, 1194.2,
24 226(a), (e), 201-203, 204(a)(b)

25 23. For each such violation, Plaintiff and all aggrieved employees are entitled to penalties
26 in an amount to be shown at the time of trial subject to the following formula:

- 27 a. With respect to the violation of Labor Code § 2699(f) for violations of
28 Labor Code §§ 226.7, 512, 558, 510, 1194, 1194.2, 226(a), (e), 201-203,
204(a)(b), \$100 for the initial violation per employee per pay period and
\$200 for each subsequent violation per employee per pay period.

29 24. These penalties will be allocated 75% to the Labor Workforce Development Agency,

1 and 25% to the affected employees.

2 25. On November 15, 2021, Plaintiff sent a letter, by certified mail, return receipt
3 requested, to the LWDA and Defendants setting forth the facts and theories of the violations alleged
4 against Defendants, as prescribed by Labor Code § 2698 *et seq.* (**Exhibit “A”**). Pursuant to Labor
5 Code § 2699.3(a)(2)(A), no notice was received by Plaintiff from the LWDA within sixty-five (65)
6 calendar days of November 15, 2021. Plaintiff may therefore commence this action to seek penalties
7 pursuant to Labor Code § 2698 *et seq.*

8 26. Wherefore, Plaintiff and the aggrieved employees he seeks to represent request relief
9 as described herein.

10 **ALLEGATIONS AS TO FAILURE TO PROVIDE MEAL PERIODS OR COMPENSATION**
11 **IN LIEU THEREOF (LABOR CODE §§ 226.7, 512, 558)**

12 27. Plaintiff incorporates all preceding paragraphs of this Complaint as though fully set
13 forth herein.

14 28. Plaintiff and all other aggrieved employees are entitled to one hour of pay for each
15 day that Defendants failed to properly provide one or more meal or rest periods as set forth in the
16 IWC Wage Orders and Labor Code §§ 226.7, 512, and 558.

17 29. Defendants have failed to provide Plaintiff and all other aggrieved employees one or
18 more meal or rest periods during their employment. Defendants have failed to compensate Plaintiff
19 and all other aggrieved employees at the rate of one hour or pay at his or her regular rate of pay for
20 each day on which one or more meal or rest periods were not provided.

21 30. Plaintiff and Defendant’s California employees were routinely unable,
22 and not authorized to take their ten (10) minute rest periods and were also unable to take an
23 uninterrupted thirty (30) minute meal break for every shift they worked. Specifically, Plaintiff and
24 Defendant’s California employees were forced to continue working through their meal and rest
25 breaks in order to assist Defendant’s needs. Because of this, Plaintiff and Defendant’s California
26 employees were unable to take their required meal and rest breaks. Moreover, Defendants failed to
27 pay premium wages of one hour’s pay for each missed meal and rest break to Plaintiff and
28 Defendants’ California employees who were denied timely meal and rest breaks, in violation of
Labor Code §§ 226.7, 512, and 558, and IWC Order No. 5-2001, Section 12.

29 31. Pursuant to Labor Code §§ 226.7 and 512, Plaintiff seeks the payment of all meal
and rest period compensations, which she was owed since she commenced working for Defendants,

1 according to proof.

2 32. Additionally, Plaintiff is entitled to, and seeks, attorney's fees and costs, and
3 prejudgment interest.

4 **ALLEGATIONS AS TO FAILURE TO PAY ALL WAGES**
5 **IN VIOLATION OF (LABOR CODE §§ 510, 1194, 1194.2)**

6 33. Plaintiff incorporates all preceding paragraphs of this Complaint as though fully set
7 forth herein.

8 34. Plaintiff and all other California employees of Defendants also claims that
9 Defendants have failed to pay all overtime wages due to non-exempt employees. As a result,
10 employees are not properly compensated for work performance in excess of eight (8) hours in a
11 workday and work performed in excess of forty (40) hours in a workweek at a rate of no less than
12 one and one-half times the regular rate of pay. Employees of Defendants regularly work in excess of
13 eight (8) hours in a day or more than forty (40) hours per week and do not receive overtime
14 compensation at a rate of one and one half of their regular rate. Plaintiff and Defendant's California
15 employees were forced to work overtime and were not paid for all hours worked including all
16 straight time wages, and overtime wages. These failures to pay all overtime wages constitute
17 violations of Labor Code §§ 510, 1194, 1194.2.

18 35. As a result of the unlawful acts of Defendants in willfully failing to pay all wages,
19 Plaintiff and Defendant's California employees have been deprived of wages in amounts to be
20 determined at trial, and are entitled to restitution and recovery of such amounts, plus interest thereon,
21 attorneys' fees, and costs pursuant to Labor Code § 1194 and liquidated damages pursuant to Labor
22 Code § 1194.2.

23 **ALLEGATIONS AS TO KNOWING AND INTENTIONAL FAILURE TO COMPLY WITH**
24 **ITEMIZED EMPLOYEE WAGE STATEMENT PROVISIONS**
25 **(LABOR CODE § 226(a), (e))**

26 36. Plaintiff incorporates all preceding paragraphs of this Complaint as though fully set
27 forth herein.

28 37. Section 226(a) of the California Labor Code requires Defendants to provide wage
statements to employees. In those wage statements, Defendants must accurately set forth, among
other things, the total gross and net wages earned, the total hours worked, and the hourly rates in
effect, for its employees. Defendants have knowingly and intentionally failed to comply with Labor

1 Code § 226(a).

2 38. Defendant failed to issue Plaintiff and Defendant's California employees accurately
3 itemized wage statements. As Defendant failed to compensate Plaintiff and other non-exempt
4 California employees with all wages due, as detailed above, their wage statements failed to
5 accurately state all gross wages earned, in violation of Labor Code § 226(a)(1), total hours worked,
6 in violation of Labor Code § 226(a)(2), net wages earned, in violation of Labor Code § 226(a)(5).
7 Moreover, Plaintiff and the California employees wage statements' failed to accurately state all
8 applicable hourly rates during the pay period and the corresponding number of hours worked, in
9 violation of Labor Code § 226(a)(9), as a result of Defendant's failure to pay all overtime wages due.
10 These violations also violate Labor Code §§ 226(e) and 226.3 with respect to Plaintiff and
11 Defendant's California employees.

12 39. The wage statements provided to Plaintiff and all other aggrieved employees fail to
13 accurately itemize in wage statements total gross and net wages earned, and the total hours worked,
14 and all hourly rates in effect, for its employees. Defendants' violations of Labor Code § 226(a) are
15 knowing and intentional, and Plaintiff has suffered injury as a result of the receipt of defective wage
16 statements, thereby entitling her to penalties pursuant to Labor Code § 226(e).

17 **ALLEGATIONS AS TO FAILURE TO PAY WAGES DUE AT THE TIME OF**
18 **DISCHARGE IN VIOLATION OF LABOR CODE §§ 201-202, RESULTING IN**
19 **SECTION 203 WAGES AND PENALTIES (WAITING TIME PENALTIES)**

20 40. Plaintiff hereby incorporates all preceding paragraphs of this Complaint as
21 though fully set forth herein.

22 41. At all times material herein, the California Labor Code Sections 201, 202, and
23 203 were in effect and binding on Defendants.

24 42. California Labor Code § 202 requires employers to pay employees all wages due
25 within seventy-two (72) hours of resignation. California Labor Code § 201 states in pertinent
26 part that "if an employer discharges an employee, the wages earned and unpaid at the time of
27 discharge are due and payable immediately." California Labor Code § 203 provides that if an
28 employer willfully fails to timely pay such wages the employer must, as penalty, continue to
pay the subject employee's wages until the back wages are paid in full or an action is
commenced. The penalty cannot exceed 30 days of wages.

43. Plaintiff was entitled to compensation for unpaid wages, but to date has not

1 received such compensation. Specifically, Defendants failed to pay Plaintiff all wages due to
2 Plaintiff at the time of her termination. Thus, since Defendants failed to promptly pay Plaintiff
3 all wages due to Plaintiff at the time of her termination, Defendants violated Section 201 of the
4 Labor Code and Plaintiff is therefore entitled to wages and penalties pursuant to Labor Code
5 Section 203.

6 44. More than 30 days have passed since Plaintiff's employment ended with
7 Defendants.

8 45. As a consequence of Defendants' willful conduct in not paying wages owed to
9 Plaintiff, Plaintiff is entitled to 30 days of wages as a penalty pursuant to Labor Code § 203 for
10 Defendants' failure to timely pay legal wages.

11 **ALLEGATIONS AS TO FAILURE TO TIMELY PAY EMPLOYEES**
12 **IN VIOLATION OF LABOR CODE § 204(a)(b)**

13 46. Plaintiff incorporates all preceding paragraphs of this Complaint as though fully set
14 forth herein.

15 47. At all times relevant herein, Labor Code § 204 was in full force and effect and
16 binding on Defendants.

17 48. Wages must be paid according to a regularly set schedule. (Labor Code § 204). All
18 earned wages must be paid at least twice a month, on days designated in advance by the employer.
19 Work performed between the 1st and the 15th days, inclusive, of any calendar month must be paid
20 between the 16th and 26th day of the same month. Work performed between the 16th and the last
21 day of the month must be paid between the 1st and 10th day of the following month. (Labor Code §
22 204). Weekly or bi-weekly (every two weeks) payroll must be paid within seven (7) days of the end
23 of the pay period in which the wages were earned (Labor Code §§ 204(a), 204(b)).

24 49. Defendants pay Plaintiff and its California employees on a bi-monthly basis and have
25 failed to comply with Labor Code § 204(a) which holds that wages earned on a bi-monthly basis
26 must be paid no later than ten calendar days following the close of the payroll period. Due to the
27 violations described above, Plaintiff and Defendants' California employees did not receive all of
28 their wages earned in a timely manner as required by Labor Code § 204(a)(b).

50. Defendants have failed to comply with the above-section because they waited longer
than ten days from the close of the pay period to pay its bi-monthly paid employees.

RELIEF REQUESTED

WHEREFORE, Plaintiff prays for the following relief:

1. For penalties pursuant to Labor Code § 203 for Plaintiff and all other aggrieved employees who are no longer employed by Defendants, equal to their daily wage multiplied by thirty (30) days;
2. For penalties pursuant to Labor Code § 226(e) for Plaintiff and all other aggrieved employees;
3. For penalties pursuant to Labor Code § 226.7 for Plaintiff and all other aggrieved employees;
4. For penalties pursuant to Labor Code § 1194.2 for Plaintiff and all other aggrieved employees;
5. For penalties pursuant to Labor Code § 204(b) for Plaintiff and all other aggrieved employees;
6. For penalties and other relief pursuant to Labor Code § 2698 et seq. for Plaintiff and all other aggrieved employees;
7. An award providing for payment of costs of suit pursuant to Labor Code § 2699(g)(1);
8. An award of attorneys' fees pursuant to Labor Code § 2699(g)(1);
9. An award of prejudgment and post-judgment interest;
10. An award providing for payment of costs of suit; and
11. Such other and further relief as this Court may deem just and proper.

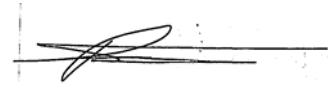

Dear Sir or Madam:

This office represents Tylor Johnsen (“Plaintiff”), a former California employee of Restif Cleaning Service Cooperative, Inc. (“Defendant”). The purpose of this letter is to comply with the Private Attorneys General Act of 2004, pursuant to California Labor Code § 2698 *et seq.*

Our client works for Defendant in Northern California. Herein we set forth the facts and theories of California Labor Code violations which we allege Defendant engaged in with respect to our client and other of its California employees.

Plaintiff began working for Defendants in or around July of 2021. While working for Defendant as a Housekeeper, Plaintiff was fifteen (\$15.00) dollars per hour.

Plaintiff and Defendant's California employees were routinely unable, and not authorized to take their 10-minute rest periods and were also unable to take an uninterrupted 30-minute meal break for every shift they worked. Specifically, Plaintiff and Defendant's California employees were forced to continue working through their meal and rest breaks in order to assist Defendant's needs. Because of this, Plaintiff and Defendant's California employees were unable to take their required meal and rest breaks. Moreover, Defendants failed to pay premium wages of one hour's pay for each missed meal and rest break to Plaintiff and Defendant's California employees who were denied timely meal and rest breaks, in violation of Labor Code §§ 226.7, 512, and 558, and IWC Order No. 5-2001, Section 12.

Plaintiff also claims that Defendant has failed to pay all overtime wages due to non-exempt employees. As a result, employees are not properly compensated for work performance in excess of eight (8) hours in a workday and work performed in excess of forty (40) hours in a workweek at a rate of no less than one and one-half times the regular rate of pay. Employees of Defendant regularly work in excess of eight (8) hours in a day or more than forty (40) hours per week and do not receive overtime compensation at a rate of one and one half of their regular rate. Plaintiff and Defendant's California employees were forced to work overtime and were not paid for all hours worked including all straight time wages, and overtime wages. These failures to pay all overtime wages constitute violations of Labor Code §§ 510, 1194, 1194.2.

Defendants failed to issue Plaintiff and Defendant's California employees accurately itemized wage statements. As Defendants failed to compensate Plaintiff and Defendants' California employees with all wages due, as detailed above, their wage statements failed to accurately state all gross wages earned, in violation of Labor Code § 226(a)(1), total hours worked, in violation of Labor Code § 226(a)(2), and net wages earned, in violation of Labor Code § 226(a)(5), and all applicable hourly rates during the pay period and the corresponding number of hours worked, in violation of Labor Code § 226(a)(9), as a result of Defendants' failure to pay all overtime wages due. These violations also violate Labor Code §§ 226(e) and 226.3 with respect to Plaintiff and Defendants' California employees.

Our client further alleges that Defendants paid him and Defendant's California employees their final wages beyond the time frames set forth in Labor Code §§ 201 and 202. As they were not paid all wages due and owing throughout the course of their employment as a result of Defendants' failure to pay all premium wages as detailed above, at the time of their separation, they were not paid all final wages due and owing for the entirety of their employment. This violates Labor Code §§ 201-203.

Defendant pays Plaintiff and it's California employees on a bi-monthly basis and has failed to comply with Labor Code § 204(a) which holds that wages earned on a bi-monthly basis must be paid no later

than ten calendar days following the close of the payroll period. Due to the violations described above, Plaintiff and Defendant's California employees did not receive all of their wages earned in a timely manner as required by Labor Code § 204(a)(b).

We invite Defendants or its attorney(s) to contact our office to discuss this matter, including whether an early resolution of the claims can be reached.

Our office awaits your response.
