1 AMENDED JUDGMENT

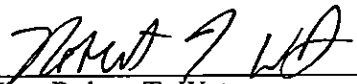
2 This Amended Judgement is entered in accordance with the Court's April 24, 2024 Order
3 granting Plaintiff's Motion for Final Approval of Class Action Settlement.

4 On April 24, 2024, this Court granted the Parties' stipulated request for an alternative
5 distribution of uncashed settlement checks to a designated *cy pres* beneficiary, Legal Aid at
6 Work. Upon entry of this Amended Judgment, the Settlement Administrator is approved to
7 distribute the uncashed funds of \$12,157.62 to the *cy pres* recipient, Legal Aid at Work. Once
8 this Amended Judgment is entered, the clerk is directed to send a copy to the Judicial Council
9 pursuant to Code of Civil Procedure section 384.5.

10 Without affecting the finality of this Amended Judgment, the Court shall retain exclusive
11 and continuing jurisdiction over the above-captioned action and the parties for purposes of
12 enforcing the terms of the Amended Judgment. This document shall constitute a judgement
13 (and separate document constituting said judgment) for purposes of California Rules of Court,
14 Rule 3.769(h).
