JUDGMENT

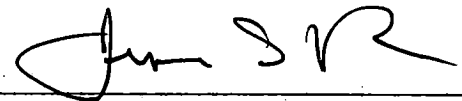
On December 23, 2025, this court entered an order granting final approval of the settlement of this class and PAGA action and awarding attorney's fees, costs, and service awards. IT IS HEREBY ORDERED, ADJUDGED, AND DECREED THAT:

1. Judgment is hereby entered in accordance with the terms of this court's final approval order.
2. The Settlement Classes are defined as follows:
  - The "Class" is defined as: all current and former nonexempt employees employed by Defendant in California during the Class Period, which is from January 24, 2018, through September 6, 2024. (SA, ¶¶ 4, 8.)
  - "PAGA Aggrieved Employees" are defined as: all current and former nonexempt employees employed by Defendant in California during the PAGA Period, which is from January 24, 2021, through September 6, 2024. (SA, ¶¶ 2, 23.)
3. Tomomi Sherrick requested exclusion and is thus not a member of the Settlement Class and

1 shall take nothing from the class settlement.

2 4. Pursuant to Code of Civil Procedure section 664.6, and Rule 3.769(h) of the California Rules of  
3 Court and without impacting the finality of this judgment-the court retains jurisdiction over  
4 plaintiffs, all members of the Settlement Classes, and defendants for the purpose of supervising  
5 the implementation, enforcement, construction, administration, and interpretation of the  
6 Settlement Agreement, Final Approval Order, and judgment thereon.
