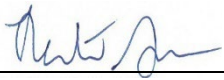

**DECLARATION OF ARRON WEISEL
REGARDING DISBURSEMENT**

DECLARATION OF ARRON WEISEL

I, Arron Weisel hereby declare:

1. I am employed as a Project Manager by Simpluris, Inc. ("Simpluris") the claims administrator in the above-entitled action. My business address is 3194-C Airport Loop Dr., Costa Mesa, CA 92626. My telephone number is (714) 640-5644. I am over twenty-one years of age and authorized to make this declaration on behalf of Simpluris and myself.

2. On September 15, 2025, Simpluris mailed Settlement checks with Notice of Settlement of Private Attorneys General Act Claims in English to one thousand one (1,001) PAGA Settlement Members via USPS.

3. The breakdown of the total funds in this case is as follows:

Total Funds:	\$425,000.00
Attorneys' Fees	\$127,500.00
Attorneys' Costs	\$18,378.79
Plaintiffs' Enhancement Payment	\$ 10,000.00
LWDA Payment	\$198,090.91
Settlement Administration Costs	\$ 5,000.00
<u>Amount for Aggrieved Employees</u>	<u>\$ 66,030.30</u>
Account Balance	= \$ 0.00

4. It should be noted that the Court's approval order reduced Plaintiff's Counsel's attorneys' fees from the requested \$141,666.66 to \$127,500.00, a difference of \$14,166.66. This \$14,166.66 was then added to the net to the PAGA penalties, which increased from \$249,954.55 to \$264,121.21. The LWDA receives 75% of the penalties, which equals \$198,090.91, as listed above. The Aggrieved Employees receive 25% of the penalties, which equals \$66,030.30, as listed above.

5. As of this date, all payments have been made for Attorney's Fees and Costs, Plaintiffs' Enhancement Payment, Settlement Administration Costs, and PAGA payment to the

1 LWDA.

2 6. The check cashing period expired on March 14, 2026, which is 180 days from the
3 issuance date of September 15, 2025.

4 7. There were three hundred forty-four (344) uncashed checks, equaling a total of
5 \$7,195.71. On April 10, 2026, Simpluris issued a check in the amount of \$7,195.71 to the
6 California Labor & Workforce Development Agency.

7 8. All disbursements have been made.

8 I declare under penalty of perjury under the laws of the State of California that the foregoing
9 is true and correct, and that this declaration was executed on the 21st day of April, 2026, in Costa
10 Mesa, California.

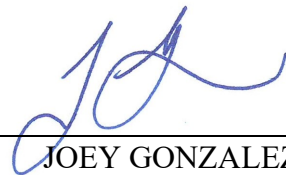
