1 I, Ronald Z. Gomez, declare as follows:

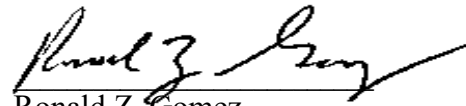
2 1. I am an attorney licensed to practice law in the State of California. I am an attorney
