IT IS HEREBY ORDERED that Plaintiff's Motion to Approve PAGA Settlement is GRANTED
as follows:

That out of a total settlement amount of \$91,000.00 as a final resolution of all
of Plaintiff's claims:

1. \$1,000.00 of the total settlement amount will be paid to Plaintiff as an
enhancement for bringing the claim.

2. \$30,333.30 of the total settlement amount will be paid to Plaintiff's counsel
for attorney's fees incurred in litigating the PAGA claim.

4. \$49,666.70 of the total settlement amount will be allocated to Plaintiff's PAGA claim with Seventy-Five Percent (75%), or \$37,250.03 allocated for PAGA paid directly to the California Labor and Workforce Development Agency ("LWDA"), and Twenty-Five Percent (25%), or \$12,416.68, paid to the other "aggrieved employees".
