**AMENDED JOINT STIPULATION OF CLASS ACTION
AND PAGA SETTLEMENT AND RELEASE**

This Amended Joint Stipulation of Class Action and PAGA Settlement and Release (“Settlement” or “Settlement Agreement”) is made and entered into by and between Plaintiff Zahira Page (“Plaintiff” or “Class Representative”), as an individual and on behalf of all others similarly situated, and Defendants Avila’s El Ranchito #4 Inc.; Avila’s CDM, Inc.; Avila’s Cocina, Inc.; Avila’s El Ranchito Corporation; Avila’s El Ranchito Grill, Inc.; Avila’s El Ranchito, Inc.; Avila’s MC, Inc.; Avila’s Mexican Grill, Inc.; Avila’s Mexican Restaurant, Inc.; AER Surfer, Inc.; Aliva Mexican Grill, Inc.; Don Chava, Inc.; Micus, Inc.; and Sergio’s El Ranchito, Inc. (“Defendants”) (collectively with Plaintiff, the “Parties”).

DEFINITIONS

The following definitions are applicable to this Settlement Agreement. Definitions contained elsewhere in this Settlement Agreement will also be effective:

1. “Action” means *Page v. Avila’s El Ranchito #4 Inc.*, No. 22STCV11109 (Los Angeles County Superior Court).

2. “Attorneys’ Fees and Costs” means attorneys’ fees agreed upon by the Parties and approved by the Court for Class Counsel’s litigation and resolution of the Action, and all out-of-pocket costs incurred and to be incurred by Class Counsel in the Action, including but not limited to expert/consultant fees, investigation costs, and costs associated with documenting the Settlement, providing any notices required as part of the Settlement or Court order, securing the Court’s approval of the Settlement, administering the Settlement, and obtaining entry of a Judgment terminating the Action. Class Counsel will request attorneys’ fees not in excess of one-third (1/3) of the Gross Settlement Amount, or Three Hundred Sixty-Six Thousand Six Hundred Sixty-Seven Dollars (\$366,667). The Attorneys’ Fees and Costs will also mean and include the additional reimbursement of any costs and expenses associated with Class Counsel’s litigation and settlement of the Action, up to Twenty-Five Thousand Dollars (\$25,000), subject to the Court’s approval. Defendants have agreed not to oppose Class Counsel’s request for fees and reimbursement of costs as set forth above.

3. “Class Counsel” means Capstone Law APC.

4. “Class List” means a complete list of all Class Members that Defendants will diligently and in good faith compile from their records and provide to the Settlement Administrator and Class Counsel within twenty (20) calendar days after Preliminary Approval of this Settlement. The Class List will be formatted in Microsoft Office Excel and will include each Class Member’s full name; most recent mailing address and telephone number; Social Security number; dates of employment; the respective number of Workweeks that each Class Member worked during the Class Period and PAGA Period; and any other relevant information needed to calculate settlement payments.

5. “Class Member(s)” or “Settlement Class” means all persons who worked for Defendants as non-exempt, hourly paid employees in the State of California at any time during the Class Period.

6. “Class Notice” means the Notice of Class Action Settlement, substantially in the form attached as Exhibit A.

7. “Class Period” means the period from January 1, 2019 through February 20, 2025.

8. “Class Representative Enhancement Payment” means the amount to be paid to Plaintiff in recognition of her effort and work in prosecuting the Action on behalf of Class Members, and for her general release of claims. Subject to the Court granting final approval of this Settlement Agreement and subject to the exhaustion of any and all appeals, Plaintiff will request Court approval of a Class Representative Enhancement Payment of up to Ten Thousand Dollars (\$10,000).

9. “Court” means the Los Angeles County Superior Court.

10. “Defendants” means Defendants Avila’s El Ranchito #4 Inc.; Avila’s CDM, Inc.; Avila’s Cocina, Inc.; Avila’s El Ranchito Corporation; Avila’s El Ranchito Grill, Inc.; Avila’s El Ranchito, Inc.; Avila’s MC, Inc.; Avila’s Mexican Grill, Inc.; Avila’s Mexican Restaurant, Inc.; AER Surfer, Inc.; Aliva Mexican Grill, Inc.; Don Chava, Inc.; Micus, Inc.; and Sergio’s El Ranchito, Inc..

11. “Effective Date” means the later of: (a) if no timely objections are filed, or are withdrawn prior to Final Approval, then the date of Final Approval; or (b) if a Class Member files an objection to the Settlement, the Effective Date shall be the sixty-first (61st) calendar day after the date of Final Approval, provided no appeal is initiated by an objector; or (c) if a timely appeal is initiated by an objector, then the Effective Date will be the date of final resolution of that appeal (including any requests for rehearing and/or petitions for certiorari), resulting in final judicial approval of the Settlement.

12. “Final Approval” means the date on which the Court enters an order granting final approval of the Settlement Agreement.

13. “Gross Settlement Amount” means the Gross Settlement Amount of One Million One Hundred Thousand Dollars (\$1,100,000), to be paid by Defendants in full satisfaction of all Released Class Claims and Released PAGA Claims, which includes all Individual Settlement Payments, Attorneys’ Fees and Costs, the Class Representative Enhancement Payment, the PAGA Settlement Amount, and Settlement Administration Costs. This Gross Settlement Amount has been agreed to by Plaintiff and Defendants based on the aggregation of the agreed-upon settlement value of individual claims. In no event will Defendants be liable for more than the Gross Settlement Amount except as otherwise explicitly set forth herein. There will be no reversion of the Gross Settlement Amount to Defendants. Defendants will be separately responsible for any employer payroll taxes required by law, including the employer FICA, FUTA, and SDI contributions, which shall not be paid from the Gross Settlement Amount.

14. “Individual Settlement Payment” means each Participating Class Member’s and PAGA Member’s respective shares of the Net Settlement Fund and PAGA Fund.

15. “Net Settlement Fund” means the portion of the Gross Settlement Amount remaining after deducting the Attorneys’ Fees and Costs, the Class Representative Enhancement Payment, the PAGA Settlement Amount, and Settlement Administration Costs. The Net Settlement Fund will be distributed to Participating Class Members. There will be no reversion of the Net Settlement Fund to Defendants.

16. “Notice of Objection” means a Class Member’s valid and timely written objection to the Settlement Agreement. For the Notice of Objection to be valid, it must include: (a) the objector’s full name, signature, address, and telephone number, (b) a written statement of all grounds for the objection accompanied by any legal support for such objection; (c) copies of any papers, briefs, or other documents upon which the objection is based; and (d) a statement whether the objector intends to appear at the final fairness hearing.

17. “PAGA Members” means all persons who worked for Defendants as non-exempt, hourly paid employees in the State of California at any time during the PAGA Period.

18. “PAGA Period” means the period from March 30, 2021 through February 20, 2025.

19. “PAGA Settlement Amount” means the amount that the Parties have agreed to pay to the Labor and Workforce Development Agency (“LWDA”) and PAGA Members in connection with Plaintiff’s claim under the Labor Code Private Attorneys General Act of 2004 (Cal. Lab. Code §§ 2698, *et seq.*, “PAGA”) (“PAGA Settlement”). The Parties have agreed that Sixty Thousand Dollars (\$60,000) of the Gross Settlement Amount will be allocated to the PAGA Settlement. Pursuant to PAGA, Seventy-Five Percent (75%), or Forty-Five Thousand Dollars (\$45,000), of the PAGA Settlement Amount will be paid to the California Labor and Workforce Development Agency (“Labor and Workforce Development Agency Payment”), and Twenty-Five Percent (25%), or Fifteen Thousand Dollars (\$15,000) (“PAGA Fund”), of the PAGA Settlement will be disbursed to PAGA Members, and regardless whether they request to be excluded from the Settlement Class.

20. “Parties” means Plaintiff and Defendants collectively.

21. “Participating Class Members” means all Class Members who do not submit timely and valid Requests for Exclusion.

22. “Plaintiff” means Plaintiff Zahira Page.

23. “Preliminary Approval” means the date on which the Court enters an order granting preliminary approval of the Settlement Agreement.

24. “Released Class Claims” means all claims, rights, demands, liabilities, and causes of action that are asserted in the operative Complaint, or that could reasonably have been asserted based on the facts alleged in the operative Complaint and Plaintiff’s LWDA Letter, including all claims for violation of: (1) California Labor Code §§ 510 and 1198 (unpaid overtime); (2) California Labor Code §§ 1182.12, 1194, 1197, 1197.1, and 1198 (unpaid minimum wages); (3) California Labor Code §§ 226.7, 512(a), 516, and 1198 (failure to provide meal periods); (4) California Labor Code §§ 226.7, 516, and 1198 (failure to authorize and permit rest periods); (5) California Labor Code §§ 226(a), 1174(d), and 1198 (non-compliant wage statements and failure to maintain payroll records); (6) California Labor Code §§ 201, 202, 203 (wages not timely paid upon termination); (7) California Labor Code § 204 (failure to timely pay wages during employment); (8) California Labor Code §§ 221 and 224 (unlawful deductions); (9) California Labor Code § 223 (secret payment of lower wages); (10) California Labor

Code § 1198 and California Code of Regulations, title 8, section 11050 subdivision 5(a) (failure provide reporting time pay); (11) California Labor Code § 1198 and California Code of Regulations, title 8, section 11050(13)(B) (failure to provide suitable resting facilities); (12) California Labor Code § 2802 (unreimbursed business expenses); (13) California Labor Code § 2810.5 (failure to provide notice of material terms of employment); (14) California Labor Code § 558; California Business & Professions Code §§ 17200, *et seq.* (unlawful business practices); and (15) California Business & Professions Code §§ 17200, *et seq.* (unfair business practices).

25. “Released PAGA Claims” means all claims for civil penalties under California Labor Code §§ 2698, *et seq.*, that were alleged or could reasonably have been alleged based on the facts alleged in Plaintiff’s LWDA letter, including all claims for violation of: (1) California Labor Code §§ 510 and 1198 (unpaid overtime); (2) California Labor Code §§ 1182.12, 1194, 1197, 1197.1, and 1198 (unpaid minimum wages); (3) California Labor Code §§ 226.7, 512(a), 516, and 1198 (failure to provide meal periods); (4) California Labor Code §§ 226.7, 516, and 1198 (failure to authorize and permit rest periods); (5) California Labor Code §§ 226(a), 1174(d), and 1198 (non-compliant wage statements and failure to maintain payroll records); (6) California Labor Code §§ 201, 202, 203 (wages not timely paid upon termination); (7) California Labor Code § 204 (failure to timely pay wages during employment); (8) California Labor Code §§ 221 and 224 (unlawful deductions); (9) California Labor Code § 223 (secret payment of lower wages); (10) California Labor Code § 1198 (failure provide reporting time pay); (11) California Labor Code § 1198 (failure to provide suitable resting facilities); (12) California Labor Code § 2802 (unreimbursed business expenses); (13) California Labor Code § 2810.5 (failure to provide notice of material terms of employment); (14) California Labor Code § 558.

26. “Released Parties” means Defendants, their past or present officers, directors, shareholders, agents, principals, heirs, representatives, accountants, auditors, consultants, insurers and reinsurers, and their respective successors and predecessors in interest, subsidiaries, affiliates, parents and attorneys, if any.

27. “Request for Exclusion” means a timely letter submitted by a Class Member indicating a request to be excluded from the Settlement Class. The Request for Exclusion must: (a) set forth the name, address, telephone number and last four digits of the Social Security Number of the Class

1 Member requesting exclusion; (b) be signed by the Class Member; (c) be returned to the Settlement
2 Administrator; (d) clearly state that the Class Member does not wish to be included in the Settlement;
3 and (e) be faxed or postmarked on or before the Response Deadline.

4 28. "Response Deadline" means the deadline by which Class Members must postmark or
5 fax to the Settlement Administrator Requests for Exclusion, postmark or fax disputes concerning the
6 calculation of Individual Settlement Payments, or postmark Notices of Objection to the Settlement
7 Administrator. The Response Deadline will be forty-five (45) calendar days from the initial mailing of
8 the Class Notice by the Settlement Administrator, unless the forty-fifth (45th) calendar day falls on a
9 Sunday or State holiday, in which case the Response Deadline will be extended to the next day on which
10 the U.S. Postal Service is open.

11 29. "Settlement Administration Costs" means the costs payable from the Gross Settlement
12 Amount to the Settlement Administrator for administering this Settlement, including, but not limited to,
13 printing, distributing, and tracking documents for this Settlement, tax reporting, distributing the Gross
14 Settlement Amount, and providing necessary reports and declarations, as requested by the Parties. The
15 Settlement Administration Costs will be paid from the Gross Settlement Amount, including, if necessary,
16 any such costs in excess of the amount represented by the Settlement Administrator as being the
17 maximum costs necessary to administer the Settlement. Settlement Administration Costs are currently
18 estimated to be Twenty Thousand Dollars (\$20,000).

19 30. "Settlement Administrator" means CPT Group, Inc., or any other third-party class action
20 settlement administrator agreed to by the Parties and approved by the Court for the purposes of
21 administering this Settlement. The Parties each represent that they do not have any financial interest in
22 the Settlement Administrator or otherwise have a relationship with the Settlement Administrator that
23 could create a conflict of interest.

24 31. "Workweeks" means the number of weeks worked by each Class Member and PAGA
25 Member during the respective Class Period and PAGA Period, calculated by taking the total hours
26 worked by each Class Member/PAGA Member during the Class Period/PAGA Period in non-exempt
27 positions, dividing by forty (40) hours, and rounding up to the nearest whole number. All Class
28 Members will be credited with at least one Workweek during the Class Period, and all PAGA Members

will be credited with at least one Workweek during the PAGA Period.

TERMS OF AGREEMENT

The Plaintiff, on behalf of herself and the Settlement Class, and Defendants agree as follows:

32. Funding of the Gross Settlement Amount. Defendants will make a one-time deposit of the Gross Settlement Amount of One Million One Hundred Thousand Dollars (\$1,100,000) into a Qualified Settlement Account to be established by the Settlement Administrator. Defendants will pay the employer's share of payroll taxes separately. After the Effective Date, the Gross Settlement Amount will be used for: (a) Individual Settlement Payments; (b) the Labor and Workforce Development Agency Payment; (c) the Class Representative Enhancement Payment; (d) Attorneys' Fees and Costs; and (e) Settlement Administration Costs. Defendants will deposit the Gross Settlement Amount and the employer's share of payroll taxes within thirty (30) calendar days of the Effective Date ("Funding Date"). Defendants Avila's Cocina, Inc.; Avila's MC, Inc.; Avila's Mexican Grill, Inc.; Avila's Mexican Restaurant, Inc.; Aliva Mexican Grill, Inc.; and Micus, Inc. (collectively, "The CDF Group") will pay 32.5% of the Gross Settlement Amount plus 32.5% of any additional funds owed as a result of the Escalator Clause. The CDF Group will pay its employer taxes based on the taxes owed by the Defendants within The CDF Group only and it will have no responsibility for employer taxes on behalf of any other Defendants. Attorneys for Defendants Avila's El Ranchito #4 Inc.; Avila's CDM, Inc.; Avila's El Ranchito Corporation; Avila's El Ranchito Grill, Inc.; Avila's El Ranchito, Inc.; AER Surfer, Inc.; Don Chava, Inc.; and Sergio's El Ranchito, Inc. ("The FBT Group") will pay 67.5% of the Gross Settlement Amount plus 67.5% of any additional funds owed as a result of the Escalator Clause. A default by one defendant shall not be construed as a default by the other defendant, but the entire Gross Settlement Amount must be funded by Defendants for this Settlement and all releases to take effect.

33. Attorneys' Fees and Costs. Defendants agree not to oppose or impede any application or motion for attorneys' fees and costs by Class Counsel for Attorneys' Fees and Costs of not more than Three Hundred Sixty-Six Thousand Six Hundred Sixty-Seven Dollars (\$366,667), plus the reimbursement of all out-of-pocket costs and expenses associated with Class Counsel's litigation and settlement of the Action (including expert/consultant fees, investigations costs, etc.), not to exceed Twenty-Five Thousand Dollars (\$25,000), both of which will be paid from the Gross Settlement

1 Amount.

2 34. Class Representative Enhancement Payment. In exchange for a general release, and in
3 recognition of her effort and work in prosecuting the Action on behalf of Class Members, Defendants
4 agree not to oppose or impede any application or motion for a Class Representative Enhancement
5 Payment of up to Ten Thousand Dollars (\$10,000). The Class Representative Enhancement Payment
6 will be paid from the Gross Settlement Amount and will be in addition to Plaintiff's Individual
7 Settlement Payment paid pursuant to the Settlement. Plaintiff will be solely and legally responsible to
8 pay any and all applicable taxes on the Class Representative Enhancement Payment. Plaintiff
9 understands and agrees that this Settlement Agreement shall remain in full force and effect even if the
10 full amount of Class Representative Enhancement Payment sought by Plaintiff is not ultimately awarded
11 by the Court.

12 35. Settlement Administration Costs. The Settlement Administrator will be paid for the
13 reasonable costs of administration of the Settlement and distribution of payments from the Gross
14 Settlement Amount, which is currently estimated to be Twenty Thousand Dollars (\$20,000). These
15 costs, which will be paid from the Gross Settlement Amount, will include, *inter alia*, the required tax
16 reporting on the Individual Settlement Payments, the issuing of 1099 and W-2 IRS Forms, distributing
17 Class Notices, calculating and distributing the Gross Settlement Amount, and providing necessary
18 reports and declarations.

19 36. PAGA Settlement Amount. Subject to Court approval, the Parties agree that the amount
20 of Sixty Thousand Dollars (\$60,000) from the Gross Settlement Amount will be designated for
21 satisfaction of Plaintiff's PAGA claim. Pursuant to PAGA, Seventy-Five Percent (75%), or Forty-Five
22 Thousand Dollars (\$45,000), of this sum will be paid to the LWDA and Twenty-Five Percent (25%), or
23 Fifteen Thousand Dollars (\$15,000), will be paid to PAGA Members in proportion to the number of
24 Workweeks worked during the PAGA Period.

25 37. No Right to Exclusion or Objections to the PAGA Settlement. Because this settlement
26 resolves claims and actions brought pursuant to PAGA by Plaintiff acting as a proxy and as a Private
27 Attorney General of, and for, the State of California and the LWDA, the Parties agree that no PAGA
28 Member has the right to exclude himself or herself from the release of the Released PAGA Claims, and

all PAGA Members will receive their shares of the PAGA Fund. The Parties also agree that no PAGA Member has the right to object to the PAGA Settlement Amount.

38. Net Settlement Fund. The entire Net Settlement Fund will be distributed to Participating Class Members. No portion of the Net Settlement Fund will revert to or be retained by Defendants.

39. PAGA Fund. The entire PAGA Fund will be distributed to all PAGA Members. No portion of the PAGA Fund will revert to or be retained by Defendants.

40. Individual Settlement Payment Calculations. Individual Settlement Payments will be calculated and apportioned from the Net Settlement Fund and PAGA Fund based on the number of Workweeks a Class Member worked during the Class Period and PAGA Period. Specific calculations of Individual Settlement Payments will be made as follows:

40(a) Payments from the Net Settlement Fund. Defendants will calculate the total number of Workweeks worked by each Class Member during the Class Period and the aggregate total number of Workweeks worked by all Class Members during the Class Period. To determine each Class Member's estimated "Individual Settlement Payment" from the Net Settlement Fund, the Settlement Administrator will use the following formula: The Net Settlement Fund will be divided by the aggregate total number of Workweeks during the Class Period, resulting in the "Workweek Value." Each Class Member's "Individual Settlement Payment" will be calculated by multiplying each individual Class Member's total number of Workweeks by the Workweek Value. The Individual Settlement Payment will be reduced by any required deductions for each Participating Class Member as specifically set forth herein, including employee-side tax withholdings or deductions. The entire Net Settlement Fund will be disbursed to all Class Members who do not submit timely and valid Requests for Exclusion. If there are any valid and timely Requests for Exclusion, the Settlement Administrator shall proportionately increase the Individual Settlement Payment for each Participating Class Member according to the number of

Workweeks worked, so that the amount actually distributed to the Settlement Class equals 100% of the Net Settlement Fund.

40(b) Payments from the PAGA Fund. Defendants will calculate the total number of Workweeks worked by each PAGA Member during the PAGA Period and the aggregate total number of Workweeks worked by all PAGA Members during the PAGA Period. To determine each PAGA Member's estimated "Individual Settlement Payment," the Settlement Administrator will use the following formula: The PAGA Fund will be divided by the aggregate total number of Workweeks during the PAGA Period, resulting in the "PAGA Workweek Value." Each PAGA Member's "Individual Settlement Payment" will be calculated by multiplying each individual PAGA Member's total number of Workweeks by the PAGA Workweek Value. The entire PAGA Fund will be disbursed to all PAGA Members.

41. No Credit Toward Benefit Plans. The Individual Settlement Payments made to Participating Class Members under this Settlement, as well as any other payments made pursuant to this Settlement, will not be utilized to calculate any additional benefits under any benefit plans to which any Class Members may be eligible, including, but not limited to profit-sharing plans, bonus plans, 401(k) plans, stock purchase plans, vacation plans, sick leave plans, PTO plans, and any other benefit plan. Rather, it is the Parties' intention that this Settlement Agreement will not affect any rights, contributions, or amounts to which any Class Members may be entitled under any benefit plans.

42. Administration Process. The Parties agree to cooperate in the administration of the settlement and to make all reasonable efforts to control and minimize the costs and expenses incurred in administration of the Settlement.

43. Delivery of the Class List. Within twenty (20) calendar days of Preliminary Approval, Defendants will provide the Class List to the Settlement Administrator and to Class Counsel.

44. Notice by First-Class U.S. Mail. Within ten (10) calendar days after receiving the Class List from Defendants, the Settlement Administrator will mail a Class Notice to all Class Members via regular First-Class U.S. Mail, using the most current, known mailing addresses identified in the Class

List.

45. Confirmation of Updated Contact Information in the Class Lists. Prior to mailing, the Settlement Administrator will perform a search based on the National Change of Address Database for information to update and correct for any known or identifiable address changes. Any Class Notices returned to the Settlement Administrator as non-deliverable on or before the Response Deadline will, within five (5) business days of receipt, be sent promptly via regular First-Class U.S. Mail to the forwarding address affixed thereto and the Settlement Administrator will indicate the date of such re-mailing on the Class Notice. If no forwarding address is provided, the Settlement Administrator will promptly attempt to determine the correct address using a skip-trace, or other search using the name, address and/or Social Security Number of the Class Member involved, and will then perform a single re-mailing. Those Class Members who receive a re-mailed Class Notice, whether by skip-trace or by request, will have either (a) an additional fifteen (15) calendar days or (b) until the Response Deadline, whichever is later, to submit a Request for Exclusion or an objection to the Settlement.

46. Class Notices. All Class Members will be mailed a Class Notice. Each Class Notice will provide: (a) information regarding the nature of the Action; (b) a summary of the Settlement's principal terms; (c) the Settlement Class and PAGA Member definitions; (d) the total number of Workweeks each respective Class Member and PAGA Member worked for Defendants during the Class Period and PAGA Period; (e) each Class Member's and PAGA Member's estimated Individual Settlement Payment and the formula for calculating Individual Settlement Payments; (f) the dates which comprise the Class Period and PAGA Period; (g) instructions on how to submit Requests for Exclusion or Notices of Objection; (h) the deadlines by which the Class Member must postmark or fax Request for Exclusions, or postmark Notices of Objection to the Settlement; and (i) the claims to be released.

47. Disputed Information on Class Notices. Class Members will have an opportunity to dispute the information provided in their Class Notices. To the extent Class Members dispute their employment dates or the number of Workweeks on record, Class Members may produce evidence to the Settlement Administrator showing that such information is inaccurate. Defendants' records will be presumed correct, but the Settlement Administrator shall contact the Parties regarding the dispute and the Parties will work in good faith to resolve it. All disputes must be submitted by the Response Deadline,

1 and will be decided within ten (10) business days after the Response Deadline.

2 48. Defective Submissions. If a Class Member's Request for Exclusion is defective as to the
3 requirements listed herein, that Class Member will be given an opportunity to cure the defect(s). The
4 Settlement Administrator will mail the Class Member a cure letter within three (3) business days of
5 receiving the defective submission to advise the Class Member that his/her/their submission is defective
6 and that the defect must be cured to render the Request for Exclusion valid. The Class Member will have
7 until (a) the Response Deadline or (b) fifteen (15) calendar days from the date of the cure letter,
8 whichever date is later, to postmark or fax a revised Request for Exclusion. If the revised Request for
9 Exclusion is not postmarked or received by fax within that period, it will be deemed untimely.

10 49. Request for Exclusion Procedures. Any Class Member wishing to opt-out from the
11 Settlement Agreement must sign and fax or postmark a written Request for Exclusion to the Settlement
12 Administrator within the Response Deadline. In the case of Requests for Exclusion that are mailed to the
13 Settlement Administrator, the postmark date will be the exclusive means to determine whether a Request
14 for Exclusion has been timely submitted.

15 50. Escalator Clause. The Gross Settlement Amount was calculated with, and is premised
16 on, the understanding that Class Members worked approximately 103,000 Workweeks during the Class
17 Period. If the actual number of Workweeks worked by Class Members is greater than 10% of this
18 estimate, then Defendants must either: (a) agree to increase the \$1,100,000 Gross Settlement Amount on
19 a proportional basis above 10% (i.e., if there is an 11% increase in the number of workweeks during the
20 Class Period, Defendants would agree to increase the Gross Settlement Amount by 1%); or (b) begin the
21 Class Period on a later date in order to limit the covered Workweeks to 10% more than the estimate
22 provided in lieu of paying an increase to the Gross Settlement Amount ("Escalator Clause").

23 51. Defendants' Option to Rescind. Defendants shall have the unilateral right to void this
24 Agreement in its entirety if more than ten percent (10%) of the Class Members submit timely and valid
25 Request for Exclusions. Defendants must exercise this right by providing written notice to Class
26 Counsel and the Settlement Administrator within fifteen (15) calendar days after receiving the final
27 Requests for Exclusion list. If Defendants elect to void the Settlement Agreement under this provision,
28 the Settlement shall be null and void in its entirety, and the Parties shall be restored to their respective

positions as of the date of execution of the Settlement Agreement, with no rights or obligations accruing under this Settlement Agreement, except that Defendants will be responsible for all Settlement Administration Costs incurred up to the date on which the Settlement is voided.

52. Settlement Terms Bind All Class Members Who Do Not Opt-Out. Any Class Member who does not affirmatively opt-out of the Settlement Agreement by submitting a timely and valid Request for Exclusion will be bound by all of its terms, including those pertaining to the Released Class Claims, as well as any Judgment that may be entered by the Court if it grants final approval to the Settlement.

53. Releases by Participating Class Members. Upon the Funding Date, and except as to such rights or claims as may be created by this Settlement Agreement, each Participating Class Member, together and individually, on their behalf and on behalf of their respective heirs, executors, administrators, agents, and attorneys, shall fully and forever release and discharge all of the Released Parties, or any of them, from each of the Released Class Claims arising during the Class Period.

54. Releases by PAGA Members. Upon the Funding Date, and except as to such rights or claims as may be created by this Settlement Agreement, each PAGA Member, together and individually, on their behalf and on behalf of their respective heirs, executors, administrators, agents, and attorneys, shall fully and forever release and discharge all of the Released Parties, or any of them, from each of the Released PAGA Claims during the PAGA Period.

55. Objection Procedures. To object to the Settlement Agreement, a Class Member may either postmark a valid Notice of Objection to the Settlement Administrator on or before the Response Deadline, or appear in person at the Final Approval Hearing. Class Members who fail to object either by submitting a valid Notice of Objection or appearing in person at the Final Approval Hearing will be deemed to have waived all objections to the Settlement and will be foreclosed from making any objections, whether by appeal or otherwise, to the Settlement Agreement. At no time will any of the Parties or their counsel seek to solicit or otherwise encourage Class Members to submit written objections to the Settlement Agreement or appeal from the final approval order and judgment. Class Counsel will not represent any Class Members with respect to any such objections to this Settlement. If a Class Member timely submits both a Notice of Objection and a Request for Exclusion, the Request for

1 Exclusion will be given effect and considered valid, the Notice of Objection shall be rejected, and the
2 Class Member shall not participate in or be bound by the Settlement.

3 56. Certification Reports Regarding Individual Settlement Payment Calculations. The
4 Settlement Administrator will provide Defendants' counsel and Class Counsel a weekly report that
5 certifies the number of Class Members who have submitted valid Requests for Exclusion or objections to
6 the Settlement, and whether any Class Member has submitted a challenge to any information contained
7 in their Class Notice, including those received after the Response Deadline. Additionally, the Settlement
8 Administrator will provide to counsel for both Parties any updated reports regarding the administration
9 of the Settlement Agreement as needed or requested.

10 57. Distribution Timing of Individual Settlement Payments. Within ten (10) calendar days
11 of the Funding Date, the Settlement Administrator will issue payments to: (a) Participating Class
12 Members and PAGA Members; (b) the Labor and Workforce Development Agency; (c) Plaintiff; and
13 (d) Class Counsel. The Settlement Administrator will also issue a payment to itself for Court-approved
14 services performed in connection with the Settlement.

15 58. Un-cashed Settlement Checks. Funds represented by Individual Settlement Payment
16 checks returned as undeliverable and Individual Settlement Payment checks remaining un-cashed for
17 more than one hundred and eighty (180) calendar days after issuance will be tendered to the State
18 Controller's Office, Unclaimed Property Division in the name of each Class Member who did not
19 negotiate his or her check, thereby leaving no "unpaid residue" subject to the requirements of California
20 Code of Civil Procedure Section 384, subd. (b).

21 59. Certification of Completion. Upon completion of administration of the Settlement, the
22 Settlement Administrator will provide a written declaration under oath to certify such completion to the
23 Court and counsel for all Parties.

24 60. Treatment of Individual Settlement Payments. All Individual Settlement Payments will
25 be allocated as follows: (a) Twenty Percent (20%) of each Individual Settlement Payment will be
26 allocated as wages for which IRS Forms W-2 will be issued; and (b) Eighty Percent (80%) will be
27 allocated as non-wages for which IRS Forms 1099-MISC will be issued. Payments issued to PAGA
28 Members from the PAGA Fund will be treated as non-wages for which IRS Forms 1099-MISC will be

1 issued.

2 61. Administration of Taxes by the Settlement Administrator. The Settlement Administrator
3 will be responsible for issuing to Plaintiff, Participating Class Members, PAGA Members, and Class
4 Counsel any W-2, 1099, or other tax forms as may be required by law for all amounts paid pursuant to
5 this Settlement. The Settlement Administrator will also be responsible for forwarding all payroll taxes
6 and penalties to the appropriate government authorities.

7 62. Tax Liability. The Parties make no representation as to the tax treatment or legal effect
8 of the payments called for hereunder, and Plaintiff, Participating Class Members, and PAGA Members
9 are not relying on any statement, representation, or calculation by Defendants or by the Settlement
10 Administrator in this regard.

11 63. Circular 230 Disclaimer. EACH PARTY TO THIS AGREEMENT (FOR PURPOSES
12 OF THIS SECTION, THE “ACKNOWLEDGING PARTY” AND EACH PARTY TO THIS
13 AGREEMENT OTHER THAN THE ACKNOWLEDGING PARTY, AN “OTHER PARTY”)
14 ACKNOWLEDGES AND AGREES THAT (1) NO PROVISION OF THIS AGREEMENT, AND
15 NO WRITTEN COMMUNICATION OR DISCLOSURE BETWEEN OR AMONG THE PARTIES
16 OR THEIR ATTORNEYS AND OTHER ADVISERS, IS OR WAS INTENDED TO BE, NOR
17 WILL ANY SUCH COMMUNICATION OR DISCLOSURE CONSTITUTE OR BE CONSTRUED
18 OR BE RELIED UPON AS, TAX ADVICE WITHIN THE MEANING OF UNITED STATES
19 TREASURY DEPARTMENT CIRCULAR 230 (31 CFR PART 10, AS AMENDED); (2) THE
20 ACKNOWLEDGING PARTY (A) HAS RELIED EXCLUSIVELY UPON HIS, HER, OR ITS
21 OWN, INDEPENDENT LEGAL AND TAX COUNSEL FOR ADVICE (INCLUDING TAX
22 ADVICE) IN CONNECTION WITH THIS AGREEMENT, (B) HAS NOT ENTERED INTO THIS
23 AGREEMENT BASED UPON THE RECOMMENDATION OF ANY OTHER PARTY OR ANY
24 ATTORNEY OR ADVISOR TO ANY OTHER PARTY, AND (C) IS NOT ENTITLED TO RELY
25 UPON ANY COMMUNICATION OR DISCLOSURE BY ANY ATTORNEY OR ADVISER TO
26 ANY OTHER PARTY TO AVOID ANY TAX PENALTY THAT MAY BE IMPOSED ON THE
27 ACKNOWLEDGING PARTY; AND (3) NO ATTORNEY OR ADVISER TO ANY OTHER
28 PARTY HAS IMPOSED ANY LIMITATION THAT PROTECTS THE CONFIDENTIALITY OF

1 ANY SUCH ATTORNEY'S OR ADVISER'S TAX STRATEGIES (REGARDLESS OF WHETHER
2 SUCH LIMITATION IS LEGALLY BINDING) UPON DISCLOSURE BY THE
3 ACKNOWLEDGING PARTY OF THE TAX TREATMENT OR TAX STRUCTURE OF ANY
4 TRANSACTION, INCLUDING ANY TRANSACTION CONTEMPLATED BY THIS
5 AGREEMENT.

6 64. No Prior Assignments. The Parties and their counsel represent, covenant, and warrant
7 that they have not directly or indirectly assigned, transferred, encumbered, or purported to assign,
8 transfer, or encumber to any person or entity any portion of any liability, claim, demand, action, cause of
9 action or right herein released and discharged.

10 65. Nullification of Settlement Agreement. In the event that: (a) the Court does not finally
11 approve the Settlement as provided herein; or (b) the Settlement does not become final for any other
12 reason, then this Settlement Agreement, and any documents generated to bring it into effect, will be null
13 and void. Any order or judgment entered by the Court in furtherance of this Settlement Agreement will
14 likewise be treated as void from the beginning.

15 66. Preliminary Approval Hearing. Plaintiff will obtain a hearing before the Court to request
16 the Preliminary Approval of the Settlement Agreement, and the entry of a Preliminary Approval Order
17 for: (a) conditional certification of the Settlement Class for settlement purposes only, (b) preliminary
18 approval of the proposed Settlement Agreement, (c) setting a date for a final fairness hearing. The
19 Preliminary Approval Order will provide for the Class Notice to be sent to all Class Members as
20 specified herein. In conjunction with the Preliminary Approval hearing, Plaintiff will submit this
21 Settlement Agreement, which sets forth the terms of this Settlement, and will include the proposed
22 Notice of Class Action Settlement, attached as Exhibit A. Class Counsel will be responsible for drafting
23 all documents necessary to obtain preliminary approval.

24 67. Final Settlement Approval Hearing and Entry of Judgment. Upon expiration of the
25 deadlines to postmark Requests for Exclusion or objections to the Settlement Agreement, and with the
26 Court's permission, a final fairness hearing will be conducted to determine the Final Approval of the
27 Settlement Agreement along with the amounts properly payable for: (a) Attorneys' Fees and Costs; (b)
28 the Class Representative Enhancement Payment; (c) Individual Settlement Payments; (d) the Labor and

1 Workforce Development Agency Payment; (e) all Settlement Administration Costs. Class Counsel will
2 be responsible for drafting all documents necessary to obtain final approval. Class Counsel will also be
3 responsible for drafting the attorneys' fees and costs application to be heard at the final approval hearing.

4 68. Judgment and Continued Jurisdiction. Upon final approval of the Settlement by the
5 Court or after the final fairness hearing, the Parties will present the Judgment to the Court for its
6 approval. After entry of the Judgment, the Court will have continuing jurisdiction solely for purposes of
7 addressing: (a) the interpretation and enforcement of the terms of the Settlement, (b) Settlement
8 administration matters, and (c) such post-Judgment matters as may be appropriate under court rules or as
9 set forth in this Settlement Agreement. A copy of the Judgment will be posted to the Settlement
10 Administrator's website.

11 69. Release by Plaintiff. Upon the Funding Date, in addition to the claims being released by
12 all Participating Class Members, Plaintiff will release and forever discharge the Released Parties, to the
13 fullest extent permitted by law, of and from any and all claims, known and unknown, asserted and not
14 asserted, which Plaintiff has or may have against the Released Parties as of the date of execution of this
15 Settlement Agreement. To the extent the foregoing release is a release to which Section 1542 of the
16 California Civil Code or similar provisions of other applicable law may apply, Plaintiff expressly waives
17 any and all rights and benefits conferred upon her by the provisions of Section 1542 of the California
18 Civil Code or similar provisions of applicable law which are as follows:

19 A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS THAT THE
20 CREDITOR OR RELEASING PARTY DOES NOT KNOW OR SUSPECT TO
21 EXIST IN HIS OR HER FAVOR AT THE TIME OF EXECUTING THE RELEASE
22 AND THAT, IF KNOWN BY HIM OR HER, WOULD HAVE MATERIALLY
23 AFFECTED HIS OR HER SETTLEMENT WITH THE DEBTOR OR RELEASED
24 PARTY.

25 70. Exhibits Incorporated by Reference. The terms of this Settlement Agreement include the
26 terms set forth in any attached Exhibits, which are incorporated by this reference as though fully set forth
27 herein. Any Exhibits to this Settlement Agreement are an integral part of the Settlement.

28 71. Entire Agreement. This Settlement Agreement and any attached Exhibits constitute the

1 entirety of the Parties' settlement terms. No other prior or contemporaneous written or oral agreements
2 may be deemed binding on the Parties. The Parties expressly recognize California Civil Code Section
3 1625 and California Code of Civil Procedure Section 1856(a), which provide that a written agreement is
4 to be construed according to its terms and may not be varied or contradicted by extrinsic evidence, and
5 the Parties agree that no such extrinsic oral or written representations or terms will modify, vary or
6 contradict the terms of this Settlement Agreement.

7 72. Amendment or Modification. No amendment, change, or modification to this Settlement
8 Agreement will be valid unless in writing and signed, either by the Parties or their counsel, and approved
9 by the Court.

10 73. Authorization to Enter Into Settlement Agreement. Counsel for all Parties warrant and
11 represent they are expressly authorized by the Parties whom they represent to negotiate this Settlement
12 Agreement and to take all appropriate action required or permitted to be taken by such Parties pursuant
13 to this Settlement Agreement to effectuate its terms and to execute any other documents required to
14 effectuate the terms of this Settlement Agreement. The Parties and their counsel will cooperate with each
15 other and use their best efforts to effect the implementation of the Settlement. If the Parties are unable to
16 reach agreement on the form or content of any document needed to implement the Settlement, or on any
17 supplemental provisions that may become necessary to effectuate the terms of this Settlement, the Parties
18 may seek the assistance of the Court to resolve such disagreement.

19 74. Binding on Successors and Assigns. This Settlement Agreement will be binding upon,
20 and inure to the benefit of, the successors or assigns of the Parties hereto, as previously defined.

21 75. California Law Governs. All terms of this Settlement Agreement and Exhibits hereto
22 will be governed by and interpreted according to the laws of the State of California.

23 76. Execution and Counterparts. This Settlement Agreement is subject only to the execution
24 of all Parties. However, the Settlement Agreement may be executed in one or more counterparts. All
25 executed counterparts and each of them, including electronic (e.g., DocuSign), facsimile, and scanned
26 copies of the signature page, will be deemed to be one and the same instrument.

27 77. Acknowledgement that the Settlement is Fair and Reasonable. The Parties believe this
28 Settlement Agreement is a fair, adequate and reasonable settlement of the Action and have arrived at this

Settlement after arm's-length negotiations and in the context of adversarial litigation, taking into account all relevant factors, present and potential. The Parties further acknowledge that they are each represented by competent counsel and that they have had an opportunity to consult with their counsel regarding the fairness and reasonableness of this Settlement.

78. Invalidity of Any Provision. Before declaring any provision of this Settlement Agreement invalid, the Court will first attempt to construe the provision as valid to the fullest extent possible consistent with applicable precedents so as to define all provisions of this Settlement Agreement valid and enforceable.

79. Waiver of Certain Appeals. The Parties agree to waive appeals and to stipulate to class certification for purposes of this Settlement only; except, however, that Plaintiff or Class Counsel may appeal any reduction to the Attorneys' Fees and Costs below the amount they request from the Court, and either party may appeal any court order that materially alters the Settlement Agreement's terms.

80. Class Action Certification for Settlement Purposes Only. The Parties agree to stipulate to class action certification for purposes of the Settlement only. If, for any reason, the Settlement is not approved, the stipulation to certification will be void. The Parties further agree that certification for purposes of the Settlement is not an admission that class action certification is proper under the standards applied to contested certification motions and that this Settlement Agreement will not be admissible in this or any other proceeding as evidence that either (a) a class action should be certified or (b) Defendants are liable to Plaintiff or any Class Member, other than according to the Settlement's terms.

81. Non-Admission of Liability. The Parties enter into this Settlement to resolve the dispute that has arisen between them and to avoid the burden, expense and risk of continued litigation. In entering into this Settlement, Defendants do not admit, and specifically deny, that they violated any federal, state, or local law; violated any regulations or guidelines promulgated pursuant to any statute or any other applicable laws, regulations or legal requirements; breached any contract; violated or breached any duty; engaged in any misrepresentation or deception; or engaged in any other unlawful conduct with respect to their employees. Neither this Settlement Agreement, nor any of its terms or provisions, nor any of the negotiations connected with it, will be construed as an admission or concession by Defendants of any such violations or failures to comply with any applicable law. Except as necessary in a proceeding to

enforce the terms of this Settlement, this Settlement Agreement and its terms and provisions will not be offered or received as evidence in any action or proceeding to establish any liability or admission on the part of Defendants or to establish the existence of any condition constituting a violation of, or a non-compliance with, federal, state, local or other applicable law.

82. No Public Comment: Prior to Preliminary Approval, the Parties and their counsel agree that they will not issue any press releases, initiate any contact with the press, respond to any press inquiry, or have any communication with the press about the fact, amount or terms of the Settlement.

83. Waiver. No waiver of any condition or covenant contained in this Settlement Agreement or failure to exercise a right or remedy by any of the Parties hereto will be considered to imply or constitute a further waiver by such party of the same or any other condition, covenant, right or remedy.

84. Enforcement Actions. In the event that one or more of the Parties institutes any legal action or other proceeding against any other Party or Parties to enforce the provisions of this Settlement or to declare rights and/or obligations under this Settlement, the successful Party or Parties will be entitled to recover from the unsuccessful Party or Parties reasonable attorneys' fees and costs, including expert witness fees incurred in connection with any enforcement actions.

85. Mutual Preparation. The Parties have had a full opportunity to negotiate the terms and conditions of this Settlement Agreement. Accordingly, this Settlement Agreement will not be construed more strictly against one party than another merely by virtue of the fact that it may have been prepared by counsel for one of the Parties, it being recognized that, because of the arms'-length negotiations between the Parties, all Parties have contributed to the preparation of this Settlement Agreement.

86. Representation By Counsel. The Parties acknowledge that they have been represented by counsel throughout all negotiations that preceded the execution of this Settlement Agreement, and that this Settlement Agreement has been executed with the consent and advice of counsel. Further, Plaintiff and Class Counsel warrant and represent that there are no liens on the Settlement Agreement.

87. All Terms Subject to Final Court Approval. All amounts and procedures described in this Settlement Agreement herein will be subject to final Court approval.

88. Cooperation and Execution of Necessary Documents. All Parties will cooperate in good faith and execute all documents to the extent reasonably necessary to effectuate the terms of this

1 Settlement Agreement.

2 89. Binding Agreement. The Parties warrant that they understand and have full authority to
 3 enter into this Settlement Agreement, and further intend that this Settlement Agreement will be fully
 4 enforceable and binding on all parties, and agree that it will be admissible and subject to disclosure in
 5 any proceeding to enforce its terms, notwithstanding any mediation confidentiality provisions that
 6 otherwise might apply under federal or state law.

Plaintiff Zahira Page, on her behalf and on behalf of other current and former non-exempt employees, alleges that Defendants violated California state labor laws as a result of their alleged failure to, among other things: (1) pay minimum and overtime wages to employees for all hours worked; (2) provide employees with meal and rest breaks; (3) timely pay all wages owed to employees during each pay period and upon termination of their employment; and (4) provide employees with accurate, itemized wage statements.

After the exchange of relevant information and evidence, the parties agreed to enter into settlement negotiations in an attempt to informally resolve the claims in the case. On November 20, 2024, the parties participated in a mediation with Louis Marlin, Esq., an experienced and well-respected class action mediator. With Mr. Marlin's guidance, the parties were able to negotiate a complete settlement of Plaintiff's claims.

Counsel for Plaintiff, and the attorneys appointed by the Court to represent the class, Capstone Law APC ("Class Counsel"), have investigated and researched the facts and circumstances underlying the issues raised in the case and the applicable law. While Class Counsel believe that the claims alleged in this lawsuit have merit, Class Counsel also recognize that the risk and expense of continued litigation justify settlement. Based on the foregoing, Class Counsel believe the proposed settlement is fair, adequate, reasonable, and in the best interests of Class Members.

Defendants have denied, and continue to deny the factual and legal allegations in the case and believe that they have valid defenses to Plaintiff's claims.
