DECLARATION OF LANCE DACRE

I, Lance Dacre, declare as follows:

1. I am an individual over the age of 18. I am one of the attorneys of record for Plaintiffs in the case of *Hoffman et al. v. Centene Management Company, LLC* (Case No. 34-2022-00322629). I submit this declaration in support of the Motion for Final Approval of Class Action Settlement, Attorney Fees, Costs and Service Awards which Plaintiffs filed concurrently herewith, along with the supporting Memorandum of Points and Authorities. I have personal knowledge of the facts set forth below, and if called to testify regarding them, I could and would do so competently.

3. Class Counsel commands a high hourly rate due to our success in overtime, meal and rest period, expense reimbursement, misclassification, vacation pay, and various other wage and hour class actions, and we take pride in being held in very high regard by the legal community.

4. James Hawkins APLC is a boutique law firm that specializes in wage and hour class actions and is primarily comprised of several seasoned attorneys and staff. While this matter did not conclusively preclude other employment, it did impact our ability to take on other cases. The hourly rates for the attorneys who worked on this case, James Hawkins, Isandra Fernandez, Anthony Draper and myself are comparable to hourly rates charged by other firms that handle complex litigation in California.

1 5. Mr. Hawkins has been practicing law in California since 1997 and in 2007
2 incorporated his wage and hour class action practice as James Hawkins APCL. Since its inception,
3 Mr. Hawkins has been lead and/or co-lead counsel in hundreds of wage and hour class action cases.

4 6. Ms. Fernandez has been a member of the Florida Bar since January 1996 and a
5 member of the California Bar since August 2002. Ms. Fernandez has specialized in employment-
6 related litigation including complex wage and hour civil litigation since 2003. Ms. Fernandez has
7 been, and currently is, co-counsel in over 60 wage and hour class action litigations for our firm
8 and has produced excellent results for this firm's clients in the wage and hour class actions.

9 7. Mr. Draper has been a member of the California Bar since July 2022 and was
10 provisionally licensed prior to that time. He has specialized in complex wage and hour litigation
11 since October 2021. He has been, and currently is, co-counsel in over 40 complex wage and hour
12 cases and have successfully litigated wage and hour class and PAGA actions for our firm.

13 8. I have been practicing law in California since 1997 and joined the James Hawkins,
14 APLC law firm in February 2022, and now exclusively litigate plaintiff-related wage and hour
15 class action cases. I have been involved in litigating, mediating and settling numerous wage and
16 hour class actions dealing with class sizes ranging from several hundred to several thousand class
17 members in both State and Federal courts.

18 9. Since on or about December 2022, prior to the inception of the filing of this Action
19 on February 3, 2023, through the present James Hawkins APLC has had to, among other things,
20 expend time on the following: engage in numerous discussions with Plaintiffs, conduct
21 comprehensive investigations including but not limited to researching Defendant's structure,
22 business relationship, positions, locations; conduct research and analysis regarding potential class
23 members within the scope of the putative class and potential claims; draft Complaint and PAGA
24 letter; receive and review Defendant's Answer, discussions with Defendant regarding prior filed
25 cases; draft First Amended Complaint; review documents produced by Defendant prior to
26 mediation; discussions with Plaintiffs; prepare for and attend mediation; exchange multiple drafts
27 of the Memorandum of Understanding and discussions regarding its terms; exchange multiple
28 drafts of formal settlement agreement and supporting documents; discussions with clients and

1 other plaintiffs' counsel regarding the same; draft request for dismissal of action to consolidate
2 with prior filed cases; prepare joint status conference reports; review draft preliminary approval
3 motion and supporting documents; draft supporting declarations for Plaintiffs Lawhorn and
4 Ortegón; discussions with them regarding the same; review tentative ruling and order granting
5 preliminary approval; review reports provided by Administrator; draft declaration in support of
6 final approval motion; review draft of final approval motion. A good deal time and effort has been
7 expended to properly and comprehensively perform the job required of this case and prepare for
8 all contingencies that may arise, regardless of whether the case settles.

9 10. The attorneys who have worked on this matter are Mr. Hawkins, Ms. Fernandez,
10 Mr. Draper and me. My hourly rate is \$900, Ms. Fernandez's hourly rate is \$950, Mr. Hawkins'
11 hourly rate is \$1,000 and Mr. Draper's hour rate is \$475. Since the inception of this matter, prior
12 to filing the Complaint, the total amount of attorney time and paralegal time estimated to have
13 been expended and also estimated to be expended in finalizing this matter is 133.6 (James
14 Hawkins 10.5 hours, Ms. Fernandez 43.1 hours, Mr. Draper 15, Lance Dacre 65 hours) which
15 equates to \$117,070 in total fees. (Attached as Exhibit 1 and included by reference are true and
16 correct copies of the billing records for this matter.)

17 11. Here, the parties' contractual agreement to pay counsel's attorneys' fees is
18 reasonable. My firm has been the only counsel to represent Plaintiffs and the Class Members in
19 this matter, and we have borne the entire risk and cost of this litigation on a pure contingency
20 basis. To date, Class Counsel has not received any compensation and expended litigation costs on
21 behalf of the Class. Class action contingency cases are inherently risky. Upon retention, Class
22 Counsel makes a commitment to litigate the case through trial. These types of cases can take
23 years, hundreds of hours of work and cost an enormous amount of money; these risks are known
24 upon retention. The risks involved coupled with the contingency basis of this case further support
25 Class Counsels' request for attorneys' fees and costs.
