**DECLARATION OF AMY J. OSBORNE

I, Amy J. Osborne, hereby declare as follows:

1. I am an attorney for Stream Kim Hicks Wrage & Alfaro, PC, attorneys of record for Defendant, Mission Ambulance, Inc. I am providing this declaration in support of Plaintiff's Motion for Preliminary Approval of the class action settlement and pursuant to the Court's Class Action Case Management Order #1, paragraph H.3.b.
2. I am not aware of any class, representative or other collective action in any other court in this or any other jurisdiction that asserts claims similar to those asserted in this action on behalf of a class or group of individuals, some or all of whom would also be members of

1 the class defined in this action.

- 2 3. To make the determination that there are no other actions against Mission Ambulance, I
3 had my assistant search the Riverside and San Bernardino Superior Courts active cases on
4 May 15, 2025, and did not find any active cases in those jurisdictions where Mission
5 Ambulance operated.
- 6 4. On May 15, 2025, I emailed the company's representative, Lyndsay Candelario, inquiring
7 if she knew of any other actions pending against Mission Ambulance. She responded that
8 "[t]here are no other lawsuits against Mission Ambulance." No other attorneys in my office
9 are aware of any other actions against Mission Ambulance. No officer, director, or manager
10 of Mission Ambulance has any relationship with Riverside Legal Aid.
- 11 5. The law firm of Stream Kim Hicks Wrage & Alfaro, employs attorneys that provide pro
12 bono legal services through Riverside Legal Aid, and one of its shareholders, Jamie Wrage,
13 is a board member.
