DEMAND FOR JURY TRIAL

COMES NOW, Plaintiff GABRIEL QUEZADA (“Plaintiff”), individually, and on behalf of other members of the general public similarly situated, and alleges as follows:

JURISDICTION AND VENUE

1. This class action is brought pursuant to the Code of Civil Procedure section 382. The monetary damages and restitution sought by Plaintiff exceeds the minimal jurisdiction limits of the Superior Court and will be established according to proof at trial.

2. This Court has jurisdiction over this action pursuant to the California Constitution, Article VI, Section 10, which grants the superior court “original jurisdiction in all other causes” except those given by statute to other courts. The statutes under which this action is brought do not specify any other basis for jurisdiction.

3. This Court has jurisdiction over Defendants because, upon information and belief, Defendants are citizens of California, have sufficient minimum contacts in California, or otherwise intentionally avail themselves of the California market so as to render the exercise of jurisdiction over them by the California courts consistent with traditional notions of fair play and substantial justice.

4. Venue is proper in this Court because, upon information and belief, Defendants maintain offices, have agents, and/or transact business in the State of California, including the County of Monterey. The majority of the acts and omissions alleged herein relating to Plaintiff took place in the State of California, County of Monterey. Defendants employed Plaintiff within the State of California, County of Monterey.

PARTIES

5. Plaintiff GABRIEL QUEZADA is an individual residing in the State of California, County of Monterey.

6. Defendant B & P PACKING CO., INC., at all times herein mentioned, was and is, upon information and belief, a California corporation, headquartered in the State of California, and at all times herein mentioned, was and is, an employer whose employees are engaged throughout the State of California, including the County of Monterey.

1 7. At all relevant times, Defendant B & P PACKING CO., INC. was the
2 “employer” of Plaintiff within the meaning of all applicable laws and statutes.

3 8. At all times herein relevant, Defendant B & P PACKING CO., INC. and DOES
4 1 through 100, and each of them, were the agents, partners, joint venturers, joint employers,
5 representatives, servants, employees, successors-in-interest, co-conspirators and assigns, each
6 of the other, and at all times relevant hereto were acting within the course and scope of their
7 authority as such agents, partners, joint venturers, joint employers, representatives, servants,
8 employees, successors, co-conspirators and assigns, and all acts or omissions alleged herein
9 were duly committed with the ratification, knowledge, permission, encouragement,
10 authorization, and consent of each defendant designated herein.

11 9. The true names and capacities, whether corporate, associate, individual or
12 otherwise, of Defendants DOES 1 through 100, inclusive, are unknown to Plaintiff, who sues
13 said defendants by such fictitious names. Plaintiff is informed and believes, and based on that
14 information and belief alleges, that each of the Defendants designated as a DOE is legally
15 responsible for the events and happenings referred to in this Complaint, and unlawfully
16 caused the injuries and damages to Plaintiff and the other class members as alleged in this
17 Complaint. Plaintiff will seek leave of court to amend this Complaint to show the true names
18 and capacities when the same have been ascertained.

19 10. Defendant B & P PACKING CO., INC. and DOES 1 through 100 will
20 hereinafter collectively be referred to as “Defendants.”

21 11. Plaintiff further alleges that Defendants directly or indirectly controlled or
22 affected the working conditions, wages, working hours, and conditions of employment of
23 Plaintiff and the other class members so as to make each of said Defendants employers and
24 employers liable under the statutory provisions set forth herein.

25 **CLASS ACTION ALLEGATIONS**

26 12. Plaintiff brings this action on his own behalf and on behalf of all other
27 members of the general public similarly situated, and, thus, seeks class certification under
28

Code of Civil Procedure section 382.

13. The proposed class is defined as follows:

All current and former hourly-paid or non-exempt employees of Defendants within the State of California at any time from February 18, 2018, through the date of preliminary approval.

14. Plaintiff reserves the right to establish subclasses as appropriate.

15. The class is ascertainable and there is a well-defined community of interest in the litigation:

a. Numerosity: The class members are so numerous that joinder of all class members is impracticable. The membership of the entire class is unknown to Plaintiff at this time. However, the class is estimated to be greater than two hundred (200) individuals and the identity of such membership is readily ascertainable by inspection of Defendants' employment records.

b. Typicality: Plaintiff's claims are typical of all other class members' claims as demonstrated herein. Plaintiff will fairly and adequately protect the interests of the other class members with whom he has a well-defined community of interest.

c. Adequacy: Plaintiff will fairly and adequately protect the interests of each class member, with whom he has a well-defined community of interest and typicality of claims, as demonstrated herein. Plaintiff has no interest that is antagonistic to the other class members. Plaintiff's attorneys, the proposed class counsel, are versed in the rules governing class action discovery, certification, and settlement. Plaintiff has incurred, and during the pendency of this action will continue to incur, costs and attorneys' fees, that have been, are, and will be necessarily expended for the prosecution of this action for the substantial benefit of

1 each class member.

2 d. Superiority: A class action is superior to other available methods for the
3 fair and efficient adjudication of this litigation because individual
4 joinder of all class members is impractical.

5 e. Public Policy Considerations: Certification of this lawsuit as a class
6 action will advance public policy objectives. Employers of this great
7 state violate employment and labor laws every day. Current employees
8 are often afraid to assert their rights out of fear of direct or indirect
9 retaliation. However, class actions provide the class members who are
10 not named in the complaint anonymity that allows for the vindication of
11 their rights.

12 16. There are common questions of law and fact as to the class members that
13 predominate over questions affecting only individual members. The following common
14 questions of law or fact, among others, exist as to the members of the class:

- 15 a. Whether Defendants' failure to pay wages, without abatement or
16 reduction, in accordance with the Labor Code, was willful;
- 17 b. Whether Defendants failed to pay their hourly-paid or non-exempt
18 employees within the State of California for all hours worked, missed
19 meal periods and rest breaks in violation of the law;
- 20 c. Whether Defendants required Plaintiff and the other class members to
21 work over eight (8) hours per day and/or over forty (40) hours per week
22 and failed to pay the legally required overtime compensation to Plaintiff
23 and the other class members;
- 24 d. Whether Defendants properly calculated the regular rate for Plaintiff
25 and the other class members to worked overtime and earned incentive
26 pay and sick leave pay;

27 ///

- 1 e. Whether Defendants deprived Plaintiff and the other class members of
2 meal and/or rest periods or required Plaintiff and the other class
3 members to work during meal and/or rest periods without
4 compensation;
- 5 f. Whether Defendants failed to pay minimum wages to Plaintiff and the
6 other class members for all hours worked;
- 7 g. Whether Defendants failed to pay all wages due to Plaintiff and the
8 other class members within the required time upon their discharge or
9 resignation;
- 10 h. Whether Defendants failed to timely pay all wages due to Plaintiff and
11 the other class members during their employment;
- 12 i. Whether Defendants complied with wage reporting as required by the
13 Labor Code, including, inter alia, section 226;
- 14 j. Whether Defendants failed to reimburse Plaintiff and the other class
15 members for necessary business-related expenses and costs;
- 16 k. Whether Defendants' conduct was willful or reckless;
- 17 l. Whether Defendants engaged in unfair business practices in violation of
18 Business & Professions Code section 17200, *et seq.*;
- 19 m. The appropriate amount of damages, restitution, and/or monetary
20 penalties resulting from Defendants' violation of the law; and
- 21 n. Whether Plaintiff and the other class members are entitled to
22 compensatory damages pursuant to the Labor Code.

23 **GENERAL ALLEGATIONS**

24 17. During the relevant time period set forth herein, Defendants employed Plaintiff
25 and other persons as hourly-paid or non-exempt employees within the State of California.

26 18. Defendants, jointly and severally, employed Plaintiff as an hourly-paid non-
27 exempt employee during the relevant time period in the State of California, County of
28

1 Monterey.

2 19. Defendants had the authority to hire and terminate Plaintiff and the other class
3 members; to set work rules and conditions governing Plaintiff's and other class members'
4 employment; and to supervise their daily employment activities.

5 20. Defendants exercised sufficient authority over the terms and conditions of
6 Plaintiff and other class members' employment for them to be joint employers of Plaintiff and
7 the other class members.

8 21. Defendants directly hired and paid wages and benefits to Plaintiff and the other
9 class members.

10 22. Defendants continue to employ hourly-paid or non-exempt employees within
11 the State of California.

12 23. Plaintiff and the other class members worked over eight (8) hours in a day,
13 and/or forty (40) hours in a week during their employment with Defendants.

14 24. Plaintiff is informed and believes, and based thereon alleges, that Defendants
15 engaged in a uniform policy and systematic scheme of wage abuse against their hourly-paid or
16 non-exempt employees within the State of California. This scheme involved, inter alia, failing
17 to pay them for all hours worked, sick leave, missed meal periods, and missed rest breaks in
18 violation of the law.

19 25. Plaintiff is informed and believes, and based thereon alleges, that Defendants
20 knew or should have known that Plaintiff and the other class members were entitled to receive
21 certain wages for overtime compensation and that Plaintiff and the other class members were
22 not receiving wages for overtime compensation.

23 26. Plaintiff is informed and believes, and based thereon alleges, that Defendants
24 failed to provide Plaintiff and the other class members the required rest and meal periods
25 during the relevant time period as required under the Industrial Welfare Commission Wage
26 Orders and thus they are entitled to any and all applicable penalties.

27 ///

1 27. Plaintiff is informed and believes, and based thereon alleges, that Defendants
2 knew or should have known that Plaintiff and the other class members were entitled to receive
3 all timely and complete meal periods or payment of one additional hour of pay at Plaintiff's
4 and the other class members' regular rate of pay when a meal period was missed, late or
5 interrupted, and that Plaintiff and the other class members did not receive all timely and
6 proper meal periods or payment of one additional hour of pay at their regular rate of pay when
7 a meal period was missed.

8 28. Plaintiff is informed and believes, and based thereon alleges, that Defendants
9 knew or should have known that Plaintiff and other class members were entitled to receive all
10 timely rest periods without interruption or payment of one additional hour of pay at Plaintiff
11 and the other class members' regular rate of pay when a rest period was missed, late or
12 interrupted, and that Plaintiff and the other class members did not receive all rest periods or
13 payment of one additional hour of pay at their regular rate of pay when a rest period was
14 missed.

15 29. Plaintiff is informed and believes, and based thereon alleges, that Defendants
16 knew or should have known that Plaintiff and the other class members were entitled to receive
17 at least minimum wages for compensation and that Plaintiff and the other class members were
18 not receiving at least minimum wages for all hours worked.

19 30. Plaintiff is informed and believes, and based thereon alleges, that Defendants
20 knew or should have known that Plaintiff and the other class members were entitled to receive
21 the wages owed to them upon discharge or resignation, including overtime and minimum
22 wages and meal and rest period premiums, and that Plaintiff and the other class members did
23 not, in fact, receive such wages owed to them at the time of their discharge or resignation.

24 31. Plaintiff is informed and believes, and based thereon alleges, that Defendants
25 knew or should have known that Plaintiff and the other class members were entitled to receive
26 complete and accurate wage statements in accordance with the law, but, in fact, Plaintiff and
27 the other class members did not receive complete and accurate wage statements from
28

Defendants. The deficiencies included, inter alia, the failure to include the total number of hours worked by Plaintiff and the other class members.

32. Plaintiff is informed and believes, and based thereon alleges, that Defendants knew or should have known that Plaintiff and the other class members were entitled to reimbursement for necessary business-related expenses.

33. Plaintiff is informed and believes, and based thereon alleges, that Defendants knew or should have known that Defendants had to keep complete and accurate payroll records for Plaintiff and the other class members in accordance with the law, but, in fact, did not keep complete and accurate payroll records for Plaintiff and the other class members.

34. Plaintiff is informed and believes, and based thereon alleges, that Defendants knew or should have known that they had a duty to compensate Plaintiff and the other class members pursuant to the law, and that Defendants had the financial ability to pay such compensation, but willfully, knowingly, and intentionally failed to do so, and falsely represented to Plaintiff and the other class members that they were properly denied wages, all in order to increase Defendants' profits.

35. During the relevant time period set forth herein, Defendants failed to pay overtime wages to Plaintiff and the other class members for all hours worked. Plaintiff and other class members were required to work more than eight (8) hours per day and/or forty (40) hours per week without overtime compensation.

36. During the relevant time period set forth herein, Defendants failed to properly calculate and pay sick leave to Plaintiff and the other class members.

37. During the relevant time period set forth herein, Defendants failed to provide the requisite uninterrupted and timely meal and rest periods to Plaintiff and the other class members.

38. During the relevant time period set forth herein, Defendants failed to pay Plaintiff and the other class members at least minimum wages for all hours worked.

39. During the relevant time period set forth herein, Defendants failed to pay Plaintiff and the other class members the wages owed to them upon discharge or resignation.

40. During the relevant time period set forth herein, Defendants failed to provide complete or accurate wage statements to Plaintiff and the other class members.

41. During the relevant time period set forth herein, Defendants failed to keep complete or accurate payroll records for Plaintiff and the other class members.

42. During the relevant time period set forth herein, Defendants failed to properly compensate Plaintiff and the other class members pursuant to the law in order to increase Defendants' profits.

43. Labor Code section 218 states that nothing in Article 1 of the Labor Code shall limit the right of any wage claimant to “sue directly . . . for any wages or penalty due to him [or her] under this article.”

FIRST CAUSE OF ACTION

(Violation of California Labor Code §§ 510 and 1198)

(Against B & P PACKING CO., INC. and DOES 1 through 100)

44. Plaintiff incorporates by reference the allegations contained in Paragraphs 1 through 43, and each and every part thereof with the same force and effect as though fully set forth herein.

45. Labor Code section 1198 and the applicable Industrial Welfare Commission (“IWC”) Wage Order provide that it is unlawful to employ persons without compensating them at a rate of pay either time-and-one-half or two-times that person’s regular rate of pay, depending on the number of hours worked by the person on a daily or weekly basis.

46. The applicable IWC Wage Order provides that Defendants are and were required to pay Plaintiff and the other class members employed by Defendants, who work(ed) more than eight (8) hours in a day or more than forty (40) hours in a workweek, at the rate of time-and-one-half for all hours worked in excess of eight (8) hours in a day or more than forty (40) hours in a workweek.

1 47. The applicable IWC Wage Order further provides that Defendants are and were
2 required to pay Plaintiff and the other class members overtime compensation at a rate of two
3 times their regular rate of pay for all hours worked in excess of twelve (12) hours in a day.

4 48. Labor Code section 510 codifies the right to overtime compensation at one-
5 and-one-half times the regular hourly rate for hours worked in excess of eight (8) hours in a
6 day or forty (40) hours in a week or for the first eight (8) hours worked on the seventh day of
7 work, and overtime compensation at twice the regular hourly rate for hours worked in excess
8 of twelve (12) hours in a day or in excess of eight (8) hours in a day on the seventh day of
9 work.

10 49. During the relevant time period set forth herein, Plaintiff and the other class
11 members worked in excess of eight (8) hours in a day, and/or in excess of forty (40) hours in a
12 week.

13 50. During the relevant time period set forth herein, Defendants intentionally and
14 willfully failed to pay overtime wages owed to Plaintiff and the other class members.

15 51. Defendants' failure to pay Plaintiff and the other class members the unpaid
16 balance of overtime compensation, as required by the laws, violates the provisions of Labor
17 Code sections 510 and 1198, and is therefore unlawful.

18 52. Pursuant to Labor Code section 1194, Plaintiff and the other class members are
19 entitled to recover unpaid overtime compensation, as well as interest, costs, and attorneys'
20 fees.

21 **SECOND CAUSE OF ACTION**

22 **(Violation of California Labor Code §§ 226.7 and 512(a))**

23 **(Against B & P PACKING CO., INC. and DOES 1 through 100)**

24 53. Plaintiff incorporates by reference the allegations contained in paragraphs 1
25 through 52, and each and every part thereof with the same force and effect as though fully set
26 forth herein.

27 ///

1 54. During the relevant time period set forth herein, the IWC Order and Labor
2 Code sections 226.7 and 512(a) were applicable to Plaintiff's and the other class members'
3 employment by Defendants.

4 55. During the relevant time period set forth herein, Labor Code section 226.7
5 provides that no employer shall require an employee to work during any meal or rest period
6 mandated by an applicable order of the IWC.

7 56. During the relevant time period set forth herein, the applicable IWC Wage
8 Order and Labor Code section 512(a) provide that an employer may not require, cause or
9 permit an employee to work for a work period of more than five (5) hours per day without
10 providing the employee with a meal period of not less than thirty (30) minutes, except that if
11 the total work period per day of the employee is no more than six (6) hours, the meal period
12 may be waived by mutual consent of both the employer and employee.

13 57. During the relevant time period set forth herein, the applicable IWC Wage
14 Order and Labor Code section 512(a) further provide that an employer may not require, cause,
15 or permit an employee to work for a work period of more than ten (10) hours per day without
16 providing the employee with a second uninterrupted meal period of not less than thirty (30)
17 minutes, except that if the total hours worked is no more than twelve (12) hours, the second
18 meal period may be waived by mutual consent of the employer and the employee only if the
19 first meal period was not waived.

20 58. During the relevant time period set forth herein, Plaintiff and the other class
21 members who were scheduled to work for a period of time no longer than six (6) hours, and
22 who did not waive their legally-mandated meal periods by mutual consent, were required to
23 work for periods longer than five (5) hours without an uninterrupted meal period of not less
24 than thirty (30) minutes and/or without a rest period.

25 59. During the relevant time period set forth herein, Plaintiff and the other class
26 members who were scheduled to work for a period of time no longer than twelve (12) hours,
27 and who did not waive their legally-mandated meal periods by mutual consent, were required
28

1 to work for periods longer than ten (10) hours without an uninterrupted meal period of not less
2 than thirty (30) minutes and/or without a rest period.

3 60. During the relevant time period set forth herein, Plaintiff and the other class
4 members who were scheduled to work for a period of time in excess of six (6) hours were
5 required to work for periods longer than five (5) hours without an uninterrupted meal period
6 of not less than thirty (30) minutes and/or without a rest period.

7 61. During the relevant time period set forth herein, Plaintiff and the other class
8 members who were scheduled to work for a period of time in excess of twelve (12) hours
9 were required to work for periods longer than ten (10) hours without an uninterrupted meal
10 period of not less than thirty (30) minutes and/or without a rest period.

11 62. During the relevant time period set forth herein, Defendants intentionally and
12 willfully required Plaintiff and the other class members to work during meal periods and
13 failed to compensate Plaintiff and the other class members the full meal period premium for
14 work performed during meal periods.

15 63. During the relevant time period set forth herein, Defendants failed to pay
16 Plaintiff and the other class members the full meal period premium due pursuant to Labor
17 Code section 226.7.

18 64. Defendants' conduct violates applicable IWC Wage Order and Labor Code
19 sections 226.7 and 512(a).

20 65. Pursuant to the applicable IWC Wage Order and California Labor Code section
21 226.7(b), Plaintiff and the other class members are entitled to recover from Defendants one
22 additional hour of pay at the employee's regular rate of compensation for each workday that
23 the meal or rest period is not provided.

2 73. Defendants' conduct violates applicable IWC Wage Orders and Labor Code
3 section 226.7.

4 74. Pursuant to the applicable IWC Wage Orders and Labor Code section 226.7(b),
5 Plaintiff and the other class members are entitled to recover from Defendants one additional
6 hour of pay at the employees' regular hourly rate of compensation for each workday that the
7 rest period was not provided.

8 **FOURTH CAUSE OF ACTION**

9 **(Violation of California Labor Code §§ 1194 and 1197)**

10 **(Against B & P PACKING CO., INC. and DOES 1 through 100)**

11 75. Plaintiff incorporates by reference the allegations contained in paragraphs 1
12 through 74 and each and every part thereof with the same force and effect as though fully set
13 forth herein.

14 76. During the relevant time period set forth herein, Labor Code sections 1194 and
15 1197 provide that the minimum wage to be paid to employees, and the payment of a lesser
16 wage than the minimum so fixed, is unlawful.

17 77. During the relevant time period set forth herein, Defendants failed to pay
18 minimum wages to Plaintiff and the other class members as required, pursuant to Labor Code
19 sections 1194 and 1197.

20 78. Defendants' failure to pay Plaintiff and the other class members the minimum
21 wage as required violates Labor Code sections 1194 and 1197. Pursuant to those sections,
22 Plaintiff and other class members are entitled to recover the unpaid balance of their minimum
23 wage compensation as well as interest, costs, and attorney's fees, and liquidated damages in
24 an amount equal to the wages unlawfully unpaid and interest thereon.

25 79. Pursuant to Labor Code section 1194.2, Plaintiff and the other class members
26 are entitled to recover liquidated damages in an amount equal to the wages unlawfully unpaid
27 and interest thereon.

1 **FIFTH CAUSE OF ACTION**

2 **(Violation of California Labor Code §§ 201 and 202)**

3 **(Against B & P PACKING CO., INC. and DOES 1 through 100)**

4 80. Plaintiff incorporates by reference the allegations contained in paragraphs 1
5 through 79, and each and every part thereof with the same force and effect as though fully set
6 forth herein.

7 81. During the relevant time period set forth herein, Labor Code sections 201 and
8 202 provide that if an employer discharges an employee, the wages earned and unpaid at the
9 time of discharge are due and payable immediately, and if an employee quits his or her
10 employment, his or her wages shall become due and payable not later than seventy-two (72)
11 hours thereafter, unless the employee has given seventy-two (72) hours' notice of his or her
12 intention to quit, in which case the employee is entitled to his or her wages at the time of
13 quitting.

14 82. During the relevant time period set forth herein, Defendants intentionally and
15 willfully failed to pay Plaintiff and the other class members who are no longer employed by
16 Defendants their wages, earned and unpaid, within seventy-two (72) hours of their leaving
17 Defendants' employ.

18 83. Defendants' failure to pay Plaintiff and the other class members who are no
19 longer employed by Defendants their wages, earned and unpaid, within seventy-two (72)
20 hours of their leaving Defendants' employ, is in violation of Labor Code sections 201 and
21 202.

22 84. Labor Code section 203 provides that if an employer willfully fails to pay
23 wages owed, in accordance with sections 201 and 202, then the wages of the employee shall
24 continue as a penalty from the due date thereof at the same rate until paid or until an action is
25 commenced; but the wages shall not continue for more than thirty (30) days.

26 85. Plaintiff and the other class members are entitled to recover from Defendants
27 the statutory penalty wages for each day they were not paid, up to the thirty (30) day
28

1 maximum as provided by Labor Code section 203.

2 **SIXTH CAUSE OF ACTION**

3 **(Violation of California Labor Code § 226(a))**

4 **(Against B & P PACKING CO., INC. and DOES 1 through 100)**

5 86. Plaintiff incorporates by reference the allegations contained in paragraphs 1
6 through 85, and each and every part thereof with the same force and effect as though fully set
7 forth herein.

8 87. During the relevant time period set forth herein, Labor Code section 226(a)
9 provides that every employer shall furnish each of his or her employees an accurate itemized
10 statement in writing showing: (a) gross wages earned, (b) total hours worked by the employee,
11 (c) the number of piece-rate units earned and any applicable piece rate if the employee is paid
12 on a piece-rate basis, (d) all deductions, provided that all deductions made on written orders
13 of the employee may be aggregated and shown as one item, (e) net wages earned, (f) the
14 inclusive dates of the period for which the employee is paid, (g) the name of the employee and
15 his or her social security number, (h) the name and address of the legal entity that is the
16 employer, and (i) all applicable hourly rates in effect during the pay period and the
17 corresponding number of hours worked at each hourly rate by the employee. The deductions
18 made from payments of wages shall be recorded in ink or other indelible form, properly dated,
19 showing the month, day, and year, and a copy of the statement or a record of the deductions
20 shall be kept on file by the employer for at least three years at the place of employment or at a
21 central location within the State of California.

22 88. Defendants have intentionally and willfully failed to provide Plaintiff and the
23 other class members with complete and accurate wage statements. The deficiencies include,
24 but are not limited to, the failure to include the total number of hours worked by Plaintiff and
25 other class members.

26 89. As a result of Defendants' violation of Labor Code section 226(a), Plaintiff and
27 the other class members have suffered injury and damage to their statutorily protected rights.

1 90. Plaintiff and the other class members have been injured by Defendants'
2 intentional and willful violation of Labor Code section 226(a) because they were denied both
3 their legal right to receive, and their protected interest in receiving, accurate and itemized
4 wage statements pursuant to Labor Code section 226(a).

5 91. Plaintiff and the other class members are entitled to recover from Defendants
6 the greater of their actual damages caused by Defendants' failure to comply with Labor Code
7 section 226(a), or an aggregate penalty not exceeding four thousand dollars per employee.

8 92. Plaintiff and the other class members are also entitled to injunctive relief to
9 ensure compliance with this section, pursuant to Labor Code section 226(g).

10 **SEVENTH CAUSE OF ACTION**

11 **(Violation of California Labor Code §§ 2800 and 2802)**

12 **(Against B & P PACKING CO., INC. and DOES 1 through 100)**

13 93. Plaintiff incorporates by reference the allegations contained in paragraphs 1
14 through 92, and each and every part thereof with the same force and effect as though fully set
15 forth herein.

16 94. Pursuant to Labor Code sections 2800 and 2802, an employer must reimburse its
17 employee for all necessary expenditures incurred by the employee in direct consequence of the
18 discharge of his or her job duties or in direct consequence of his or her obedience to the
19 directions of the employer.

20 95. Defendants have intentionally and willfully failed to reimburse Plaintiff and the
21 other class members for all necessary business-related expenses and costs. Plaintiff and the
22 other class members are entitled to recover from Defendants their business-related expenses and
23 costs incurred during the course and scope of their employment, plus interest accrued from the
24 date on which the employee incurred the necessary expenditures at the same rate as judgments
25 in civil actions in the State of California.

26 ///

27 ///

1 **EIGHTH CAUSE OF ACTION**

2 **(Violation of California Labor Code § 2698, *et seq.*)**

3 **(Against B & P PACKING CO., INC. and DOES 1 through 100)**

4 96. Plaintiff incorporates by reference the allegations contained in paragraphs 1
5 through 95, and each and every part thereof with the same force and effect as though fully set
6 forth herein.

7 97. The Private Attorneys General Act of 2004 (“PAGA”) expressly establishes
8 that any provision of the Labor Code which provides for a civil penalty to be assessed and
9 collected by the California Labor and Workforce Development Agency (“LWDA”), or any of
10 its departments, divisions, commissions, boards, agencies, or employees for a violation of the
11 Labor Code, may be recovered through a civil action brought by an aggrieved employee on
12 behalf of himself or herself, and other current or former employees.

13 98. On January 15, 2025, Plaintiff provided written notice to the LWDA and
14 Defendants of the specific provisions of the Labor Code he contends were violated and the
15 theories supporting his contentions. Attached hereto as **Exhibit 1** and incorporated by
16 reference is a copy of the written notice to the LWDA. Plaintiff believes that on or about
17 March 21, 2025, the sixty-five (65) day notice period will expire, and the LWDA will not take
18 any action to investigate or prosecute this matter. Thus, Plaintiff exhausted the statutory time
19 period to bring this action.

20 99. Plaintiff and the other hourly-paid or non-exempt employees are “aggrieved
21 employees” as defined by Labor Code section 2699(c) in that they are all current and former
22 hourly-paid or non-exempt employees of Defendants within the State of California at any time
23 from January 15, 2024, through the date of preliminary approval, and one or more of the
24 alleged violations was committed against them.

25 **Failure to Pay Minimum and Overtime Wages**

26 100. At all times relevant herein, Defendants were required to compensate their non-
27 exempt employees minimum wages for all hours worked and overtime wages for all hours
28

1 worked in excess of eight (8) hours in a day or forty (40) hours in a workweek, pursuant to the
2 mandate of Labor Code sections 510, 1194, 1197, and 1198.

3 101. As a policy and practice, Defendants failed to compensate Plaintiff and the
4 other aggrieved current and former employees for all hours worked, resulting in a failure to
5 pay all minimum wages and overtime wages, where applicable.

6 **Failure to Provide Meal Periods and Rest Breaks**

7 102. In accordance with the mandates of Labor Code sections 226.7 and 512,
8 Defendants were required to authorize and permit their non-exempt employees to take a 10-
9 minute rest break for every four (4) hours worked or major fraction thereof and were further
10 required to provide their non-exempt employees with a 30-minute meal period for every five
11 (5) hours worked.

12 103. As a policy and practice, Defendants failed to provide Plaintiff and the other
13 aggrieved current and former employees with legally mandated meal periods and rest breaks
14 and failed to pay proper compensation for this failure.

15 **Failure to Timely Pay Wages During Employment**

16 104. At all times relevant herein, Defendants were required to pay their employees
17 within a specified time period pursuant to the mandate of Labor Code section 204.

18 105. As a policy and practice, Defendants failed to pay Plaintiff and the other
19 aggrieved current and former employees all wages due and owing them within the required
20 time period.

21 **Failure to Timely Pay Wages Upon Termination**

22 106. At all times relevant herein, Defendants were required to pay their employees
23 all wages owed in a timely fashion at the end of employment pursuant to Labor Code sections
24 201 to 204.

25 107. As a result of Defendants' Labor Code violations alleged above, Defendants
26 failed to pay Plaintiff and the other aggrieved former employees their final wages pursuant to
27 Labor Code sections 201 to 204 and accordingly owe waiting time penalties pursuant to Labor
28

1 Code section 203.

2 **Failure to Provide Complete and Accurate Wage Statements**

3 108. At all times relevant herein, Defendants were required to keep accurate records
4 regarding their California employees pursuant to the mandate of Labor Code sections 226,
5 1174, and 1776.

6 109. As a result of Defendants' various Labor Code violations, Defendants failed to
7 keep accurate records regarding Plaintiff and the other aggrieved current and former
8 employees. For example, Defendants failed in their affirmative obligation to keep accurate
9 records regarding Plaintiff and the other aggrieved current and former employees' gross
10 wages earned, total hours worked, all deductions, net wages earned, and all applicable hourly
11 rates and the number of hours worked at each hourly rate.

12 **Failure to Provide and Properly Pay Paid Sick Days**

13 110. At all times relevant herein, Defendants were required to provide their
14 employees with paid sick days at their regular rate of pay pursuant to Labor Code section 246
15 *at seq.*

16 111. As a policy and practice, Defendants failed to provide Plaintiff and other
17 aggrieved current and former employees with paid sick days at the proper rate of pay pursuant
18 to Labor Code section 246 *et seq.*

19 **Failure to Reimburse Business Expenses**

20 112. At all times relevant herein, Defendants were required to reimburse its
21 employees for any and all necessary expenditures or losses incurred by the employees in
22 direct consequences of the discharge or his or her duties pursuant to the mandate of Labor
23 Code sections 2800 and 2802.

24 113. As a policy and practice, Defendants failed to reimburse Plaintiff and the other
25 aggrieved current and former employees for all business expenses incurred and owing them
26 within the required time period.

27 ///

Penalties

114. Pursuant to Labor Code section 2699, Plaintiff, individually, and on behalf of the other current and former aggrieved employees, requests and is entitled to recover from Defendants, and each of them, civil penalties, interest, attorneys' fees and costs, including but not limited to:

- a. Penalties under Labor Code section 2699 in the amount of a hundred dollars (\$100) for each aggrieved employee per pay period for the initial violation, and two hundred dollars (\$200) for each aggrieved employee per pay period for each subsequent violation;
- b. Penalties under Code of Regulations Title 8 section 11040 in the amount of fifty dollars (\$50) for each aggrieved employee per pay period for the initial violation, and one hundred dollars (\$100) for each aggrieved employee per pay period for each subsequent violation;
- c. Penalties under Labor Code section 210 in addition to, and entirely independent and apart from, any other penalty provided in the Labor Code in the amount of a hundred dollars (\$100) for each aggrieved employee per pay period for the initial violation, and two hundred dollars (\$200) for each aggrieved employee per pay period for each subsequent violation;
- d. Penalties under Labor Code section 1197.1 in the amount of a hundred dollars (\$100) for each aggrieved employee per pay period for the initial violation, and two hundred fifty dollars (\$250) for each aggrieved employee per pay period for each subsequent violation;
- e. Any and all additional penalties as provided by the Labor Code and/or other statutes; and
- f. Attorneys' fees and costs pursuant to Labor Code sections 210, 1194, and 2699, and any other applicable statute.

1 **NINTH CAUSE OF ACTION**

2 **(Violation of California Business & Professions Code § 17200, *et seq.*)**

3 **(Against B & P PACKING CO., INC. and DOES 1 through 100)**

4 115. Plaintiff incorporates by reference the allegations contained in paragraphs 1
5 through 114, and each and every part thereof with the same force and effect as though fully
6 set forth herein.

7 116. Defendants' conduct, as alleged herein, has been, and continues to be unfair,
8 unlawful and harmful to Plaintiff, the other class members, to the general public, and
9 Defendants' competitors. Accordingly, Plaintiff seeks to enforce important rights affecting the
10 public interest within the meaning of Code of Civil Procedure section 1021.5.

11 117. Defendants' activities as alleged herein are violations of law, and constitute
12 unlawful business acts and practices in violation of Business & Professions Code section
13 17200, *et seq.*

14 118. A violation of Business & Professions Code section 17200, *et seq.* may be
15 predicated on the violation of any state or federal law. In this instant case, Defendants' policy
16 and practice of requiring Plaintiff and the other class members work overtime hours without
17 paying them proper compensation violate Labor Code sections 510 and 1198. Defendants'
18 policy and practice of requiring Plaintiff and the other class members, to work through their
19 meal and rest periods without paying them proper compensation violate Labor Code sections
20 226.7 and 512(a). Defendants' policy and practice of failing to timely pay wages to Plaintiff
21 and the other class members violate Labor Code sections 201 and 202. Defendants also
22 violated Labor Code sections 226(a), 1194, 1197, 2800, and 2802.

23 119. As a result of the herein described violations of the law, Defendants unlawfully
24 gained an unfair advantage over other businesses.

25 120. Plaintiff and the other class members have been personally injured by
26 Defendants' unlawful business acts and practices as alleged herein, including but not
27 necessarily limited to the loss of money and/or property.

1 121. Pursuant to Business & Professions Code section 17200, *et seq.*, Plaintiff and
2 the other class members are entitled to restitution of the wages withheld and retained by
3 Defendants during a period that commences four years prior to the filing of this Complaint; an
4 award of attorneys' fees pursuant to Code of Civil procedure section 1021.5 and other
5 applicable laws; and an award of costs.

6 **DEMAND FOR JURY TRIAL**

7 Plaintiff, individually, and on behalf of other members of the general public similarly
8 situated, requests a trial by jury.

9 **PRAYER FOR RELIEF**

10 WHEREFORE, Plaintiff, individually and on behalf of all other members of the
11 general public similarly situated, prays for relief and judgment against Defendants, jointly and
12 severally, as follows:

13 **Class Certification**

- 14 1. That this action be certified as a class action;
15 2. That Plaintiff be appointed as representative of the Class;
16 3. That counsel for Plaintiff be appointed as Class Counsel; and
17 4. That Defendants provide to Class Counsel immediately the names and most
18 current contact information (address, e-mail, and telephone numbers) of all class members.

19 **As to the First Cause of Action**

- 20 5. That the Court declare, adjudge, and decree that Defendants violated Labor
21 Code sections 510 and 1198 and applicable IWC Wage Orders by willfully failing to pay all
22 overtime wages due to Plaintiff and the other class members;

- 23 6. For general unpaid wages at overtime wage rates and such general and special
24 damages as may be appropriate;

- 25 7. For pre-judgment interest on any unpaid overtime compensation commencing
26 from the date such amounts were due;

- 27 8. For reasonable attorneys' fees and costs of suit incurred herein pursuant to
28

Labor Code section 1194; and

9. For such other and further relief as the court may deem just and proper.

As to the Second Cause of Action

10. That the Court declare, adjudge, and decree that Defendants violated Labor Code sections 226.7 and 512 and applicable IWC Wage Orders by willfully failing to provide all meal periods (including second meal periods) to Plaintiff and the other class members;

11. That the Court make an award to Plaintiff and the other class members of one (1) hour of pay at each employee's regular rate of compensation for each workday that a meal period was not provided;

12. For all actual, consequential, and incidental losses and damages, according to proof;

13. For premium wages pursuant to Labor Code section 226.7(b);

14. For pre-judgment interest on any unpaid wages from the date such amounts were due;

15. For reasonable attorneys' fees and costs of suit incurred herein; and

16. For such other and further relief as the court may deem just and proper.

As to the Third Cause of Action

17. That the Court declare, adjudge, and decree that Defendants violated Labor Code section 226.7 and applicable IWC Wage Orders by willfully failing to provide all rest periods to Plaintiff and the other class members;

18. That the Court make an award to Plaintiff and the other class members of one (1) hour of pay at each employee's regular rate of compensation for each workday that a rest period was not provided;

19. For all actual, consequential, and incidental losses and damages, according to proof;

20. For premium wages pursuant to Labor Code section 226.7(b);

21. For pre-judgment interest on any unpaid wages from the date such amounts

1 were due; and

2 22. For such other and further relief as the court may deem just and proper.

3 **As to the Fourth Cause of Action**

4 23. That the Court declare, adjudge, and decree that Defendants violated Labor
5 Code sections 1194 and 1197 by willfully failing to pay minimum wages to Plaintiff and the
6 other class members;

7 24. For general unpaid wages and such general and special damages as may be
8 appropriate;

9 25. For pre-judgment interest on any unpaid compensation from the date such
10 amounts were due;

11 26. For reasonable attorneys' fees and costs of suit incurred herein pursuant to
12 Labor Code section 1194(a);

13 27. For liquidated damages pursuant to Labor Code section 1194.2; and

14 28. For such other and further relief as the court may deem just and proper.

15 **As to the Fifth Cause of Action**

16 29. That the Court declare, adjudge, and decree that Defendants violated Labor
17 Code sections 201, 202, and 203 by willfully failing to pay all compensation owed at the time
18 of termination of the employment of Plaintiff and the other class members no longer
19 employed by Defendants;

20 30. For all actual, consequential, and incidental losses and damages, according to
21 proof;

22 31. For statutory wage penalties pursuant to Labor Code section 203 for the other
23 class members who have left Defendants' employ;

24 32. For pre-judgment interest on any unpaid compensation from the date such
25 amounts were due; and

26 33. For such other and further relief as the court may deem just and proper.

27 ///

1 **As to the Sixth Cause of Action**

2 34. That the Court declare, adjudge, and decree that Defendants violated the record
3 keeping provisions of Labor Code section 226(a) and applicable IWC Wage Orders as to
4 Plaintiff and the other class members, and willfully failed to provide accurate itemized wage
5 statements thereto;

6 35. For actual, consequential and incidental losses and damages, according to
7 proof;

8 36. For statutory penalties pursuant to Labor Code section 226(e);

9 37. For injunctive relief to ensure compliance with this section, pursuant to Labor
10 Code section 226(g); and

11 38. For such other and further relief as the court may deem just and proper.

12 **As to the Seventh Cause of Action**

13 39. That the Court declare, adjudge, and decree that Defendants violated Labor
14 Code sections 2800 and 2802 by willfully failing to reimburse Plaintiff and the other class
15 members for all necessary business-related expenses as required by Labor Code sections 2800
16 and 2802;

17 40. For actual, consequential and incidental losses and damages, according to
18 proof;

19 41. For the imposition of civil penalties and/or statutory penalties;

20 42. For punitive damages and/or exemplary damages according to proof at trial;

21 43. For reasonable attorneys' fees and costs of suit incurred herein; and

22 44. For such other and further relief as the court may deem just and proper.

23 **As to the Eighth Cause of Action**

24 45. That the Court declare, adjudge, and decree that Defendants violated Labor
25 Code sections 2698, *et seq.*, the PAGA, for civil penalties pursuant to Defendants' violations
26 of Labor Code sections 201, 202, 203, 204, 218.5, 221, 226(a), 226.3, 226.7, 229, 246(l), 510,
27 512(a), 558, 1174(d), 1174.5, 1194, 1197, 1197.1, 1198, 2800, and 2802;

1 46. Upon this Cause of Action, for costs and attorneys' fees pursuant to Labor
2 Code sections 210, 1194, and 2699, and any other applicable statute; and

3 47. For such other and further relief as the Court may deem just and proper.

4 **As to the Ninth Cause of Action**

5 48. That the Court declare, adjudge, and decree that Defendants violated Business
6 and Professions Code sections 17200, *et seq.* by failing to provide Plaintiff and the other class
7 members all overtime compensation due to them, failing to provide all meal and rest periods
8 to Plaintiff and the other class members, failing to pay at least minimum wages to Plaintiff
9 and the other class members, failing to pay Plaintiff's and the other class members' wages
10 timely as required by Labor Code section 201 and 202.

11 49. For restitution of unpaid wages to Plaintiff and other class members and all
12 pre-judgment interest from the day such amounts were due and payable;

13 50. For the appointment of a receiver to receive, manage and distribute any and all
14 funds disgorged from Defendants and determined to have been wrongfully acquired by
15 Defendants as a result of violation of Business and Professions Code sections 17200, *et seq.*;

16 51. For reasonable attorneys' fees and costs of suit incurred herein pursuant to
17 Code of Civil Procedure section 1021.5;

18 52. For injunctive relief to ensure compliance with this section, pursuant to
19 Business and Professions Code sections 17200, *et seq.*; and

20 53. For such other and further relief as the court may deem just and proper.

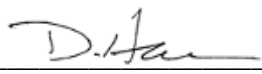

We have been retained to represent Gabriel Quezada against B & P Packing Co., Inc. (including any and all affiliates, managers, members, subsidiaries, and parents, and their shareholders, officers, directors, and employees), any individual, owner, officer and managing agent, DOES 1-10 as an "Employer" or person acting on behalf of an "Employer" pursuant to California Labor Code section 558.1, for violations of California wage-and-hour laws (collectively referred to as "B & P PACKING").

Mr. Quezada is pursuing his California Labor Code section 2698, *et seq.*, the Private Attorneys General Act of 2004 ("PAGA") claim on a representative basis. Therefore, Mr. Quezada may seek penalties for violations of the Labor Code on behalf of the State of California and aggrieved employees, which are recoverable under PAGA. This letter is sent in compliance with the reporting requirements of California Labor Code section 2699.3.

B & P PACKING is a California corporation headquartered at 300 Nestles Road, Soledad, California 93960.

B & P PACKING employed Mr. Quezada as an hourly-paid, non-exempt employee in the State of California. B & P PACKING directly controlled the wages, hours, and/or working conditions of Mr. Quezada and other aggrieved employees' employment, including direction, retention, scheduling, supervision, and termination.

The "aggrieved employees" that Mr. Quezada may seek penalties on behalf of are all current and former hourly-paid or non-exempt employees of B & P PACKING within the State of California.

///

B & P PACKING failed to properly pay its hourly-paid or non-exempt employees for all hours worked, failed to properly provide or compensate minimum wages and overtime wages and for noncompliant meal and rest breaks, failed to issue compliant wage statements and failed to reimburse for all necessary business-related costs and expenses, resulting in other Labor Code violations as stated below.

Pursuant to *Huff v. Securitas Security Services USA, Inc.* (2018) 23 Cal.App.5th 745, 751, an employee who brings a representative action and was affected by at least one of the violations alleged in the complaint has standing to pursue penalties on behalf of the state not only for that violation, but for violations affecting other employees as well. Accordingly, Mr. Quezada has standing to pursue penalties on behalf of the state for violations affecting all the aggrieved employees at B & P PACKING, regardless of their classification, job title, location, or whether they were hired directly or through a staffing agency.

B & P PACKING has violated and/or continues to violate, among other provisions of the California Labor Code and applicable wage law, California Labor Code sections 201, 202, 203, 204, 218.5, 221, 226(a), 226.3, 226.7, 229, 246(l), 510, 512(a), 558, 1174(d), 1174.5, 1194, 1197, 1197.1, 1198, 2800, and 2802, and the Industrial Welfare Commission ("IWC") Wage Orders.

California Labor Code sections 510, 1194, and 1198 require employers to pay at least minimum wage for all hours worked, pay time-and-a-half, or double-time overtime wages, and make it unlawful to work employees for hours longer than 8 hours in one day and/or over 40 hours in one week without paying the premium overtime rates.

During the relevant time period, Mr. Quezada and other aggrieved employees routinely worked in excess of 8 hours in a day and 40 hours in a week. Firstly, B & P PACKING did not compensate Mr. Quezada and other aggrieved employees for the time it took to wait in line to clock in almost every day. Secondly, B & P PACKING required Mr. Quezada and other aggrieved employees to don and doff their personal protective equipment ("PPE") before clocking in and after clocking out respectively. Thirdly, even after Mr. Quezada and other aggrieved employees had completed their shifts and clocked out for the day, supervisors would still instruct them to continue working. Thus, Mr. Quezada and other aggrieved employees were entitled to receive certain wages for minimum and overtime compensation, but they were not paid for all hours worked.

California Labor Code section 246 requires that employers provide employees with paid sick leave of not less than 1 hour per every 30 hours worked. California Labor Code section 246(l) also requires that paid sick leave be paid at a non-exempt employee's regular rate of pay for the workweek in which the employee uses paid sick time or at a rate calculated by dividing the employee's total wages, not including overtime premium pay, by the employee's total hours worked in the full pay periods of the prior 90 days of employment.

During the relevant time period, B & P PACKING failed to pay Mr. Quezada and other aggrieved employees paid sick leave that complied with California Labor Code section 246. This included failing to pay paid sick leave at non-exempt employees' regular rate of pay or at a rate calculated by dividing the employee's total wages, not including overtime premium pay, by the employee's total hours worked in the full pay periods of the prior 90 days of employment. Instead, B & P PACKING only paid sick leave at Mr. Quezada and other aggrieved employees' base hourly rate of pay.

California Labor Code sections 226.7 and 512 require employers to pay an employee 1 additional hour of pay at the employee's regular rate for each workday that a meal or rest break is not provided.

During the relevant time period, B & P PACKING frequently prevented employees from receiving compliant meal and rest breaks. B & P PACKING failed to maintain *Brinker*-compliant meal and rest break policies during the relevant time period. B & P PACKING also failed to permit Mr. Quezada and other aggrieved employees to take duty-free rest breaks since they were not permitted to leave the work premises without first clocking out. Furthermore, Mr. Quezada and other aggrieved employees were regularly forced to work through their meal and rest breaks to meet packaging quotas, especially since they could not leave their machines unattended while they were being washed. Even when Mr. Quezada and other aggrieved employees were afforded opportunities to take their meal and rest breaks, they were cut short by supervisors and coworkers asking them work-related questions. Finally, despite these facts, B & P PACKING failed to compensate Mr. Quezada and other aggrieved employees all the premium wages they were owed.

California Labor Code section 201 requires that if an employer discharges an employee, the wages earned and unpaid at the time of discharge are due and payable immediately. California Labor Code section 202 requires that if an employee not having a written contract for a definite period quits his or her employment, his or her wages shall become due and payable not later than 72 hours thereafter, unless the employee has given 72 hours previous notice of his or her intention to quit, in which case the employee is entitled to his or her wages at the time of quitting. California Labor Code section 203 provides that if an employer willfully fails to pay, without abatement or reduction, in accordance with Labor Code sections 201, 201.3, 201.5, 201.6, 201.8, 201.9, 202, and 205.5, any wages of an employee who is discharged or who quits, the wages of the employee shall continue as a penalty from the due date thereof at the same rate until paid or until an action therefor is commenced. But the wages shall not continue for more than 30 days.

During the relevant time period, B & P PACKING failed to pay Mr. Quezada and other aggrieved employees all wages, including as a result of uncompensated off-the-clock work, unpaid sick leave, unpaid overtime wages, and unpaid premium wages for failing to provide legally mandated meal and rest breaks owed within any time period specified by California Labor Code sections 201 through 203. Therefore, B & P PACKING is liable under California Labor Code section 203.

California Labor Code section 204 requires that all wages earned by any person in any employment between the 1st and the 15th days, inclusive, of any calendar month, other than those wages due upon termination of an employee, are due and payable between the 16th and the 26th day of the month during which the labor was performed. California Labor Code section 204 also requires that all wages earned by any person in any employment between the 16th and the last day, inclusive, of any calendar month, other than those wages due upon termination of an employee, are due and payable between the 1st and the 10th day of the following month. In addition, California Labor Code section 204 requires that all wages earned for labor in excess of the normal work period shall be paid no later than the payday for the next regular payroll period.

During the relevant time period, B & P PACKING failed to pay Mr. Quezada and other aggrieved employees all wages due to them, including as a result of uncompensated off-the-clock work, unpaid sick leave, unpaid overtime wages, and unpaid premium wages owed for failing to provide legally mandated meal and rest breaks owed within any time period specified by California Labor Code section 204.

California Labor Code section 226 requires employers to make, keep and provide complete and accurate itemized wage statements to their employees.

During the relevant time period, B & P PACKING did not provide Mr. Quezada and other aggrieved employees with complete and accurate itemized wage statements. The wage statements Mr. Quezada and other aggrieved employees received from B & P PACKING were in violation of California Labor Code section 226(a). The violations include, but are not limited to, the failure to include: (1) gross wages earned by Mr. Quezada and other aggrieved employees; (2) total hours worked by Mr. Quezada and other aggrieved employees; (3) all deductions for Mr. Quezada and other aggrieved employees; (4) net wages earned by Mr. Quezada and other aggrieved employees; and (5) all applicable hourly rates in effect during the pay period and the corresponding number of hours worked at each hourly rate by Mr. Quezada and other aggrieved employees.

California Labor Code section 558 allows recovery of penalties. Any employer or other person acting on behalf of an employer who violates, or causes to be violated, a section of this chapter or any provision regulating hours and days of work in any order of the IWC Wage Order shall be subject to a civil penalty. The civil penalty is as follows: (1) for any initial violation, fifty dollars (\$50) for each underpaid employee for each pay period for which the employee was underpaid in addition to an amount sufficient to recover underpaid wages; (2) for each subsequent violation, one hundred dollars (\$100) for each underpaid employee for each pay period for which the employee was underpaid in addition to an amount sufficient to recover underpaid wages; and (3) wages recovered pursuant to this section shall be paid to the affected employee.

During the relevant time period, Mr. Quezada and other aggrieved employees have been denied their wages and premium wages and are entitled to penalties.

California Labor Code section 1174(d) requires an employer to keep at a central location in the state or at the plants or establishments at which employees are employed payroll records showing the hours worked daily by and the wages paid to employees employed at the respective plants or establishments. These records shall be kept with rules established for this purpose by the commission, but in any case, shall be kept on file for not less than 3 years.

During the relevant time period, B & P PACKING failed to keep accurate and complete payroll records showing the hours worked daily and the wages paid to Mr. Quezada and other aggrieved employees.

California Labor Code sections 1194, 1197, and 1197.1 provide that the minimum wage to be paid to employees, and the payment of a lesser wage than the minimum so fixed is unlawful.

During the relevant time period, B & P PACKING did not provide Mr. Quezada and other aggrieved employees with the minimum wages to which they were entitled despite having constructive and actual knowledge of off-the-clock work and work performed during meal and rest breaks.

California Labor Code sections 2800 and 2802 require an employer to reimburse its employee for all necessary expenditures incurred by the employee in direct consequence of the discharge of his or her job duties or in direct consequence of his or her obedience to the directions of the employer.

During the relevant time period, Mr. Quezada and other aggrieved employees incurred various necessary business-related expenses that were not fully reimbursed by B & P PACKING. This included purchasing steel-toed boots out-of-pocket to effectively and safely perform their duties.

We believe that Mr. Quezada and other current and former California-based hourly-paid or non-exempt employees are entitled to penalties as allowed under California Labor Code section 2698, *et seq.* for violations of Labor Code sections 201, 202, 203, 204, 218.5, 221, 226(a), 226.3, 226.7, 229, 246(l), 510, 512(a), 558, 1174(d), 1174.5, 1194, 1197, 1197.1, 1198, 2800, and 2802, and the IWC Wage Orders.

California Labor Code section 2699.3 requires that a claimant must send a certified letter to the employer in questions and the California Labor & Workforce Development Agency setting forth the claims and the basis for the claims, thereby giving the California Labor & Workforce Development Agency an opportunity to investigate the claims and/or take any action it deems appropriate.

The purpose of this letter is to satisfy the requirement created by California Labor code section 2699 prior to seeking penalties allowed by law for the aforementioned statutory violations. We look forward to determining whether California Labor & Workforce Development Agency intends to take any action in reference to these claims. We kindly request that you respond to this notice according to the time frame contemplated by the California Labor Code.

Mr. Quezada will seek these penalties on his own behalf and on behalf of other similarly situated California-based hourly-paid or non-exempt employees of B & P PACKING within 1 year of the date of this letter, as allowed by law.
