**24STCV28690 -- Saut and Nakatani v McKesson Corporation**

Previously, the Court granted the Motion for Preliminary Approval. The papers for Final Approval and for Fees and Costs follow the recitations of the Order for Preliminary Approval and, therefore, the Court grants both motions as follows:

- (1) granting final approval of the Class Action and PAGA Settlement reached between Plaintiffs and Defendant McKesson Corporation, the terms of which are set forth in the Class Action and PAGA Settlement Agreement;
- (2) certifying the Class for Settlement Purposes;
- (3) granting the requested settlement administration expenses to the Settlement

Administrator, ILYM Group, Inc., which administered the settlement;

- (4) entering final judgement in the proposed order submitted.
- (5) approving Class Counsel's attorneys' fee of 35% of the Gross Settlement Amount

(or \$787,500) and actual litigation costs of \$39,540.51 and the Class Representative Service Payments in the amount of \$10,000.00 to Plaintiffs Sovatana Saut and John Nakatani (total \$20,000).

The Court orders the Amended Complaint (1st) filed by SOVATANA SAUT, individually and on behalf of themselves and all others similarly situated, et al. on 08/29/2024 dismissed Without Prejudice.
