6. In addition, my office is currently counsel of record to approximately 80 wage and hour class/PAGA action lawsuits.

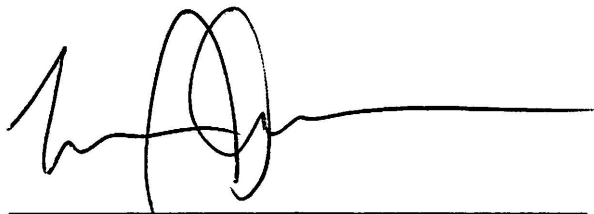
