MEMORANDUM OF POINTS AND AUTHORITIES

I. INTRODUCTION

Plaintiff Thelma Samantha Palmerin (“Plaintiff”) seeks preliminary approval of a proposed \$680,000.00 non-reversionary, wage-and-hour class action settlement (the “Settlement”) with Defendant Self-Help Services Corporation (“Defendant”) (together with Plaintiff, the “Parties”). The Settlement will provide substantial monetary payments to an estimated 282 Class Members who worked an estimated aggregate of 35,365 Workweeks, of which roughly 178 are Aggrieved Employees who worked an estimated aggregate of 5,895 PAGA Pay Periods. As set forth more fully below, the proposed Settlement satisfies all the criteria for settlement approval under California law. The Settlement was reached after extensive investigation, informal discovery, and negotiations between the Parties. The negotiations were at arm’s-length and were facilitated through private mediation by an experienced and neutral class action mediator, Brandon McKelvey. Accordingly, Plaintiff requests the Court preliminarily approve the Settlement, certify the proposed Class, approve the proposed Class Notice to Class Members, and set a final approval hearing no earlier than 120 days from the date of preliminary approval.

II. SUMMARY OF THE LITIGATION AND SETTLEMENT

A. Plaintiff’s Claims and Procedural History

This is a wage-and-hour class action and representative action for alleged Labor Code violations and claims for civil penalties pursuant to the California Private Attorneys General Act, Labor Code sections 2698, *et seq.* (“PAGA”). (Declaration of Kane Moon in Support of Plaintiff’s Motion for Preliminary Approval of Class and Representative Action Settlement [“Moon Decl.”], ¶ 2.) Plaintiff seeks to represent a class of all individuals who worked for Defendant in California as hourly, non-exempt employees at any time during the Class Period, as set forth in the Joint Stipulation of Class and Representative Action Settlement Agreement (the “Settlement”). (*Id.*, ¶ 2, Ex. 1.)

Defendant specializes in financial services and is headquartered in Durham, North Carolina. (*Id.* at ¶ 3) Defendant employed Plaintiff and other non-exempt, hourly-paid employees during the Class Period. (*Id.*) Plaintiff worked for Defendant from approximately 2013 through

1 December 2024, in a non-exempt, hourly-paid position. (Declaration of Plaintiff Thelma Samantha
2 Palmerin in Support of Class and Representative Action Settlement [“Plaintiff Decl.”], ¶¶ 2, 7.)
3 Plaintiff contends she and her coworkers were subjected to the same unlawful labor practices,
4 including failure to pay wages for all hours worked. (*Id.* at ¶ 6; Moon Decl., ¶ 3.)

5 Plaintiff’s claim for unpaid minimum and overtime wages stem from allegations that
6 Defendant failed to compensate Plaintiff and others for off-the-clock work, failed to incorporate all
7 remuneration into employees’ regular rate of pay for purposes of paying overtime, meal premiums, or
8 sick pay, and that Defendant rounded employees’ time to their detriment. (Moon Decl., ¶ 4.)
9 Plaintiff’s meal and rest period claims are based on allegations that due to the nature of their work,
10 Class Members’ breaks were often short, late, interrupted, and sometimes missed altogether, and
11 that Defendant did not pay all premium wages for non-compliant breaks. (*Id.*) Plaintiff further
12 brings a claim for unreimbursed necessary business expenses based on allegations that Class
13 Members were not reimbursed by Defendant for purchase and use of home office supplies. (*Id.*)
14 Finally, Plaintiff also brings derivative claims for waiting time penalties, wage statement
15 violations, unfair business practices, and civil penalties under PAGA. (*Id.*)

16 Because of the foregoing alleged violations of various provisions of the Labor Code,
17 Plaintiff filed a class action on March 18, 2025, which alleges Defendant systematically: (1) failed
18 to pay minimum wages, (2) failed to pay overtime compensation, (3) failed to provide meal
19 periods, (4) failed to authorize and permit rest periods, (5) failed to indemnify necessary business
20 expenses, (6) failed to timely pay final wages at termination, (7) failed to provide accurate
21 itemized wage statements, and (8) engaged in unfair business practices. (*Id.* at ¶ 5.)

22 Pursuant to PAGA, on March 16, 2025, Plaintiff gave written notice to the California Labor
23 and Workforce Development Agency (the “LWDA”) of the alleged Labor Code violations, with
24 certified mail service on Defendant, and paid the required filing fee. (*Id.* at ¶ 6, Ex. 2.) On May
25 29, 2025, Plaintiff timely filed a First Amended Class and Representative Action Complaint to
26 add a ninth cause of action for civil penalties under PAGA (the “Operative Complaint”). (*Id.* at ¶
27 6.) In compliance with Labor Code section 2699(s)(1), Plaintiff subsequently submitted to the
28 LWDA a file-stamped copy of the Operative Complaint containing the Court-assigned case number.

1 (*Id.*) To date, the LWDA has not indicated its intent to investigate the alleged violations or
2 intervene in this Action. (*Id.*)

3 Defendant ardently opposes the merits of this case and denies Plaintiff’s factual allegations.
4 (*Id.* at ¶ 7.) Defendant asserts it complied with all its compensation obligations, including
5 compensating Class Members for any and all off-the-clock work and overtime work, and therefore,
6 Plaintiff and other Class Members were paid all wages owed. (*Id.*) Defendant argues it did not fail
7 to incorporate any non-discretionary bonuses into the regular rate of pay for purposes of paying
8 overtime, meal premiums, or sick pay, and that all bonuses were discretionary. (*Id.*) Defendant
9 argues its time-rounding practice is neutral on its face and in compliance with California law, and
10 that many employees and pay periods were overpaid due to rounding. (*Id.*) Defendant maintains
11 compliance with all its meal and rest period obligations. (*Id.*) Defendant asserts it complied with
12 all its reimbursement obligations, and that Plaintiff and other employees were compensated for
13 any and all business expenses necessarily incurred. (*Id.*) To the extent employees received wage
14 statements that were allegedly inaccurate, Defendant asserts employees suffered no actual damage
15 or harm as a result. (*Id.*; *see, e.g., Angeles v. U.S. Airways, Inc.* (N.D. Cal. Feb. 19, 2013, No. C
16 12–05860 CRB) 2013 WL 622032, at *10 [“A plaintiff must adequately plead an injury arising
17 from an employer’s failure to provide full and accurate wage statements, and the omission of the
18 required information alone is not sufficient.”].) With respect to Plaintiff’s claim for waiting time
19 penalties, Defendant alleges its good-faith belief that it paid all wages precludes the imposition of
20 waiting time penalties since Plaintiff cannot prove Defendant’s alleged failure to pay all final
21 wages at the time of separation was “willful.” (Moon Decl., ¶ 7; *see, e.g., Pedroza v. PetSmart,*
22 *Inc.* (C.D. Cal. June 14, 2012, No. ED CV 11–298 GHK (DTBx)) 2012 WL 9506073, *5.) For
23 these reasons, among others, Defendant denies all of Plaintiff’s claims and allegations, and further
24 claims it did not engage in any unfair business practices and denies liability under PAGA. (Moon
25 Decl., ¶ 7.) Defendant also maintains the claims are improper for class treatment, in part, due to
26 the individualized and testimony-intensive nature of the wage claims that could bar class
27 certification or significantly reduce Defendant’s overall liability. (*Id.*)

1 **B. Discovery and Investigation**

2 The Parties agreed to mediate this action with Brandon McKelvey, an experienced class and
3 PAGA action mediator. (*Id.* at ¶ 8.) In preparation for mediation, the Parties agreed to a protocol for
4 an informal production of documents and information before mediation. (*Id.*) Prior to mediation,
5 Plaintiff obtained from Defendant, through informal discovery, documents and data that were
6 necessary and helpful to evaluate the claims asserted in this action. (*Id.*) Defendant produced a
7 statistically sound sample of time and pay records for the putative Class for approximately 24.5% of
8 the putative Class, and Defendant's written employment policies in effect during the Class Period.
9 (*Id.*) Defendant also provided information regarding the estimated number of current and formerly
10 employed Class Members, Aggrieved Employees, and PAGA Pay Periods. (*Id.*)

11 In preparation for mediation, Class Counsel reviewed and analyzed all the information
12 Defendant provided, including the sample records and documents regarding Defendant's wage-and-
13 hour policies. (*Id.* at ¶ 9.) Class Counsel retained a statistics expert to analyze the sample records and
14 prepare a damage analysis prior to the mediation. (*Id.*) The sample time and pay records analyzed
15 contained 26,217 actual shifts worked (representing roughly 17% of total shifts worked in the Class
16 Period), which allowed Plaintiff's expert to prepare an analysis with a reasonable degree of certainty.
17 (*Id.*) In conjunction with their extensive factual investigation, Class Counsel also investigated the
18 applicable law regarding the claims and defenses asserted in the litigation. (*Id.*) Accordingly, Class
19 Counsel was able to evaluate the probability of class certification, success on the merits, and
20 Defendant's maximum and realistic monetary exposure for all claims. (*Id.*) Thus, Plaintiff's and her
21 Counsel's familiarity with the facts of the case and the legal issues raised by the pleadings allowed
22 them to act intelligently in negotiating the Settlement. (*Id.*)

23 **C. Settlement Negotiations and Notice of Settlement to the LWDA**

24 On September 12, 2025, the Parties participated in a full day of private mediation with
25 Brandon McKelvey (*Id.* at ¶ 10.) The negotiations were at arm's length and, although conducted
26 in a professional manner, were adversarial. (*Id.*) The Parties went into the mediation willing to
27 explore the potential for a settlement of the dispute, but each side was also prepared to litigate
28 their position through trial and appeal if a settlement had not been reached. (*Id.*) After a full

1 discussion regarding the strengths and weaknesses of Plaintiff’s claims and Defendant’s defenses
2 and with the assistance of the mediator, the Parties reached a resolution. (*Id.*) The material terms
3 of the settlement are set out in the Settlement. (*Id.* at ¶¶ 2, 10, Ex. 1.)

4 In compliance with Labor Code section 2699(s)(2), notice of settlement and a copy of the
5 proposed Settlement has been submitted to the LWDA along with a copy of Plaintiff’s preliminary
6 approval motion and the hearing date. (*Id.* at ¶ 11, Ex. 3.) To date, the LWDA has not indicated
7 any objection to the Settlement. (*Id.*)

8 **D. Key Terms of the Proposed Settlement**

9 Under the Settlement, Defendant will pay a non-reversionary, all-inclusive amount of *no*
10 *less than \$680,000.00* (“GSA”) to resolve this action. (Settlement, ¶ 3.0.) Other key terms of the
11 Settlement are outlined in the counsel declaration submitted concurrently herewith. (Moon Decl.,
12 ¶¶ 12–27.) The proposed Settlement Administrator—APEX Class Action Administration
13 Solutions (“Apex”)—was jointly selected by the Parties following a competitive bidding process.
14 (*Id.* at ¶ 16; Settlement, ¶ 1.1.)¹

15 The Settlement allocates \$50,000.00 from the GSA for settlement of the Released PAGA
16 Claims, which will be distributed 65% (\$32,500.00) to the LWDA and 35% (\$17,500.00) to
17 Aggrieved Employees pursuant to PAGA law governing Plaintiff’s claims. (Settlement, ¶ 1.34.)
18 Each Aggrieved Employee will be entitled to a pro rata share of the 35% share of the PAGA
19 Penalties directly proportional to their number of PAGA Pay Periods. (*Id.* at ¶ 3.1.4.1.) This results
20 in an average Individual PAGA Payment of roughly **\$98.31** for each of the estimated 178
21 Aggrieved Employees (\$17,500 / 178), and a PAGA Pay Period value of roughly **\$2.97** for each
22 of the 5,895 estimated Pay Periods in the PAGA Period (\$17,500 / 5,895). (Moon Decl., ¶ 17.)

23 After deducting the Class Representative Enhancement Award, the Class Counsel Fees
24 Payment and Class Counsel Expenses Payment, the PAGA Penalties, and the Administration
25 Expenses Payment from the GSA, in the amounts specifically approved by the Court, any

bid at \$7,500.00. (Moon Decl., ¶ 16, n.1.)

1 difference in the amounts requested and the amounts awarded will be allocated to the Net
2 Settlement Amount for distribution to Participating Class Members. (Settlement, ¶ 3.1.)
3 Accordingly, the Net Settlement Amount will be *no less than* **\$360,600.00** for an estimated Class
4 of **282 individuals**.² (Moon Decl., ¶ 18.) Each Class Member who does not opt-out will be entitled
5 to a pro rata share of the Net Settlement Amount that is directly proportional to the number of
6 Workweeks worked during the Class Period. (Settlement, ¶ 3.1.3.1.) The estimated **\$360,600.00**
7 Net Settlement Amount results in an average Individual Class Payment of roughly **\$1,278.72** for each
8 of the estimated 282 Class Members ($\$360,600.00 / 282$),³ and a Class Workweek value of roughly
9 **\$10.20** for each of the 35,365 estimated Workweeks in the Class Period ($\$360,600.00 / 35,365$). (Moon
10 Decl., ¶ 20.)

11 To the best of Plaintiff's knowledge, there is no other pending litigation involving similar
12 claims against Defendant that may be impacted by approval of the Settlement at issue, nor has
13 Defendant pointed to any. (Moon Decl., ¶ 28.)

14 **III. THE COURT SHOULD GRANT PRELIMINARY APPROVAL**

15 The law favors the settlement of lawsuits, particularly in class actions and other complex
16 cases. (*See, e.g., Neary v. Regents of Univ. of Cal.* (1992) 3 Cal.4th 272, 277–81.) To prevent fraud,
17 collusion, or unfairness to the class, the settlement of a class action requires court approval. (*Dunk v.*
18 *Ford Motor Co.* (1996) 48 Cal.App.4th 1794, 1800–01 [citing authority omitted].) To approve a
19 settlement, the Court must find “the settlement is fair, adequate, and reasonable.” (*Id.*) This Court
20 has wide discretion in making this determination. (*Mallick v. Super. Ct.* (1979) 89 Cal.App.3d 434,
21 438.) Fairness, adequacy, and reasonableness are presumed, as here, when: “(1) the settlement is
22 reached through arm's-length bargaining; (2) investigation and discovery are sufficient to allow
23

24 ² The Net Settlement Amount was calculated by deducting the following from the \$680,000.00
25 GSA: \$7,500.00 for the Class Representative Enhancement Award, up to \$7,500.00 for the
26 Administration Expenses Payment, \$50,000.00 for the PAGA Penalties to the LWDA and Aggrieved
Employees, \$224,400.00 for the Class Counsel Fees Payment, and up to \$30,000.00 for the Class
Counsel Litigation Costs Payment. (Moon Decl., ¶ 18, n.2; Settlement, ¶¶ 3.0–3.1.4.)

27 ³ At this time, the actual amounts to Class Members and/or Aggrieved Employees are unknown
28 and will be calculated by the Administrator following preliminary approval and receipt and processing
of the Class Data. (Settlement, ¶ 6.1.) The high and low range of payments will be provided to the
Court in a motion for final approval. (Moon Decl., ¶ 20, n.3.)

1 counsel and the court to act intelligently; (3) counsel is experienced in similar litigation; and (4) the
2 percentage of objectors is small.” (*Dunk*, 48 Cal.App.4th at p. 1802 [citing Newberg, Newberg on
3 Class Actions (3rd ed. 1992) § 11.41].)

4 In evaluating a settlement, the trial court considers the following factors: (1) the strength of
5 plaintiff’s case; (2) the risk, expense, complexity, and likely duration of further litigation; (3) the risk
6 of maintaining class action status through trial; (4) the settlement amount offered; (5) the extent of
7 discovery completed and the stage of the proceedings; (6) counsel’s experience and views; (7) the
8 presence of a governmental participant; and (8) the class members’ reaction to the proposed
9 settlement. (*Kullar v. Foot Locker Retail, Inc.* (2008) 168 Cal.App.4th 116, 128.) To approve a class
10 action settlement, “the court must satisfy itself that the class settlement is within the ‘ballpark’ of
11 reasonableness.” (*Id.* at p. 133.) The record need not contain an explicit statement of the maximum
12 theoretical recovery. (*Munoz v. BCI Coca-Cola Bottling Co. of L.A.* (2010) 186 Cal.App.4th 399,
13 408–09 [holding that *Kullar* does not require “an explicit statement of the maximum amount the
14 plaintiff class could recover if it prevailed on all its claims,” but instead, only an “understanding
15 of the amount that is in controversy and the realistic range of outcomes of the litigation”].)

16 As discussed below, Class Counsel have provided materials and information exceeding the
17 threshold required for this Court to conclude the Settlement is fair, reasonable, and adequate.

18 **A. The Settlement Is Fair, Reasonable, Adequate, and the Product of Investigation,**
19 **Litigation, and Negotiation**

20 **1. The Settlement Is the Product of Discovery, Investigation, Informed and Non-**
21 **Collusive Arm’s-Length Negotiations, and Realistic Claims Analysis**

22 Courts presume the absence of fraud or collusion in the negotiation of a settlement, unless
23 evidence to the contrary is offered. (Newberg, Newberg on Class Actions (3rd ed. 1992) § 11.51.)
24 Settlement is favored, and settlement agreements are realistically assessed. (*Stamburgh v. Super. Ct.*
25 (1976) 62 Cal.App.3d 231, 236; *Priddy v. Edelman* (6th Cir. 1989) 883 F.2d 438, 447 [“The fact that
26 the plaintiff might have received more if the case had been fully litigated is no reason not to approve
27 the settlement.”].) Thus, there is a presumption here that negotiations were conducted in good faith.

1 Here, Class Counsel have conducted a thorough investigation into the facts of this case.
2 (Moon Decl., ¶ 29.) As previously noted, the Settlement at issue was reached through arms'-length
3 negotiations, private mediation, and the assistance of a statistics expert. (*Id.*) Based on Defendant's
4 informal class-wide discovery production, on Class Counsel's independent investigation and
5 evaluation, and on counsel's extensive experience in wage-and-hour litigation, Class Counsel are of the
6 opinion that the proposed Settlement is fair, reasonable, and adequate. (*Id.*)

7 Based on Class Counsel's review of the time, payroll, and additional data provided by
8 Defendant, on Plaintiff's expert's analysis of the sample records provided by Defendant, and on
9 information from Plaintiff, Class Counsel evaluated the estimated maximum and risk-adjusted
10 exposure that Defendant faced. (*Id.* at ¶ 30.) Specifically, based on the information provided for
11 mediation, the total estimated **realistic recovery** (adjusted for risks at certification and proof on the
12 merits) for the alleged claims, including penalties, is estimated to be **\$943,345.81**. (Moon Decl., ¶
13 30.) This amount was calculated as follows: **a negligible amount** for the rounding claim;
14 **\$112,331.00** (75% discount) for the off-the-clock work claim; **\$5,475.00** (50% discount) for the
15 regular rate claim; **\$205,120.55** (50% discount) for the meal period claim; **\$390,023.46** (90%
16 discount) for the rest period claim; **\$54,750.00** (75% discount) for the unreimbursed business
17 expenses claim; **\$58,855.80** (90% discount) for the waiting time penalties claim; **\$57,840.00** (90%
18 discount) for the wage statement claim; and **\$58,950.00** (90% discount) for the PAGA penalties
19 claim. (*Id.* at ¶¶ 30–37.) The foregoing discounts were based on the evidence presented for mediation
20 and arguments made during arm's-length settlement negotiations. (*Id.*)

21 **The \$680,000.00 gross settlement figure represents roughly 72% of the total realistic**
22 **recovery.** (*Id.* at ¶ 38.) This is an excellent result for the Class, particularly because, under the
23 Settlement, Class Members will receive timely and guaranteed relief, avoiding the risk of not being
24 able to recover anything. (*Id.*)

25 **2. The Class Settlement Is Fair Considering the Parties' Respective Positions**

26 **and Significant Risks to Certification and Proof on the Merits**

27 A settlement is not judged against what a plaintiff might recover had he prevailed at trial, nor
28 does the settlement have to provide 100% of the damages sought to be fair and reasonable. (*Wershba*

1 *v. Apple Comp., Inc.* (2001) 91 Cal.App.4th 224, 246, 250 [“Compromise is inherent and necessary
2 in the settlement process . . . even if ‘the relief afforded by the proposed settlement is substantially
3 narrower than it would be if the suits were to be successfully litigated,’ this is no bar to a class
4 settlement because ‘the public interest may indeed be served by a voluntary settlement in which each
5 side gives ground in the interest of avoiding litigation.’”] [quoting *Air Line Stewards v. Am. Airlines,*
6 *Inc.* (7th Cir. 1972) 455 F.2d 101, 109].)

7 Here, considering all known facts and circumstances, the risk of significant delay, trial risk,
8 appellate risk, and the defenses Defendant may assert both to certification and on the merits, the
9 Settlement is in the best interest of the Class and LWDA. (Moon Decl., ¶ 29.) While Plaintiff is
10 confident in the merits of her claims, a legitimate controversy exists as to each cause of action. (*Id.*
11 at ¶ 41.) Plaintiff also recognizes that proving the amount owed to each Class Member would be an
12 expensive, time-consuming, and uncertain proposition. (*Id.*)

13 The Settlement obviates the significant risk that this Court may deny certification of all or
14 some of Plaintiff’s claims. (*Id.* at ¶ 42.) Class Counsel took into account the risk of not prevailing at
15 trial due to low or no participation by Class Members. (*Id.*) Indeed, the individualized and testimony-
16 intensive nature of the claims could bar manageability of the representative claims or otherwise
17 significantly reduce any recovery whatsoever. (*Id.*) For example, the rest period and unreimbursed
18 expense claims are testimony-driven claims and assume a 100% violation rate, which would not
19 likely be demonstrated at trial, as it assumes either the participation of all employees (which would
20 be difficult given the reality that many, if not all, employees would be unwilling to participate due to
21 fear of retaliation), or alternatively, the use of surveys or statistical data as a surrogate (which would
22 still require the participation of a majority of employees to establish a sound representation of all
23 non-exempts). (*Id.*) Even assuming employees would be willing to participate, obtaining declarations
24 would potentially reveal that each individual employee had a different experience. (*Id.*)

25 Furthermore, even if Plaintiff was able to pursue her claims on a class-wide basis and obtain
26 certification of all or some of the claims, continued litigation would be expensive, involving a trial
27 and possible appeals, and would substantially delay and reduce any recovery by the Class. (*Id.* at ¶
28 43.) Although the Parties have engaged in a significant amount of investigation, informal discovery,

1 and class-wide data analysis, they have not conducted depositions. (*Id.*) Moreover, preparation for
2 class certification and a trial would remain for the Parties as well as the prospect of appeals in the
3 wake of a disputed class certification ruling for Plaintiff and/or any summary judgment ruling. (*Id.*)
4 As a result, the Parties would incur considerably more attorneys' fees and costs through trial. (*Id.*) In
5 sum, this Settlement avoids the risks, burdens, and the accompanying expense of further litigation.
6 (*Id.*)

7 The proposed \$680,000.00 Settlement therefore represents a substantial recovery when
8 compared to the reasonably forecasted recovery for the Class. (*Id.* at ¶ 44) When considering the
9 risks of litigation, the uncertainties involved in continued litigation, the burdens of proof necessary
10 to establish liability, and the probability of appeal, it is clear the Settlement amount is within the
11 "ballpark" of reasonableness, and that preliminary settlement approval is appropriate. (*Id.*; (*Kullar*,
12 *supra*, 168 Cal.App.4th at p. 133; *see Munoz, supra*, 186 Cal.App.4th at pp. 408–09.)

13 **3. The PAGA Settlement is Fair Considering the Parties' Respective Positions** 14 **and Significant Risks**

15 With regards to the PAGA claims, the Settlement is a fair and reasonable resolution that
16 satisfies PAGA's dual statutory purposes of deterrence and punishment, on the one hand, and
17 providing Aggrieved Employees with genuine and meaningful relief, on the other. (Moon Decl., ¶ 39;
18 Lab. Code §§ 2698, *et seq.*) As a result of this litigation, Defendant has had to hire legal counsel, engage
19 in informal class-wide discovery, and participate in mediation. (Moon Decl., ¶ 39.) Defendant will also
20 have to pay civil penalties to the LWDA under the Settlement, assuming final settlement approval is
21 granted. (*Id.*) Not including its own attorneys' fees and costs as well as the employer's share of payroll
22 taxes, Defendant will pay no less than \$680,000.00 to resolve this matter—of which \$50,000.00 is
23 allocated toward the PAGA claims and will be distributed, in compliance with PAGA law governing
24 the claims in this action, as 65% (\$32,500.00) to the LWDA and 35% (\$17,500.00) to Aggrieved
25 Employees—and the release obtained under the Settlement does not preclude Aggrieved Employees
26 from pursuing any individual claims they may have against Defendant or the other Released Parties.
27 (*Id.*)

Moreover, Class Counsel are of the opinion that because the issues here are fairly contested, there is a possibility of the Court not awarding the PAGA penalties even if Plaintiff prevailed on the merits due to the largely discretionary nature of awarding PAGA penalties. (*Id.*) Indeed, under PAGA, a Court can reduce penalties “if, based on the facts and circumstances of the particular case, to do otherwise would result in an award that is unjust, arbitrary and oppressive, or confiscatory.” (Lab. Code § 2699(e)(2).) In other words, were this matter to go to trial, any award granted would be at the discretion of the Court and subject to a substantial reduction. (Moon Decl., ¶ 39.) Further, Class Counsel took into account the risk of not being able to proceed on a representative basis due to the potential manageability issues and that even if Plaintiff prevailed at trial, penalties would likely be limited due to the largely discretionary nature of awarding PAGA penalties and in light of other defenses available to Defendant. (*Id.* at ¶ 40.) Thus, it is entirely possible that even if Plaintiff would be successful at trial, assuming she is first able to certify the claims and defeat the manageability issues presented at litigation, Plaintiff could be awarded substantially less than what was obtained through the Settlement. (*Id.*)

In sum, the \$50,000 PAGA Penalties allocation under the Settlement constitutes “genuine and meaningful” that is “consistent with the underlying purpose of the statute to benefit the public.” (*See O’Connor v. Uber Tech., Inc.* (N.D. Cal. 2016) 201 F.Supp.3d 1110, 1133–35 [denying settlement approval where allocation for PAGA claims was 0.1% of the estimated full worth].)

4. Class Counsel Have Extensive Experience in Class and PAGA Action Litigation, Which Was Integral to Negotiating the Settlement

The Settlement negotiations were conducted by highly capable counsel with considerable experience and demonstrated competence with litigating wage-and-hour class actions. (Moon Decl., ¶¶ 49–64.) Class Counsel have a strong record of vigorous and effective advocacy for their clients and are experienced in handling complex wage-and-hour class action litigation. (*Id.*) Their experience was helpful in assessing the reasonableness of the Settlement at issue here, and from this experience they concluded that this litigation could not have been settled on better terms than provided under the Settlement. (*Id.* at ¶ 65.) Although Plaintiff and her counsel were prepared to try the claims alleged in the litigation, they support the proposed Settlement as being in the best interest of the Class based

1 on objective evidence that has been considered and weighed against the risks, expenses, and time
2 consumption to both sides of continued litigation. (*Id.* at ¶¶ 10, 29.)

3 **B. The Proposed Attorneys’ Fees and Costs Are Reasonable**

4 Subject to the Court’s approval, the Settlement provides a fee application of one-third of the
5 GSA for Class Counsel’s attorneys’ fees, plus reimbursement for out-of-pocket litigation costs not to
6 exceed \$30,000.00.⁴ (Settlement, ¶ 3.1.2.) These amounts are disclosed to Class Members in the
7 proposed Class Notice and are reasonable. (*Id.* at Ex. A.)

8 **1. Counsel Request a Fees Award Based On the “Common Fund” Method**

9 California courts have long awarded attorneys’ fees as a percentage of the benefit created by
10 counsel in pursuing claims on behalf of a class. (*See, e.g., Serrano v. Priest* (1977) 20 Cal.3d 25.)
11 The California Supreme Court has held, “when a number of persons are entitled in common to a
12 specific fund, and an action brought by a plaintiff or plaintiffs for the benefit of all results in the
13 creation or preservation of that fund, such plaintiff or plaintiffs may be awarded attorney’s fees out
14 of the fund.” (*Id.* at p. 34.)

15 Class Counsel seek an award of attorneys’ fees on the “percentage of recovery/common fund”
16 theory. (Moon Decl., ¶ 69.) The purpose of this approach is to “spread litigation costs proportionately
17 among all the beneficiaries so that the active beneficiary does not bear the entire burden alone.”
18 (*Vincent v. Hughes Air W., Inc.* (9th Cir. 1977) 557 F.2d 759, 769.) In *Quinn v. State of California*
19 (1975) 15 Cal.3d 162, the California Supreme Court stated, “one who expends attorneys’ fees in
20 winning a suit which creates a fund from which others derive benefits, may require those passive
21 beneficiaries to bear a fair share of the litigation costs.” (*Id.* at p. 167.) Similarly, in *City and County*
22 *of San Francisco v. Sweet* (1995) 12 Cal.4th 105, the California Supreme Court recognized that the
23 common fund doctrine has been applied “consistently in California when an action brought by one
24 party creates a fund in which other persons[] are entitled to share.” (*Id.* at pp. 110–11 [pincite
25 omitted].)

26
27
28 ⁴ Class Counsel’s current litigation costs are \$24,253.12, and they anticipate incurring additional costs up to final approval. (Moon Decl., ¶ 74, Ex. 4.)

1 The California Supreme Court affirmed in *Laffitte v. Robert Half International Inc.* (2016) 1
2 Cal.5th 480 that, “when class action litigation establishes a monetary fund for the benefit of the class
3 members, and the trial court in its equitable powers awards class counsel a fee out of that fund, the
4 court may determine the amount of a reasonable fee by choosing an appropriate percentage of the
5 fund created.” (*Id.* at p. 503.) The court explained: “The recognized advantages of the percentage
6 method—including relative ease of calculation, alignment of incentives between counsel and the
7 class, a better approximation of market conditions in a contingency case, and the encouragement it
8 provides counsel to seek an early settlement and avoid unnecessarily prolonging the litigation[]—
9 convince us the percentage method is a valuable tool that should not be denied our trial courts.” (*Id.*
10 [internal citations omitted].) This line of legal authority supports a request for attorneys’ fees based
11 on the percentage of recovery/common fund method.

12 **2. The Requested Fee Award Is in Line with Typical Cases**

13 According to a leading treatise on class actions: “No general rule can be articulated on what
14 is a reasonable percentage of a common fund. Usually 50% of the fund is the upper limit on a
15 reasonable fee award from a common fund in order to assure that the fees do not consume a
16 disproportionate part of the recovery obtained for the class, although somewhat larger percentages
17 are not unprecedented.” (Newberg, *Newberg on Class Actions* (3rd ed. 1992) § 14.03.) Attorneys’
18 fees that are fifty percent of the fund are typically considered the upper limit, with thirty to forty
19 percent commonly awarded in cases where the settlement is relatively small. (*Id.*; *see also Van*
20 *Vranken v. Atlantic Richfield Co.* (N.D. Cal. 1995) 901 F.Supp. 294, 297 [stating that most cases
21 where 30–50% was awarded involved “smaller” settlement funds of under \$10 million].)

22 Here, Class Counsel’s fees request for one-third of the GSA is in line with the prevailing
23 guidelines established in California case law and academic literature and is consistent with awards in
24 California. (*Compare* Settlement, ¶ 3.1.2, *with Chavez v. Netflix, Inc.* (2008) 162 Cal.App.4th 43, 66,
25 n.11 [“Empirical studies show that, regardless whether the percentage method or the lodestar method
26 is used, fee awards in class actions average around one-third of the recovery.”].) Accordingly,
27 Plaintiff requests the Court preliminarily approve the attorneys’ fees as negotiated by the Parties.
28

1 **3. This Matter Involves a “Fee-Shifting” Provision of the Labor Code**

2 Labor Code sections 218.5, 226, 1194, 2699, and 2802 provide for the recovery of reasonable
3 fees and costs of suit, for the claims made in this action. (Lab. Code §§ 218.5, 226, 1194, 2699(k)(1),
4 2802(d).) Under these sections, Plaintiff would be permitted to recover her actual attorneys’ fees,
5 even if those fees were larger than the total class recovery at the conclusion of this case. (*Id.*) This
6 Settlement is beneficial in that it limits the risk of continued expenses and consumption of time,
7 energy, and resources facing Defendant while at the same time rewarding Class Counsel for their
8 decision to assume risk by taking on this matter on a contingent basis with no guarantee of recovery.
9 (Moon Decl., ¶¶ 69–75.) In fact, prosecution of this action involved significant financial risk for
10 Class Counsel. (*Id.*) Once Class Counsel undertook this litigation, they committed to pursue it to its
11 conclusion, placing their fiduciary duty to the Class ahead of all other concerns. (*Id.* at ¶ 72.)

12 **4. Counsel’s Experience, Reputation, and Ability Support the Fees Request**

13 As demonstrated by their past experience in pursuing class actions on behalf of consumers
14 and employees, Class Counsel possess considerable expertise in litigating class actions. (*Id.* at ¶¶ 49–
15 64.) Class Counsel have been involved as lead counsel or co-counsel in numerous class actions that
16 resulted in millions in recovery. (*Id.*) As noted above, their experience in wage-and-hour litigation
17 was integral in evaluating the strengths and weaknesses of the case against Defendant and the
18 reasonableness of the Settlement. (*Id.* at ¶ 67.) Practice in the narrow field of wage-and-hour litigation
19 requires skill and knowledge concerning the rapidly evolving substantive law (state and federal) as
20 well as the procedural law of class action litigation. (*Id.* at ¶ 65.) Based on these and other factors,
21 Class Counsel have frequently received fee awards of this percentage from the gross recovery for the
22 class. (*See id.* at ¶¶ 53, 58, 63.) Because it is reasonable to compensate counsel commensurate with
23 their skill, reputation, and experience, the requested fee award is supported here.

24 **C. The Enhancement Award to Plaintiff Is Reasonable**

25 Named plaintiffs in class action lawsuits “are eligible for reasonable incentive payments to
26 compensate them for the expense or risk they have incurred in conferring a benefit on other members
27 of the class.” (*Munoz, supra*, 186 Cal.App.4th at p. 412.) Courts routinely grant approval of class
28 action settlement agreements containing enhancements for the class representatives, which are

1 necessary to provide incentive to represent the class and are appropriate given the benefit the class
2 representatives help to bring about for the class. (*See Rodriguez v. W. Publ'g Corp.* (9th Cir. 2009)
3 563 F.3d 948, 958–59.) Service awards are particularly important to plaintiffs in wage-and-hour cases
4 because they promote the important public policies underlying the wage-and-hour laws. This strong
5 policy is codified in California Labor Code section 90.5, which provides, “[i]t is the policy of this
6 state to vigorously enforce minimum labor standards in order to ensure employees are not required
7 or permitted to work under substandard unlawful conditions . . .” (Lab. Code § 90.5.) Nonetheless,
8 the California Supreme Court has noted that “retaliation against employees for asserting statutory
9 rights under the Labor Code is widespread,” despite anti-retaliation statutes designed to protect
10 employees. (*Gentry v. Super. Ct.* (2007) 42 Cal.4th 443, 460–61.) In this context, class
11 representatives should be rewarded for assuming the risk of retaliation for the sake of class members.
12 (*See Frank v. Eastman Kodak Co.* (W.D.N.Y. 2005) 228 F.R.D. 174, 187.)

13 Under the Settlement here, subject to the Court’s approval, a Class Representative
14 Enhancement Award of \$7,500.00 will go to Plaintiff, in addition to her amount as a Class Member.
15 (Settlement, ¶ 3.1.1.) This award is for having initiated and provided services in support of the Action
16 and in recognition of the risks attendant to the role as the named Plaintiff and Class Representative.
17 (*Id.* at ¶ 1.14.) Plaintiff has devoted a great deal of time and work assisting counsel in the case and
18 communicated with counsel frequently for litigation and to prepare for mediation. (Moon Decl., ¶¶
19 45–48; Plaintiff Decl., ¶¶ 19–22.) The requested award is fair and reasonable, particularly considering
20 the substantial benefits Plaintiff generated for all Class Members. (Moon Decl., ¶ 44.)

21 When compared with the amounts awarded in typical class action cases, the amount requested
22 here is particularly reasonable. A 2006 study examining the average incentive award given to class
23 action plaintiffs from 1993 to 2002 found that the “average award per class representative was
24 \$15,992 and the median award per class representative was \$4357.” (Eisenberg & Miller, *Incentive*
25 *Awards to Class Action Plaintiffs: An Empirical Study* (2006) 53 UCLA L. Rev. 1303, 1307–08.)
26 The same study found that named plaintiffs in employment discrimination class actions received an
27 average award of \$69,850 and a median award of \$31,081, while named plaintiffs in other
28 employment class actions received an average award of \$12,121 and a median award of \$13,059. (*Id.*

1 at p. 1333.) The authors of the study found that higher awards in employment cases reflected the
2 “courts’ wish to make representative plaintiffs whole by compensating them for the high costs of
3 their service to the class, including risks of stigmatization or retaliation on the job.” (*Id.* at p. 1308.)

4 **IV. CERTIFICATION FOR SETTLEMENT PURPOSES IS WARRANTED**

5 **A. Legal Standard**

6 The proposed Settlement Class is well suited for class certification. The claims all derive from
7 a core set of alleged violations of California’s wage and hour laws and regulations. (Moon Decl., ¶¶
8 3–4.) For the reasons set forth more fully below, the Class, for purposes of Settlement, satisfies the
9 prerequisites for certification under Code of Civil Procedure section 382. (Code Civ. Proc. § 382.)
10 Section 382 provides that “when the question is one of a common or general interest, of many
11 persons, or when the parties are numerous, and it is impracticable to bring them all before the court,
12 one or more may sue or defend for the benefit of all.” (*Id.*) There are two requirements to section
13 382: “(1) there must be an ascertainable class[]; and (2) there must be a well defined community of
14 interest in the questions of law and fact involved affecting the parties to be represented.” (*Daar v.*
15 *Yellow Cab Co.* (1967) 67 Cal. 2d 695, 704 [internal citations omitted].) To clarify these
16 requirements, the California Supreme Court has looked to Federal Rule of Civil Procedure 23 to
17 explain that the community-of-interest requirement itself embodies three factors: “(1) predominant
18 common questions of law or fact; (2) class representatives with claims or defenses typical of the
19 class; and (3) class representatives who can adequately represent the class.” (*Richmond v. Dart*
20 *Indus., Inc.* (1981) 29 Cal. 3d 462, 470.)

21 California law and policy favor the fullest and most flexible use of the class action device.
22 (*Id.* at pp. 469–73.) Indeed, “Courts long have acknowledged the importance of class actions as a
23 means to prevent a failure of justice in our judicial system” particularly where the rights of consumers
24 are at issue. (*Linder v. Thrifty Oil Co.* (2000) 23 Cal. 4th 429, 434.) Any doubt as to the
25 appropriateness of class treatment should be resolved in favor of certification. (*Richmond, supra*, 29
26 Cal.3d at pp. 473–75.)

1 **B. The Criteria for Class Certification Are Satisfied**

2 **1. The Class Is Ascertainable and Numerous**

3 When determining whether a class is ascertainable, California courts focus on the following
4 three factors: “(1) the class definition, (2) the size of the class and (3) the means of identifying class
5 members.” (*Miller v. Woods* (1983) 148 Cal.App.3d 862, 873.) Here, Plaintiff maintains there is an
6 easily ascertainable Class, defined by objective and precise criteria. (Settlement, ¶¶ 1.4, 1.12.) The
7 proposed Class that Plaintiff seeks to represent is ascertainable because (1) the Class definition is
8 sufficiently precise, (2) the Class consists of about 282 individuals, and (3) Class Members can be
9 readily identified by Defendant’s records. (*Id.* at ¶¶ 1.4, 1.8, 1.12, 4.1.) Because Class Members are
10 identified using specific criteria in the regular business records of Defendant—their employment by
11 Defendant in California, non-exempt classification, hourly wage, and actual work during the Class
12 Period—the Class is ascertainable. (*See Wilner v. Sunset Life Ins. Co.* (2000) 78 Cal.App.4th 952,
13 959–60 [class membership defined by ownership of product that is the subject of the lawsuit is
14 sufficient to make the class ascertainable].) “The requirement of Code of Civil Procedure section 382
15 that there be ‘many’ parties to a class action suit is indefinite and has been construed liberally.” (*Rose*
16 *v. City of Hayward* (1981) 126 Cal.App.3d 926, 934.) “Where a question is of common interest to
17 ‘many’ persons, an action may be maintained as a class action even where the parties are numerous
18 and it is in fact practicable to join them all.” (*Id.*) “No set number is required as a matter of law for
19 the maintenance of a class action.” (*Id.*) “Thus, our Supreme Court has upheld a class representing
20 the 10 beneficiaries of a trust in an action for removal of the trustees.” (*Id.* [citing *Bowles v. Super.*
21 *Ct.* (1955) 44 Cal.2d 574]; *see also Collins v. Rocha* (1972) 7 Cal.3d 232 [upholding a class of 9
22 plaintiffs and 35 members].) Therefore, numerosity is plainly satisfied.

23 **2. There Are Many Common Issues of Law and Fact Which Predominate**

24 To satisfy the community of interest requirement, a proponent must show (1) common
25 questions of law and fact that predominate over individual issues, (2) class representatives have
26 claims or defenses typical of the class, and (3) class representatives adequately represent the class.
27 (*Dunk, supra*, 48 Cal.App.4th at p. 1806.) This inquiry tests whether proposed classes are sufficiently
28

1 cohesive to rationally warrant adjudication by representation. (*See, e.g., Clothesrigger, Inc. v. GTE*
2 *Corp.* (1987) 191 Cal.App.3d 605, 611–12.)

3 Here, Plaintiff’s claims satisfy all three requirements. The employment practices at issue
4 include whether Defendant: paid employees all minimum, overtime, double time, and sick pay wages
5 owed; reimbursed employees for necessary business expenses; provided employees with and
6 authorize meal and rest periods or paid premiums for non-compliant breaks; paid all final wages to
7 employees at the time of termination; intentionally failed to pay all final wages; provided inaccurate
8 itemized wage statements and whether Class Members were harmed; engaged in unfair business
9 practices; and violated civil penalty provisions under PAGA. (Moon Decl., ¶¶ 3–4.) Plaintiff contends
10 the factual and legal issues are the same for all Class Members, and further that all Class Members
11 suffered from and seek redress for the same alleged injuries. (Plaintiff Decl., ¶¶ 3–6.) Considering
12 Class Members would need to prove the same issues of law and fact to prevail, and their legal
13 remedies are identical, it would be preferable to resolve all claims through a settlement than to force
14 each Class Member to litigate their own individual claims. Thus, the Court should grant conditional
15 class certification for settlement purposes because common questions of law and fact predominate
16 over any individual questions within the Class.

17 **3. Plaintiff’s Claims Are Typical of the Claims of the Class**

18 The typicality requirement does not focus on the individual characteristics or circumstances
19 of the representative plaintiff compared to those of the remainder of the class, but rather, upon the
20 typicality of the proposed representative’s claims as they relate to the defendant’s conduct and
21 activities. (*Classen v. Weller* (1983) 145 Cal.App.3d 27, 47 [“The only requirements a re [sic] that
22 common questions of law and fact *predominate* and that the class representative be *similarly* situated”
23 vis-à-vis the class.] [emphasis in original].) A representative plaintiff’s claims are typical of the class
24 if they arise from the same event, practice, or course of conduct, and if the claims rest on the same
25 legal theories. (*Id.*) That is precisely the case here. Plaintiff is a former employee of Defendant and
26 alleges she was subject to the same policies and practices as other similarly situated employees.
27 (Plaintiff Decl., ¶¶ 2–7.)

4. Plaintiff and Her Counsel Meet the Adequacy Requirement

The adequacy of representation requirements is met by fulfilling two conditions: (1) a named plaintiff must be represented by counsel qualified to conduct the pending litigation, and (2) a named plaintiff's interests cannot be antagonistic to those of the class. (*McGhee v. Bank of Am.* (1976) 60 Cal.App.3d 442, 450.)

Here, all requirements are met. Plaintiff retained counsel with extensive experience in prosecuting complex class actions, including similar class actions that previously settled. (Moon Decl., ¶¶ 49–64.) Based on their experience, Class Counsel unquestionably are “qualified, experienced and generally able to conduct the proposed litigation.” (*Miller, supra*, 148 Cal.App.3d at p. 874.) Plaintiff has, with counsel, litigated this case and diligently reviewed the settlement terms, showing dedication, and with full knowledge and acceptance of duties, she has committed to her role as Class Representative. (Plaintiff Decl., ¶¶ 11–22.) In addition, Plaintiff and her Counsel have no conflicts with one another, other Class Members, or the proposed Administrator. (*Id.* at ¶¶ 8–10; Moon Decl., ¶ 68.)

5. A Class Action Is Superior to a Multiplicity of Litigation

Finally, in making its class certification decision, the Court must determine that a class action would be superior to alternative means for the fair and efficient adjudication of the litigation. (*See Leyva v. Medline Indus. Inc.* (9th Cir. 2013) 716 F.3d 510, 514–15.) By consolidating many potential individual actions into a single proceeding, this Court's use of the class action device enables it to manage this litigation in a manner that serves the economics of time, effort, and expense for the litigants and the judicial system. (*Id.*) Absent class treatment, similarly situated employees with small, but nevertheless meritorious, claims for damages would, as a practical matter, have no means of redress because of the time, effort, and expense required to prosecute individual actions. (*Id.* at p. 515; *Gentry, supra*, 42 Cal.4th at pp. 457–62.) Moreover, in the context of settlement, the superiority concerns are essentially non-existent. (*See generally, e.g., Stamburgh, supra*, 62 Cal.App.3d.)

1 **V. THE PROPOSED CLASS NOTICE IS CONSTITUTIONALLY SOUND AND**
2 **SATISFIES RULES OF COURT**

3 Class Notice requirements are set forth in the California Rules of Court. (Cal. Rules of Court,
4 rule 3.766(e)–(f), rule 3.769(f).) Here, the proposed Class Notice, in the form attached to the
5 Settlement as **Exhibit A**, meets all the requirements of California Rules of Court. The Notice
6 summarizes the proceedings to date and the terms and conditions of the proposed Settlement in an
7 informative and coherent manner. (Settlement, ¶ 6.3, Ex. A.) It also states that the final approval
8 decision has yet to be made, and provides the date, time, and location of the Final Approval Hearing.
9 (*Id.*) It explains the right and procedures to opt-out or submit any written objections and/or arrange
10 to appear at the Final Approval Hearing and verbally state any objections. (*Id.*) It makes clear the
11 Settlement does not constitute an admission of liability by Defendant, who denies all liability, and it
12 recognizes that this Court has not ruled on the merits of the action. (*Id.*) Thus, the proposed Class
13 Notice meets all the requirements of California Rule of Court 3.769(f). (Cal. Rules of Court, rule
14 3.769(f).)

15 The Class Notice also fulfills the requirement of neutrality in class notices. (Newberg,
16 Newberg on Class Actions (3rd ed. 1992) § 8.39.) Accordingly, the Class Notice complies with the
17 standards of fairness, completeness, and neutrality required of a combined settlement-certification
18 class notice.

19 California law vests the Court with broad discretion in fashioning an appropriate notice
20 program. (*Cartt v. Super. Ct.* (1975) 50 Cal.App.3d 960, 970, 973–74.) There is no statutory or due
21 process requirement that all class members receive actual notice, but in this matter, Class Members
22 will receive direct mailed notice, which is the best possible form of notice under the circumstances.
23 (Settlement, ¶ 6.3.) As the Court of Appeals has explained, “[t]he notice given should have a
24 reasonable chance of reaching a substantial percentage of the Class Members . . .” (*Cartt*, 50
25 Cal.App.3d at p. 974.)

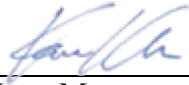
1 **VI. CONCLUSION**
