DECLARATION OF KEVIN MACDONALD

I, Kevin MacDonald, declare as follows:

1. I am the Chief Executive Officer (“CEO”) of the Santa Clarita Valley Committee on Aging Corporation (“SCVCOA” or “Defendant”). I have held this position since July 2016 and have been employed with SCVCOA for more than nine years. I have personal knowledge of the facts set forth in this declaration, and if called as a witness, I could and would testify competently thereto.

2. I submit this declaration on behalf of SCVCOA regarding actual or potential conflicts

of interest with the Third Party Administrator (“TPA”), and other pending matters or actions asserting claims that will be extinguished or adversely affected by the Settlement in this matter.

3. After a reasonable inquiry, SCVCOA is unaware of any actual or potential conflicts of interest with the TPA engaged to administer settlement in this action.

4. After a reasonable inquiry, including: (a) reviewing internal human resources and legal files; (b) conferring with management regarding pending litigation; and (c) checking our records of claims, demands, and subpoenas, SCVCOA is not aware of any class, representative, or other collective action in any court asserting similar claims against SCVCOA.

5. SCVCOA is not a party to any related, overlapping, or similar action as described above. Accordingly, there is no case name or case number to report, no procedural status to describe, and no anticipated impact from any settlement in this case on any other case.

6. I declare under penalty of perjury under the laws of the State of California that the foregoing is true and correct.
