5 The Court granted the motion subject to submission of a revised class notice and
6 Proposed Order no later than August 11, 2026. The Court set the following schedule regarding
7 the settlement:

- 8 1. **August 25, 2026**, is Defendant's last day to deliver the class list to the Administrator;
- 9 2. **September 8, 2026**, is the last day to mail the class notice to all Class Members;
- 10 3. **November 9, 2026**, the last day for any Class Member to object, opt out, and/or file
11 a workweek dispute;
- 12 4. **October 9, 2026**, is the last day to file any motion for final approval, attorneys' fees
13 and costs, and incentive payments, including any corresponding evidence;
- 14 5. **November 25, 2026**, is the last day to file responses to Objections and for the
15 Administrator to submit a final report regarding Opt-Outs and Objections; and
- 16 6. **December 9, 2026**, is set for the Hearing on Motion for Final Approval of Settlement
17 at 09:00 a.m. in Department 6 of the above-captioned court.
