

JUAN BECERRA V. PTG LINEN SERVICE, LLC; PETER SOPKA

AMENDMENT

WAGE AND HOUR CLASS ACTION AND PRIVATE ATTORNEYS GENERAL ACT (LABOR CODE § 2698 ET SEQ.) SETTLEMENT AGREEMENT AND RELEASE OF CLAIMS

This Amendment to the Settlement Agreement (the “Amendment”) is made and entered into by and between Defendants PTG Linen Service, LLC and Peter Sopka (collectively referred to as “Defendants”), and Plaintiff Juan Pablo Becerra Garcia (“Representative Plaintiff”) on behalf of himself individually and on behalf of all members of the “Plaintiff Class”, collectively referred to as the “Parties.”

WHEREAS, the Parties entered into a Settlement Agreement dated [Original Agreement Date] (the “Original Agreement”); and

WHEREAS, the Parties wish to amend the Original Agreement in the manner set forth herein;

NOW, THEREFORE, in consideration of the mutual covenants contained herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

AMENDMENT

1. Section 33 of the Original Agreement shall be read as:

Within five (5) business days of Defendants’ **final installment payment** as set forth in paragraph 32 above, the Settlement Administrator shall issue proportionate payments to the Settlement Class Members (each member’s pro rata share of the Net Settlement Fund as described herein), the LWDA, the Representative Plaintiff (for his enhancement award payment), Class Counsel (for their awarded attorney’s fees and costs), and the Settlement Administrator (for its awarded costs).

2. Section 49 of the Original Agreement shall be read as:

Subject to Court approval of its form and content, the Class Notice shall be sent to the Plaintiff

Class, by first class mail, within **fifteen (15) business days** of the entry of an Order granting preliminary approval of this Settlement Agreement. The Class Notice will, subject to Court approval, advise all Class Members of the nature of the case, the terms of the Settlement, the binding nature of the release, the final approval hearing date, and Class Members' right to opt-out or object. The Settlement Administrator will, at the time of mailing of Class Notice, cause to be published the Class Notice, the Complaint, this Settlement Agreement and the Court's Order preliminarily approving the Settlement on a website designed for this Settlement, with the URL for such website appearing in the mailed Class Notice.

FULL FORCE AND EFFECT

3. Except as expressly amended and modified by this Amendment, all terms and provisions of the Original Agreement are and shall remain in full force and effect.

GOVERNING LAW

4. This Amendment shall be governed by and construed in accordance with the laws of California.

COUNTERPARTS

5. This Amendment may be executed in counterparts, each of which shall be deemed an original, but all of which together will constitute one and the same instrument.

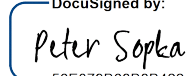

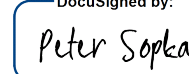

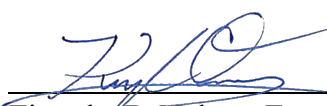
