Plaintiff Lorena Alvarenga (hereinafter referred to as "REPRESENTATIVE
PLAINTIFF") alleges as follows:

PARTIES

1. REPRESENTATIVE PLAINTIFF is an individual who resides in California and
was employed by ALL VALLEY PEDIATRICS, A MEDICAL CORPORATION, KIDS &
TEENS MEDICAL GROUP INC, JANESRI DE SILVA, M.D., A PROFESSIONAL CORP.,
SERENDIB HEALTHWAYS INC., and NORTHRIDGE AFTER-HOURS PEDIATRIC

URGENT CARE, INC. from on or about March 1, 2003 until on or about March 10, 2023.

2. REPRESENTATIVE PLAINTIFF is informed and believes, and based on such information and belief, alleges that at all times mentioned herein, DEFENDANT ALL VALLEY PEDIATRICS, A MEDICAL CORPORATION is a California corporation, licensed to do business and actually doing business in the State of California.

3. REPRESENTATIVE PLAINTIFF is informed and believes, and based on such information and belief, alleges that at all times mentioned herein, DEFENDANT KIDS & TEENS MEDICAL GROUP INC is an entity of unknown form, licensed to do business and actually doing business in the State of California.

4. REPRESENTATIVE PLAINTIFF is informed and believes, and based on such information and belief, alleges that at all times mentioned herein, DEFENDANT JANESRI DE SILVA, M.D., A PROFESSIONAL CORP. is a California corporation, licensed to do business and actually doing business in the State of California.

5. REPRESENTATIVE PLAINTIFF is informed and believes, and based on such information and belief, alleges that at all times mentioned herein, DEFENDANT SERENDIB HEALTHWAYS INC. is a California corporation, licensed to do business and actually doing business in the State of California.

6. REPRESENTATIVE PLAINTIFF is informed and believes, and based on such information and belief, alleges that at all times mentioned herein, DEFENDANT NORTHRIDGE AFTER-HOURS PEDIATRIC URGENT CARE, INC. is a California corporation, licensed to do business and actually doing business in the State of California.

7. REPRESENTATIVE PLAINTIFF is informed and believes, and based on such information and belief, alleges that DEFENDANTS are medical corporations. Thus, DEFENDANTS are subject to the applicable California laws as alleged throughout this Complaint.

8. REPRESENTATIVE PLAINTIFF is unaware of the true names and capacities, whether corporate, individual, or otherwise, of DEFENDANTS named as DOES 1 through 50, inclusive. Pursuant to California Code of Civil Procedure section 474, REPRESENTATIVE

1 PLAINTIFF will seek leave of court to amend this complaint to state said DEFENDANTS' true
2 names and capacities when the same have been ascertained. REPRESENTATIVE PLAINTIFF
3 is informed and believes, and based thereon alleges, that said fictitiously-named
4 DEFENDANTS are responsible in some manner for the injuries and damages to
5 REPRESENTATIVE PLAINTIFF and the other AGGRIEVED EMPLOYEES as further
6 alleged herein.

7 9. The AGGRIEVED EMPLOYEES worked for all of the DEFENDANTS or for
8 any of the DEFENDANTS as non-exempt, hourly-paid employees. Nothing in this Complaint
9 should be interpreted as limiting the AGGRIEVED EMPLOYEES to non-exempt, hourly-paid
10 employees who worked for all DEFENDANTS only.

11 10. The definition of "employer" for purposes of the California Labor Code includes
12 irregular working arrangements, and was specifically drafted in order to prevent evasion and
13 subterfuge of California's labor laws. To that end, REPRESENTATIVE PLAINTIFF is
14 informed and believes, and based thereon alleges, that DEFENDANTS, including any as of now
15 unknown entities, must be classified as joint-employers for purposes of liability for civil
16 penalties under the Private Attorneys General Act ("PAGA"). As such, DEFENDANTS are each
17 liable for civil penalties for violation of the California Labor Code as to REPRESENTATIVE
18 PLAINTIFF and the other AGGRIEVED EMPLOYEES.

19 11. The term "DEFENDANTS" used throughout this Complaint includes all named
20 DEFENDANTS whether corporate, individual, or otherwise, and all unnamed DEFENDANTS
21 whether corporate, individual, or otherwise, that are now unknown but are referred to throughout
22 this Complaint as DOES 1 through 50, inclusive.

23 12. This is only a Private Attorney General Action Complaint, pursuant to California
24 Labor Code section 2699 et seq., on behalf of REPRESENTATIVE PLAINTIFF and all other
25 persons similarly situated who worked for DEFENDANTS in their California locations as non-
26 exempt, hourly employees (herein collectively identified as "AGGRIEVED EMPLOYEES")
27 for:
28

- (i) failure to provide employment records in violation of Labor Code sections 226, 432, and 1198.5;
- (ii) failure to pay overtime and double time in violation of Labor Code sections 510 and the applicable Wage Orders;
- (iii) failure to provide rest and meal periods in violation of Labor Code sections 226.7, 512(a), and the applicable Wage Orders;
- (iv) failure to pay minimum wage in violation of Labor Code sections 1182.2, 1194, 1197, 1197.1, and the applicable Wage Orders;
- (v) failure to keep accurate payroll records and provide itemized wage statements in violation of Labor Code sections 226(a), 1174(d), 1198, and the applicable Wage Orders;
- (vi) failure to pay reporting time wages in violation of California Code of Regulations, Title 8, section 11050(5)(A);
- (vii) failure to pay split shift wages in violation of California Code of Regulations 11050(4)(C);
- (viii) failure to pay all wages earned on time in violation of Labor Code section 204;
- (ix) failure to pay all wages earned upon discharge or resignation in violation of Labor Code sections 201, 202, and 203;
- (x) failure to reimburse necessary, business-related expenses in violation of Labor Code sections 2800 and 2802;
- (xi) failure to provide notice of paid sick time and accrual in violation of Labor Code section 246;
- (xii) employers, and individuals acting on behalf of employers, violating or causing to be violated a section of the Labor Code or any Wage Order in violation of Labor Code section 558(a).

VENUE AND JURISDICTION

13. Venue as to each Defendant is proper in this judicial district pursuant to California Code of Civil Procedure section 395 and under California Government Code section 12965(b), in that DEFENDANTS conduct business within the County of Los Angeles and each Defendant

is within the jurisdiction of this Court for service of process, REPRESENTATIVE PLAINTIFFS' injuries were incurred within the County of Los Angeles, the actions giving rise to REPRESENTATIVE PLAINTIFFS' Complaint arose within the County of Los Angeles, and DEFENDANTS are located in the County of Los Angeles.

14. REPRESENTATIVE PLAINTIFF is informed and believes, and based thereon alleges, that no federal question is raised and that the Class Action Fairness Act ("CAFA"), 28 U.S.C. Section 1322(d) does not apply, or in the alternative that exceptions for local cases or controversies under the CAFA do apply and prohibit removal of the action to federal Court.

15. REPRESENTATIVE PLAINTIFF is informed and believes, and based thereon alleges, that based on the total number of pay periods REPRESENTATIVE PLAINTIFF worked, REPRESENTATIVE PLAINTIFF's individual claims do not arise to the necessary amount in controversy so as to implicate traditional jurisdiction under 28 U.S.C. 1322(a) or jurisdiction under the CAFA.

16. Further, as a representative action under the PAGA, the matter is not subject to removal under 28 U.S.C. Sections 1322(a)-(d). PAGA civil penalty actions are not subject to federal jurisdiction.

17. This Court has jurisdiction over REPRESENTATIVE PLAINTIFFS' claims for civil penalties under the PAGA, California Labor Code sections 2698 *et seq.*

SCOPE

18. The "AGGRIEVED EMPLOYEES" are DEFENDANTS' current and former hourly-paid, non-exempt employees, who either were or are employed in the State of California from March 22, 2022, through the date of judgment in this action.

STATEMENT OF FACTS

19. REPRESENTATIVE PLAINTIFF was hired by DEFENDANTS as a medical assistant and office manager on or about March 1, 2003. From on or about September 1, 2022, REPRESENTATIVE PLAINTIFF's job title was Transfers Department medical assistant. DEFENDANTS operate as a chain of medical centers. REPRESENTATIVE PLAINTIFF worked for DEFENDANTS up until on or about March 10, 2023. REPRESENTATIVE

1 PLAINTIFF received a final paycheck from DEFENDANTS on or about March 10, 2023.

2 20. While employed with DEFENDANTS, REPRESENTATIVE PLAINTIFF and
3 other AGGRIEVED EMPLOYEES that REPRESENTATIVE PLAINTIFF seeks to represent
4 in this action, working as non-exempt, hourly-paid employees were regularly required to work
5 off-the-clock, and/or during their rest and/or meal periods.

6 21. REPRESENTATIVE PLAINTIFF filed a PAGA Notice on March 22, 2023, by
7 serving a PAGA Notice to all named DEFENDANTS and to the LWDA in compliance with
8 Labor Code section 2699.3. As of May 31, 2023, 65 Days after REPRESENTATIVE
9 PLAINTIFF's PAGA Notice, REPRESENTATIVE PLAINTIFF has not received
10 correspondence from the LWDA regarding its intent to investigate PLAINTIFF's claims.

11 **FAILURE TO PROVIDE EMPLOYMENT RECORDS**

12 22. California Labor Code Section 226 provides, "An employer who receives a
13 written or oral request to inspect or copy records pursuant to subdivision (b) pertaining to a
14 current or former employee [records of hours worked and wages paid]...shall comply with the
15 request as soon as practicable, but no later than 21 calendar days from the date of the request."

16 23. California Labor Code Section 432 provides, "If an employee signs any
17 instrument relating to the obtaining or holding of employment, he shall be given a copy of the
18 instrument upon request."

19 24. California Labor Code Section 1198.5 provides that every employee shall be
20 permitted to inspect and obtain a copy of their personnel records upon request.

21 25. In accordance with the process set out in Labor Code Section 226,
22 REPRESENTATIVE PLAINTIFF requested, in writing by letter via certified first-class mail to
23 DEFENDANTS and regular first-class mail to DEFENDANTS, that DEFENDANTS provide
24 REPRESENTATIVE PLAINTIFF with wage and payroll history, all documents signed by
25 REPRESENTATIVE PLAINTIFF pursuant to Labor Code Section 432, and a copy of
26 REPRESENTATIVE PLAINTIFF's personnel records pursuant to Labor Code Section 1198.5.

27 26. The time periods provided to DEFENDANTS by Labor Code Sections 226, 432,
28 1198.5 and any other relevant statutes have elapsed since DEFENDANTS received

1 REPRESENTATIVE PLAINTIFF's correspondence requesting documents pursuant to Labor
2 Code Sections 226, 432, and 1198.5, and a copy of REPRESENTATIVE PLAINTIFF's
3 personnel records pursuant to Labor Code Section 1198.5. However, DEFENDANTS failed to
4 provide REPRESENTATIVE PLAINTIFF with all of the employment documents to which
5 he/she is entitled, including, but not limited to, copies of all internal performance reviews with
6 bonus recommendations.

7 27. REPRESENTATIVE PLAINTIFF is informed and believes, and based thereon
8 alleges, that DEFENDANTS failed to provide records in compliance with Labor Code Sections
9 226, 432, and 1198.5 to other AGGRIEVED EMPLOYEES in response to their requests.

10 **OVERTIME / DOUBLE TIME**

11 28. California Labor Code sections 510 and the applicable Wage Orders require
12 employers to pay employees working more than eight (8) hours in a day or more than 40 hours
13 in a week at the rate of at least time-and-one-half (1.5) times their regular rate of pay
14 ("overtime") for time such worked, and two (2) times their regular rate of pay ("double time")
15 for such hours worked in excess of 12 hours in a day. "Regular rate" includes all remuneration,
16 including non-discretionary bonuses and incentives.

17 29. During the relevant time period, REPRESENTATIVE PLAINTIFF and other
18 AGGRIEVED EMPLOYEES regularly worked in excess of eight (8), and in excess of 12, hours
19 in a workday and/or 40 hours in a workweek.

20 30. DEFENDANTS routinely required REPRESENTATIVE PLAINTIFF and the
21 other AGGRIEVED EMPLOYEES to perform work tasks before and/or after their scheduled
22 shifts, and/or during off-the-clock meal breaks, and/or during rest breaks. As a consequence,
23 DEFENDANTS willfully failed to pay REPRESENTATIVE PLAINTIFF and the other
24 AGGRIEVED EMPLOYEES all of the wages to which they were entitled.

25 **MEAL / REST BREAKS**

26 31. California Labor Code sections 226.7, 512(a), and the applicable Wage Orders
27 require employers to pay employees one (1) additional hour of pay at the employees' regular
28 rate for each work day that a legally compliant meal and/or rest break was not provided.

Employers cannot require, cause, or permit an employee to work more than five (5) hours per day without providing an uninterrupted meal break. If an employee works over ten (10) hours in a workday, employers are required to either provide a second, uninterrupted 30-minute meal break or pay employees an additional one (1) hour of pay at the employees' regular rate. If the employer fails to properly record a valid meal period, it is presumed that no meal period was provided. Furthermore, no employer shall require an employee to work during any rest period. Rest periods requirements are based on the total hours worked; employees are legally entitled to ten (10) minutes per four (4) hours, or major fraction thereof, that employee worked.

32. DEFENDANTS failed to provide REPRESENTATIVE PLAINTIFF and other AGGRIEVED EMPLOYEES with the required rest and meal break periods. REPRESENTATIVE PLAINTIFF and other AGGRIEVED EMPLOYEES were routinely required to work through these periods instead, because of understaffing, inadequate coverage, unreasonably high workload and expectations, and/or other actions, inactions, or decisions made by and within the sole control and discretion of DEFENDANTS.

33. REPRESENTATIVE PLAINTIFF and other AGGRIEVED EMPLOYEES worked shifts in excess of five (5) hours without a meal break, and worked shifts of ten (10) hours or more without a second meal break, due to understaffing, inadequate coverage, unreasonably high workload and expectations, and/or other actions, inactions, or decisions made by and within the sole control and discretion of DEFENDANTS.

34. REPRESENTATIVE PLAINTIFF is informed and believes, and based thereon alleges, that any purported appearance of meal and rest break compliance is because DEFENDANTS systematically and routinely clocked out for and/or otherwise altered the timekeeping records of REPRESENTATIVE PLAINTIFF and other AGGRIEVED EMPLOYEES in an attempt to hide the aforementioned infractions. DEFENDANTS, knowingly and contrary to law and public policy, employed a tactic of clocking-out employees for rest and/or meal periods that were never taken and/or were legally non-compliant, and/or otherwise falsified or altered timekeeping records.

35. DEFENDANTS knew, or should have known, that their behavior caused

1 REPRESENTATIVE PLAINTIFF and other AGGRIEVED EMPLOYEES to work through the
2 above-described meal and/or rest periods. As a company-wide policy, DEFENDANTS still
3 chose not to pay meal and rest period premiums required by law.

4 **MINIMUM WAGE**

5 36. California Labor Code sections 1182.12, 1194, 1197, and 1197.1 require
6 employers to pay the minimum wage as set by the IWC. California Labor Code section 1182.12,
7 as amended by Senate Bill 3, Chapter 4, Section 3, defines the minimum wage as;

8 (1) For any employer who employs 26 or more employees:

9 (A) From January 1, 2017, to December 31, 2017, \$10.50 per hour.

10 (B) From January 1, 2018, to December 31, 2018, \$11 per hour.

11 (C) From January 1, 2019, to December 31, 2019, \$12 per hour.

12 (D) From January 1, 2020, to December 31, 2020, \$13 per hour.

13 (E) From January 1, 2021, to December 31, 2021, \$14 per hour.

14 (F) From January 1, 2022, and until adjusted by subdivision (c) \$15 per hour.

15 (2) For any employer who employs 25 or fewer employees:

16 (A) From January 1, 2018, to December 31, 2018, \$10.50 per hour.

17 (B) From January 1, 2019, to December 31, 2019, \$11 per hour.

18 (C) From January 1, 2020, to December 31, 2020, \$12 per hour.

19 (D) From January 1, 2021, to December 31, 2021, \$13 per hour.

20 (E) From January 1, 2022, to December 31, 2022, \$14 per hour.

21 (F) From January 1, 2023, and until adjusted by subdivision (c) \$15 per hour.

22 37. The minimum wage standard applies to each hour employees worked for which
23 they were not paid. Therefore, employer's failure to pay for any particular hour worked by an
24 employee is unlawful even if averaging an employee's total pay over all hours worked, paid or
25 not, results in an average hourly wage above minimum wage.

26 38. As alleged throughout this Complaint, due to the company-wide failures of
27 DEFENDANTS, REPRESENTATIVE PLAINTIFF and other AGGRIEVED EMPLOYEES
28 were forced to work off-the-clock before and/or after their scheduled work shifts, and/or during

rest breaks, and/or during meal breaks. DEFENDANTS failed to pay REPRESENTATIVE PLAINTIFF and other AGGRIEVED EMPLOYEES minimum wage for this time and/or falsified timekeeping records to hide this fact.

ACCURATE/ITEMIZED WAGE STATEMENTS

39. California Labor Code 226(a) requires employers to create and provide to employees true and accurate employment records. California Labor Code section 226(e) provides that if an employer fails to furnish an employee with same, the employee is entitled to recover the greater of all actual damages, or \$50.00 for an initial infraction, and \$100 per employee for each subsequent violation in any pay period. California Labor Code 226.3 imposes civil penalties on any employer in violation of section 226(a) at \$250 per employee violation in an initial citation, and \$1,000 per employee for each subsequent violation.

40. California Labor Code 1174(d) requires employers to keep payroll records showing hours worked, and wages paid to and/or number of piece-rate units earned, for all employees. California Labor Code section 1174.5 subjects employers to a \$500 penalty for failing to maintain same.

41. California Labor Code section 1198 provides that maximum hours and standard conditions of labor are fixed by the Labor Commissioner in the applicable Wage Orders. Pursuant to the applicable Wage Order, employers must keep accurate records of when employees begin and end each work period and each meal period.

42. DEFENDANTS knowingly provided employees with records that do not meet the statutory requirements of truth and accuracy, because DEFENDANTS failed to truthfully and accurately document, among other things, employees off-the-clock work. As a result, DEFENDANTS failed to accurately list the correct amount of gross and/or net wages earned by REPRESENTATIVE PLAINTIFF and the other AGGRIEVED EMPLOYEES.

43. The statements in question are deficient in many other ways, including, but not limited to: failure to list total hours worked, failing to list applicable hourly rates and the numbers of hours worked at each rate, failure to list piece-rate units earned and the applicable piece-rate, failure to list deductions, failure to track sick leave, failure to list the employee and

SSN/EID properly, failure to list the full legal name and address of the employer, failure to list inclusive dates for which employees are paid, failure to provide employees with the ability to easily access wage statements and get hard copies at no expense to the employee, and/or failure to state all hours worked as a result of off-the-clock work.

44. DEFENDANTS willfully failed to maintain accurate payroll records for REPRESENTATIVE PLAINTIFF and other AGGRIEVED EMPLOYEES as a result of DEFENDANTS failure to accurately record employees rest breaks, and/or meal breaks, and/or off-the-clock work. DEFENDANTS failure makes it impossible for REPRESENTATIVE PLAINTIFF and other AGGRIEVED EMPLOYEES to accurately determine the extent of their underpayment, thereby causing further injuries to each of them.

REPORTING TIME

45. California Code of Regulations, Title 8, section 11050(5)(A) provides that for each workday when an employee is required to and does in fact report to work, but is either not put to work or is furnished less than half of said employee's usual scheduled day's work, that employee should be paid for no less than half, and in no event less than two (2) hours, of the employees' regular rate of pay.

46. REPRESENTATIVE PLAINTIFF and other AGGRIEVED EMPLOYEES were frequently told by DEFENDANTS to report to work and were either not put to work or were furnished less than half of said employee's usual scheduled day's work. DEFENDANTS routinely failed to pay the required reporting time wages to REPRESENTATIVE PLAINTIFF and other AGGRIEVED EMPLOYEES for each of these instances.

SPLIT SHIFTS

47. California Code of Regulations 11050(4)(C) provides that when an employee works a "split shift", one (1) hour's pay at the State or local minimum wage (whichever is greater) must be paid in addition to the minimum wage for that workday. A "split shift" is defined as a work schedule which is interrupted by non-paid, non-working periods established by the employer, other than *bona fide* rest or meal periods.

///

48. DEFENDANTS routinely scheduled REPRESENTATIVE PLAINTIFF and other AGGRIEVED EMPLOYEES for multiple different shifts throughout the same workday, separated by periods other than *bona fide* rest or meal breaks. DEFENDANTS failed to pay REPRESENTATIVE PLAINTIFF and other AGGRIEVED EMPLOYEES one (1) hour's pay at the applicable minimum wage, which resulted in REPRESENTATIVE PLAINTIFF and other AGGRIEVED EMPLOYEES being paid less than the applicable minimum wage for that day. As a further consequence, DEFENDANTS also failed to separately list "split shift" payments on REPRESENTATIVE PLAINTIFF and other AGGRIEVED EMPLOYEES wage statements.

ALL WAGES PAID ON TIME

49. California Labor Code section 204 requires that all wages earned, other than those due upon termination, be paid on time as defined by the statute.

50. As a result of the numerous company-wide failures of DEFENDANTS as described throughout this Complaint, DEFENDANTS failed to pay REPRESENTATIVE PLAINTIFF and other AGGRIEVED EMPLOYEES all wages due to them, including, but not limited to minimum wages, overtime wages, double time wages, split shift pay and/or reporting time pay, within the statutorily required time period.

ALL WAGES PAID ON DISCHARGE / TERMINATION

51. California Labor Code sections 201, 202, and 203 provide that employees who are terminated are due all wages earned immediately. Employees who resign their employment without giving 72-hours' notice are due all wages earned within 72 hours of their resignation. Employees who resign their employment giving 72-hours' notice are entitled to all wages earned at the time their resignation becomes effective.

52. DEFENDANTS terminated their employment relationship with REPRESENTATIVE PLAINTIFF on March 10, 2023. Accordingly, EMPLOYEE was due all wages earned immediately.

53. When REPRESENTATIVE PLAINTIFF finally received EMPLOYEE's final paycheck, that final paycheck was legally deficient in that it did not account for all wages earned despite DEFENDANTS knowing that such wages were due to REPRESENTATIVE

1 PLAINTIFF. Due to the company-wide failures of DEFENDANTS as described throughout this
2 Complaint, DEFENDANTS similarly failed to pay other AGGRIEVED EMPLOYEES timely
3 wages upon their discharge or resignation.

4 **FAILURE TO REIMBURSE**

5 54. California Labor Code Sections 2800 and 2802 require that an employer
6 indemnify employees for all necessary expenditures or losses incurred by the employee in direct
7 consequence of the discharge of their duties.

8 55. REPRESENTATIVE PLAINTIFF and other AGGRIEVED EMPLOYEES were
9 directed and expected to incur personal expenses on behalf of DEFENDANTS while performing
10 their job duties. Such personal expenses include, but are not limited to, use of personal cell
11 phone, travel expenses, and parking expenses. REPRESENTATIVE PLAINTIFF and the other
12 AGGRIEVED EMPLOYEES would not have been able to successfully accomplish their job
13 duties absent incurring these personal expenses. DEFENDANTS failed to indemnify
14 REPRESENTATIVE PLAINTIFF and other AGGRIEVED EMPLOYEES for all necessary
15 expenditures or losses accordingly.

16 **NOTICE OF PAID SICK TIME AND ACCRUAL**

17 56. California Labor Code section 246 provides that an employee who works for the
18 same employer for more than 30 days is entitled to paid sick days. Paid sick leave is to accrue
19 at a rate not less than one (1) hour per every 30 hours worked, such accrual beginning at the
20 commencement of employment. Employers must provide employees with written notice setting
21 the amount of sick leave available (or paid time off in lieu thereof) for use on either itemized
22 wage statements (as described in Labor Code section 226) or in a separate writing accompanying
23 such wage statements.

24 57. REPRESENTATIVE PLAINTIFF was hired by DEFENDANTS on or about 18
25 YEARS and worked for DEFENDANTS until on or about March 10, 2023.
26 REPRESENTATIVE PLAINTIFF and other AGGRIEVED EMPLOYEES worked for
27 DEFENDANT for more than 30 days, triggering the protections of Labor Code section 246 as
28 described above. Nevertheless, DEFENDANTS failed to furnish upon REPRESENTATIVE

PLAINTIFF and other AGGRIEVED EMPLOYEES, either on itemized wage statements or in a separate writing accompanying such wage statements, the amount of sick leave available to REPRESENTATIVE PLAINTIFF and other AGGRIEVED EMPLOYEES.

58. As such, DEFENDANTS unlawfully retained and continue to retain paid sick leave that should have been paid to REPRESENTATIVE PLAINTIFF and other AGGRIEVED EMPLOYEES but for DEFENDANTS failure to properly institute and/or adhere to a legally compliant paid sick leave program. REPRESENTATIVE EMPLOYEE is informed and believes, and based thereon alleges, that these practices were experienced and continue to be experienced by the other AGGRIEVED EMPLOYEES.

CIVIL PENALTIES AND INDIVIDUAL LIABILITY

59. California Labor Code section 558(a) provides that any employer, including individuals acting on behalf of employers, that violates, or causes to be violated, a section of the Labor Code or any applicable Wage Orders are subject to the following penalties;

- \$50 for any initial violation for each underpaid employee for each pay period for which the employee was underpaid in addition to an amount sufficient to recover unpaid wages;
- \$100 for each subsequent violation for each underpaid employee for each pay period for which the employee was underpaid in addition to an amount to recover unpaid wages;

60. Labor Code section 558.1 permits joint and several liability as to both an individual and employer for violations of Labor Code sections 203, 226, 226.7, 1194, and 2802. Labor Code section 558(c) provides that the penalties in this section are in addition to any other civil penalty.

61. DEFENDANTS are employers, and violated REPRESENTATIVE PLAINTIFF and other AGGRIEVED EMPLOYEES' rights by violating, or causing to be violated, various sections of this code as described throughout this Complaint.

FIRST CAUSE OF ACTION

VIOLATION OF LABOR CODE § 2698, *ET SEQ.*

1 **(Against DEFENDANTS and Does 1 through 50, inclusive)**

2 62. REPRESENTATIVE PLAINTIFF incorporates by reference the allegations
3 contained in each of the preceding paragraphs and each and every part thereof with the same
4 force and effect as though fully set forth herein.

5 63. PAGA expressly establishes that any provisions of the California Labor Code
6 which provides for a civil penalty to be assessed and collected by the LWDA, or any of its
7 departments, divisions, commissions, boards, agencies or employees for a violation of the
8 California Labor Code, may be recovered through a civil action brought by an aggrieved
9 employee on behalf of himself or herself, and other current or former employees.

10 64. Whenever the LWDA, or any of its departments, divisions, commissions, boards,
11 agencies, or employees has discretion to assess a civil penalty, a court in a civil action is
12 authorized to exercise the same discretion, subject to the same limitations and conditions, to
13 assess a civil penalty.

14 65. REPRESENTATIVE PLAINTIFF and the other hourly-paid or non-exempt
15 employees, are "AGGRIEVED EMPLOYEES" within the meaning of California Labor Code
16 section 2699(c) as they are all current or former employees of DEFENDANT, and one or more
17 of the alleged violations was committed against them.

18 **Failure to Provide Employment Records**

19 66. DEFENDANTS failure to provide REPRESENTATIVE PLAINTIFF and other
20 AGGRIEVED EMPLOYEES with employment records constitutes unlawful and/or unfair
21 activity and is prohibited by California Labor Code 226, 432, and 1198.5.

22 **Failure to Pay Overtime / Double Time**

23 67. DEFENDANTS failure to pay legally required overtime and double time wages
24 to REPRESENTATIVE PLAINTIFF and other AGGRIEVED EMPLOYEES is in violation of
25 the Wage Orders and constitutes unlawful and/or unfair activity prohibited by California Labor
26 Code sections 510 and 1198.

27 **Failure to Provide Meal and Rest Periods**

28 68. DEFENDANTS failure to provide legally required meal and rest periods to

1 REPRESENTATIVE PLAINTIFF and other AGGRIEVED EMPLOYEES constitutes unlawful
2 and/or unfair activity prohibited by California Labor Code sections 226.7, 512(a), and the
3 applicable Wage Orders.

4 **Failure to Pay Minimum Wages**

5 69. DEFENDANTS failure to pay legally required minimum wages to
6 REPRESENTATIVE PLAINTIFF and other AGGRIEVED EMPLOYEES constitutes unlawful
7 and/or unfair activity prohibited by California Labor Code sections 1182.12, 1194, 1197,
8 1197.1, and the applicable Wage Orders.

9 **Failure to Keep Accurate and Provide Itemized Wage Statements**

10 70. DEFENDANTS failure to keep accurate and provide itemized wage statements to
11 Plaintiff and other AGGRIEVED EMPLOYEES constitutes unlawful and/or unfair activity
12 prohibited by California Labor Code section 226(a), 1174(d), and 1198.

13 **Failure to Pay Reporting Time**

14 71. DEFENDANTS failure to pay REPRESENTATIVE PLAINTIFF and other
15 AGGRIEVED EMPLOYEES who were required to and did in fact report to work, but who were
16 then furnished less than half of such employees usual scheduled day's work, with at least half,
17 and in no event less than two (2) hours, of the employees' regular rate of pay constitutes unlawful
18 and/or unfair activity prohibited by California Code of Regulations 11050 (5)(A).

19 **Failure to Pay "Split Shift" Premiums**

20 72. DEFENDANTS failure to pay REPRESENTATIVE PLAINTIFF and other
21 AGGRIEVED EMPLOYEES one (1) hour's pay at the minimum wage in addition to the wages
22 for that workday for any workday in which REPRESENTATIVE PLAINTIFF and other
23 AGGRIEVED EMPLOYEES were scheduled for and required to work a "split shift" constitutes
24 unlawful or unfair activity prohibited by California Labor Code 1198 and California Code of
25 Regulations 11050(4)(C).

26 **Failure to Timely Pay Wages During Employment**

27 73. DEFENDANTS failure to timely pay wages to REPRESENTATIVE PLAINTIFF
28 and other AGGRIEVED EMPLOYEES during their employment constitutes unlawful and/or

unfair activity prohibited by California Labor Code section 204.

Failure to Timely Pay Wages Upon Termination

74. DEFENDANTS failure to timely pay wages to REPRESENTATIVE PLAINTIFF and other AGGRIEVED EMPLOYEES upon termination constitutes unlawful and/or unfair activity prohibited by California Labor Code sections 201, 202, and 203.

Failure to Reimburse Necessary Business-Related Expenses and Costs

75. DEFENDANTS failure to reimburse REPRESENTATIVE PLAINTIFF and other AGGRIEVED EMPLOYEES for necessary business-related expenses and costs constitutes unlawful and/or unfair activity prohibited by California Labor Code sections 2800 and 2802.

Failure to Provide Notice of Paid Sick Time and Accrual

76. DEFENDANTS failure to provide REPRESENTATIVE PLAINTIFF and other AGGRIEVED EMPLOYEES that works for DEFENDANTS for more than 30 days with written notice setting the amount of sick leave available (or paid time off in lieu thereof) for use in their itemized wage statements or in a separate writing accompanying such statements constitutes unlawful and/or unfair activity prohibited by California Labor Code section 246.

Civil Penalties

77. Pursuant to California Labor Code section 2699, REPRESENTATIVE PLAINTIFF, individually, and on behalf of all AGGRIEVED EMPLOYEES, requests and is entitled to recover penalties from DEFENDANTS and each of them, for violations of the Labor Code as more fully described herein according to proof, interest, attorneys' fees and costs pursuant to California Labor Code section 218.5, including but not limited to:

a. Penalties under California Labor Code section 2699 in the amount of a hundred dollars (\$100) for each aggrieved employee per pay period for the initial violation, and two hundred dollars (\$200) for each aggrieved employee per pay period for each subsequent violation;

b. Penalties under California Code of Regulations Title 8 section 11010, et seq. in the amount of fifty dollars (\$50) for each aggrieved employee per pay period for the initial violation, and one hundred dollars (\$100) for each aggrieved employee per pay

period for each subsequent violation;

c. Penalties under California Labor Code section 210 in addition to, and entirely independent and apart from, any other penalties provided in the California Labor Code in the amount of a hundred dollars (\$100) for each aggrieved employee per pay period for the initial violation, and two hundred dollars (\$200) for each aggrieved employee per pay period for each subsequent violation; and

d. Any and all additional penalties and sums as provided by the California Labor Code and/or other statutes, including, but not limited to, penalties pursuant to California Labor Code 558(a).

78. Pursuant to California Labor Code section 2699(i), civil penalties recovered shall be distributed as follows: seventy-five percent (75%) to the Labor and Workforce Development Agency for the enforcement of labor laws and education of employers and employees about their rights and responsibilities and twenty-five percent (25%) to the AGGRIEVED EMPLOYEES.

79. Further, REPRESENTATIVE PLAINTIFF is entitled to seek and recover reasonable attorneys' fees and costs pursuant to California Labor Code sections 210, 218.5 and 2699 and any other applicable statute.

THEREFORE, REPRESENTATIVE PLAINTIFF and the individuals he seeks to represent request relief as described below:

PRAYER

THEREFORE, REPRESENTATIVE PLAINTIFF prays for judgment against DEFENDANTS, and Does 1 through 50, and each of them, as follows:

1. Statutory attorneys' fees and costs under PAGA and California Code of Civil Procedure Section 1021.5;
2. Statutory penalties under PAGA;
3. Costs of suit; and
4. Such further relief as the Court deems just and proper.
