**COMPLAINT FOR ENFORCEMENT
UNDER THE PRIVATE ATTORNEYS
GENERAL ACT, CALIFORNIA LABOR
CODE § 2698, ET SEQ.**

Violation of California Labor Code §
2698, et seq. (California Labor Code
Private Attorneys General Act of 2004)

COMES NOW, Plaintiff RHEITTY TENG (“Plaintiff”), individually, and on behalf of other aggrieved employees pursuant to the California Private Attorneys General Act, and alleges as follows:

JURISDICTION AND VENUE

1. This representative action is brought pursuant to the California Labor Code section 2698, et seq. The civil penalties sought by Plaintiff exceed the minimal jurisdiction limits of the Superior Court and will be established according to proof at trial. The “amount in controversy” for the named Plaintiff, including claims for compensatory damages, restitution, penalties, wages, premium pay, and pro rata share of attorneys’ fees, is less than seventy-five thousand dollars (\$75,000).

2. This Court has jurisdiction over this action pursuant to the California Constitution, Article VI, Section 10, which grants the superior court “original jurisdiction in all other causes” except those given by statute to other courts. The statutes under which this action is brought do not specify any other basis for jurisdiction.

3. This Court has jurisdiction over Defendants because, upon information and belief, each Defendant is a citizen of California, has sufficient minimum contacts in California, or otherwise intentionally avails itself of the California market so as to render the exercise of jurisdiction over it by the California courts consistent with traditional notions of fair play and substantial justice.

4. Venue is proper in this Court because, upon information and belief, each Defendant maintains offices, has agents, and/or transacts business in the State of California, including the County of Los Angeles. At all relevant times, Defendants maintained their headquarters/“nerve center” within the State of California, County of Los Angeles.

PARTIES

5. Plaintiff RHEITTY TENG is an individual residing in the State of California.

6. Defendant ALLIANCE ENVIRONMENTAL GROUP, LLC at all times herein mentioned, was and is, upon information and belief, a California limited liability

1 company and an employer whose employees are engaged throughout the State of California,
2 including the County of Los Angeles.

3 7. Defendant OPM SERVICES, LLC at all times herein mentioned, was and is,
4 upon information and belief, a California limited liability company and an employer whose
5 employees are engaged throughout the State of California, including the County of Los
6 Angeles.

7 8. Defendant ALLIANCE ENVIRONMENTAL HOLDINGS, LLC at all times
8 herein mentioned, was and is, upon information and belief, an employer whose employees
9 are engaged throughout the State of California, including the County of Los Angeles.

10 9. Defendant AIRTEK INDOOR AIR SOLUTIONS, LLC at all times herein
11 mentioned, was and is, upon information and belief, a California limited liability company
12 and an employer whose employees are engaged throughout the State of California, including
13 the County of Los Angeles.

14 10. At all relevant times, Defendants ALLIANCE ENVIRONMENTAL GROUP,
15 LLC, OPM SERVICES, LLC, ALLIANCE ENVIRONMENTAL HOLDINGS, LLC, and
16 AIRTEK INDOOR AIR SOLUTIONS, LLC were the “employer” of Plaintiff within the
17 meaning of all applicable state laws and statutes.

18 11. At all times herein relevant, ALLIANCE ENVIRONMENTAL GROUP, LLC,
19 OPM SERVICES, LLC, ALLIANCE ENVIRONMENTAL HOLDINGS, LLC, AIRTEK
20 INDOOR AIR SOLUTIONS, LLC, and DOES 1 through 100, and each of them, were the
21 agents, partners, joint venturers, joint employers, representatives, servants, employees,
22 successors-in-interest, co-conspirators, and assigns of each other, and were acting within the
23 course and scope of their authority as such agents, partners, joint venturers, representatives,
24 servants, employees, successors, co-conspirators, and/or assigns, and all acts or omissions
25 alleged herein were duly committed with the ratification, knowledge, permission,
26 encouragement, authorization, and/or consent of each defendant designated as a DOE herein.

27 12. The true names and capacities, whether corporate, associate, individual, or
28 otherwise, of defendants DOES 1 through 100, inclusive, are unknown to Plaintiff who sues

1 said defendants by such fictitious names. Plaintiff is informed and believes, and based on
2 that information and belief, alleges that each of the defendants designated as a DOE is legally
3 responsible for the events and happenings referred to in this Complaint and unlawfully
4 caused the injuries and damages to Plaintiff as alleged in this Complaint. Plaintiff will seek
5 leave of court to amend this Complaint to show the true names and capacities when the same
6 have been ascertained.

7 13. ALLIANCE ENVIRONMENTAL GROUP, LLC, OPM SERVICES, LLC,
8 ALLIANCE ENVIRONMENTAL HOLDINGS, LLC, AIRTEK INDOOR AIR
9 SOLUTIONS, LLC, and DOES 1 through 100 will hereinafter collectively be referred to as
10 “Defendants.”

11 14. Plaintiff further alleges that Defendants, including the unknown defendants
12 identified as DOES, directly or indirectly controlled or affected the working conditions,
13 wages, working hours, and conditions of employment of Plaintiff and the other aggrieved
14 employees so as to make each of said Defendants employers and employers liable under the
15 statutory provisions set forth herein.

16 **PAGA ALLEGATIONS**

17 15. At all times herein set forth, California Private Attorneys General Act
18 (“PAGA”) was applicable to Plaintiff’s employment by Defendants.

19 16. At all times herein set forth, PAGA provides that any provision of law under
20 the California Labor Code that provides for a civil penalty to be assessed and collected by the
21 Labor and Workforce Development Agency (“LWDA”) for violations of the California
22 Labor Code may, as an alternative, be recovered through a civil action brought by an
23 aggrieved employee on behalf of herself and other current or former employees pursuant to
24 procedures outlined in California Labor Code section 2699.3.

25 17. Pursuant to PAGA, a civil action under PAGA may be brought by an
26 “aggrieved employee,” who is any person that was employed by the alleged violator and
27 against whom the alleged violations were committed.

28 ///

1 18. Plaintiff was employed by Defendants and the alleged violations were
2 committed against him during his time of employment, and he is, therefore, an aggrieved
3 employee. Plaintiff and the other employees are “aggrieved employees” as defined by
4 California Labor Code section 2699(c) in that they are all current or former employees of
5 Defendants, and the alleged violations were committed against them.

6 19. Pursuant to California Labor Code sections 2699.3 and 2699.5, an aggrieved
7 employee, including Plaintiff, may pursue a civil action arising under PAGA after the
8 following requirements have been met:

9 a. The aggrieved employee shall give written notice by online submission
10 (hereinafter, “Employee’s Notice”) to the LWDA and by U.S. Certified
11 Mail to the employer of the specific provisions of the California Labor
12 Code alleged to have been violated, including the facts and theories to
13 support the alleged violations.

14 b. The LWDA shall provide notice (hereinafter, “LWDA Notice”) to the
15 employer and the aggrieved employee by certified mail that it does not
16 intend to investigate the alleged violations within sixty (60) calendar
17 days of the postmark date of the Employee’s Notice. Upon receipt of
18 the LWDA Notice, or if the LWDA Notice is not provided within
19 sixty-five (65) calendar days of the postmark date of the Employee’s
20 Notice, the aggrieved employee may commence a civil action pursuant
21 to California Labor Code section 2699 to recover civil penalties, in
22 addition to any other penalties to which the employee may be entitled.

23 20. On October 15, 2025, Plaintiff provided written notice by online submission to
24 the LWDA and by U.S. Certified Mail to Defendants ALLIANCE ENVIRONMENTAL
25 GROUP, LLC, OPM SERVICES, LLC, ALLIANCE ENVIRONMENTAL HOLDINGS,
26 LLC, and AIRTEK INDOOR AIR SOLUTIONS, LLC of the specific provisions of the
27 California Labor Code alleged to have been violated, including the facts and theories to
28 support the alleged violations. Plaintiff has not received an LWDA Notice within sixty-five

(65) calendar days of the date of Plaintiff's notice. Plaintiff has not received any notice of Defendants' intention to cure the alleged violations.

21. Therefore, Plaintiff has satisfied the administrative prerequisites under California Labor Code section 2699.3(a) to recover civil penalties against Defendants for violations of California Labor Code sections 201, 202, 203, 204, 226(a), 226.7, 510, 512(a), 558, 1174(d), 1194, 1197, 1197.1, 1198, 2800 and 2802.

GENERAL ALLEGATIONS

22. At all relevant times set forth herein, Defendants employed Plaintiff and other aggrieved hourly-paid or non-exempt employees who worked for any of the Defendants in the State of California, including, but not limited to all current and former hourly-paid or non-exempt employees who worked for any of the Defendants within the State of California who earned shift differentials/non-discretionary bonuses/non-discretionary performance pay which was not used to calculate the correct regular rate of pay used to calculate the overtime rate (hereinafter collectively referred to as the "other aggrieved employees").

23. Defendants, jointly and severally, employed Plaintiff as an hourly-paid, non-exempt employee from approximately July 2025 to the present in the State of California.

24. Defendants hired Plaintiff and the other aggrieved employees and failed to compensate them for all hours worked, missed meal periods, or missed rest breaks.

25. Defendants had the authority to hire and terminate Plaintiff and the other aggrieved employees, to set work rules and conditions governing Plaintiff's and the other aggrieved employees' employment, and to supervise their daily employment activities.

26. Defendants exercised sufficient authority over the terms and conditions of Plaintiff's and the other aggrieved employees' employment for them to be joint employers of Plaintiff and the other aggrieved employees.

27. Defendants directly hired and paid wages and benefits to Plaintiff and the other aggrieved employees.

28. Defendants continue to employ hourly-paid or non-exempt employees within the State of California.

29. Plaintiff and the other aggrieved employees worked over eight (8) hours in a day and/or forty (40) hours in a week during their employment with Defendants.

30. Plaintiff is informed and believes, and based thereon alleges, that Defendants engaged in a uniform policy and systematic scheme of wage abuse against their hourly-paid or non-exempt employees. This scheme involved, *inter alia*, failing to pay them for all hours worked and for missed (short, late, interrupted, and altogether missed) meal periods and rest breaks in violation of California law.

31. Plaintiff is informed and believes, and based thereon alleges, that Defendants knew or should have known that Plaintiff and the other aggrieved employees were entitled to receive certain wages for overtime compensation and that they were not receiving wages for overtime compensation.

32. Plaintiff is informed and believes, and based thereon alleges, that Defendants failed to provide Plaintiff and the other aggrieved employees the required rest and meal periods during the relevant time period as required under the Industrial Welfare Commission ("IWC") Wage Orders, and, thus, they are entitled to any and all applicable penalties.

33. Plaintiff is informed and believes, and based thereon alleges, that Defendants knew or should have known that Plaintiff and the other aggrieved employees were entitled to receive all meal periods or payment of one additional hour of pay at Plaintiff's and the other aggrieved employees' regular rate of pay when a meal period was missed, and they did not receive all meal periods or payment of one additional hour of pay at Plaintiff's and the other aggrieved employees' regular rate of pay when a meal period was missed.

34. Plaintiff is informed and believes, and based thereon alleges, that Defendants knew or should have known that Plaintiff and the other aggrieved employees were entitled to receive all rest periods or payment of one additional hour of pay at Plaintiff's and the other aggrieved employees' regular rate of pay when a rest period was missed, and they did not receive all rest periods or payment of one additional hour of pay at Plaintiff's and the other aggrieved employees' regular rate of pay when a rest period was missed.

1 35. Plaintiff is informed and believes, and based thereon alleges, that Defendants
2 knew or should have known that Plaintiff and the other aggrieved employees were entitled to
3 receive at least minimum wages for compensation and that they were not receiving at least
4 minimum wages for all hours worked.

5 36. Plaintiff is informed and believes, and based thereon alleges, that Defendants
6 knew or should have known that Plaintiff and the other aggrieved employees were entitled to
7 receive all wages owed to them upon discharge or resignation, including overtime and
8 minimum wages and meal and rest period premiums, and they did not receive all such wages
9 owed to them at the time of their discharge.

10 37. Plaintiff is informed and believes, and based thereon alleges, that Defendants
11 knew or should have known that Plaintiff and the other aggrieved employees were entitled to
12 receive all wages owed to them during their employment. Plaintiff and the other aggrieved
13 employees did not receive payment of all wages, including overtime and minimum wages
14 and meal and rest period premiums, within any time permissible under California Labor
15 Code section 204.

16 38. Plaintiff is informed and believes, and based thereon alleges, that Defendants
17 knew or should have known that Plaintiff and the other aggrieved employees were entitled to
18 receive complete and accurate wage statements in accordance with California law, but they
19 did not receive complete and accurate wage statements from Defendants. The deficiencies
20 included, *inter alia*, the failure to include the total number of hours worked by Plaintiff and
21 the other aggrieved employees and the complete and accurate name of the legal entity that
22 was the employer.

23 39. Plaintiff is informed and believes, and based thereon alleges, that Defendants
24 knew or should have known that Defendants had to keep complete and accurate payroll
25 records for Plaintiff and the other aggrieved employees in accordance with California law,
26 but they did not keep complete and accurate payroll records.

27 ///

28 ///

1 40. Plaintiff is informed and believes, and based thereon alleges, that Defendants
2 knew or should have known that Plaintiff and the other aggrieved employees were entitled to
3 reimbursement for necessary business-related expenses and costs.

4 41. Plaintiff is informed and believes, and based thereon alleges, that Defendants
5 knew or should have known that they had a duty to compensate Plaintiff and the other
6 aggrieved employees pursuant to California law, and that Defendants had the financial ability
7 to pay such compensation, but willfully, knowingly, and intentionally failed to do so and
8 falsely represented to Plaintiff and the other aggrieved employees that they were properly
9 denied wages, all in order to increase Defendants' profits.

10 42. At all material times set forth herein, Defendants failed to pay overtime wages
11 to Plaintiff and the other aggrieved employees. Plaintiff and the other aggrieved employees
12 were required to work more than eight (8) hours per day and/or forty (40) hours per week
13 without overtime compensation.

14 43. At all material times set forth herein, Defendants failed to provide
15 uninterrupted meal and rest periods to Plaintiff and the other aggrieved employees.

16 44. At all material times set forth herein, Defendants failed to pay Plaintiff and the
17 other aggrieved employees at least minimum wages for all hours worked.

18 45. At all material times set forth herein, Defendants failed to pay Plaintiff and the
19 other aggrieved employees all wages owed to them upon discharge or resignation.

20 46. At all material times set forth herein, Defendants failed to pay Plaintiff and the
21 other aggrieved employees' wages within any time permissible under California law,
22 including, *inter alia*, California Labor Code section 204.

23 47. At all material times set forth herein, Defendants failed to provide complete
24 and accurate wage statements to Plaintiff and the other aggrieved employees.

25 48. At all material times set forth herein, Defendants failed to keep complete and
26 accurate payroll records for Plaintiff and the other aggrieved employees.

27 49. At all material times set forth herein, Defendants failed to reimburse Plaintiff
28 and the other aggrieved employees for necessary business-related expenses and costs.

1 50. At all material times set forth herein, Defendants failed to properly
2 compensate Plaintiff and the other aggrieved employees pursuant to California law in order
3 to increase Defendants' profits.

4 51. California Labor Code section 218 states that noting in Article 1 of the Labor
5 Code shall limit the right of any wage claimant to “sue directly . . . for any wages or penalty
6 due to him [or her] under this article.”

FIRST CAUSE OF ACTION

Violation of California Labor Code § 2698, et seq.

**(Against ALLIANCE ENVIRONMENTAL GROUP, LLC, OPM SERVICES, LLC,
ALLIANCE ENVIRONMENTAL HOLDINGS, LLC, AIRTEK INDOOR AIR
SOLUTIONS, LLC, and DOES 1 through 100)**

12 52. Plaintiff incorporates by reference the allegations contained in paragraphs 1
13 through 51, and each and every part thereof with the same force and effect as though fully set
14 forth herein.

53. PAGA expressly establishes that any provision of the California Labor Code which provides for a civil penalty to be assessed and collected by the LWDA or any of its departments, divisions, commissions, boards, agencies, or employees for a violation of the California Labor Code, may be recovered through a civil action brought by an aggrieved employee on behalf of himself or herself and other current or former employees.

54. Whenever the LWDA or any of its departments, divisions, commissions, boards, agencies, or employees has discretion to assess a civil penalty, a court in a civil action is authorized to exercise the same discretion, subject to the same limitations and conditions, to assess a civil penalty.

55. Plaintiff and the other hourly-paid or non-exempt employees are “aggrieved employees” as defined by California Labor Code section 2699(c) in that they are all current or former employees of Defendants, and the alleged violations were committed against them.

Failure to Pay Overtime

56. Defendants' failure to pay legally required overtime wages to Plaintiff and the other aggrieved employees is in violation of the IWC Wage Orders and constitutes a violation of California Labor Code sections 510 and 1198.

Failure to Provide Meal Periods

57. Defendants' failure to provide legally required meal periods to Plaintiff and the other aggrieved employees is in violation of the IWC Wage Orders and constitutes a violation of California Labor Code sections 226.7 and 512(a).

Failure to Provide Rest Periods

58. Defendants' failure to provide legally required rest periods to Plaintiff and the other aggrieved employees is in violation of the IWC Wage Orders and constitutes a violation of California Labor Code section 226.7.

Failure to Pay Minimum Wages

59. Defendants' failure to pay legally required minimum wages to Plaintiff and the other aggrieved employees is in violation of the IWC Wage Orders and constitutes a violation of California Labor Code sections 1194, 1197, and 1197.1.

Failure to Timely Pay Wages Upon Termination

60. Defendants' failure to timely pay wages to Plaintiff and the other aggrieved employees upon termination in accordance with Labor Code sections 201 and 202 constitutes a violation of California Labor Code sections 201 and 202.

Failure to Timely Pay Wages During Employment

61. Defendants' failure to timely pay wages to Plaintiff and the other aggrieved employees during employment in accordance with Labor Code section 204 constitutes a violation of California Labor Code section 204.

Failure to Provide Complete and Accurate Wage Statements

62. Defendants' failure to provide complete and accurate wage statements to Plaintiff and the other aggrieved employees in accordance with Labor Code section 226(a) constitutes a violation of California Labor Code section 226(a).

Failure to Keep Complete and Accurate Payroll Records

63. Defendants' failure to keep complete and accurate payroll records relating to Plaintiff and the other aggrieved employees in accordance with California Labor Code section 1174(d) constitutes a violation of California Labor Code section 1174(d).

Failure to Reimburse Necessary Business-Related Expenses and Costs

64. Defendants' failure to reimburse Plaintiff and the other aggrieved employees for necessary business-related expenses and costs in accordance with California Labor Code sections 2800 and 2802 constitutes a violation of California Labor Code sections 2800 and 2802.

65. Pursuant to California Labor Code section 2699, Plaintiff, individually, and on behalf of all aggrieved employees, requests and is entitled to recover from Defendants, and each of them, attorneys' fees and costs pursuant to California Labor Code section 218.5, as well as all penalties pursuant to PAGA against Defendants, and each of them, including but not limited to:

- a. Penalties under California Labor Code section 2699(f) in the amount of one hundred dollars (\$100) for each aggrieved employee per pay period or two hundred dollars (\$200) for each aggrieved employee per pay period for each violation where there has been a prior finding or determination that Defendants' policies or practices were unlawful or where Defendants' conduct was malicious, fraudulent, or oppressive;
- b. Penalties under California Code of Regulations Title 8 section 11010, et seq. in the amount of fifty dollars (\$50) for each aggrieved employee per pay period for the initial violation, and one hundred dollars (\$100) for each aggrieved employee per pay period for each subsequent violation;
- c. Penalties under California Labor Code section 210 in addition to, and entirely independent and apart from, any other penalty provided in the California Labor Code in the amount of one hundred dollars (\$100) for each aggrieved employee per pay period for the initial violation, and two

hundred dollars (\$200) for each aggrieved employee per pay period for each subsequent violation; and

d. Any and all additional penalties and sums as provided by the California Labor Code and/or other statutes.

66. Pursuant to California Labor Code section 2699(m), civil penalties recovered by aggrieved employees shall be distributed as follows: sixty-five percent (65%) to the LWDA for the enforcement of labor laws and education of employers and employees about their rights and responsibilities and thirty-five percent (35%) to the aggrieved employees.

67. Further, Plaintiff is entitled to seek and recover reasonable attorneys' fees and costs pursuant to California Labor Code sections 210, 218.5, 2699, and any other applicable statute.

PRAYER FOR RELIEF

WHEREFORE, Plaintiff, individually, and on behalf of other aggrieved employees pursuant to the Private Attorneys General Act, prays for relief and judgment against Defendants, jointly and severally, in excess of twenty-five thousand dollars (\$25,000):

As to the First Cause of Action

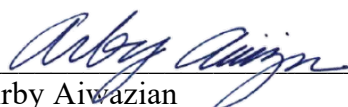
1. For civil penalties pursuant to California Labor Code sections 2699(a), (f), (k), and 558, plus costs/expenses and attorneys' fees for violation of California Labor Code sections 201, 202, 203, 204, 226(a), 226.7, 510, 512(a), 1174(d), 1194, 1197, 1197.1, 1198, 2800, and 2802; and

2. For such other and further relief as the Court may deem equitable and appropriate.
