JOINT STIPULATION OF CLASS ACTION AND PAGA SETTLEMENT AND RELEASE

This Joint Stipulation of Class Action and PAGA Settlement and Release (“Settlement” or “Settlement Agreement”) is made and entered into by and between Plaintiff Leonel Ramirez (“Plaintiff” or “Class Representative”), as an individual and on behalf of all others similarly situated, and Defendant So Cal Sanitation LLC (“Defendant”) (collectively with Plaintiff, the “Parties”).

DEFINITIONS

The following definitions are applicable to this Settlement Agreement. Definitions contained elsewhere in this Settlement Agreement will also be effective:

1. “Action” means *Ramirez v. So Cal Sanitation, LLC*, No. 23STCV08845 (Los Angeles County Superior Court).

2. “Attorneys’ Fees and Costs” means attorneys’ fees agreed upon by the Parties and approved by the Court for Class Counsel’s litigation and resolution of the Action, and all out-of-pocket costs incurred and to be incurred by Class Counsel in the Action, including but not limited to expert/consultant fees, investigation costs, and costs associated with documenting the Settlement, providing any notices required as part of the Settlement or Court order, securing the Court’s approval of the Settlement, administering the Settlement, and obtaining entry of a Judgment terminating the Action. Class Counsel will request attorneys’ fees not in excess of one-third (1/3) of the Gross Settlement Amount, or Three Hundred Fifty Thousand Dollars (\$350,000). The Attorneys’ Fees and Costs will also mean and include the additional reimbursement of any costs and expenses associated with Class Counsel’s litigation and settlement of the Action, up to Fifteen Thousand Dollars (\$15,000), subject to the Court’s approval. Defendant has agreed not to oppose Class Counsel’s request for fees and reimbursement of costs as set forth above.

3. “Class Counsel” means Capstone Law APC.

4. “Class List” means a complete list of all Class Members that Defendant will diligently and in good faith compile from its records and provide to the Settlement Administrator and Class Counsel within twenty (20) calendar days after Preliminary Approval of this Settlement. The Class List will be formatted in Microsoft Office Excel and will include each Class Member’s full name; most recent mailing address and telephone number; Social Security number; dates of employment; the

respective number of Workweeks that each Class Member worked during the Class Period and PAGA Period; and any other relevant information needed to calculate settlement payments.

5. “Class Member(s)” or “Settlement Class” means all persons who were employed by Defendant as non-exempt, hourly paid employees in the State of California at any time during the Class Period.

6. “Class Notice” means the Notice of Class Action Settlement, substantially in the form attached as Exhibit A.

7. “Class Period” means the period from April 20, 2019 through the earlier of (a) February 16, 2025 or (b) the date of Preliminary Approval.

8. “Class Representative Enhancement Payment” means the amount to be paid to Plaintiff in recognition of his effort and work in prosecuting the Action on behalf of Class Members. Subject to the Court granting final approval of this Settlement Agreement and subject to the exhaustion of any and all appeals, Plaintiff will request Court approval of a Class Representative Enhancement Payment of up to Five Thousand Dollars (\$5,000).

9. “Court” means the Los Angeles County Superior Court.

10. “Defendant” means Defendant So Cal Sanitation LLC.

11. “Effective Date” means the later of: (a) if no timely objections are filed, or are withdrawn prior to Final Approval, then the date of Final Approval; or (b) if a Class Member files an objection to the Settlement, the Effective Date shall be the sixty-first (61st) calendar day after the date of Final Approval, provided no appeal is initiated by an objector; or (c) if a timely appeal is initiated by an objector, then the Effective Date will be the date of final resolution of that appeal (including any requests for rehearing and/or petitions for certiorari), resulting in final judicial approval of the Settlement.

12. “Final Approval” means the date on which the Court enters an order granting final approval of the Settlement Agreement.

13. “General Release Payment” means the amount to be paid to Plaintiff for a general release of all claims arising out of his employment with Defendant. Subject to the Court granting final approval of this Settlement Agreement and subject to the exhaustion of any and all appeals, Plaintiff will request Court approval of a General Release Payment of up to Five Thousand Dollars (\$5,000).

14. “Gross Settlement Amount” means the Gross Settlement Amount of One Million Fifty Thousand Dollars (\$1,050,000), to be paid by Defendant in full satisfaction of all Released Class Claims and Released PAGA Claims, which includes all Individual Settlement Payments, Attorneys’ Fees and Costs, the Class Representative Enhancement Payment, the General Release Payment, the PAGA Settlement Amount, and Settlement Administration Costs. This Gross Settlement Amount has been agreed to by Plaintiff and Defendant based on the aggregation of the agreed-upon settlement value of individual claims. In no event will Defendant be liable for more than the Gross Settlement Amount except as otherwise explicitly set forth herein. There will be no reversion of the Gross Settlement Amount to Defendant. Defendant will be separately responsible for any employer payroll taxes required by law, including the employer FICA, FUTA, and SDI contributions, which shall not be paid from the Gross Settlement Amount.

15. “Individual Settlement Payment” means each Participating Class Member’s and PAGA Member’s respective shares of the Net Settlement Fund and PAGA Fund.

16. “Net Settlement Fund” means the portion of the Gross Settlement Amount remaining after deducting the Attorneys’ Fees and Costs, the Class Representative Enhancement Payment, the General Release Payment, the PAGA Settlement Amount, and Settlement Administration Costs. The Net Settlement Fund will be distributed to Participating Class Members. There will be no reversion of the Net Settlement Fund to Defendant.

17. “Notice of Objection” means a Class Member’s valid and timely written objection to the Settlement Agreement. For the Notice of Objection to be valid, it must include: (a) the objector’s full name, signature, address, and telephone number, (b) a written statement of all grounds for the objection accompanied by any legal support for such objection; (c) copies of any papers, briefs, or other documents upon which the objection is based; and (d) a statement whether the objector intends to appear at the final fairness hearing.

18. “PAGA Members” means all persons who were employed by Defendant as non-exempt, hourly paid employees in the State of California at any time during the PAGA Period.

19. “PAGA Period” means the period from May 24, 2023 through the earlier of (a) February 16, 2025 or (b) the date of Preliminary Approval.

20. “PAGA Settlement Amount” means the amount that the Parties have agreed to pay to the Labor and Workforce Development Agency (“LWDA”) and PAGA Members in connection with Plaintiff’s claim under the Labor Code Private Attorneys General Act of 2004 (Cal. Lab. Code §§ 2698, *et seq.*, “PAGA”) (“PAGA Settlement”). The Parties have agreed that One Hundred Thousand Dollars (\$100,000) of the Gross Settlement Amount will be allocated to the PAGA Settlement. Pursuant to PAGA, Seventy-Five Percent (75%), or Seventy Five Thousand Dollars (\$75,000), of the PAGA Settlement Amount will be paid to the California Labor and Workforce Development Agency (“Labor and Workforce Development Agency Payment”), and Twenty-Five Percent (25%), or Twenty Five Thousand Dollars (\$25,000) (“PAGA Fund”), of the PAGA Settlement will be disbursed to PAGA Members, and regardless whether they request to be excluded from the Settlement Class.

21. “Parties” means Plaintiff and Defendant collectively.

22. “Participating Class Members” means all Class Members who do not submit timely and valid Requests for Exclusion.

23. “Plaintiff” means Plaintiff Leonel Ramirez.

24. “Preliminary Approval” means the date on which the Court enters an order granting preliminary approval of the Settlement Agreement.

25. “Released Class Claims” means all claims, rights, demands, liabilities, and causes of action that are asserted in the operative Complaint, or that could have been asserted based on the facts alleged in the operative Complaint, including claims for violation of: (1) Labor Code sections 510 and 1198 (unpaid overtime); (2) Labor Code sections 1182.12, 1194, 1197, 1197.1, and 1198 (unpaid minimum wages); (3) Labor Code sections 226.7, 512(a), 516, and 1198 (failure to provide meal periods); (4) Labor Code sections 226.7, 516, and 1198 (failure to authorize and permit rest periods); (5) Labor Code sections 226.7, 516, and 1198 (failure to provide recovery periods); (6) Labor Code sections 226(a), 1174(d), and 1198 (non-compliant wage statements and failure to maintain accurate payroll records); (7) Labor Code sections 201 and 202 (wages not timely paid upon termination); (8) Section 204 (failure to timely pay wages during employment); (9) Labor Code section 2802 (unreimbursed business expenses); (10) California Business & Professions Code sections 17200, *et seq.* (unlawful business practices); and (11) California Business & Professions Code sections 17200, *et seq.* (unfair

1 business practices).

2 26. “Released PAGA Claims” means all claims for civil penalties under California Labor
3 Code §§ 2698, *et seq.*, that were brought or could reasonably have been brought based on the same facts
4 alleged in Plaintiff’s LWDA letter during the PAGA Period.

5 27. “Released Parties” means Defendant, its past or present officers, directors, shareholders,
6 agents, principals, heirs, representatives, accountants, auditors, consultants, insurers and reinsurers, and
7 its respective successors and predecessors in interest, subsidiaries, affiliates, parents and attorneys, if any.

8 28. “Request for Exclusion” means a timely letter submitted by a Class Member indicating a
9 request to be excluded from the Settlement Class. The Request for Exclusion must: (a) set forth the
10 name, address, telephone number and last four digits of the Social Security Number of the Class
11 Member requesting exclusion; (b) be signed by the Class Member; (c) be returned to the Settlement
12 Administrator; (d) clearly state that the Class Member does not wish to be included in the Settlement;
13 and (e) be faxed or postmarked on or before the Response Deadline.

14 29. “Response Deadline” means the deadline by which Class Members must postmark or
15 fax to the Settlement Administrator Requests for Exclusion, postmark or fax disputes concerning the
16 calculation of Individual Settlement Payments, or postmark Notices of Objection to the Settlement
17 Administrator. The Response Deadline will be forty-five (45) calendar days from the initial mailing of
18 the Class Notice by the Settlement Administrator, unless the forty-fifth (45th) calendar day falls on a
19 Sunday or State holiday, in which case the Response Deadline will be extended to the next day on which
20 the U.S. Postal Service is open.

21 30. “Settlement Administration Costs” means the costs payable from the Gross Settlement
22 Amount to the Settlement Administrator for administering this Settlement, including, but not limited to,
23 printing, distributing, and tracking documents for this Settlement, tax reporting, distributing the Gross
24 Settlement Amount, and providing necessary reports and declarations, as requested by the Parties. The
25 Settlement Administration Costs will be paid from the Gross Settlement Amount, including, if necessary,
26 any such costs in excess of the amount represented by the Settlement Administrator as being the
27 maximum costs necessary to administer the Settlement. Based on an estimated Settlement Class of
28 approximately Three Hundred Fifty (350) Class Members, the Settlement Administration Costs are

1 currently estimated to be Eight Thousand Two Hundred Fifty Dollars (\$8,250).

2 31. "Settlement Administrator" means CPT Group, Inc., or any other third-party class action
3 settlement administrator agreed to by the Parties and approved by the Court for the purposes of
4 administering this Settlement. The Parties each represent that they do not have any financial interest in
5 the Settlement Administrator or otherwise have a relationship with the Settlement Administrator that
6 could create a conflict of interest.

7 32. "Workweeks" means the number of days of employment for each Class Member during
8 the Class Period, subtracting days on leave of absence (if any), dividing by seven (7), and rounding up to
9 the nearest whole number. All Class Members will be credited with at least one Workweek during the
10 Class Period, and all PAGA Members will be credited with at least one Workweek during the PAGA
11 Period.

12 TERMS OF AGREEMENT

13 The Plaintiff, on behalf of himself and the Settlement Class, and Defendant agree as follows:

14 33. Funding of the Gross Settlement Amount. Defendant will make a one-time deposit of
15 the Gross Settlement Amount of One Million Fifty Thousand Dollars (\$1,050,000) into a Qualified
16 Settlement Account to be established by the Settlement Administrator. Defendant will pay the
17 employer's share of payroll taxes separately. After the Effective Date, the Gross Settlement Amount will
18 be used for: (a) Individual Settlement Payments; (b) the Labor and Workforce Development Agency
19 Payment; (c) the Class Representative Enhancement Payment and General Release Payment; (d)
20 Attorneys' Fees and Costs; and (e) Settlement Administration Costs. Defendant will deposit the Gross
21 Settlement Amount and the employer's share of payroll taxes within thirty (30) calendar days of the
22 Effective Date ("Funding Date").

23 34. Attorneys' Fees and Costs. Defendant agrees not to oppose or impede any application or
24 motion for attorneys' fees and costs by Class Counsel for Attorneys' Fees and Costs of not more than
25 Three Hundred Fifty Thousand Dollars (\$350,000), plus the reimbursement of all out-of-pocket costs
26 and expenses associated with Class Counsel's litigation and settlement of the Action (including
27 expert/consultant fees, investigations costs, etc.), not to exceed Fifteen Thousand Dollars (\$15,000), both
28 of which will be paid from the Gross Settlement Amount.

1 35. Class Representative Enhancement Payment. In recognition of his effort and work in
2 prosecuting the Action on behalf of Class Members, Defendant agrees not to oppose or impede any
3 application or motion for a Class Representative Enhancement Payment of up to Five Thousand Dollars
4 (\$5,000). The Class Representative Enhancement Payment will be paid from the Gross Settlement
5 Amount and will be in addition to Plaintiff's Individual Settlement Payment and General Release
6 Payment paid pursuant to the Settlement. Plaintiff will be solely and legally responsible to pay any and
7 all applicable taxes on the Class Representative Enhancement Payment. Plaintiff understands and agrees
8 that this Settlement Agreement shall remain in full force and effect even if the full amount of Class
9 Representative Enhancement Payment sought by Plaintiff is not ultimately awarded by the Court.

10 36. General Release Payment. In exchange for a general release of all claims arising out of
11 his employment with Defendant, Defendant agrees not to oppose or impede any application or motion
12 for a General Release Payment of up to Five Thousand Dollars (\$5,000). The General Release Payment
13 will be paid from the Gross Settlement Amount and will be in addition to Plaintiff's Individual
14 Settlement Payment and Class Representative Enhancement Payment paid pursuant to the Settlement.
15 Plaintiff will be solely and legally responsible to pay any and all applicable taxes on the General Release
16 Payment. Plaintiff understands and agrees that this Settlement Agreement shall remain in full force and
17 effect even if the full amount of General Release Payment sought by Plaintiff is not ultimately awarded
18 by the Court.

19 37. Settlement Administration Costs. The Settlement Administrator will be paid for the
20 reasonable costs of administration of the Settlement and distribution of payments from the Gross
21 Settlement Amount, which is currently estimated to be Eight Thousand Two Hundred Fifty Dollars
22 (\$8,250). These costs, which will be paid from the Gross Settlement Amount, will include, *inter alia*, the
23 required tax reporting on the Individual Settlement Payments, the issuing of 1099 and W-2 IRS Forms,
24 distributing Class Notices, calculating and distributing the Gross Settlement Amount, and providing
25 necessary reports and declarations.

26 38. PAGA Settlement Amount. Subject to Court approval, the Parties agree that the amount
27 of One Hundred Thousand Dollars (\$100,000) from the Gross Settlement Amount will be designated for
28 satisfaction of Plaintiff's PAGA claim. Pursuant to PAGA, Seventy-Five Percent (75%), or Seventy-

Five Thousand Dollars (\$75,000), of this sum will be paid to the LWDA and Twenty-Five Percent (25%), or Twenty-Five Thousand Dollars (\$25,000), will be paid to PAGA Members in proportion to the number of Workweeks worked during the PAGA Period.

39. No Right to Exclusion or Objections to the PAGA Settlement. Because this settlement resolves claims and actions brought pursuant to PAGA by Plaintiff acting as a proxy and as a Private Attorney General of, and for, the State of California and the LWDA, the Parties agree that no PAGA Member has the right to exclude himself or herself from the release of the Released PAGA Claims, and all PAGA Members will receive their shares of the PAGA Fund. The Parties also agree that no PAGA Member has the right to object to the PAGA Settlement Amount.

40. Net Settlement Fund. The entire Net Settlement Fund will be distributed to Participating Class Members. No portion of the Net Settlement Fund will revert to or be retained by Defendant.

41. PAGA Fund. The entire PAGA Fund will be distributed to all PAGA Members. No portion of the PAGA Fund will revert to or be retained by Defendant.

42. Individual Settlement Payment Calculations. Individual Settlement Payments will be calculated and apportioned from the Net Settlement Fund and PAGA Fund based on the number of Workweeks a Class Member worked during the Class Period and PAGA Period. Specific calculations of Individual Settlement Payments will be made as follows:

42(a) Payments from the Net Settlement Fund. Defendant will calculate the total number of Workweeks worked by each Class Member during the Class Period and the aggregate total number of Workweeks worked by all Class Members during the Class Period. To determine each Class Member's estimated "Individual Settlement Payment" from the Net Settlement Fund, the Settlement Administrator will use the following formula: The Net Settlement Fund will be divided by the aggregate total number of Workweeks during the Class Period, resulting in the "Workweek Value." Each Class Member's "Individual Settlement Payment" will be calculated by multiplying each individual Class Member's total number of Workweeks by the Workweek Value. The Individual Settlement Payment will be

reduced by any required deductions for each Participating Class Member as specifically set forth herein, including employee-side tax withholdings or deductions. The entire Net Settlement Fund will be disbursed to all Class Members who do not submit timely and valid Requests for Exclusion. If there are any valid and timely Requests for Exclusion, the Settlement Administrator shall proportionately increase the Individual Settlement Payment for each Participating Class Member according to the number of Workweeks worked, so that the amount actually distributed to the Settlement Class equals 100% of the Net Settlement Fund.

42(b) Payments from the PAGA Fund. Defendant will calculate the total number of Workweeks worked by each PAGA Member during the PAGA Period and the aggregate total number of Workweeks worked by all PAGA Members during the PAGA Period. To determine each PAGA Member's estimated "Individual Settlement Payment," the Settlement Administrator will use the following formula: The PAGA Fund will be divided by the aggregate total number of Workweeks during the PAGA Period, resulting in the "PAGA Workweek Value." Each PAGA Member's "Individual Settlement Payment" will be calculated by multiplying each individual PAGA Member's total number of Workweeks by the PAGA Workweek Value. The entire PAGA Fund will be disbursed to all PAGA Members.

43. No Credit Toward Benefit Plans. The Individual Settlement Payments made to Participating Class Members under this Settlement, as well as any other payments made pursuant to this Settlement, will not be utilized to calculate any additional benefits under any benefit plans to which any Class Members may be eligible, including, but not limited to profit-sharing plans, bonus plans, 401(k) plans, stock purchase plans, vacation plans, sick leave plans, PTO plans, and any other benefit plan. Rather, it is the Parties' intention that this Settlement Agreement will not affect any rights, contributions, or amounts to which any Class Members may be entitled under any benefit plans.

44. Administration Process. The Parties agree to cooperate in the administration of the

settlement and to make all reasonable efforts to control and minimize the costs and expenses incurred in administration of the Settlement.

45. Delivery of the Class List. Within twenty (20) calendar days of Preliminary Approval, Defendant will provide the Class List to the Settlement Administrator and to Class Counsel.

46. Notice by First-Class U.S. Mail. Within ten (10) calendar days after receiving the Class List from Defendant, the Settlement Administrator will mail a Class Notice to all Class Members via regular First-Class U.S. Mail, using the most current, known mailing addresses identified in the Class List.

47. Confirmation of Updated Contact Information in the Class Lists. Prior to mailing, the Settlement Administrator will perform a search based on the National Change of Address Database for information to update and correct for any known or identifiable address changes. Any Class Notices returned to the Settlement Administrator as non-deliverable on or before the Response Deadline will, within five (5) business days of receipt, be sent promptly via regular First-Class U.S. Mail to the forwarding address affixed thereto and the Settlement Administrator will indicate the date of such re-mailing on the Class Notice. If no forwarding address is provided, the Settlement Administrator will promptly attempt to determine the correct address using a skip-trace, or other search using the name, address and/or Social Security Number of the Class Member involved, and will then perform a single re-mailing. Those Class Members who receive a re-mailed Class Notice, whether by skip-trace or by request, will have either (a) an additional fifteen (15) calendar days or (b) until the Response Deadline, whichever is later, to submit a Request for Exclusion or an objection to the Settlement.

48. Class Notices. All Class Members will be mailed a Class Notice. Each Class Notice will provide: (a) information regarding the nature of the Action; (b) a summary of the Settlement's principal terms; (c) the Settlement Class and PAGA Member definitions; (d) the total number of Workweeks each respective Class Member and PAGA Member worked for Defendant during the Class Period and PAGA Period; (e) each Class Member's and PAGA Member's estimated Individual Settlement Payment and the formula for calculating Individual Settlement Payments; (f) the dates which comprise the Class Period and PAGA Period; (g) instructions on how to submit Requests for Exclusion or Notices of Objection; (h) the deadlines by which the Class Member must postmark or fax Request for Exclusions,

or postmark Notices of Objection to the Settlement; and (i) the claims to be released.

49. Disputed Information on Class Notices. Class Members will have an opportunity to dispute the information provided in their Class Notices. To the extent Class Members dispute their employment dates or the number of Workweeks on record, Class Members may produce evidence to the Settlement Administrator showing that such information is inaccurate. Defendant's records will be presumed correct, but the Settlement Administrator shall contact the Parties regarding the dispute and the Parties will work in good faith to resolve it. All disputes must be submitted by the Response Deadline, and will be decided within ten (10) business days after the Response Deadline.

50. Defective Submissions. If a Class Member's Request for Exclusion is defective as to the requirements listed herein, that Class Member will be given an opportunity to cure the defect(s). The Settlement Administrator will mail the Class Member a cure letter within three (3) business days of receiving the defective submission to advise the Class Member that his/her/their submission is defective and that the defect must be cured to render the Request for Exclusion valid. The Class Member will have until (a) the Response Deadline or (b) fifteen (15) calendar days from the date of the cure letter, whichever date is later, to postmark or fax a revised Request for Exclusion. If the revised Request for Exclusion is not postmarked or received by fax within that period, it will be deemed untimely.

51. Request for Exclusion Procedures. Any Class Member wishing to opt-out from the Settlement Agreement must sign and fax or postmark a written Request for Exclusion to the Settlement Administrator within the Response Deadline. In the case of Requests for Exclusion that are mailed to the Settlement Administrator, the postmark date will be the exclusive means to determine whether a Request for Exclusion has been timely submitted.

52. Escalator. The Gross Settlement Amount was calculated with, and is premised on, the understanding that Class Members worked approximately Thirty-Nine Thousand Four Hundred Fifty-Eight (39,458) Workweeks during the Class Period. If the actual number of Workweeks eligible to participate in the Settlement is ten percent (10%) higher or 3,946 workweeks worked, then the Gross Settlement Amount will be increased by the same proportion above ten percent (10%).

53. Settlement Terms Bind All Class Members Who Do Not Opt-Out. Any Class Member who does not affirmatively opt-out of the Settlement Agreement by submitting a timely and valid

1 Request for Exclusion will be bound by all of its terms, including those pertaining to the Released Class
2 Claims, as well as any Judgment that may be entered by the Court if it grants final approval to the
3 Settlement.

4 54. Releases by Participating Class Members. Upon the Funding Date, and except as to such
5 rights or claims as may be created by this Settlement Agreement, each Participating Class Member,
6 together and individually, on their behalf and on behalf of their respective heirs, executors,
7 administrators, agents, and attorneys, shall fully and forever release and discharge all of the Released
8 Parties, or any of them, from each of the Released Class Claims arising during the Class Period.

9 55. Releases by PAGA Members. Upon the Funding Date, and except as to such rights or
10 claims as may be created by this Settlement Agreement, each PAGA Member, together and individually,
11 on their behalf and on behalf of their respective heirs, executors, administrators, agents, and attorneys,
12 shall fully and forever release and discharge all of the Released Parties, or any of them, from each of the
13 Released PAGA Claims during the PAGA Period.

14 56. Defendant's Right to Rescind. Defendant will have, in its sole discretion, the right to
15 void and withdraw from the Settlement within thirty (30) days after the expiration of the opt out period, if
16 ten percent (10%) or more of the Class Members opt out of the settlement. If the option to rescind is
17 exercised, then Defendant will be solely responsible for all Settlement Administration Costs incurred to
18 the date of rescission.

19 57. Objection Procedures. To object to the Settlement Agreement, a Class Member may
20 either postmark a valid Notice of Objection to the Settlement Administrator on or before the Response
21 Deadline, or appear in person at the Final Approval Hearing. Class Members who fail to object either by
22 submitting a valid Notice of Objection or appearing in person at the Final Approval Hearing will be
23 deemed to have waived all objections to the Settlement and will be foreclosed from making any
24 objections, whether by appeal or otherwise, to the Settlement Agreement. At no time will any of the
25 Parties or their counsel seek to solicit or otherwise encourage Class Members to submit written
26 objections to the Settlement Agreement or appeal from the final approval order and judgment. Class
27 Counsel will not represent any Class Members with respect to any such objections to this Settlement. If a
28 Class Member timely submits both a Notice of Objection and a Request for Exclusion, the Request for

1 Exclusion will be given effect and considered valid, the Notice of Objection shall be rejected, and the
2 Class Member shall not participate in or be bound by the Settlement.

3 58. Certification Reports Regarding Individual Settlement Payment Calculations. The
4 Settlement Administrator will provide Defendant's counsel and Class Counsel a weekly report that
5 certifies the number of Class Members who have submitted valid Requests for Exclusion or objections to
6 the Settlement, and whether any Class Member has submitted a challenge to any information contained
7 in their Class Notice, including those received after the Response Deadline. Additionally, the Settlement
8 Administrator will provide to counsel for both Parties any updated reports regarding the administration
9 of the Settlement Agreement as needed or requested.

10 59. Distribution Timing of Individual Settlement Payments. Within ten (10) calendar days
11 of the Funding Date, the Settlement Administrator will issue payments to: (a) Participating Class
12 Members and PAGA Members; (b) the Labor and Workforce Development Agency; (c) Plaintiff; and
13 (d) Class Counsel. The Settlement Administrator will also issue a payment to itself for Court-approved
14 services performed in connection with the Settlement.

15 60. Un-cashed Settlement Checks. Proceeds represented by Individual Settlement Payment
16 checks returned as undeliverable and Individual Settlement Payment checks remaining un-cashed for
17 more than one hundred and eighty (180) calendar days after issuance will be tendered to the State
18 Controller's Office, Unclaimed Property Fund in the name of those Class Members/PAGA Members
19 who did not cash their checks.

20 61. Certification of Completion. Upon completion of administration of the Settlement, the
21 Settlement Administrator will provide a written declaration under oath to certify such completion to the
22 Court and counsel for all Parties.

23 62. Treatment of Individual Settlement Payments. All Individual Settlement Payments will
24 be allocated as follows: (a) Twenty Percent (20%) of each Individual Settlement Payment will be
25 allocated as wages for which IRS Forms W-2 will be issued; and (b) Eighty Percent (80%) will be
26 allocated as non-wages for which IRS Forms 1099-MISC will be issued. Payments issued to PAGA
27 Members from the PAGA Fund will be treated as non-wages for which IRS Forms 1099-MISC will be
28 issued.

63. Administration of Taxes by the Settlement Administrator. The Settlement Administrator will be responsible for issuing to Plaintiff, Participating Class Members, PAGA Members, and Class Counsel any W-2, 1099, or other tax forms as may be required by law for all amounts paid pursuant to this Settlement. The Settlement Administrator will also be responsible for forwarding all payroll taxes and penalties to the appropriate government authorities.

64. Tax Liability. The Parties make no representation as to the tax treatment or legal effect of the payments called for hereunder, and Plaintiff, Participating Class Members, and PAGA Members are not relying on any statement, representation, or calculation by Defendant or by the Settlement Administrator in this regard.

65. Circular 230 Disclaimer. EACH PARTY TO THIS AGREEMENT (FOR PURPOSES OF THIS SECTION, THE “ACKNOWLEDGING PARTY” AND EACH PARTY TO THIS AGREEMENT OTHER THAN THE ACKNOWLEDGING PARTY, AN “OTHER PARTY”) ACKNOWLEDGES AND AGREES THAT (1) NO PROVISION OF THIS AGREEMENT, AND NO WRITTEN COMMUNICATION OR DISCLOSURE BETWEEN OR AMONG THE PARTIES OR THEIR ATTORNEYS AND OTHER ADVISERS, IS OR WAS INTENDED TO BE, NOR WILL ANY SUCH COMMUNICATION OR DISCLOSURE CONSTITUTE OR BE CONSTRUED OR BE RELIED UPON AS, TAX ADVICE WITHIN THE MEANING OF UNITED STATES TREASURY DEPARTMENT CIRCULAR 230 (31 CFR PART 10, AS AMENDED); (2) THE ACKNOWLEDGING PARTY (A) HAS RELIED EXCLUSIVELY UPON HIS, HER, OR ITS OWN, INDEPENDENT LEGAL AND TAX COUNSEL FOR ADVICE (INCLUDING TAX ADVICE) IN CONNECTION WITH THIS AGREEMENT, (B) HAS NOT ENTERED INTO THIS AGREEMENT BASED UPON THE RECOMMENDATION OF ANY OTHER PARTY OR ANY ATTORNEY OR ADVISOR TO ANY OTHER PARTY, AND (C) IS NOT ENTITLED TO RELY UPON ANY COMMUNICATION OR DISCLOSURE BY ANY ATTORNEY OR ADVISER TO ANY OTHER PARTY TO AVOID ANY TAX PENALTY THAT MAY BE IMPOSED ON THE ACKNOWLEDGING PARTY; AND (3) NO ATTORNEY OR ADVISER TO ANY OTHER PARTY HAS IMPOSED ANY LIMITATION THAT PROTECTS THE CONFIDENTIALITY OF ANY SUCH ATTORNEY’S OR ADVISER’S TAX STRATEGIES (REGARDLESS OF WHETHER

5 66. No Prior Assignments. The Parties and their counsel represent, covenant, and warrant
6 that they have not directly or indirectly assigned, transferred, encumbered, or purported to assign,
7 transfer, or encumber to any person or entity any portion of any liability, claim, demand, action, cause of
8 action or right herein released and discharged.

9 67. Nullification of Settlement Agreement. In the event that: (a) the Court does not finally
10 approve the Settlement as provided herein; or (b) the Settlement does not become final for any other
11 reason, then this Settlement Agreement, and any documents generated to bring it into effect, will be null
12 and void. Any order or judgment entered by the Court in furtherance of this Settlement Agreement will
13 likewise be treated as void from the beginning.

14 68. Preliminary Approval Hearing. Plaintiff will obtain a hearing before the Court to request
15 the Preliminary Approval of the Settlement Agreement, and the entry of a Preliminary Approval Order
16 for: (a) conditional certification of the Settlement Class for settlement purposes only, (b) preliminary
17 approval of the proposed Settlement Agreement, (c) setting a date for a final fairness hearing. The
18 Preliminary Approval Order will provide for the Class Notice to be sent to all Class Members as
19 specified herein. In conjunction with the Preliminary Approval hearing, Plaintiff will submit this
20 Settlement Agreement, which sets forth the terms of this Settlement, and will include the proposed
21 Notice of Class Action Settlement, attached as Exhibit A. Class Counsel will be responsible for drafting
22 all documents necessary to obtain preliminary approval.

23 69. Final Settlement Approval Hearing and Entry of Judgment. Upon expiration of the
24 deadlines to postmark Requests for Exclusion or objections to the Settlement Agreement, and with the
25 Court's permission, a final fairness hearing will be conducted to determine the Final Approval of the
26 Settlement Agreement along with the amounts properly payable for: (a) Attorneys' Fees and Costs; (b)
27 the Class Representative Enhancement Payment and General Release Payment; (c) Individual
28 Settlement Payments; (d) the Labor and Workforce Development Agency Payment; (e) all Settlement

Administration Costs. Class Counsel will be responsible for drafting all documents necessary to obtain final approval. Class Counsel will also be responsible for drafting the attorneys' fees and costs application to be heard at the final approval hearing.

70. Judgment and Continued Jurisdiction. Upon final approval of the Settlement by the Court or after the final fairness hearing, the Parties will present the Judgment to the Court for its approval. After entry of the Judgment, the Court will have continuing jurisdiction solely for purposes of addressing: (a) the interpretation and enforcement of the terms of the Settlement, (b) Settlement administration matters, and (c) such post-Judgment matters as may be appropriate under court rules or as set forth in this Settlement Agreement. A copy of the Judgment will be posted to the Settlement Administrator's website.

71. Release by Plaintiff. Upon the Funding Date, in addition to the claims being released by all Participating Class Members, Plaintiff will release and forever discharge the Released Parties, to the fullest extent permitted by law, of and from any and all claims, known and unknown, asserted and not asserted, which Plaintiff has or may have against the Released Parties as of the date of execution of this Settlement Agreement. To the extent the foregoing release is a release to which Section 1542 of the California Civil Code or similar provisions of other applicable law may apply, Plaintiff expressly waives any and all rights and benefits conferred upon him by the provisions of Section 1542 of the California Civil Code or similar provisions of applicable law which are as follows:

A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS THAT THE CREDITOR OR RELEASING PARTY DOES NOT KNOW OR SUSPECT TO EXIST IN HIS OR HER FAVOR AT THE TIME OF EXECUTING THE RELEASE AND THAT, IF KNOWN BY HIM OR HER, WOULD HAVE MATERIALLY AFFECTED HIS OR HER SETTLEMENT WITH THE DEBTOR OR RELEASED PARTY.

72. Exhibits Incorporated by Reference. The terms of this Settlement Agreement include the terms set forth in any attached Exhibits, which are incorporated by this reference as though fully set forth herein. Any Exhibits to this Settlement Agreement are an integral part of the Settlement.

73. Entire Agreement. This Settlement Agreement and any attached Exhibits constitute the

entirety of the Parties' settlement terms. No other prior or contemporaneous written or oral agreements may be deemed binding on the Parties. The Parties expressly recognize California Civil Code Section 1625 and California Code of Civil Procedure Section 1856(a), which provide that a written agreement is to be construed according to its terms and may not be varied or contradicted by extrinsic evidence, and the Parties agree that no such extrinsic oral or written representations or terms will modify, vary or contradict the terms of this Settlement Agreement.

74. Amendment or Modification. No amendment, change, or modification to this Settlement Agreement will be valid unless in writing and signed, either by the Parties or their counsel, and approved by the Court.

75. Authorization to Enter Into Settlement Agreement. Counsel for all Parties warrant and represent they are expressly authorized by the Parties whom they represent to negotiate this Settlement Agreement and to take all appropriate action required or permitted to be taken by such Parties pursuant to this Settlement Agreement to effectuate its terms and to execute any other documents required to effectuate the terms of this Settlement Agreement. The Parties and their counsel will cooperate with each other and use their best efforts to effect the implementation of the Settlement. If the Parties are unable to reach agreement on the form or content of any document needed to implement the Settlement, or on any supplemental provisions that may become necessary to effectuate the terms of this Settlement, the Parties may seek the assistance of the Court to resolve such disagreement.

76. Binding on Successors and Assigns. This Settlement Agreement will be binding upon, and inure to the benefit of, the successors or assigns of the Parties hereto, as previously defined.

77. California Law Governs. All terms of this Settlement Agreement and Exhibits hereto will be governed by and interpreted according to the laws of the State of California.

78. Execution and Counterparts. This Settlement Agreement is subject only to the execution of all Parties. However, the Settlement Agreement may be executed in one or more counterparts. All executed counterparts and each of them, including electronic (e.g., DocuSign), facsimile, and scanned copies of the signature page, will be deemed to be one and the same instrument.

79. Acknowledgement that the Settlement is Fair and Reasonable. The Parties believe this Settlement Agreement is a fair, adequate and reasonable settlement of the Action and have arrived at this

1 Settlement after arm's-length negotiations and in the context of adversarial litigation, taking into account
2 all relevant factors, present and potential. The Parties further acknowledge that they are each represented
3 by competent counsel and that they have had an opportunity to consult with their counsel regarding the
4 fairness and reasonableness of this Settlement.

5 80. Invalidity of Any Provision. Before declaring any provision of this Settlement
6 Agreement invalid, the Court will first attempt to construe the provision as valid to the fullest extent
7 possible consistent with applicable precedents so as to define all provisions of this Settlement Agreement
8 valid and enforceable.

9 81. Waiver of Certain Appeals. The Parties agree to waive appeals and to stipulate to class
10 certification for purposes of this Settlement only; except, however, that Plaintiff or Class Counsel may
11 appeal any reduction to the Attorneys' Fees and Costs below the amount they request from the Court,
12 and either party may appeal any court order that materially alters the Settlement Agreement's terms.

13 82. Class Action Certification for Settlement Purposes Only. The Parties agree to stipulate to
14 class action certification for purposes of the Settlement only. If, for any reason, the Settlement is not
15 approved, the stipulation to certification will be void. The Parties further agree that certification for
16 purposes of the Settlement is not an admission that class action certification is proper under the standards
17 applied to contested certification motions and that this Settlement Agreement will not be admissible in
18 this or any other proceeding as evidence that either (a) a class action should be certified or (b) Defendant
19 is liable to Plaintiff or any Class Member, other than according to the Settlement's terms.

20 83. Non-Admission of Liability. The Parties enter into this Settlement to resolve the dispute
21 that has arisen between them and to avoid the burden, expense and risk of continued litigation. In
22 entering into this Settlement, Defendant does not admit, and specifically denies, that it violated any
23 federal, state, or local law; violated any regulations or guidelines promulgated pursuant to any statute or
24 any other applicable laws, regulations or legal requirements; breached any contract; violated or breached
25 any duty; engaged in any misrepresentation or deception; or engaged in any other unlawful conduct with
26 respect to its employees. Neither this Settlement Agreement, nor any of its terms or provisions, nor any
27 of the negotiations connected with it, will be construed as an admission or concession by Defendant of
28 any such violations or failures to comply with any applicable law. Except as necessary in a proceeding to

enforce the terms of this Settlement, this Settlement Agreement and its terms and provisions will not be offered or received as evidence in any action or proceeding to establish any liability or admission on the part of Defendant or to establish the existence of any condition constituting a violation of, or a non-compliance with, federal, state, local or other applicable law.

84. No Public Comment: Prior to Preliminary Approval, the Parties and their counsel agree that they will not issue any press releases, initiate any contact with the press, respond to any press inquiry, or have any communication with the press about the fact, amount or terms of the Settlement.

85. Waiver. No waiver of any condition or covenant contained in this Settlement Agreement or failure to exercise a right or remedy by any of the Parties hereto will be considered to imply or constitute a further waiver by such party of the same or any other condition, covenant, right or remedy.

86. Enforcement Actions. In the event that one or more of the Parties institutes any legal action or other proceeding against any other Party or Parties to enforce the provisions of this Settlement or to declare rights and/or obligations under this Settlement, the successful Party or Parties will be entitled to recover from the unsuccessful Party or Parties reasonable attorneys' fees and costs, including expert witness fees incurred in connection with any enforcement actions.

87. Mutual Preparation. The Parties have had a full opportunity to negotiate the terms and conditions of this Settlement Agreement. Accordingly, this Settlement Agreement will not be construed more strictly against one party than another merely by virtue of the fact that it may have been prepared by counsel for one of the Parties, it being recognized that, because of the arms'-length negotiations between the Parties, all Parties have contributed to the preparation of this Settlement Agreement.

88. Representation By Counsel. The Parties acknowledge that they have been represented by counsel throughout all negotiations that preceded the execution of this Settlement Agreement, and that this Settlement Agreement has been executed with the consent and advice of counsel. Further, Plaintiff and Class Counsel warrant and represent that there are no liens on the Settlement Agreement.

89. All Terms Subject to Final Court Approval. All amounts and procedures described in this Settlement Agreement herein will be subject to final Court approval.

90. Cooperation and Execution of Necessary Documents. All Parties will cooperate in good faith and execute all documents to the extent reasonably necessary to effectuate the terms of this

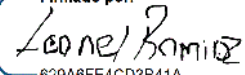
Settlement Agreement.

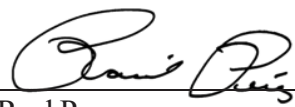

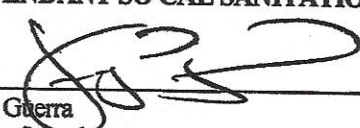

NOTICE OF CLASS ACTION SETTLEMENT

You are not being sued. This notice affects your rights. Please read it carefully

To: All persons who were employed by Defendant So Cal Sanitation LLC (“Defendant”) as non-exempt, hourly paid employees in the State of California at any time during the period from April 20, 2019 through February 16, 2025 (“Class Members”).

All persons who were employed by Defendant as non-exempt, hourly paid employees in the State of California at any time during the period from May 24, 2023 through February 16, 2025 (“PAGA Members”).

On _____, the Honorable Lawrence P. Riff of the Los Angeles County Superior Court granted preliminary approval of this class action settlement and ordered the litigants to notify all Class Members of the settlement. **You have received this notice because Defendant’s records indicate that you are a Class Member, and therefore entitled to a payment from the settlement.**

Unless you choose to opt out of the settlement by following the procedures described below, you will be deemed a Class Member and, if the Court grants final approval of the settlement, you will be mailed a check for your share of the settlement fund. The Final Fairness Hearing on the adequacy, reasonableness, and fairness of the Settlement will be held at __:00 __m. on _____, 2025 in Department 7 of the Los Angeles County Superior Court located at 312 North Spring Street, Los Angeles, California 90012.

You are not required to attend the hearing, but if you wish to attend, you may attend the hearing telephonically (remotely), which can be set up through LA Court Connect (www.lacourt.org/lacc/).

Please also note that the Final Fairness Hearing may be rescheduled by the Court to another date and/or time. Please visit [settlement website] for any scheduling changes.

Summary of the Litigation

Plaintiff Leonel Ramirez, on his behalf and on behalf of other current and former non-exempt employees, alleges that Defendant violated California state labor laws as a result of its alleged failure to, among other things: (1) pay minimum and overtime wages to employees for all hours worked; (2) provide employees with meal and rest breaks; (3) timely pay all wages owed to employees during each pay period and upon termination of their employment; (4) reimburse employees for necessary business expenses; and (5) provide employees with accurate, itemized wage statements.

After the exchange of relevant information and evidence, the parties agreed to enter into settlement negotiations in an attempt to informally resolve the claims in the case. On August 19, 2024, the parties participated in a mediation with the Hon. Carl J. West (Ret.), an experienced and well-respected class action mediator. With Judge West’s guidance, the parties were able to negotiate a complete settlement of Plaintiff’s claims.

Counsel for Plaintiff, and the attorneys appointed by the Court to represent the class, Capstone Law APC (“Class Counsel”), have investigated and researched the facts and circumstances underlying the issues raised in the case and the applicable law. While Class Counsel believe that the claims alleged in this lawsuit have merit, Class Counsel also recognize that the risk and expense of continued litigation justify settlement. Based on the foregoing, Class Counsel believe the proposed settlement is fair, adequate, reasonable, and in the best interests of Class Members.

The Court has not made any determination as to whether the claims advanced by the Plaintiff have any merit. In other words, the Court has not determined whether any laws have been violated, nor has it decided in favor of Plaintiff or Defendant. Instead, both sides agreed to resolve the lawsuit with no decision or admission of who is right or wrong.

Defendant has denied, and continues to deny the factual and legal allegations in the case and believes that it has valid defenses to Plaintiff’s claims. By agreeing to settle, Defendant is not admitting liability on any of the factual allegations or claims in the case or that the case can or should proceed as a class action. Defendant has agreed to settle the case as part of a compromise with Plaintiff.

Summary of The Proposed Settlement Terms

Plaintiff and Defendant have agreed to settle the underlying class claims in exchange for a Gross Settlement Amount of \$1,050,000. This amount is inclusive of: (1) individual settlement payments to all Participating Class Members; (2) a Class Representative Enhancement Payment of \$5,000 to Leonel Ramirez for his services on behalf of the class, and a

General Release Payment of \$5,000 for a release of all claims arising out of his employment with Defendant; (3) \$350,000 in attorneys' fees and up to \$15,000 in litigation costs and expenses; (4) a \$100,000 settlement of claims under the Labor Code Private Attorneys General Act of 2004 ("PAGA"), inclusive of a \$75,000 payment to the California Labor and Workforce Development Agency ("LWDA") in connection with the PAGA, and a \$25,000 payment ("PAGA Fund") to all PAGA Members; and (5) reasonable Settlement Administrator's fees and expenses currently estimated at \$_. The Individual Settlement Payment will be reduced by any required deductions for each Class Members as specifically set forth herein, including employee-side tax withholdings or deductions. If there are any valid and timely Requests for Exclusion, the Settlement Administrator shall proportionately increase each Participating Class Member's share of the Net Settlement Fund according to the number of Workweeks worked, so that the amount actually distributed to the Settlement Class equals 100% of the Net Settlement Fund.

A Request for Exclusion does not exclude a PAGA Member from the release of claims under California Labor Code §§ 2698, *et seq.* and the PAGA Member will receive their portion of the PAGA fund even if he/she/they submits a valid Request for Exclusion.

Taxes on Settlement Payments. IRS Forms W-2 and 1099 will be distributed to participating Class Members and the appropriate taxing authorities reflecting the payments they receive under the settlement. Class Members should consult their tax advisors concerning the tax consequences of the payments they receive under the Settlement. For purposes of this settlement, 20% of each settlement payment will be allocated as wages for which IRS Forms W-2 will be issued, and 80% will be allocated as non-wages for which IRS Forms 1099-MISC will be issued. Payments issued to PAGA Members from the PAGA Fund will be treated as non-wages for which IRS Forms 1099-MISC will be issued.

Your Options Under the Settlement

Option 1 – *Automatically Receive a Payment from the Settlement*

If you want to receive your payment from the settlement, then no further action is required on your part. You will automatically receive your settlement payment from the Settlement Administrator if and when the Settlement receives final approval by the Court.

If you choose **Option 1**, and if the Court grants final approval of the settlement, you will be mailed a check for your share of the settlement funds. In addition, you will be deemed to have released or waived the Released Class Claims, and if you are also a PAGA Member, the Released PAGA Claims:

Released Class Claims: All claims, rights, demands, liabilities, and causes of action that are asserted in the operative Complaint, or that could have been asserted based on the facts alleged in the operative Complaint, including claims for violation of: (1) Labor Code sections 510 and 1198 (unpaid overtime); (2) Labor Code sections 1182.12, 1194, 1197, 1197.1, and 1198 (unpaid minimum wages); (3) Labor Code sections 226.7, 512(a), 516, and 1198 (failure to provide meal periods); (4) Labor Code sections 226.7, 516, and 1198 (failure to authorize and permit rest periods); (5) Labor Code sections 226.7, 516, and 1198 (failure to provide recovery periods); (6) Labor Code sections 226(a), 1174(d), and 1198 (non-compliant wage statements and failure to maintain accurate payroll records); (7) Labor Code sections 201 and 202 (wages not timely paid upon termination); (8) Section 204 (failure to timely pay wages during employment); (9) Labor Code section 2802 (unreimbursed business expenses); (10) California Business & Professions Code sections 17200, *et seq.* (unlawful business practices); and (11) California Business & Professions Code sections 17200, *et seq.* (unfair business practices).

Released PAGA Claims: All claims for civil penalties under California Labor Code §§ 2698, *et seq.*, that were brought or could reasonably have been brought based on the same facts alleged in Plaintiff's LWDA letter during the PAGA Period.

Option 2 – *Opt Out of the Settlement*

If you do not wish to participate in the settlement, you may exclude yourself from participating by submitting a written request to the Settlement Administrator expressly and clearly indicating that you have received this Notice of Class Action Settlement, decided not to participate in the settlement, and desire to be excluded from the settlement. The written request for exclusion must include your name, signature, address, telephone number, and last four digits of your Social Security Number. Option 3 – Object to the Settlement

If you decide to object to the settlement because you find it unfair or unreasonable, you may submit a written objection stating why you object to the settlement, or you may instead appear at the Final Fairness Hearing to object to the Settlement. Written objections must provide: (1) your full name, signature, address, and telephone number, (2) a written statement of all grounds for the objection accompanied by any legal support for such objection; (3) copies of any papers, briefs, or other documents upon which the objection is based; and (4) a statement about whether you intend to appear at the Fairness Hearing. The objection must be mailed to the administrator at [administrator's address].

All written objections must be received by the administrator by not later than _____ 2025. By submitting an objection, you are not excluding yourself from the settlement. To exclude yourself from the settlement, you must follow the directions described above. Please note that you cannot both object to the settlement and exclude yourself. You must choose one option only.

You may also, if you wish, appear at the Final Fairness Hearing set for _____ at _____ a.m./p.m. in the Superior Court of the State of California, for the County of Los Angeles and discuss your objection with the Court and the Parties at your own expense.
