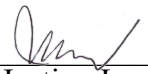
1 As discussed in the concurrently filed Supplemental Brief In Support Of Plaintiff's Motion

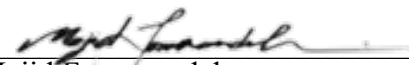
