DECLARATION OF ARRASH T. FATTAHI

I, Arrash T. Fattahi, declare as follows:

1. I am admitted, in good standing, to practice as an attorney in the State of California, and the United States District Courts for the Central, Southern, Eastern, and Northern Districts of California. I am a Partner at Wilshire Law Firm, PLC, counsel of record for Plaintiffs Timothy McCormick, Michael Kindt, Kelly Carter, Carlos Aterrado, Alex Martinez, and Eric Aragaki (collectively “Plaintiffs”). I have personal knowledge of the facts set forth in this declaration and could and would competently testify to them under oath if called as a witness. This Declaration is submitted in support of Plaintiffs’ Motion for Final Approval of Class Action and PAGA Settlement.

2. Plaintiffs are represented by Wilshire Law Firm, PLC. The attorneys at Wilshire Law Firm, PLC performed significant work and expended litigation costs in prosecuting this matter with no guarantee of payment.

3. Wilshire Law Firm, PLC was selected by Best Lawyers and U.S. News & World Report as one of the nation’s Best Law Firms since 2020 and is comprised of more than 100 attorneys and over 600 employees. Wilshire Law Firm, PLC is actively and continuously practicing in employment litigation, representing employees in both individual and class actions in both state and federal courts throughout California.

4. Wilshire Law Firm, PLC is qualified to handle this litigation because its attorneys are experienced in litigating Labor Code violations in individual, class action, and representative action cases. Wilshire Law Firm, PLC has handled, and is currently handling, numerous wage and hour class action lawsuits, as well as class actions involving consumer rights and data privacy litigation.

5. I graduated from the University of California, Los Angeles with a Bachelor of Arts in Political Science, *summa cum laude*. I received my Juris Doctor from The George Washington University Law School. During law school, I was a member of the student editorial board for the Federal Circuit Bar Journal.

1 6. My practice is focused on advocating for the rights of consumers and employees in
2 class action litigation. I am currently the managing attorney in charge of litigating several class
3 action cases in state and federal courts in California.

4 7. As the attorney responsible for day-to-day management of this matter at the
5 Wilshire Law Firm, PLC, I have over five years of experience litigating wage and hour class
6 actions. Over the past five plus years, I have managed and assisted with the litigation and
7 settlement of several wage and hour class actions. In those class actions, I performed similar tasks
8 as those performed in the course of prosecuting this action.

9 8. I was selected as a “Southern California Rising Star” in 2025 and 2026.

10 9. My current contingent billing rate of \$850 per hour is consistent with the legal
11 market, accepted hourly rates, and my expertise and knowledge as it pertains to wage and hour

10. Arman A. Salehi is a third-year Associate Attorney at Wilshire Law Firm, PLC. He was admitted to practice law in the State of California in 2023. Mr. Salehi graduated from the University of California, Los Angeles with a Bachelor of Arts in Sociology. He received his Juris Doctor from the University of California College of the Law, San Francisco (formerly known as U.C. Hastings). Since November 2023, his practice has mainly been focused on wage and hour class action litigation. He currently bills at an hourly rate of \$600.00.

11. Courtney M. Miller is a Settlement Attorney at Wilshire Law Firm, PLC. She was admitted to practice law in the State of California in 2019. Ms. Miller graduated from the

1 University of California, Santa Cruz, with a Bachelor of Arts in Sociology. Prior to becoming an
2 attorney, Ms. Miller worked at a boutique civil litigation firm for nearly a decade, primarily
3 handling employment matters. She earned her Juris Doctor from Southwestern Law School in
4 2019. Ms. Miller has prosecuted wage and hour class and PAGA actions, almost exclusively, since
5 2020. As a handling attorney, Ms. Miller obtained over \$30 million dollars in settlements on behalf
6 of California employees. Ms. Miller currently bills at an hourly rate of \$700.00.

7 12. In support of the reasonableness of WLF's hourly rates, attached as **Exhibit 1** is a
8 true and correct excerpt from the *2025 Real Rate Report* published by Wolters Kluwer. The Real
9 Rate Report is widely relied upon in the legal industry because it is derived from anonymized
10 billing data taken from actual law firm invoices that were submitted to clients and approved for
11 payment, rather than from voluntary surveys or self-reported rates. Although the report refers to
12 "2025" rates, the data reflects rates charged by law firms during the first half of 2024 and therefore
13 represents the most recent available objective evidence of prevailing market rates.

14 a. The report provides rate information filtered by geographic market,
15 practice type, and timekeeper role. Page 33 of the report reflects rates drawn from 565 partners
16 and 518 associates practicing in Los Angeles. In that dataset, the third-quartile hourly rate is
17 \$1,365 for partners and \$982 for associates. These figures confirm that Los Angeles is a high-
18 rate legal market and that experienced litigation partners routinely bill in excess of \$1,300 per
19 hour based on rates actually paid by clients in 2024. The Real Rate Report further shows that in
20 the San Diego market, partners with 21 or more years of experience command third-quartile
21 billing rates of approximately \$1,334 per hour, confirming that highly experienced litigators in
22 major California markets routinely bill at the upper end of the rate spectrum.

23 b. The 2025 Real Rate Report's practice-area-specific data further supports
24 this conclusion. Page 81 provides third-quartile rates for the detailed practice category
25 "Employment and Labor: Other Litigation," which is directly analogous to the type of work
26 performed in this case. That dataset includes 24 partners and 14 associates and shows a third-
27 quartile rate of \$1,252 per hour for partners and \$564 per hour for associates. These figures
28 demonstrate that even within the specialized employment litigation market, partners regularly bill

1 well above \$1,200 per hour based on rates actually charged to clients. When this practice-specific
2 benchmark is considered together with the broader regional market data, it confirms that WLF's
3 hourly rate for highly experienced counsel in a representative employment action falls within the
4 upper range of prevailing market rates rather than outside it.

5 13. In an article entitled "Big Law Rates Topping \$2,000 Leave Value 'In Eye of
6 Beholder,'" written by Roy Strom and published by Bloomberg Law on June 9, 2022, the author
7 describes how Big Law firms have crossed the \$2,000-per hour rate. The article also notes that law
8 firm rates have been increasing by just under 3% per year. A true and correct copy of this article
9 is attached hereto as **Exhibit 2**.

10 14. Wilshire Law Firm, PLC, has performed significant work and incurred litigation
11 costs in prosecuting this matter with no guarantee of payment. The efforts expended by Class
12 Counsel to achieve this result include, but are not limited to, the following:

- 13 a. the investigation of the matter, including meeting with Plaintiffs, reviewing
14 Defendant Amerifleet Transportation, Inc.'s ("Defendant") policies, and requesting
15 Plaintiffs' time and pay records, personnel files, and exploring the corporate
16 structure of Defendant;
- 17 b. filing the Action;
- 18 c. attending status conferences and meeting and conferring with Defendant's counsel
19 regarding the case;
- 20 d. drafting and filing joint stipulations and joint reports;
- 21 e. meeting and conferring with Defendant regarding mediation, exchange of informal
22 discovery beforehand, and negotiating with opposing counsel regarding the
23 parameters thereof;
- 24 f. selecting a mediator and mediation date;
- 25 g. working with opposing counsel for the receipt of a representative sampling and
26 analyzing the same with the aid of an expert consultant and Plaintiffs to perform
27 analyses of liability and exposure prior to attendance of the mediation in this matter;
- 28 h. reviewing policy documents from Defendant and researching applicable defenses;

- i. preparing a mediation brief and damages model for use at mediation;
- j. attending mediation;
- k. communicating with Plaintiffs;
- l. negotiating the settlement;
- m. preparing and filing the Motion for Preliminary Approval and supporting documents;
- n. preparing and filing a first amended complaint;
- o. amending, finalizing and fully executing the settlement agreement and class notice;
- p. preparing and filing supplemental papers for the Motion for Preliminary Approval;
- q. communicating with the Settlement Administrator and defense counsel to ensure the class data was received and that Class Notice was properly distributed; and
- r. preparing the instant Motion for Final Approval and supporting documents.

15. Wilshire Law Firm, PLC's current lodestar reflects the efficiencies achieved by the attorneys' experience in this field with **188.4** hours of work resulting in **\$137,865.00** in fees. Wilshire Law Firm, PLC, dedicated significant resources to this case by dividing the tasks required according to skill level. The hours expended by each attorney were not duplicative and reflect the extensive investigation and analysis that was required to achieve this Settlement. **This amount does not include the time Class Counsel will spend at the final approval hearing and assisting the Settlement Administrator following final approval.** The chart below shows the calculation of hours spent by each of Wilshire Law Firm, PLC's attorneys on this case:

1 16. The risk factors present in this case favor the application of a 1.05 multiplier. To
2 begin, Class Counsel has singularly assumed the risk and costs of litigation purely on a contingency
3 basis. And, while Plaintiffs are confident in the merits of their claims, a legitimate controversy
4 exists as to each cause of action posing an actual risk that Plaintiffs may not succeed at class
5 certification and/or trial. Any of these obstacles could have prevented recovery completely,
6 meaning Class Counsel would have been left with no compensation for all the time and money
7 invested in litigating this case. Despite these risks, Class Counsel took this case on a contingency
8 basis so that Class Members (a particularly vulnerable group of hourly paid workers) could be
9 compensated for their unpaid wages. Consequently, Class Counsel was precluded from focusing
10 on, or taking on, other cases which could have resulted in a larger, and less risky, monetary gain.
11 This time could have been spent on other potentially lucrative cases.

12 17. In litigation costs, Wilshire Law Firm, PLC, has spent \$5,324.32 on items such as
13 filing fees, service fees, mediation fees, and expert fees. A true and correct copy of Wilshire Law
14 Firm, PLC's cost reports for this matter is attached hereto as **Exhibit 3**. Wilshire Law Firm, PLC's
15 total costs include those in the cost reports as well as the \$60.00 filing fee to file the instant Motion.
16 Since Class Counsel's costs did not reach the maximum of \$25,000.00, the remaining \$19,675.68
17 will revert to and increase the Net Settlement Amount. All of the costs incurred were reasonable
18 and necessary for the prosecution of this case.

19 18. Class Counsel has negotiated a settlement here that they believe is fair, reasonable,
20 and adequate based on their prior experience litigating these types of cases.

21 19. A copy of the Class Action and PAGA Settlement Agreement has previously been
22 submitted to the LWDA. To date, the LWDA has not responded to or objected to the Settlement in
23 this matter.

24 20. Class Counsel is not aware of any other pending matter or action asserting claims
25 that will be extinguished or affected by the Settlement.

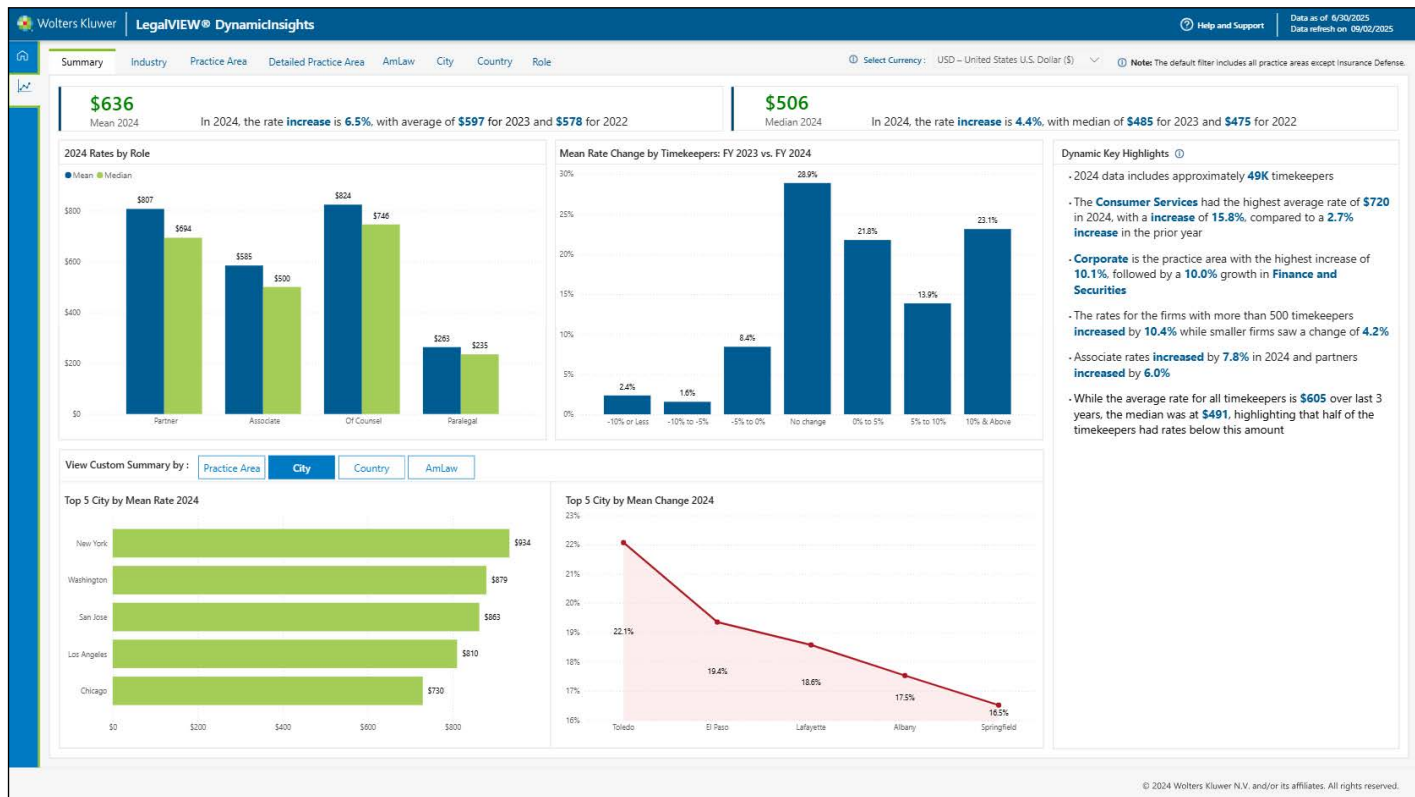
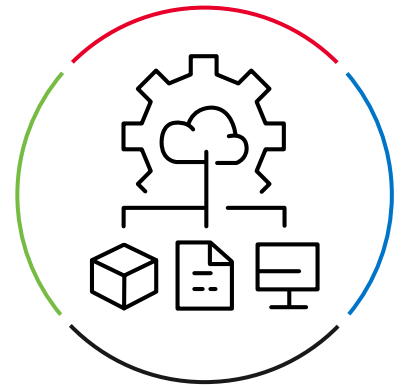


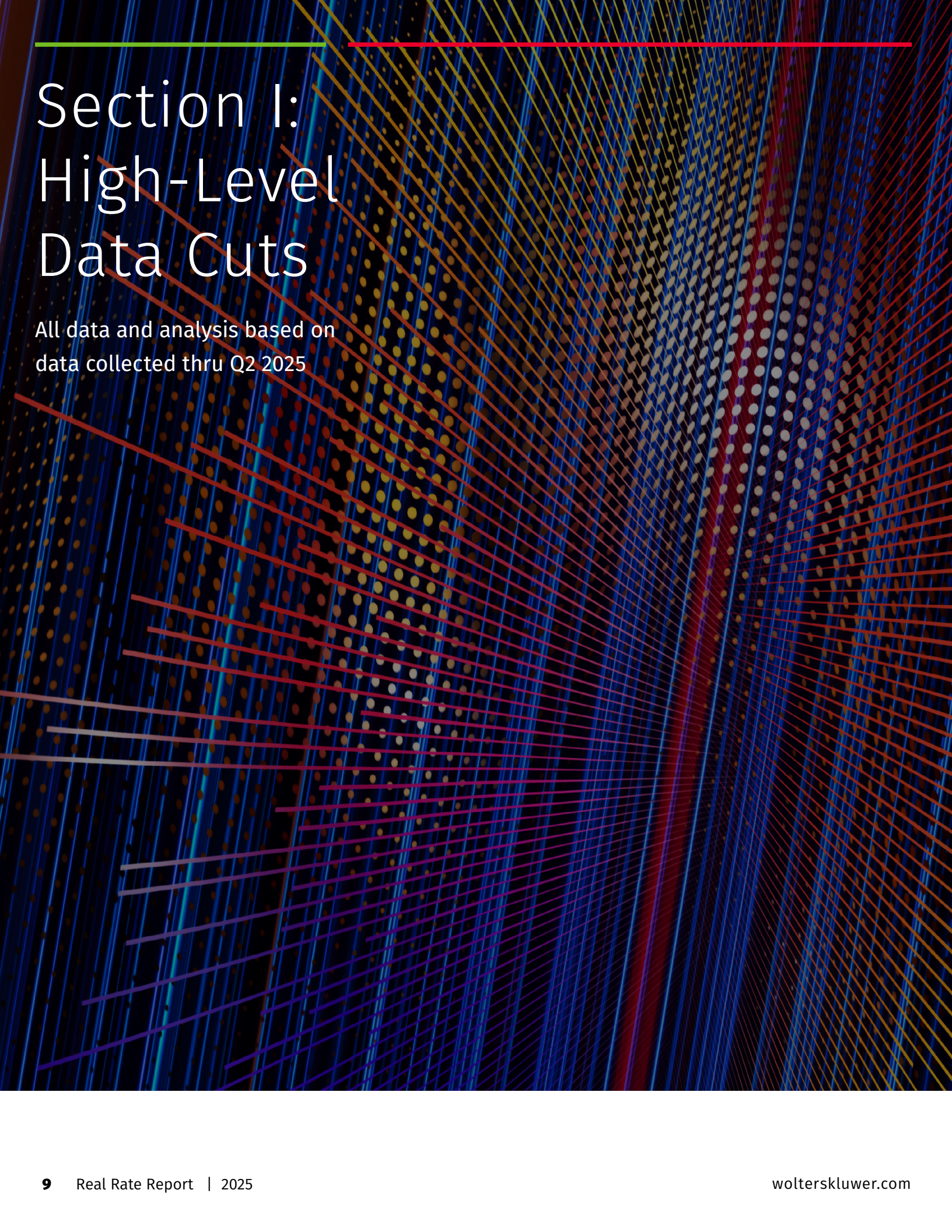

Big Law Rates Topping \$2,000 Leave Value ‘In Eye of Beholder’

Welcome back to the Big Law Business column on the changing legal marketplace written by me, Roy Strom. Today, we look at a new threshold for lawyers' billing rates and why it's so difficult to put a price on high-powered attorneys. Sign up to receive this column in your inbox on Thursday mornings. Some of the nation's top law firms are charging more than \$2,000 an hour, setting a new pinnacle after a two-year burst in demand.

Partners at Hogan Lovells and Latham & Watkins have crossed the threshold, according to court documents in bankruptcy cases filed within the past year.

Other firms came close to the mark, billing more than \$1,900, according to the documents. They include Kirkland & Ellis, Simpson Thacher & Bartlett, Boies Schiller Flexner, and Sidley Austin.

Simpson Thacher & Bartlett litigator Bryce Friedman, who helps big-name clients out of jams, especially when they're accused of fraud, charges \$1,965 every 60 minutes, according to a court document.

In need of a former acting US Solicitor General? Hogan Lovells partner Neal Katyal bills time at \$2,465 an hour. Want to hire famous litigator David Boies? That'll cost \$1,950 an hour (at least). Reuters was first to report their fees.

Eye-watering rates are nothing new for Big Law firms, which typically ask clients to pay higher prices at least once a year, regardless of broader market conditions.

"Value is in the eye of the beholder," said John O'Connor, a San Francisco-based expert on legal fees. "The perceived value of a good lawyer can reach into the multi-billions of dollars."

Kirkland & Ellis declined to comment on its billing rates. None of the other firms responded to requests to comment.

Charge It Up

Big Law firms are crossing the \$2,000-an-hour threshold after two years of surging rates driven by an increase in demand for lawyers.

Law firms have been more successful raising rates than most other businesses over the past 15 years.

Law firm rates rose by roughly 40 percent from 2007 to 2020, or just short of 3 percent per year, Thomson Reuters Peer Monitor data show. US inflation rose by about 28% during that time.

The 100 largest law firms in the past two years achieved their largest rate increases in more than a decade, Peer Monitor says. The rates surged more than 6% in 2020 and grew another 5.6% through November of last year. Neither level had been breached since 2008.

The price hikes occurred during a once-in-a-decade surge in demand for law services, which propelled profits at firms to new levels. Fourteen law firms reported average profits per equity partner in 2021 over \$5 million, according to data from The American Lawyer. That was up from six the previous year.

The highest-performing firms, where lawyers charge the highest prices, have outperformed their smaller peers. Firms with leading practices in markets such as mergers and acquisitions, capital markets, and real estate were forced to turn away work at some points during the pandemic-fueled surge.

Firms receive relatively tepid pushback from their giant corporate clients, especially when advising on bet-the-company litigation or billion-dollar deals.

The portion of bills law firms collected—a sign of how willingly clients pay full-freight—rose during the previous two years after drifting lower following the Great Financial Crisis. Collection rates last year breached 90% for the first time since 2009, Peer Monitor data show.

Professional rules prohibit lawyers from charging “unconscionable” or “unreasonable” rates. But that doesn’t preclude clients from paying any price they perceive as valuable, said Jacqueline Vinaccia, a San Diego-based lawyer who testifies on lawyer fee disputes.

Lawyers’ fees are usually only contested when they will be paid by a third party.

That happened recently with Hogan Lovells’ Katyal, whose nearly \$2,500 an hour fee was contested in May by a US trustee overseeing a bankruptcy case involving a Johnson & Johnson unit facing claims its talc-based powders caused cancer.

The trustee, who protects the financial interests of bankruptcy estates, argued Katyal’s fee was more than \$1,000 an hour higher than rates charged by lawyers in the same case at Jones Day and Skadden Arps Slate Meagher & Flom.

A hearing on the trustee’s objection is scheduled for next week. Hogan Lovells did not respond to a request for comment on the objection.

Vinaccia said the firm’s options will be to reduce its fee, withdraw from the case, or argue the levy is reasonable, most likely based on Katyal’s extensive experience arguing appeals.

Still, the hourly rate shows just how valuable the most prestigious lawyers’ time can be—even compared to their highly compensated competitors.

“If the argument is that Jones Day and Skadden Arps are less expensive, then you’re already talking about the cream of the crop, the top-of-the-barrel law firms,” Vinaccia said. “I can’t imagine a case in which I might argue those two firms are more reasonable than the rates I’m dealing with.”

Worth Your Time

On Cravath: Cravath Swaine & Moore is heading to Washington, opening its first new office since 1973 by hiring former heads of the U.S. Securities and Exchange Commission and Federal Deposit Insurance Corporation. Meghan Tribe reports the move comes as Big Law firms are looking to add federal government expertise as clients face more regulatory scrutiny.
