8 Plaintiff addresses the Court's concerns herein. I also submit a revised proposed order herewith.

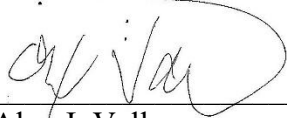
9 3. Pursuant to the Court's guidance, the Parties have revised the scope of the PAGA release
