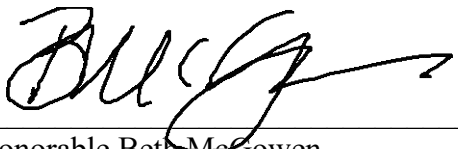
2 Having read and considered Plaintiff Joey Altamirano's ("Plaintiff") Request for

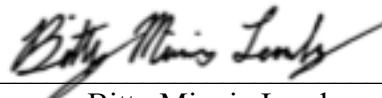
