6 3. At my direction, on May 8, 2024 and June 11, 2024, a research librarian performed
7 a search to look for any other civil action lawsuits filed against Mattco Forge, Inc. The search
8 included a search of Courthouse News, Westlaw and Lexis dockets, and Docket Alarm. The only
9 case that was found was this case filed by Mr. Carbajal. Based on this search, I am not aware of
10 any other pending, filed, civil lawsuits asserting claims that will be extinguished or adversely
11 affected by the settlement in this case.

12 4. At my direction, on June 18, 2024, a conflicts attorney searched to see if there were
13 any actual or potential conflicts with the Administrator in this case, Apex Class Action LLC. This
14 search did not yield any results. Based on this search, I am not aware of any conflicts with using
15 Apex Class Action LLC to administer the settlement in this case.

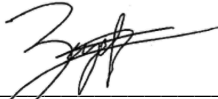
