2 7. As the attorney responsible for day-to-day management of this matter at the

10. John G. Yslas is a Senior Partner at Wilshire Law Firm, PLC. He graduated from the University of California, Santa Barbara with High Honors in 1991 with Bachelor of Arts degrees in Psychology. He received his Juris Doctor from UCLA Law School in 1996.

11. Upon graduating from law school in 1996, Mr. Yslas worked for a boutique law firm practicing general litigation which included employment law matters. Since 2000 (that is, the last 25 years) his practice has been exclusively focused on labor and employment matters including handling wage and hour class, collective and representative actions (including the California Private Attorneys General Act, or “PAGA”), including in the international law firms of Morgan, Lewis & Bockius LLP (where he was a senior associate), Foley & Lardner LLP (where he was a partner and a national Vice Chair of the Labor and Employment Group), Norton Rose Fulbright LLP (where he was a partner) and Seyfarth Shaw LLP (where he was a partner and member of the Wage and Hour Practice Group). During his time at these law firms, Mr. Yslas was the primary attorney or took a major leading role in defending employers on numerous wage and hour class, collective and representative actions.

12. In late June 2022 Mr. Yslas left Seyfarth Shaw LLP and joined his current firm, Wilshire Law Firm, PLC, to represent plaintiff employees. He has been and is handling many wage and hour class and representative actions litigating such matters on behalf of plaintiff employees

1 in numerous Superior Courts and District Courts. From matters representing both plaintiffs and  
2 defendants, he has successfully mediated the resolution of many wage and hour class, collective,  
3 and representative actions. Just since starting to settle cases in late April 2023, Mr. Yslas has  
4 already successfully mediated matters in which he has been counsel or co-counsel resulting in **well**  
5 **over \$200 million** in settlements and verdicts which are in the process of being finalized, and with  
6 numerous upcoming mediations scheduled. In those and numerous other matters, he has managed  
7 and assisted with the litigation and settlement of many wage and hour PAGA and class actions. In  
8 those actions, he performed similar tasks as those performed in the course of prosecuting this  
9 action. Indeed, Mr. Yslas recently tried and prevailed in achieving a jury verdict in a wage and  
10 hour class action in the matter of *Aguilar-Flores v. Javier's – CC LLC*, Los Angeles County  
11 Superior Court, Case No. 19STCV36438 (settled after verdict).

12 13. Mr. Yslas has received numerous awards for his legal work. For example, from 2015  
13 to 2018, he was listed in Los Angeles Super Lawyers for Employment Litigation (Thomson  
14 Reuters). He has also served on numerous prominent boards and in other leadership positions,  
15 including serving as Southern California Regional President for the Hispanic National Bar  
16 Association and on the board of directors of the Mexican American Bar Foundation. Mr. Yslas  
17 also previously served on the 5-member Los Angeles Civil Service Commission, which generally  
18 oversees the personnel decisions for the City of Los Angeles.

19 14. Mr. Yslas has also published numerous blogs on labor and employment issues  
20 including on wage and hour issues. For example, he published “Headline News: Wal-Mart v.  
21 Dukes-Impact on Class Action Litigation” (while a partner with Foley & Lardner LLP) and “Are  
22 You Really Protected From Wage-and-Hour Successor Liability in an Asset Purchase” (while a  
23 partner with Seyfarth Shaw LLP). He has also been a presenter at numerous conferences, including  
24 being a presenter involving the “Employment Law Update” at a National Employment Law  
25 Council conference. He currently bills at an hourly rate of \$1,500.00.

26 15. Lisa B. Iturriaga is a Settlement Attorney at Wilshire Law Firm, PLC. She was  
27 admitted to practice law in the State of California in 2021. Ms. Iturriaga graduated from University  
28 of South Florida with a Bachelor of Science in Finance and a Bachelor of Arts in Marketing. She

1 received her Juris Doctor from Chapman University Dale E. Fowler School of Law. Since  
2 graduating, her practice has been in insurance defense (previously) and employment law  
3 (currently). Since 2023, she has exclusively worked on Plaintiff-side wage and hour cases. Ms.  
4 Iturriaga is also a member of the California Employment Lawyers Association (CELA). She  
5 currently bills at an hourly rate of \$550.00.

6 16. Arman A. Salehi is a third-year Associate Attorney at Wilshire Law Firm, PLC. He  
7 was admitted to practice law in the State of California in 2023. Mr. Salehi graduated from the  
8 University of California, Los Angeles with a Bachelor of Arts in Sociology. He received his Juris  
9 Doctor from the University of California College of the Law, San Francisco (formerly known as  
10 U.C. Hastings). Since November 2023, his practice has mainly been focused on wage and hour  
11 class action litigation. He currently bills at an hourly rate of \$500.00.

12 17. Wilshire Law Firm, PLC, has performed significant work and incurred litigation  
13 costs in prosecuting this matter with no guarantee of payment. The efforts expended by Class  
14 Counsel to achieve this result include, but are not limited to, the following

- 15 a. the investigation of the matter, including meeting with Plaintiff, reviewing  
16 Defendant The Cajun Pub, Inc.'s ("Defendant") policies, and requesting Plaintiff's  
17 time and pay records, personnel files, and exploring the corporate structure of  
18 Defendant;
- 19 b. filing the Action;
- 20 c. drafting and finalizing the First Amended Complaint;
- 21 d. meeting and conferring with Defendant's counsel regarding the case;
- 22 e. meeting and conferring with Defendant regarding mediation, exchange of informal  
23 discovery beforehand, and negotiating with opposing counsel regarding the  
24 parameters thereof;
- 25 f. selecting a mediator and mediation date;
- 26 g. working with opposing counsel and expert consultants for the receipt of a  
27 representative sampling and analyzing the same with the aid of expert consultants  
28 and Plaintiff to perform analyses of liability and exposure prior to attendance of the

mediation in this matter;

- h. reviewing policy documents from Defendant and researching applicable defenses;
- i. preparation of a mediation brief and damages model for use at mediation;
- j. attendance at mediation by all Parties and Counsel;
- k. communicating with Plaintiff;
- l. negotiating, finalizing and fully executing the settlement agreement;
- m. preparing and filing the Motion for Preliminary Approval and supporting documents;
- n. attending the Motion for Preliminary Approval hearing;
- o. communicating with the Settlement Administrator to ensure the Class Notice was properly distributed; and
- p. preparing the instant Motion for Final Approval and supporting documents.

18. Wilshire Law Firm, PLC's current lodestar reflects the efficiencies achieved by the attorneys' experience in this field with 139.5 hours of work resulting in \$90,625.00 in fees. Wilshire Law Firm, PLC, dedicated significant resources to this case by dividing the tasks required according to skill level. The hours expended by each attorney were not duplicative and reflect the extensive investigation and analysis that was required to achieve this Settlement. This amount does not include the time Class Counsel will spend at the final approval hearing and assisting the Settlement Administrator following final approval. The chart below shows the calculation of hours spent by each of Wilshire Law Firm, PLC's attorneys on this case:

1           19.     This amount surpasses the requested fee award of \$83,333.33, resulting in a negative  
2 multiplier. Class Counsel has singularly assumed the risk and costs of litigation purely on a  
3 contingency basis. And, while Plaintiff is confident in the merits of her claims, a legitimate  
4 controversy exists as to each cause of action posing an actual risk that Plaintiff may not succeed at  
5 class certification and/or trial. Any of these obstacles could have prevented recovery completely,  
6 meaning Class Counsel would have been left with no compensation for all the time and money  
7 invested in litigating this case. Despite these risks, Class Counsel took this case on a contingency  
8 basis so that Class Members (a particularly vulnerable group of hourly paid workers) could be  
9 compensated for their unpaid wages. Consequently, Class Counsel was precluded from focusing  
10 on, or taking on, other cases which could have resulted in a larger, and less risky, monetary gain.  
11 This time could have been spent on other potentially lucrative cases.

12           20.     In litigation costs, Wilshire Law Firm, PLC, has spent \$12,164.25 on items such as  
13 filing fees, service fees, mediation fees, and expert fees. A true and correct copy of a breakdown  
14 of costs incurred by my office is attached hereto as **Exhibit 1**.<sup>1</sup> Additionally, we anticipate  
15 incurring \$300.00 in anticipated future costs for filing fees and service fees for a total of \$12,464.25  
16 in costs. Since Class Counsel's costs did not reach the maximum of \$25,000.00, the remaining  
17 \$12,535.75 will revert to and increase the Net Settlement Amount. All of the costs incurred were  
18 reasonable and necessary for the prosecution of this case.

19           21.     Class Counsel has negotiated a settlement here that they believe is fair, reasonable,  
20 and adequate based on their prior experience litigating these types of cases.

21           22.     A copy of the Class Action and PAGA Settlement Agreement has previously been  
22 submitted to the LWDA. To date, the LWDA has not responded to or objected to the Settlement in  
23 this matter.

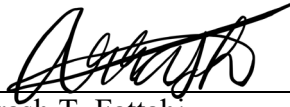
