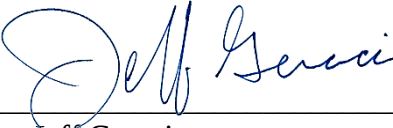
2 NOTICE IS GIVEN that on April 6, 2026, the Court issued an Order granting Plaintiff

3 following:

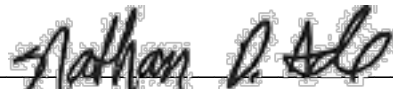
4 1. The individual claims of Plaintiff Derek Raymond Whitfield against Defendant
