1 Plaintiff Hector Cardenaz (“Plaintiff”) and Defendant Vintage Wine Estates, Inc.
2 (“Defendant”) (collectively, the “Parties”), by and through their respective counsel of record,
3 hereby enter into the stipulation below with reference to the following facts:

4 **WHEREAS**, on July 26, 2023, Plaintiff filed a class action complaint in the above-entitled
5 Court alleging violations of California law for: (1) failure to pay minimum and straight time wages;
6 (2) failure to pay overtime wages; (3) failure to provide meal periods; (4) failure to authorize and
7 permit rest periods; (5) failure to timely pay final wages at termination; (6) failure to provide
8 accurate itemized wage statements; (7) failure to indemnify employees for expenditures; and (8)
9 unfair business practices;

10 **WHEREAS**, on August 22, 2023, Plaintiff provided notice to Defendant and the California
11 Labor & Workforce Development Agency (“LWDA”) regarding Plaintiff’s intent to pursue a
12 California Labor Code Private Attorney’s General Act (“PAGA”) representative action;

13 **WHEREAS**, in order to effectively and economically litigate the claims, the Parties have
14 agreed that Plaintiff will file a First Amended Class and Representative Action Complaint (“FAC”)
15 to include claims for civil penalties under PAGA;

16 **WHEREAS**, Plaintiff seeks leave to file a FAC, attached hereto as **Exhibit A**, to include
17 claims for civil penalties under PAGA. A red-lined version of the FAC is attached hereto as
18 **Exhibit B**;

19 **THEREFORE**, the Parties, by and through their undersigned counsel of record, hereby
20 stipulate and agree to Plaintiff’s filing of a FAC, and respectfully request that the Court enter an
21 order as follows:

22 1. Plaintiff be allowed leave to file its FAC in the form attached as **Exhibit A** to this
23 Stipulation;

24 2. Plaintiff’s FAC be deemed effective as of the date that the Court approves and issues
25 its Order with respect hereto; and

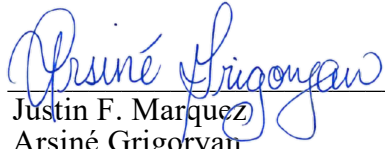
26 3. Defendant shall have thirty (30) days from the service of the Order granting this

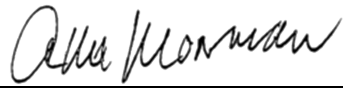

**FIRST AMENDED CLASS AND
REPRESENTATIVE ACTION
COMPLAINT:**

1. Failure to Pay Minimum and Straight Time Wages (Cal. Lab. Code §§ 204, 1194, 1194.2, and 1197);
2. Failure to Pay Overtime Wages (Cal. Lab. Code §§ 1194 and 1198);
3. Failure to Provide Meal Periods (Cal. Lab. Code §§ 226.7, 512);
4. Failure to Authorize and Permit Rest Periods (Cal. Lab. Code §§ 226.7);
5. Failure to Timely Pay Final Wages at Termination (Cal. Lab. Code §§ 201-203);
6. Failure to Provide Accurate Itemized Wage Statements (Cal. Lab. Code § 226);
7. Failure to Indemnify Employees for Expenditures (Cal. Lab. Code § 2802);
8. Unfair Business Practices (Cal. Bus. & Prof. Code §§ 17200, *et seq.*); and
9. Civil Penalties Under PAGA (Cal. Lab. Code §§ 2699, *et seq.*).

DEMAND FOR JURY TRIAL

1 Plaintiff HECTOR CARDENAZ (“Plaintiff”), based upon facts that either have evidentiary
2 support or are likely to have evidentiary support after a reasonable opportunity for further
3 investigation and discovery, alleges as follows:

4 **INTRODUCTION & PRELIMINARY STATEMENT**

5 1. Plaintiffs bring this action against Defendant VINTAGE WINE ESTATES, INC.
6 and DOES 1 through 10 (hereinafter collectively referred to as “Defendants”) for California Labor
7 Code violations and unfair business practices stemming from Defendants’ failure to pay for all
8 hours worked (minimum, straight time, and overtime wages), failure to provide meal periods,
9 failure to authorize and permit rest periods, failure to timely pay final wages, failure to furnish
10 accurate wage statements, and failure to indemnify employees for expenditures.

11 2. Plaintiff brings the First through Eighth Causes of Action individually and as a class
12 action on behalf of himself and certain current and former employees of Defendants (hereinafter
13 collectively referred to as the “Class” or “Class Members,” and defined more fully below). The
14 Class consists of Plaintiff and all other persons who have been employed by any Defendant in
15 California as an hourly-paid or non-exempt employee during the statute of limitations period
16 applicable to the claims pleaded here.

17 3. Plaintiff brings the Ninth Cause of Action as a representative action under the California
18 Private Attorneys General Act (“PAGA”) to recover civil penalties that are owed to Plaintiff, the
19 State of California, and past and present non-exempt employees by Defendants in the State of
20 California during the statute of limitations period for his PAGA claim (hereinafter referred to as
21 the “Aggrieved Employees”).

22 4. Defendants own/owned and operate/operated an industry, business, and
23 establishment within the State of California, including Mendocino County. As such and based
24 upon all the facts and circumstances incident to Defendants’ business in California, Defendants are
25 subject to the California Labor Code, Wage Orders issued by the Industrial Welfare Commission
26 (“IWC”), and the California Business & Professions Code.

27 5. Despite these requirements, throughout the statutory period, Defendants maintained
28 a systematic, company-wide policy and practice of:

- (a) Failing to pay employees for all hours worked, including all minimum, straight time, and overtime wages in compliance with the California Labor Code and IWC Wage Orders;
- (b) Failing to provide employees with timely and duty-free meal periods in compliance with the California Labor Code and IWC Wage Orders, failing to maintain accurate records of all meal periods taken or missed, and failing to pay an additional hour's pay for each workday a meal period violation occurred;
- (c) Failing to authorize and permit employees to take timely and duty-free rest periods in compliance with the California Labor Code and IWC Wage Orders, and failing to pay an additional hour's pay for each workday a rest period violation occurred;
- (d) Willfully failing to pay employees all minimum, straight time, overtime, meal period premium, and rest period premium wages due within the time period specified by California law when employment terminates;
- (e) Failing to provide employees with accurate, itemized wage statements containing all the information required by the California Labor Code and IWC Wage Orders; and,
- (f) Failing to indemnify employees for expenditures incurred in direct discharge of duties of employment.

6. On information and belief, Defendants, and each of them were on actual and constructive notice of the improprieties alleged herein and intentionally refused to rectify their unlawful policies. Defendants' violations, as alleged above, during all relevant times herein were willful and deliberate.

7. At all relevant times, Defendants were and are legally responsible for all of the unlawful conduct, policies, practices, acts and omissions as described in each and all of the foregoing paragraphs as the employers of Plaintiff, the Class, and the Aggrieved Employees. Further, Defendants are responsible for each of the unlawful acts or omissions complained of

herein under the doctrine of “respondeat superior.”

THE PARTIES

A. Plaintiffs

8. Plaintiff HECTOR CARDENAZ is a resident of Mendocino County, California who worked for Defendants in Mendocino County, California at its Ray’s Station Winery location as a non-exempt employee from approximately February 2022 to May 2023.

9. Plaintiff reserves the right to seek leave to amend this complaint to add new Plaintiffs, if necessary, in order to establish suitable representative(s) pursuant to *La Sala v. American Savings and Loan Association* (1971) 5 Cal.3d 864, 872, and other applicable law.

B. Defendants

10. Plaintiff is informed and believes, and based upon that information and belief alleges, that Defendant VINTAGE WINE ESTATES, INC. is, and at all times herein mentioned, was:

- (a) A California corporation conducting business in numerous counties throughout the State of California, including Mendocino County; and,
- (b) The former employer of Plaintiff and the current and/or former employer of the putative Class and Aggrieved Employees because Defendant VINTAGE WINE ESTATES, INC. suffered and permitted Plaintiff, the Class, and the Aggrieved Employees to work, and/or controlled their wages, hours, or working conditions.

11. Plaintiff does not know the true names or capacities of the persons or entities sued herein as Does 1-10, inclusive, and therefore sue said Defendants by such fictitious names. Each of the Doe Defendants was in some manner legally responsible for the damages suffered by Plaintiff, the Class, and the Aggrieved Employees as alleged herein. Plaintiff will amend this complaint to set forth the true names and capacities of these Defendants when they have been ascertained, together with appropriate charging allegations, as may be necessary.

12. At all times mentioned herein, the Defendants named as Does 1-10, inclusive, and each of them, were residents of, doing business in, availed themselves of the jurisdiction of, and/or

injured a significant number of the Plaintiff, the Class, and the Aggrieved Employees in the State of California.

13. Plaintiff is informed and believes and thereon alleges that at all relevant times each Defendant, directly or indirectly, or through agents or other persons, employed Plaintiff and the other employees described in the class definitions below, and exercised control over their wages, hours, and working conditions. Plaintiff is informed and believes and thereon alleges that, at all relevant times, each Defendant was the principal, agent, partner, joint venturer, officer, director, controlling shareholder, subsidiary, affiliate, parent corporation, successor in interest, and/or predecessor in interest of some or all of the other Defendants, and was engaged with some or all of the other Defendants in a joint enterprise, and bore such other relationships to some or all of the other Defendants so as to be liable for their conduct with respect to the matters alleged below. Plaintiff is informed and believes and thereon alleges that each Defendant acted pursuant to and within the scope of the relationships alleged above, that each Defendant knew or should have known about, and authorized, ratified, adopted, approved, controlled, aided, and abetted the conduct of all other Defendants.

ALLEGATIONS COMMON TO ALL CAUSES OF ACTION

14. During Plaintiff's employment for Defendants, Defendants paid Plaintiff an hourly wage and classified Plaintiff as non-exempt from overtime. Defendants typically scheduled Plaintiff to work five days in a workweek, from Mondays through Thursdays and sometimes Fridays, from 4:45 a.m. to 3:15 p.m.

15. Throughout Plaintiff's employment, Defendants failed to pay for all hours worked (including minimum, straight time, and overtime wages), failed to provide Plaintiff with legally compliant meal periods, failed to authorize and permit Plaintiff to take rest periods, failed to timely pay all final wages to Plaintiff when Defendants terminated their employment, failed to furnish accurate wage statements to Plaintiff, and failed to indemnify Plaintiff for expenditures. As discussed below, Plaintiff's experience working for Defendants was typical and illustrative.

16. Throughout the statutory period, Defendants maintained a policy and practice of not paying Plaintiff, the Class, and the Aggrieved Employees for all hours worked, including

1 minimum, straight time, and overtime wages. Defendants required Plaintiff, the Class, and the
2 Aggrieved Employees to work “off-the-clock,” uncompensated, by, for example, requiring
3 Plaintiff, the Class, and the Aggrieved Employees to perform work before clocking in for the day.
4 Some of this unpaid work should have been paid at the overtime rate. In failing to pay for all hours
5 worked, Defendants also failed to maintain accurate records of the hours Plaintiff, the Class, and
6 the Aggrieved Employees worked.

7 17. Throughout the statutory period, Defendants wrongfully failed to provide Plaintiff,
8 the Class, and the Aggrieved Employees with their legally mandated 30-minute, uninterrupted, and
9 duty-free meal periods. Defendants regularly, but not always, required Plaintiff, the Class, and
10 the Aggrieved Employees to work in excess of five consecutive hours a day without providing a
11 30-minute, uninterrupted, and duty-free meal period for every five hours of work, or without
12 compensating Plaintiff, the Class, and the Aggrieved Employees for meal periods that were not
13 provided by the end of the fifth hour of work or tenth hour of work. Instead, Defendants continued
14 to assert control over Plaintiff, the Class, and the Aggrieved Employees by requiring, pressuring,
15 or encouraging them to perform work tasks that could not be completed without working in lieu of
16 taking mandatory meal periods, or by denying Plaintiff, the Class, and the Aggrieved Employees
17 permission to take a meal period. Accordingly, Defendants’ policy and practice was not to provide
18 meal periods to Plaintiff, the Class, and the Aggrieved Employees in compliance with California
19 law.

20 18. Throughout the statutory period, Defendants have wrongfully failed to authorize
21 and permit Plaintiff, the Class, and the Aggrieved Employees to take legally compliant rest periods.
22 Defendants regularly required Plaintiff, the Class, and the Aggrieved Employees to work in excess
23 of four consecutive hours a day without Defendants authorizing and permitting them to take a 10-
24 minute, uninterrupted, duty-free rest period for every four hours of work (or major fraction of four
25 hours), or without compensating Plaintiff, the Class, and the Aggrieved Employees for rest periods
26 that were not authorized or permitted. Instead, Defendants continued to assert control over
27 Plaintiff, the Class, and the Aggrieved Employees by requiring, pressuring, or encouraging them
28 to perform work tasks that could not be completed without working in lieu of taking mandatory

1 rest periods, or by denying Plaintiff, the Class, and the Aggrieved Employees permission to take a
2 rest period. Accordingly, Defendants' policy and practice was to not authorize and permit Plaintiff,
3 the Class, and the Aggrieved Employees to take rest periods in compliance with California law.

4 19. Throughout the statutory period, Defendants willfully failed and refused to timely
5 pay Plaintiff, the Class, and the Aggrieved Employees all final wages due at their termination of
6 employment. In addition, Plaintiff's final paychecks did not include payment for all expenditures,
7 minimum wages, straight-time wages, overtime wages, meal period premium wages, and rest
8 period premium wages owed to her by Defendants at the conclusion of his employment. On
9 information and belief, Defendants' failure to timely pay Plaintiff's final wages when his
10 employment terminated was not a single, isolated incident, but was instead consistent with
11 Defendants' policy and practice that applied to Plaintiff, the Class, and the Aggrieved Employees.

12 20. Throughout the statutory period, Defendants failed to furnish Plaintiff, the Class,
13 and the Aggrieved Employees with accurate, itemized wage statements showing all applicable
14 hourly rates, and all gross and net wages earned (including correct hours worked, correct wages
15 for meal periods that were not provided in accordance with California law, and correct wages for
16 rest periods that were not authorized and permitted to take in accordance with California law). As
17 a result of these violations of California Labor Code § 226(a), the Plaintiff, the Class, and the
18 Aggrieved Employees suffered injury because, among other things:

- 19 (a) the violations led them to believe that they were not entitled to be paid
20 minimum, straight time, overtime, meal period premium, and rest period
21 premium wages, even though they were entitled;
- 22 (b) the violations led them to believe that they had been paid the minimum,
23 straight time, overtime, meal period premium, and rest period premium
24 wages, even though they had not been;
- 25 (c) the violations led them to believe they were not entitled to be paid minimum,
26 straight time, overtime, meal period premium, and rest period premium
27 wages at the correct California rate even though they were entitled;
- 28 (d) the violations led them to believe they had been paid minimum, straight time,

overtime, meal period premium, and rest period premium wages at the correct California rate even though they had not been;

(e) the violations hindered them from determining the amounts of minimum, straight time, overtime, meal period premium, and rest period premium wages owed to them;

(f) in connection with their employment before and during this action, and in connection with prosecuting this action, the violations caused them to have to perform mathematical computations to determine the amounts of wages owed to them, computations they would not have to make if the wage statements contained the required accurate information;

(g) by understating the wages truly due to them, the violations caused them to lose entitlement and/or accrual of the full amount of Social Security, disability, unemployment, and other governmental benefits;

(h) the wage statements inaccurately understated the wages, hours, and wage rates to which Plaintiff, the Class, and the Aggrieved Employees were entitled, and Plaintiff, the Class, and the Aggrieved Employees were paid less than the wages and wage rates to which they were entitled.

Thus, Plaintiff, the Class, and the Aggrieved Employees are owed the amounts provided for in California Labor Code § 226 and injunctive relief under California Labor Code § 226(h).

21. Throughout the statutory period, Defendants have wrongfully required Plaintiff, the Class, and the Aggrieved Employees to pay expenses that they incurred in the direct discharge of their duties for Defendants. Plaintiff, the Class, and the Aggrieved Employees regularly paid out-of-pocket for necessary employment-related expenses, including but not limited to cell phone use.

22. Plaintiff, the Class, and the Aggrieved Employees incurred substantial expenses as a direct result of performing their job duties for Defendants, but Defendants failed to indemnify Plaintiff, the Class, and the Aggrieved Employees for these employment-related expenses.

CLASS ACTION ALLEGATIONS

23. Plaintiff brings certain claims individually, as well as on behalf of each and all other

persons similarly situated, and thus, seeks class certification under California Code of Civil Procedure § 382.

24. All claims alleged herein arise under California law for which Plaintiff seeks relief authorized by California law.

25. The proposed Class consists of and is defined as:

All persons who worked for any Defendant in California as an hourly-paid or non-exempt employee at any time during the period beginning four years and 178 days before the filing of the initial complaint in this action and ending when notice to the Class is sent.¹

26. At all material times, Plaintiff was a member of the Class.

27. Plaintiff undertakes this concerted activity to improve the wages and working conditions of all Class Members.

28. There is a well-defined community of interest in the litigation and the Class is readily ascertainable:

(a) Numerosity: The members of the Class (and each subclass, if any) are so numerous that joinder of all members would be unfeasible and impractical. The membership of the entire Class is unknown to Plaintiff at this time; however, the Class is estimated to be greater than forty (40) individuals and the identity of such membership is readily ascertainable by inspection of Defendants' records.

(b) Typicality: Plaintiff is qualified to, and will, fairly and adequately protect the interests of each Class Member with whom there is a shared, well-defined community of interest, and Plaintiff's claims (or defenses, if any) are typical of all Class Members' claims as demonstrated herein.

(c) Adequacy: Plaintiff is qualified to, and will, fairly and adequately protect the interests of each Class Member with whom there is a shared, well-defined community of interest and typicality of claims, as demonstrated

¹ In response to the COVID-19 pandemic, the Judicial Council of California adopted Emergency Rule 9(a) (California Rules of Court), whereby "statutes of limitations and repose for civil causes of action that exceed 180 days are tolled from April 6, 2020 to October 1, 2020."

herein. Plaintiff has no conflicts with or interests antagonistic to any Class Member. Plaintiff's attorneys, the proposed class counsel, are versed in the rules governing class action discovery, certification, and settlement. Plaintiff has incurred, and throughout the duration of this action, will continue to incur costs and attorneys' fees that have been, are, and will be necessarily expended for the prosecution of this action for the substantial benefit of each class member.

(d) Superiority: A Class Action is superior to other available methods for the fair and efficient adjudication of the controversy, including consideration of:

- 1) The interests of the members of the Class in individually controlling the prosecution or defense of separate actions;
- 2) The extent and nature of any litigation concerning the controversy already commenced by or against members of the Class;
- 3) The desirability or undesirability of concentrating the litigation of the claims in the particular forum; and,
- 4) The difficulties likely to be encountered in the management of a class action.

(e) Public Policy Considerations: The public policy of the State of California is to resolve the California Labor Code claims of many employees through a class action. Indeed, current employees are often afraid to assert their rights out of fear of direct or indirect retaliation. Former employees are also fearful of bringing actions because they believe their former employers might damage their future endeavors through negative references and/or other means. Class actions provide the class members who are not named in the complaint with a type of anonymity that allows for the vindication of their rights at the same time as their privacy is protected.

29. There are common questions of law and fact as to the Class (and each subclass, if any) that predominate over questions affecting only individual members, including without

1 limitation, whether, as alleged herein, Defendants have:

- 2 (a) Failed to pay Class Members for all hours worked, including minimum,
3 straight time, and overtime wages;
- 4 (b) Failed to provide meal periods and pay meal period premium wages to Class
5 Members;
- 6 (c) Failed to authorize and permit rest periods and pay rest period premium
7 wages to Class Members;
- 8 (d) Failed to provide Class Members with timely final wages;
- 9 (e) Failed to provide Class Members with accurate wage statements;
- 10 (f) Failed to indemnify Class Members for expenditures; and,
- 11 (g) Violated California Business & Professions Code §§ 17200 *et. seq.* as a
12 result of their illegal conduct as described above.

13 30. This Court should permit this action to be maintained as a class action pursuant to
14 California Code of Civil Procedure § 382 because:

- 15 (a) The questions of law and fact common to the Class predominate over any
16 question affecting only individual members;
- 17 (b) A class action is superior to any other available method for the fair and
18 efficient adjudication of the claims of the members of the Class;
- 19 (c) The members of the Class are so numerous that it is impractical to bring all
20 members of the class before the Court;
- 21 (d) Plaintiff, and the other members of the Class, will not be able to obtain
22 effective and economic legal redress unless the action is maintained as a
23 class action;
- 24 (e) There is a community of interest in obtaining appropriate legal and equitable
25 relief for the statutory violations, and in obtaining adequate compensation
26 for the damages and injuries for which Defendants are responsible in an
27 amount sufficient to adequately compensate the members of the Class for
28 the injuries sustained;

(f) Without class certification, the prosecution of separate actions by individual members of the class would create a risk of:

- 1) Inconsistent or varying adjudications with respect to individual members of the Class which would establish incompatible standards of conduct for Defendants; and/or,
- 2) Adjudications with respect to the individual members which would, as a practical matter, be dispositive of the interests of other members not parties to the adjudications, or would substantially impair or impede their ability to protect their interests, including but not limited to the potential for exhausting the funds available from those parties who are, or may be, responsible Defendants; and,

(g) Defendants have acted or refused to act on grounds generally applicable to the Class, thereby making final injunctive relief appropriate with respect to the class as a whole.

31. Plaintiff contemplates the eventual issuance of notice to the proposed members of the Class that would set forth the subject and nature of the instant action. The Defendants' own business records may be utilized for assistance in the preparation and issuance of the contemplated notices. To the extent that any further notices may be required, Plaintiff contemplates the use of additional techniques and forms commonly used in class actions, such as published notice, e-mail notice, website notice, first-class mail, or combinations thereof, or by other methods suitable to the Class and deemed necessary and/or appropriate by the Court.

FIRST CAUSE OF ACTION

(Against All Defendants for Failure to Pay Minimum and Straight Time Wages for All Hours Worked)

32. Plaintiff incorporates by reference and re-alleges as if fully stated herein paragraphs 1 through 22 in this Complaint.

33. "Hours worked" is the time during which an employee is subject to the control of an employer, and includes all the time the employee is suffered or permitted to work, whether or

not required to do so.

34. At all relevant times herein mentioned, Defendants knowingly failed to pay to Plaintiff and the Class compensation for all hours they worked. By their failure to pay compensation for each hour worked as alleged above, Defendants willfully violated the provisions of California Labor Code § 1194, and any additional applicable Wage Orders, which require such compensation to non-exempt employees.

35. Accordingly, Plaintiff and the Class are entitled to recover minimum and straight time wages for all non-overtime hours worked for Defendants.

36. By and through the conduct described above, Plaintiff and the Class have been deprived of their rights to be paid wages earned by virtue of their employment with Defendants.

37. By virtue of the Defendants' unlawful failure to pay additional compensation to Plaintiff and the Class for their non-overtime hours worked without pay, Plaintiff and the Class suffered, and will continue to suffer, damages in amounts which are presently unknown to Plaintiff and the Class, and which will be ascertained according to proof at trial.

38. By failing to keep adequate time records required by California Labor Code § 1174(d), Defendants have made it difficult to calculate the full extent of minimum wage compensation due to Plaintiff and the Class.

39. Pursuant to California Labor Code § 1194.2, Plaintiff and the Class are entitled to recover liquidated damages (double damages) for Defendants' failure to pay minimum wages.

40. California Labor Code § 204 requires employers to provide employees with all wages due and payable twice a month. Throughout the statute of limitations period applicable to this cause of action, Plaintiff and the Class were entitled to be paid twice a month at rates required by law, including minimum and straight time wages. However, during all such times, Defendants systematically failed and refused to pay Plaintiff and the Class all such wages due and failed to pay those wages twice a month.

41. Plaintiff and the Class are also entitled to seek recovery of all unpaid minimum and straight time wages, interest, and reasonable attorneys' fees and costs pursuant to California Labor Code §§ 218.5, 218.6, and 1194(a).

SECOND CAUSE OF ACTION

(Against All Defendants for Failure to Pay Overtime Wages)

42. Plaintiff incorporates by reference and re-alleges as if fully stated herein paragraphs 1 through 22 in this Complaint.

43. California Labor Code § 510 provides that employees in California shall not be employed more than eight hours in any workday or forty (40) hours in a workweek unless they receive additional compensation beyond their regular wages in amounts specified by law.

44. California Labor Code §§ 1194 and 1198 provide that employees in California shall not be employed more than eight hours in any workday unless they receive additional compensation beyond their regular wages in amounts specified by law. Additionally, California Labor Code § 1198 states that the employment of an employee for longer hours than those fixed by the IWC is unlawful.

45. At all times relevant hereto, Plaintiff and the Class have worked more than eight hours in a workday and/or more than forty (40) hours in a workweek, as employees of Defendants.

46. At all times relevant hereto, Defendants failed to pay Plaintiff and the Class overtime compensation for the hours they have worked in excess of the maximum hours permissible by law as required by California Labor Code §§ 510 and 1198.

47. By virtue of Defendants' unlawful failure to pay additional premium rate compensation to the Plaintiff and the Class for their overtime hours worked, Plaintiff and the Class have suffered and will continue to suffer, damages in amounts which are presently unknown to them but which exceed the jurisdictional minimum of this Court and which will be ascertained according to proof at trial.

48. By failing to keep adequate time records required by Labor Code § 1174(d), Defendants have made it difficult to calculate the full extent of overtime compensation due to Plaintiff and the Class.

49. Plaintiff and the Class also request recovery of overtime compensation according to proof, interest, attorneys' fees and costs pursuant to California Labor Code § 1194(a), as well as the assessment of any statutory penalties against Defendants, in a sum as provided by the California

1 Labor Code and/or other statutes.

2 50. California Labor Code § 204 requires employers to provide employees with all
3 wages due and payable twice a month. The Wage Orders also provide that every employer shall
4 pay to each employee, on the established payday for the period involved, overtime wages for all
5 overtime hours worked in the payroll period. Defendants failed to provide Plaintiff and the Class
6 with all compensation due, in violation of California Labor Code § 204.

7 **THIRD CAUSE OF ACTION**

8 **(Against All Defendants for Failure to Provide Meal Periods)**

9 51. Plaintiff incorporates by reference and re-alleges as if fully stated herein
10 paragraphs 1 through 22 in this Complaint.

11 52. Under California law, Defendants have an affirmative obligation to relieve the
12 Plaintiff and the Class of all duty in order to take their first daily meal periods no later than the
13 start of Plaintiff and the Class' sixth hour of work in a workday, and to take their second meal
14 periods no later than the start of the eleventh hour of work in the workday. California Labor Code
15 § 512, and Section 11 of the applicable Wage Orders require that an employer provide unpaid meal
16 periods of at least thirty (30) minutes for each five-hour period worked. It is a violation of
17 California Labor Code § 226.7 for an employer to require any employee to work during any meal
18 period mandated under any Wage Order.

19 53. Despite these legal requirements, Defendants regularly failed to provide Plaintiff
20 and the Class with both meal periods as required by California law. By their failure to permit and
21 authorize Plaintiff and the Class to take all meal periods as alleged above (or due to the fact that
22 Defendants made it impossible or impracticable to take these uninterrupted meal periods),
23 Defendants willfully violated the provisions of California Labor Code § 226.7 and the applicable
24 Wage Orders.

25 54. Under California law, Plaintiff and the Class are entitled to be paid one hour of
26 additional wages for each workday he or she was not provided with all required meal period(s),
27 plus interest thereon.

28 ///

FOURTH CAUSE OF ACTION

(Against All Defendants for Failure to Authorize and Permit Rest Periods)

55. Plaintiff incorporates by reference and re-alleges as if fully stated herein paragraphs 1 through 22 in this Complaint.

56. Defendants are required by California law to authorize and permit breaks of ten uninterrupted minutes for each four hours of work or major fraction of four hours (i.e. more than two hours). California Labor Code § 512, the applicable Wage Orders require that the employer permit and authorize all employees to take paid rest periods of ten minutes each for each 4-hour period worked. Thus, for example, if an employee's work time is six hours and ten minutes, the employee is entitled to two rest breaks. Each failure to authorize rest breaks as so required is itself a violation of California's rest break laws. It is a violation of California Labor Code § 226.7 for an employer to require any employee to work during any rest period mandated under any Wage Order.

57. Despite these legal requirements, Defendants failed to authorize Plaintiff and the Class to take rest breaks, regardless of whether employees worked more than four hours in a workday. By their failure to permit and authorize Plaintiff and the Class to take rest periods as alleged above (or due to the fact that Defendants made it impossible or impracticable to take these uninterrupted rest periods), Defendants willfully violated the provisions of California Labor Code § 226.7 and the applicable Wage Orders.

58. Under California law, Plaintiff and the Class are entitled to be paid one hour of premium wages rate for each workday he or she was not provided with all required rest break(s), plus interest thereon.

FIFTH CAUSE OF ACTION

**(Against All Defendants for Failure to Pay Wages of
Discharged Employees – Waiting Time Penalties)**

59. Plaintiff incorporates by reference and re-alleges as if fully stated herein paragraphs 1 through 22 in this Complaint.

60. At all times herein set forth, California Labor Code §§ 201 and 202 provide that if

1 an employer discharges an employee, the wages earned and unpaid at the time of discharge are due
2 and payable immediately, and that if an employee voluntarily leaves his or her employment, his or
3 her wages shall become due and payable not later than seventy-two (72) hours thereafter, unless
4 the employee has given seventy-two (72) hours previous notice of his or her intention to quit, in
5 which case the employee is entitled to his or her wages at the time of quitting.

6 61. Within the applicable statute of limitations, the employment of many other members
7 of the Class ended, i.e. was terminated by quitting or discharge, and the employment of others will
8 be. However, during the relevant time period, Defendants failed, and continue to fail to pay
9 terminated Class Members, without abatement, all wages required to be paid by California Labor
10 Code §§ 201 and 202 either at the time of discharge, or within seventy-two (72) hours of their
11 leaving Defendants' employ.

12 62. Defendants' failure to pay those Class members who are no longer employed by
13 Defendants their wages earned and unpaid at the time of discharge, or within seventy-two (72)
14 hours of their leaving Defendants' employ, is in violation of California Labor Code §§ 201 and
15 202.

16 63. California Labor Code § 203 provides that if an employer willfully fails to pay
17 wages owed, in accordance with §§ 201 and 202, then the wages of the employee shall continue as
18 a penalty wage from the due date, and at the same rate until paid or until an action is commenced;
19 but the wages shall not continue for more than thirty (30) days.

20 64. The Class is entitled to recover from Defendants their additionally accruing wages
21 for each day they were not paid, at their regular hourly rate of pay, up to thirty (30) days maximum
22 pursuant to California Labor Code § 203.

23 65. Pursuant to California Labor Code §§ 218.5, 218.6 and 1194, the Class is also
24 entitled to an award of reasonable attorneys' fees, interest, expenses, and costs incurred in this
25 action.

26 ///

27 ///

28 ///

SIXTH CAUSE OF ACTION

**(Against All Defendants for Failure to Provide and Maintain Accurate and
Compliant Wage Records)**

66. Plaintiff incorporates by reference and re-alleges as if fully stated herein paragraphs 1 through 22 in this Complaint.

67. At all material times set forth herein, California Labor Code § 226(a) provides that every employer shall furnish each of his or her employees an accurate itemized wage statement in writing showing nine pieces of information, including: (1) gross wages earned, (2) total hours worked by the employee, (3) the number of piece-rate units earned and any applicable piece rate if the employee is paid on a piece-rate basis, (4) all deductions, provided that all deductions made on written orders of the employee may be aggregated and shown as one item, (5) net wages earned, (6) the inclusive dates of the period for which the employee is paid, (7) the name of the employee and the last four digits of his or her social security number or an employee identification number other than a social security number, (8) the name and address of the legal entity that is the employer, and (9) all applicable hourly rates in effect during the pay period and the corresponding number of hours worked at each hourly rate by the employee.

68. Defendants have intentionally and willfully failed to provide employees with complete and accurate wage statements. The deficiencies include, among other things, the failure to correctly identify the gross wages earned by Plaintiff and the Class, the failure to list the true “total hours worked by the employee,” and the failure to list the true net wages earned.

69. As a result of Defendants’ violation of California Labor Code § 226(a), Plaintiff and the Class have suffered injury and damage to their statutorily protected rights.

70. Specifically, Plaintiff and the members of the Class have been injured by Defendants’ intentional violation of California Labor Code § 226(a) because they were denied both their legal right to receive and their protected interest in receiving, accurate, itemized wage statements under California Labor Code § 226(a).

71. Calculation of the true wage entitlement for Plaintiff and the Class is difficult and time consuming. As a result of this unlawful burden, Plaintiff and the Class were also injured as

1 a result of having to bring this action to attempt to obtain correct wage information following
2 Defendants' refusal to comply with many of the mandates of California's Labor Code and related
3 laws and regulations.

4 72. Plaintiff and the Class are entitled to recover from Defendants the greater of their
5 actual damages caused by Defendants' failure to comply with California Labor Code § 226(a).

6 73. Plaintiff and the Class are also entitled to injunctive relief, as well as an award of
7 attorney's fees and costs to ensure compliance with this section, pursuant to California Labor Code
8 § 226(h).

9 **SEVENTH CAUSE OF ACTION**

10 **(Against All Defendants for Failure to Indemnify Employees for Expenditures)**

11 74. Plaintiff incorporates by reference and re-alleges as if fully stated herein
12 paragraphs 1 through 22 in this Complaint.

13 75. As set forth above, Plaintiff and the Class were required to incur substantial
14 necessary expenditures and losses in direct consequence of the discharge of their duties or of their
15 obedience to directions of Defendants.

16 76. Defendants violated California Labor Code § 2802, by failing to pay and
17 indemnify Plaintiff and the Class for necessary expenditures and losses incurred in direct
18 consequence of the discharge of their duties or of their obedience to directions of Defendants.

19 77. As a result, Plaintiff and the Class were damaged at least in the amounts of the
20 expenses they paid, or which were deducted by Defendants from their wages.

21 78. Plaintiff and the Class are entitled to reasonable attorney's fees, expenses, and
22 costs of suit pursuant to California Labor Code § 2802(c) and interest pursuant to California Labor
23 Code § 2802(b).

24 **EIGHTH CAUSE OF ACTION**

25 **(Against All Defendants for Violation of California**

26 **Business & Professions Code §§ 17200, et seq.)**

27 79. Plaintiff incorporates by reference and re-alleges as if fully stated herein paragraphs
28 1 through 22 in this Complaint.

80. Defendants, and each of them, are “persons” as defined under California Business & Professions Code § 17201.

81. Defendants’ conduct, as alleged herein, has been, and continues to be, unfair, unlawful, and harmful to Plaintiff, other Class members, and to the general public. Plaintiff seeks to enforce important rights affecting the public interest within the meaning of Code of Civil Procedure § 1021.5.

82. Defendants’ activities, as alleged herein, are violations of California law, and constitute unlawful business acts and practices in violation of California Business & Professions Code §§ 17200, *et seq.*

83. A violation of California Business & Professions Code §§ 17200, *et seq.* may be predicated on the violation of any state or federal law. All of the acts described herein as violations of, among other things, the California Labor Code, are unlawful and in violation of public policy; in addition are immoral, unethical, oppressive, fraudulent and unscrupulous, and thereby constitute unfair, unlawful, and/or fraudulent business practices in violation of California Business & Professions Code §§ 17200, *et seq.*

Failure to Pay Minimum and Straight Time Wages

84. Defendants’ failure to pay minimum and straight time wages, and other benefits in violation of the California Labor Code constitutes unlawful and/or unfair activity prohibited by California Business & Professions Code §§ 17200, *et seq.*

Failure to Pay Overtime Wages

85. Defendants’ failure to pay overtime compensation and other benefits in violation of California Labor Code §§ 510, 1194, and 1198 constitutes unlawful and/or unfair activity prohibited by California Business & Professions Code §§ 17200, *et seq.*

Failure to Provide Meal Periods

86. Defendants’ failure to provide meal periods in accordance with California Labor Code §§ 226.7 and 512, and the IWC Wage Orders, as alleged above, constitutes unlawful and/or unfair activity prohibited by California Business & Professions Code §§ 17200, *et seq.*

///

1 **Failure to Authorize and Permit Rest Periods**

2 87. Defendants' failure to authorize and permit rest periods in accordance with
3 California Labor Code § 226.7 and the IWC Wage Orders, as alleged above, constitutes unlawful
4 and/or unfair activity prohibited by Business and Professions Code §§ 17200, *et seq.*

5 **Failure to Indemnify Business Expenses**

6 88. Defendants' failure to reimburse expenses incurred in accordance with California
7 Labor Code § 2802, as alleged above, constitutes unlawful and/or unfair activity prohibited by
8 California Business & Professions Code §§ 17200, *et seq.*

9 89. By and through their unfair, unlawful and/or fraudulent business practices described
10 herein, the Defendants, have obtained valuable property, money and services from Plaintiff, and
11 all persons similarly situated, and have deprived Plaintiff, and all persons similarly situated, of
12 valuable rights and benefits guaranteed by law, all to their detriment.

13 90. Plaintiff and the Class Members suffered monetary injury as a direct result of
14 Defendants' wrongful conduct.

15 91. Plaintiff, individually, and on behalf of members of the putative Class, is entitled
16 to, and does, seek such relief as may be necessary to disgorge money and/or property which the
17 Defendants have wrongfully acquired, or of which Plaintiff and the Class have been deprived, by
18 means of the above-described unfair, unlawful and/or fraudulent business practices. Plaintiff and
19 the Class are not obligated to establish individual knowledge of the wrongful practices of
20 Defendants in order to recover restitution.

21 92. Plaintiff, individually, and on behalf of members of the putative class, is further
22 entitled to and does seek a declaration that the above-described business practices are unfair,
23 unlawful and/or fraudulent, and injunctive relief restraining the Defendants, and each of them,
24 from engaging in any of the above-described unfair, unlawful and/or fraudulent business practices
25 in the future.

26 93. Plaintiff, individually, and on behalf of members of the putative class, has no plain,
27 speedy, and/or adequate remedy at law to redress the injuries which the Class Members suffered
28 as a consequence of the Defendants' unfair, unlawful and/or fraudulent business practices. As a

1 result of the unfair, unlawful, and/or fraudulent business practices described above, Plaintiff,
2 individually, and on behalf of members of the putative Class, has suffered and will continue to
3 suffer irreparable harm unless the Defendants, and each of them, are restrained from continuing to
4 engage in said unfair, unlawful and/or fraudulent business practices.

5 94. Plaintiff also alleges that if Defendants are not enjoined from the conduct set forth
6 herein above, they will continue to avoid paying the appropriate taxes, insurance, and other
7 withholdings.

8 95. Pursuant to California Business & Professions Code §§ 17200, *et seq.*, Plaintiff and
9 putative Class Members are entitled to restitution of the wages withheld and retained by
10 Defendants during a period that commences four years and 178 days prior to the filing of this
11 complaint; a permanent injunction requiring Defendants to pay all outstanding wages due to
12 Plaintiff and Class Members; an award of attorneys' fees pursuant to California Code of Civil
13 Procedure § 1021.5 and other applicable laws; and an award of costs.

14 **NINTH CAUSE OF ACTION**

15 **(Against all Defendants for Civil Penalties Under the**

16 **Private Attorneys General Act of 2004, Cal. Lab. Code § 2698 *et seq.*)**

17 96. Plaintiff incorporates by reference and re-alleges as if fully stated herein paragraphs
18 1 through 22 in this Complaint.

19 97. At all times herein mentioned, Defendants were subject to the Labor Code of the
20 State of California and the applicable Industrial Welfare Commission Orders.

21 98. California Labor Code § 2699(a) specifically provides for a private right of action
22 to recover penalties for violations of the Labor Code: "Notwithstanding any other provision of law,
23 any provision of this code that provides for a civil penalty to be assessed and collected by the Labor
24 and Workforce Development Agency or any of its departments, divisions, commissions, boards,
25 agencies, or employees, for a violation of this code, may, as an alternative, be recovered through a
26 civil action brought by an aggrieved employee on behalf of himself or herself and other current or
27 former employees pursuant to the procedures specified in Section 2699.3."

28 99. Plaintiff has exhausted his administrative remedies pursuant to California Labor

Code § 2699.3. He gave written notice by online filing to the LWDA and by certified mail to Defendant of the specific provisions of the Labor Code that Defendant violated against Plaintiff and current and former aggrieved employees, including the facts and theories to support the violations. Plaintiff also paid the filing fee.

100. The LWDA has not indicated that it intends to investigate Defendant's Labor Code violations discussed in the notice. Accordingly, Plaintiff may commence a civil action to recover penalties under Labor Code § 2699 pursuant to § 2699.3 for the violations of the Labor Code described in this Complaint. These penalties include, but are not limited to, penalties under California Labor Code §§ 210, 226.3, 1174.5, 1197.1, and 2699.

101. Based on the conduct described in this Complaint, Plaintiff is entitled to an award of civil penalties on behalf of himself, the State of California, and similarly Aggrieved Employees of Defendants. The exact amount of the applicable penalties, in all, is in an amount to be shown according to proof at trial. These penalties are in addition to all other remedies permitted by law.

102. In addition, Plaintiff seeks an award of reasonable attorney's fees and costs pursuant to California Labor Code § 2699(g)(1), which states, "Any employee who prevails in any action shall be entitled to an award of reasonable attorney's fees and costs."

PRAYER FOR RELIEF

Plaintiff, individually, and on behalf of all others similarly situated only with respect to the class claims, prays for relief and judgment against Defendants, jointly and severally, as follows:

Class Certification

1. That this action be certified as a class action with respect to the First, Second, Third, Fourth, Fifth, Sixth, Seventh, and Eighth Causes of Action;
2. That Plaintiff be appointed as the representative of the Class; and,
3. That counsel for Plaintiff be appointed as Class Counsel.

As to the First Cause of Action

4. That the Court declare, adjudge, and decree that Defendants violated California Labor Code §§ 204 and 1194 and applicable IWC Wage Orders by willfully failing to pay all minimum and straight time wages due;

5. For unpaid wages as may be appropriate;

6. For pre-judgment interest on any unpaid compensation commencing from the date such amounts were due;

7. For liquidated damages;

8. For reasonable attorneys' fees and for costs of suit incurred herein pursuant to California Labor Code § 1194(a); and,

9. For such other and further relief as the Court may deem equitable and appropriate.

As to the Second Cause of Action

10. That the Court declare, adjudge, and decree that Defendants violated California Labor Code §§ 510 and 1198 and applicable IWC Wage Orders by willfully failing to pay all overtime wages due;

11. For unpaid wages at overtime wage rates as may be appropriate;

12. For pre-judgment interest on any unpaid overtime compensation commencing from the date such amounts were due;

13. For reasonable attorneys' fees and for costs of suit incurred herein pursuant to California Labor Code § 1194(a); and,

14. For such other and further relief as the Court may deem equitable and appropriate.

As to the Third Cause of Action

15. That the Court declare, adjudge, and decree that Defendants violated California Labor Code §§ 226.7 and 512, and the IWC Wage Orders;

16. For unpaid meal period premium wages as may be appropriate;

17. For pre-judgment interest on any unpaid compensation commencing from the date such amounts were due;

18. For reasonable attorneys' fees under California Code of Civil Procedure § 1021.5, and for costs of suit incurred herein; and,

19. For such other and further relief as the Court may deem equitable and appropriate.

As to the Fourth Cause of Action

20. That the Court declare, adjudge, and decree that Defendants violated California

Labor Code §§ 226.7 and 512, and the IWC Wage Orders;

21. For unpaid rest period premium wages as may be appropriate;

22. For pre-judgment interest on any unpaid compensation commencing from the date such amounts were due;

23. For reasonable attorneys' fees under California Code of Civil Procedure § 1021.5, and for costs of suit incurred herein; and,

24. For such other and further relief as the Court may deem equitable and appropriate.

As to the Fifth Cause of Action

25. That the Court declare, adjudge and decree that Defendants violated California Labor Code §§ 201, 202, and 203 by willfully failing to pay all compensation owed at the time of termination of the employment;

26. For statutory wage penalties pursuant to California Labor Code § 203 for former employees who have left Defendants' employ;

27. For pre-judgment interest on any unpaid wages from the date such amounts were due;

28. For reasonable attorneys' fees and for costs of suit incurred herein; and,

29. For such other and further relief as the Court may deem equitable and appropriate.

As to the Sixth Cause of Action

30. That the Court declare, adjudge, and decree that Defendants violated the record keeping provisions of California Labor Code § 226(a) and applicable IWC Wage Orders, and willfully failed to provide accurate itemized wage statements thereto;

31. For all actual damages, according to proof;

32. For injunctive relief to ensure compliance with this section, pursuant to California Labor Code § 226(h);

33. For reasonable attorneys' fees and for costs of suit incurred herein; and,

34. For such other and further relief as the Court may deem equitable and appropriate.

As to the Seventh Cause of Action

35. That the Court declare, adjudge, and decree that Defendants violated California

1 Labor Code § 2802 by willfully failing to indemnify employees for expenditures;

2 36. For unpaid wages or unreimbursed business expenses as may be appropriate;

3 37. For pre-judgment interest on any unpaid compensation commencing from the date
4 such amounts were due;

5 38. For reasonable attorneys' fees and for costs of suit incurred herein; and,

6 39. For such other and further relief as the Court may deem equitable and appropriate.

7 As to the Eighth Cause of Action

8 40. That the Court declare, adjudge, and decree that Defendants violated California
9 Business & Professions Code §§ 17200, et seq. by failing to pay for all hours worked (minimum,
10 straight time, and overtime wages), failing to provide meal periods, failing to authorize and permit
11 rest periods, and failing to indemnify employees for expenditures;

12 41. For restitution of unpaid wages to Plaintiff and all Class Members and prejudgment
13 interest from the day such amounts were due and payable;

14 42. For the appointment of a receiver to receive, manage and distribute any and all funds
15 disgorged from Defendants and determined to have been wrongfully acquired by Defendants as a
16 result of violations of California Business & Professions Code §§ 17200 et seq.;

17 43. For reasonable attorneys' fees and costs of suit incurred herein pursuant to
18 California Code of Civil Procedure § 1021.5;

19 44. For injunctive relief to ensure compliance with this section, pursuant to California
20 Business & Professions Code §§ 17200, et seq.; and,

21 45. For such other and further relief as the Court may deem equitable and appropriate.

22 As to the Ninth Cause of Action

23 46. That the Court declare, adjudge and decree that Defendants violated the California
24 Labor Code by failing to pay wages for all hours worked (including minimum, straight time, and
25 overtime wages), failing to provide meal periods and pay the correct amount of meal period
26 premium wages, failing to authorize and permit rest periods and pay the correct amount of rest
27 period premium wages, failing to pay all final wages to terminated employees, failing to furnish
28 accurate wage statements, and failing to reimburse employees for all necessary business expenses.

1 47. For all actual, consequential, and incidental losses and damages, according to proof;

2 48. For all civil penalties pursuant to California Labor Code §§ 2699, *et seq.*, and all
3 other applicable Labor Code provisions;

4 49. For reasonable attorneys' fees and costs of suit incurred herein pursuant to
5 California Labor Code § 2699; and

6 50. For such other and further relief as the Court may deem equitable and appropriate.

7 As to all Causes of Action

8 51. For any additional relief that the Court deems just and proper.

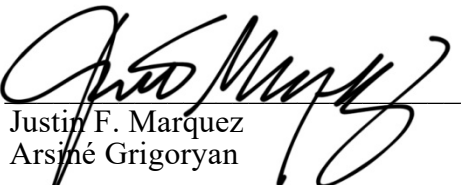

DEMAND FOR JURY TRIAL

1 Plaintiff HECTOR CARDENAZ (“Plaintiff”), based upon facts that either have evidentiary
2 support or are likely to have evidentiary support after a reasonable opportunity for further
3 investigation and discovery, alleges as follows:

4 **INTRODUCTION & PRELIMINARY STATEMENT**

5 1. Plaintiffs bring this action against Defendant VINTAGE WINE ESTATES, INC.
6 and DOES 1 through 10 (hereinafter collectively referred to as “Defendants”) for California Labor
7 Code violations and unfair business practices stemming from Defendants’ failure to pay for all
8 hours worked (minimum, straight time, and overtime wages), failure to provide meal periods,
9 failure to authorize and permit rest periods, failure to timely pay final wages, failure to furnish
10 accurate wage statements, and failure to indemnify employees for expenditures.

11 2. Plaintiff brings the First through Eighth Causes of Action individually and as a class
12 action on behalf of himself and certain current and former employees of Defendants (hereinafter
13 collectively referred to as the “Class” or “Class Members,” and defined more fully below). The
14 Class consists of Plaintiff and all other persons who have been employed by any Defendant in
15 California as an hourly-paid or non-exempt employee during the statute of limitations period
16 applicable to the claims pleaded here.

17 2.3. Plaintiff brings the Ninth Cause of Action as a representative action under the
18 California Private Attorneys General Act (“PAGA”) to recover civil penalties that are owed to
19 Plaintiff, the State of California, and past and present non-exempt employees by Defendants in the
20 State of California during the statute of limitations period for his PAGA claim (hereinafter referred
21 to as the “Aggrieved Employees”).

22 3.4. Defendants own/owned and operate/operated an industry, business, and
23 establishment within the State of California, including Mendocino County. As such and based
24 upon all the facts and circumstances incident to Defendants’ business in California, Defendants are
25 subject to the California Labor Code, Wage Orders issued by the Industrial Welfare Commission
26 (“IWC”), and the California Business & Professions Code.

27 4.5. Despite these requirements, throughout the statutory period, Defendants maintained
28 a systematic, company-wide policy and practice of:

- (a) Failing to pay employees for all hours worked, including all minimum, straight time, and overtime wages in compliance with the California Labor Code and IWC Wage Orders;
- (b) Failing to provide employees with timely and duty-free meal periods in compliance with the California Labor Code and IWC Wage Orders, failing to maintain accurate records of all meal periods taken or missed, and failing to pay an additional hour's pay for each workday a meal period violation occurred;
- (c) Failing to authorize and permit employees to take timely and duty-free rest periods in compliance with the California Labor Code and IWC Wage Orders, and failing to pay an additional hour's pay for each workday a rest period violation occurred;
- (d) Willfully failing to pay employees all minimum, straight time, overtime, meal period premium, and rest period premium wages due within the time period specified by California law when employment terminates;
- (e) Failing to provide employees with accurate, itemized wage statements containing all the information required by the California Labor Code and IWC Wage Orders; and,
- (f) Failing to indemnify employees for expenditures incurred in direct discharge of duties of employment.

5-6. On information and belief, Defendants, and each of them were on actual and constructive notice of the improprieties alleged herein and intentionally refused to rectify their unlawful policies. Defendants' violations, as alleged above, during all relevant times herein were willful and deliberate.

6-7. At all relevant times, Defendants were and are legally responsible for all of the unlawful conduct, policies, practices, acts and omissions as described in each and all of the foregoing paragraphs as the employers of Plaintiff, ~~and~~ the Class, and the Aggrieved Employees. Further, Defendants are responsible for each of the unlawful acts or omissions complained of

herein under the doctrine of “respondeat superior.”

THE PARTIES

A. Plaintiffs

~~7-8.~~ Plaintiff HECTOR CARDENAZ is a resident of Mendocino County, California who worked for Defendants in Mendocino County, California at its Ray’s Station Winery location as a non-exempt employee from approximately February 2022 to May 2023.

~~8-9.~~ Plaintiff reserves the right to seek leave to amend this complaint to add new Plaintiffs, if necessary, in order to establish suitable representative(s) pursuant to *La Sala v. American Savings and Loan Association* (1971) 5 Cal.3d 864, 872, and other applicable law.

B. Defendants

~~9-10.~~ Plaintiff is informed and believes, and based upon that information and belief alleges, that Defendant VINTAGE WINE ESTATES, INC. is, and at all times herein mentioned, was:

- (a) A California corporation conducting business in numerous counties throughout the State of California, including Mendocino County; and,
- (b) The former employer of Plaintiff and the current and/or former employer of the putative Class and Aggrieved Employees because Defendant VINTAGE WINE ESTATES, INC. suffered and permitted Plaintiff, ~~and~~ the Class, and the Aggrieved Employees to work, and/or controlled their wages, hours, or working conditions.

~~10-11.~~ Plaintiff does not know the true names or capacities of the persons or entities sued herein as Does 1-10, inclusive, and therefore sue said Defendants by such fictitious names. Each of the Doe Defendants was in some manner legally responsible for the damages suffered by Plaintiff, ~~and~~ the Class, and the Aggrieved Employees as alleged herein. Plaintiff will amend this complaint to set forth the true names and capacities of these Defendants when they have been ascertained, together with appropriate charging allegations, as may be necessary.

~~11-12.~~ At all times mentioned herein, the Defendants named as Does 1-10, inclusive, and each of them, were residents of, doing business in, availed themselves of the jurisdiction of, and/or

1 injured a significant number of the Plaintiff, ~~and~~ the Class, and the Aggrieved Employees in the
2 State of California.

3 ~~12.13.~~ Plaintiff is informed and believes and thereon alleges that at all relevant times each
4 Defendant, directly or indirectly, or through agents or other persons, employed Plaintiff and the
5 other employees described in the class definitions below, and exercised control over their wages,
6 hours, and working conditions. Plaintiff is informed and believes and thereon alleges that, at all
7 relevant times, each Defendant was the principal, agent, partner, joint venturer, officer, director,
8 controlling shareholder, subsidiary, affiliate, parent corporation, successor in interest, and/or
9 predecessor in interest of some or all of the other Defendants, and was engaged with some or all
10 of the other Defendants in a joint enterprise, and bore such other relationships to some or all of the
11 other Defendants so as to be liable for their conduct with respect to the matters alleged below.
12 Plaintiff is informed and believes and thereon alleges that each Defendant acted pursuant to and
13 within the scope of the relationships alleged above, that each Defendant knew or should have
14 known about, and authorized, ratified, adopted, approved, controlled, aided, and abetted the
15 conduct of all other Defendants.

16 **ALLEGATIONS COMMON TO ALL CAUSES OF ACTION**

17 ~~13.14.~~ During Plaintiff's employment for Defendants, Defendants paid Plaintiff an hourly
18 wage and classified Plaintiff as non-exempt from overtime. Defendants typically scheduled
19 Plaintiff to work five days in a workweek, from Mondays through Thursdays and sometimes
20 Fridays, from 4:45 a.m. to 3:15 p.m.

21 ~~14.15.~~ Throughout Plaintiff's employment, Defendants failed to pay for all hours worked
22 (including minimum, straight time, and overtime wages), failed to provide Plaintiff with legally
23 compliant meal periods, failed to authorize and permit Plaintiff to take rest periods, failed to timely
24 pay all final wages to Plaintiff when Defendants terminated their employment, failed to furnish
25 accurate wage statements to Plaintiff, and failed to indemnify Plaintiff for expenditures. As
26 discussed below, Plaintiff's experience working for Defendants was typical and illustrative.

27 ~~15.16.~~ Throughout the statutory period, Defendants maintained a policy and practice of not
28 paying Plaintiff, ~~and~~ the Class, and the Aggrieved Employees for all hours worked, including

1 minimum, straight time, and overtime wages. Defendants required Plaintiff, ~~and~~ the Class, and the
2 Aggrieved Employees to work “off-the-clock,” uncompensated, by, for example, requiring
3 Plaintiff ~~and~~ the Class, and the Aggrieved Employees to perform work before clocking in for the
4 day. Some of this unpaid work should have been paid at the overtime rate. In failing to pay for
5 all hours worked, Defendants also failed to maintain accurate records of the hours Plaintiff, ~~and~~
6 the Class, and the Aggrieved Employees worked.

7 ~~16.17.~~ Throughout the statutory period, Defendants wrongfully failed to provide Plaintiff,
8 ~~and~~ the Class, and the Aggrieved Employees with their legally mandated 30-minute, uninterrupted,
9 and duty-free meal periods. Defendants regularly, but not always, required Plaintiff, ~~and~~ the Class,
10 and the Aggrieved Employees to work in excess of five consecutive hours a day without providing
11 a 30-minute, uninterrupted, and duty-free meal period for every five hours of work, or without
12 compensating Plaintiff, ~~and~~ the Class, and the Aggrieved Employees for meal periods that were
13 not provided by the end of the fifth hour of work or tenth hour of work. Instead, Defendants
14 continued to assert control over Plaintiff, ~~and~~ the Class, and the Aggrieved Employees by requiring,
15 pressuring, or encouraging them to perform work tasks that could not be completed without
16 working in lieu of taking mandatory meal periods, or by denying Plaintiff, ~~and~~ the Class, and the
17 Aggrieved Employees permission to take a meal period. Accordingly, Defendants’ policy and
18 practice was not to provide meal periods to Plaintiff, ~~and~~ the Class, and the Aggrieved Employees
19 in compliance with California law.

20 ~~17.18.~~ Throughout the statutory period, Defendants have wrongfully failed to authorize
21 and permit Plaintiff, ~~and~~ the Class, and the Aggrieved Employees to take legally compliant rest
22 periods. Defendants regularly required Plaintiff, ~~and~~ the Class, and the Aggrieved Employees to
23 work in excess of four consecutive hours a day without Defendants authorizing and permitting
24 them to take a 10-minute, uninterrupted, duty-free rest period for every four hours of work (or
25 major fraction of four hours), or without compensating Plaintiff, ~~and~~ the Class, and the Aggrieved
26 Employees for rest periods that were not authorized or permitted. Instead, Defendants continued
27 to assert control over Plaintiff, ~~and~~ the Class, and the Aggrieved Employees by requiring,
28 pressuring, or encouraging them to perform work tasks that could not be completed without

1 working in lieu of taking mandatory rest periods, or by denying Plaintiff, ~~and the Class,~~ and the
2 Aggrieved Employees permission to take a rest period. Accordingly, Defendants' policy and
3 practice was to not authorize and permit Plaintiff, ~~and the Class,~~ and the Aggrieved Employees to
4 take rest periods in compliance with California law.

5 18-19. Throughout the statutory period, Defendants willfully failed and refused to timely
6 pay Plaintiff, ~~and the Class,~~ and the Aggrieved Employees all final wages due at their termination
7 of employment. In addition, Plaintiff's final paychecks did not include payment for all
8 expenditures, minimum wages, straight-time wages, overtime wages, meal period premium wages,
9 and rest period premium wages owed to her by Defendants at the conclusion of his employment.
10 On information and belief, Defendants' failure to timely pay Plaintiff's final wages when his
11 employment terminated was not a single, isolated incident, but was instead consistent with
12 Defendants' policy and practice that applied to Plaintiff, ~~and the Class,~~ and the Aggrieved
13 Employees.

14 19-20. Throughout the statutory period, Defendants failed to furnish Plaintiff, ~~and the~~
15 Class, and the Aggrieved Employees with accurate, itemized wage statements showing all
16 applicable hourly rates, and all gross and net wages earned (including correct hours worked, correct
17 wages for meal periods that were not provided in accordance with California law, and correct
18 wages for rest periods that were not authorized and permitted to take in accordance with California
19 law). As a result of these violations of California Labor Code § 226(a), the Plaintiff, ~~and the Class,~~
20 and the Aggrieved Employees suffered injury because, among other things:

- 21 (a) the violations led them to believe that they were not entitled to be paid
22 minimum, straight time, overtime, meal period premium, and rest period
23 premium wages, even though they were entitled;
- 24 (b) the violations led them to believe that they had been paid the minimum,
25 straight time, overtime, meal period premium, and rest period premium
26 wages, even though they had not been;
- 27 (c) the violations led them to believe they were not entitled to be paid minimum,
28 straight time, overtime, meal period premium, and rest period premium

- 1 wages at the correct California rate even though they were entitled;
- 2 (d) the violations led them to believe they had been paid minimum, straight time,
- 3 overtime, meal period premium, and rest period premium wages at the
- 4 correct California rate even though they had not been;
- 5 (e) the violations hindered them from determining the amounts of minimum,
- 6 straight time, overtime, meal period premium, and rest period premium
- 7 wages owed to them;
- 8 (f) in connection with their employment before and during this action, and in
- 9 connection with prosecuting this action, the violations caused them to have
- 10 to perform mathematical computations to determine the amounts of wages
- 11 owed to them, computations they would not have to make if the wage
- 12 statements contained the required accurate information;
- 13 (g) by understating the wages truly due to them, the violations caused them to
- 14 lose entitlement and/or accrual of the full amount of Social Security,
- 15 disability, unemployment, and other governmental benefits;
- 16 (h) the wage statements inaccurately understated the wages, hours, and wage
- 17 rates to which Plaintiff, ~~and~~ the Class, and the Aggrieved Employees were
- 18 entitled, and Plaintiff, ~~and~~ the Class, and the Aggrieved Employees were
- 19 paid less than the wages and wage rates to which they were entitled.

20 Thus, Plaintiff, ~~and~~ the Class, and the Aggrieved Employees are owed the amounts provided for in

21 California Labor Code § 226~~(e)~~ and injunctive relief under California Labor Code § 226(h).

22 20-21. Throughout the statutory period, Defendants have wrongfully required Plaintiff, ~~and~~

23 the Class, and the Aggrieved Employees to pay expenses that they incurred in the direct discharge

24 of their duties for Defendants. Plaintiff, ~~and~~ the Class, and the Aggrieved Employees regularly

25 paid out-of-pocket for necessary employment-related expenses, including but not limited to cell

26 phone use.

27 21-22. Plaintiff, ~~and~~ the Class, and the Aggrieved Employees incurred substantial expenses

28 as a direct result of performing their job duties for Defendants, but Defendants failed to indemnify

1 Plaintiff, ~~and~~ the Class, and the Aggrieved Employees for these employment-related expenses.

2 **CLASS ACTION ALLEGATIONS**

3 22-23. Plaintiff brings certain claims individually, as well as on behalf of each and all other
4 persons similarly situated, and thus, seeks class certification under California Code of Civil
5 Procedure § 382.

6 23-24. All claims alleged herein arise under California law for which Plaintiff seeks relief
7 authorized by California law.

8 24-25. The proposed Class consists of and is defined as:

9 All persons who worked for any Defendant in California as an hourly-paid or
10 non-exempt employee at any time during the period beginning four years and 178
11 days before the filing of the initial complaint in this action and ending when
notice to the Class is sent.¹

12 25-26. At all material times, Plaintiff was a member of the Class.

13 26-27. Plaintiff undertakes this concerted activity to improve the wages and working
14 conditions of all Class Members.

15 27-28. There is a well-defined community of interest in the litigation and the Class is
16 readily ascertainable:

- 17 (a) Numerosity: The members of the Class (and each subclass, if any) are so
18 numerous that joinder of all members would be unfeasible and impractical.
19 The membership of the entire Class is unknown to Plaintiff at this time;
20 however, the Class is estimated to be greater than forty (40) individuals and
21 the identity of such membership is readily ascertainable by inspection of
22 Defendants' records.
- 23 (b) Typicality: Plaintiff is qualified to, and will, fairly and adequately protect
24 the interests of each Class Member with whom there is a shared, well-
25 defined community of interest, and Plaintiff's claims (or defenses, if any)
26 are typical of all Class Members' claims as demonstrated herein.

27 ¹ In response to the COVID-19 pandemic, the Judicial Council of California adopted Emergency Rule 9(a)
28 (California Rules of Court), whereby "statutes of limitations and repose for civil causes of action that exceed 180
days are tolled from April 6, 2020 to October 1, 2020."

- (c) Adequacy: Plaintiff is qualified to, and will, fairly and adequately protect the interests of each Class Member with whom there is a shared, well-defined community of interest and typicality of claims, as demonstrated herein. Plaintiff has no conflicts with or interests antagonistic to any Class Member. Plaintiff's attorneys, the proposed class counsel, are versed in the rules governing class action discovery, certification, and settlement. Plaintiff has incurred, and throughout the duration of this action, will continue to incur costs and attorneys' fees that have been, are, and will be necessarily expended for the prosecution of this action for the substantial benefit of each class member.
- (d) Superiority: A Class Action is superior to other available methods for the fair and efficient adjudication of the controversy, including consideration of:
- 1) The interests of the members of the Class in individually controlling the prosecution or defense of separate actions;
 - 2) The extent and nature of any litigation concerning the controversy already commenced by or against members of the Class;
 - 3) The desirability or undesirability of concentrating the litigation of the claims in the particular forum; and,
 - 4) The difficulties likely to be encountered in the management of a class action.
- (e) Public Policy Considerations: The public policy of the State of California is to resolve the California Labor Code claims of many employees through a class action. Indeed, current employees are often afraid to assert their rights out of fear of direct or indirect retaliation. Former employees are also fearful of bringing actions because they believe their former employers might damage their future endeavors through negative references and/or other means. Class actions provide the class members who are not named in the complaint with a type of anonymity that allows for the vindication of their

rights at the same time as their privacy is protected.

~~28-29.~~ There are common questions of law and fact as to the Class (and each subclass, if any) that predominate over questions affecting only individual members, including without limitation, whether, as alleged herein, Defendants have:

- (a) Failed to pay Class Members for all hours worked, including minimum, straight time, and overtime wages;
- (b) Failed to provide meal periods and pay meal period premium wages to Class Members;
- (c) Failed to authorize and permit rest periods and pay rest period premium wages to Class Members;
- (d) Failed to provide Class Members with timely final wages;
- (e) Failed to provide Class Members with accurate wage statements;
- (f) Failed to indemnify Class Members for expenditures; and,
- (g) Violated California Business & Professions Code §§ 17200 *et. seq.* as a result of their illegal conduct as described above.

~~29-30.~~ This Court should permit this action to be maintained as a class action pursuant to California Code of Civil Procedure § 382 because:

- (a) The questions of law and fact common to the Class predominate over any question affecting only individual members;
- (b) A class action is superior to any other available method for the fair and efficient adjudication of the claims of the members of the Class;
- (c) The members of the Class are so numerous that it is impractical to bring all members of the class before the Court;
- (d) Plaintiff, and the other members of the Class, will not be able to obtain effective and economic legal redress unless the action is maintained as a class action;
- (e) There is a community of interest in obtaining appropriate legal and equitable relief for the statutory violations, and in obtaining adequate compensation

for the damages and injuries for which Defendants are responsible in an amount sufficient to adequately compensate the members of the Class for the injuries sustained;

(f) Without class certification, the prosecution of separate actions by individual members of the class would create a risk of:

1) Inconsistent or varying adjudications with respect to individual members of the Class which would establish incompatible standards of conduct for Defendants; and/or,

2) Adjudications with respect to the individual members which would, as a practical matter, be dispositive of the interests of other members not parties to the adjudications, or would substantially impair or impede their ability to protect their interests, including but not limited to the potential for exhausting the funds available from those parties who are, or may be, responsible Defendants; and,

(g) Defendants have acted or refused to act on grounds generally applicable to the Class, thereby making final injunctive relief appropriate with respect to the class as a whole.

~~30-31.~~ Plaintiff contemplates the eventual issuance of notice to the proposed members of the Class that would set forth the subject and nature of the instant action. The Defendants' own business records may be utilized for assistance in the preparation and issuance of the contemplated notices. To the extent that any further notices may be required, Plaintiff contemplates the use of additional techniques and forms commonly used in class actions, such as published notice, e-mail notice, website notice, first-class mail, or combinations thereof, or by other methods suitable to the Class and deemed necessary and/or appropriate by the Court.

FIRST CAUSE OF ACTION

(Against All Defendants for Failure to Pay Minimum and Straight Time Wages for All Hours Worked)

25 this cause of action, Plaintiff and the Class were entitled to be paid twice a month at rates required

28 pay those wages twice a month.

24 them but which exceed the jurisdictional minimum of this Court and which will be ascertained
25 according to proof at trial.

26 ~~47.48.~~ By failing to keep adequate time records required by Labor Code § 1174(d),
27 Defendants have made it difficult to calculate the full extent of overtime compensation due to
28 Plaintiff and the Class.

1 ~~48-49.~~ Plaintiff and the Class also request recovery of overtime compensation according to
2 proof, interest, attorneys' fees and costs pursuant to California Labor Code § 1194(a), as well as
3 the assessment of any statutory penalties against Defendants, in a sum as provided by the California

25 authorize Plaintiff and the Class to take all meal periods as alleged above (or due to the fact that

27 Defendants willfully violated the provisions of California Labor Code § 226.7 and the applicable
28 Wage Orders.

FOURTH CAUSE OF ACTION

(Against All Defendants for Failure to Authorize and Permit Rest Periods)

~~53-55.~~ Plaintiff incorporates by reference and re-alleges as if fully stated herein paragraphs 1 through ~~22~~4 in this Complaint.

54:56. Defendants are required by California law to authorize and permit breaks of ten uninterrupted minutes for each four hours of work or major fraction of four hours (i.e. more than two hours). California Labor Code § 512, the applicable Wage Orders require that the employer permit and authorize all employees to take paid rest periods of ten minutes each for each 4-hour period worked. Thus, for example, if an employee's work time is six hours and ten minutes, the employee is entitled to two rest breaks. Each failure to authorize rest breaks as so required is itself a violation of California's rest break laws. It is a violation of California Labor Code § 226.7 for an employer to require any employee to work during any rest period mandated under any Wage Order.

~~55-57.~~ Despite these legal requirements, Defendants failed to authorize Plaintiff and the Class to take rest breaks, regardless of whether employees worked more than four hours in a workday. By their failure to permit and authorize Plaintiff and the Class to take rest periods as alleged above (or due to the fact that Defendants made it impossible or impracticable to take these uninterrupted rest periods), Defendants willfully violated the provisions of California Labor Code § 226.7 and the applicable Wage Orders.

58. Under California law, Plaintiff and the Class are entitled to be paid one hour of premium wages rate for each workday he or she was not provided with all required rest break(s), plus interest thereon.

FIFTH CAUSE OF ACTION

(Against All Defendants for Failure to Pay Wages of

Discharged Employees – Waiting Time Penalties)

~~56-59.~~ Plaintiff incorporates by reference and re-alleges as if fully stated herein paragraphs 1 through ~~22~~ in this Complaint.

~~57-60.~~ At all times herein set forth, California Labor Code §§ 201 and 202 provide that if an employer discharges an employee, the wages earned and unpaid at the time of discharge are due and payable immediately, and that if an employee voluntarily leaves his or her employment, his or her wages shall become due and payable not later than seventy-two (72) hours thereafter, unless the employee has given seventy-two (72) hours previous notice of his or her intention to quit, in which case the employee is entitled to his or her wages at the time of quitting.

~~58-61.~~ Within the applicable statute of limitations, the employment of many other members of the Class ended, i.e. was terminated by quitting or discharge, and the employment of others will be. However, during the relevant time period, Defendants failed, and continue to fail to pay terminated Class Members, without abatement, all wages required to be paid by California Labor Code §§ 201 and 202 either at the time of discharge, or within seventy-two (72) hours of their leaving Defendants' employ.

15 on written orders of the employee may be aggregated and shown as one item, (5) net wages earned,
16 (6) the inclusive dates of the period for which the employee is paid, (7) the name of the employee
17 and the last four digits of his or her social security number or an employee identification number
18 other than a social security number, (8) the name and address of the legal entity that is the
19 employer, and (9) all applicable hourly rates in effect during the pay period and the corresponding
20 number of hours worked at each hourly rate by the employee.

All of the acts described herein as violations of, among other things, the California Labor Code, are unlawful and in violation of public policy; in addition are immoral, unethical, oppressive, fraudulent and unscrupulous, and thereby constitute unfair, unlawful, and/or fraudulent business practices in violation of California Business & Professions Code §§ 17200, *et seq.*

Failure to Pay Minimum and Straight Time Wages

86. Defendants' failure to provide meal periods in accordance with California Labor Code §§ 226.7 and 512, and the IWC Wage Orders, as alleged above, constitutes unlawful and/or unfair activity prohibited by California Business & Professions Code §§ 17200, *et seq.*

Failure to Authorize and Permit Rest Periods

82-87. Defendants' failure to authorize and permit rest periods in accordance with California Labor Code § 226.7 and the IWC Wage Orders, as alleged above, constitutes unlawful and/or unfair activity prohibited by Business and Professions Code §§ 17200, *et seq.*

Failure to Indemnify Business Expenses

83-88. Defendants' failure to reimburse expenses incurred in accordance with California Labor Code § 2802, as alleged above, constitutes unlawful and/or unfair activity prohibited by California Business & Professions Code §§ 17200, *et seq.*

84-89. By and through their unfair, unlawful and/or fraudulent business practices described herein, the Defendants, have obtained valuable property, money and services from Plaintiff, and all persons similarly situated, and have deprived Plaintiff, and all persons similarly situated, of valuable rights and benefits guaranteed by law, all to their detriment.

85-90. Plaintiff and the Class Members suffered monetary injury as a direct result of Defendants' wrongful conduct.

86-91. Plaintiff, individually, and on behalf of members of the putative Class, is entitled to, and does, seek such relief as may be necessary to disgorge money and/or property which the Defendants have wrongfully acquired, or of which Plaintiff and the Class have been deprived, by means of the above-described unfair, unlawful and/or fraudulent business practices. Plaintiff and the Class are not obligated to establish individual knowledge of the wrongful practices of Defendants in order to recover restitution.

87-92. Plaintiff, individually, and on behalf of members of the putative class, is further entitled to and does seek a declaration that the above-described business practices are unfair,

1 unlawful and/or fraudulent, and injunctive relief restraining the Defendants, and each of them,
2 from engaging in any of the above-described unfair, unlawful and/or fraudulent business practices
3 in the future.

4 88-93. Plaintiff, individually, and on behalf of members of the putative class, has no plain,
5 speedy, and/or adequate remedy at law to redress the injuries which the Class Members suffered
6 as a consequence of the Defendants' unfair, unlawful and/or fraudulent business practices. As a
7 result of the unfair, unlawful, and/or fraudulent business practices described above, Plaintiff,
8 individually, and on behalf of members of the putative Class, has suffered and will continue to
9 suffer irreparable harm unless the Defendants, and each of them, are restrained from continuing to
10 engage in said unfair, unlawful and/or fraudulent business practices.

11 89-94. Plaintiff also alleges that if Defendants are not enjoined from the conduct set forth
12 herein above, they will continue to avoid paying the appropriate taxes, insurance, and other
13 withholdings.

14 95. Pursuant to California Business & Professions Code §§ 17200, *et seq.*, Plaintiff and
15 putative Class Members are entitled to restitution of the wages withheld and retained by
16 Defendants during a period that commences four years and 178 days prior to the filing of this
17 complaint; a permanent injunction requiring Defendants to pay all outstanding wages due to
18 Plaintiff and Class Members; an award of attorneys' fees pursuant to California Code of Civil
19 Procedure § 1021.5 and other applicable laws; and an award of costs.

20 NINTH CAUSE OF ACTION

21 (Against all Defendants for Civil Penalties Under the

22 Private Attorneys General Act of 2004, Cal. Lab. Code § 2698 et seq.)

23 96. Plaintiff incorporates by reference and re-alleges as if fully stated herein paragraphs
24 1 through 22 in this Complaint.

25 97. At all times herein mentioned, Defendants were subject to the Labor Code of the
26 State of California and the applicable Industrial Welfare Commission Orders.

27 98. California Labor Code § 2699(a) specifically provides for a private right of action
28 to recover penalties for violations of the Labor Code: "Notwithstanding any other provision of law,

1 any provision of this code that provides for a civil penalty to be assessed and collected by the Labor
2 and Workforce Development Agency or any of its departments, divisions, commissions, boards,
3 agencies, or employees, for a violation of this code, may, as an alternative, be recovered through a
4 civil action brought by an aggrieved employee on behalf of himself or herself and other current or
5 former employees pursuant to the procedures specified in Section 2699.3.”

6 99. Plaintiff has exhausted his administrative remedies pursuant to California Labor
7 Code § 2699.3. He gave written notice by online filing to the LWDA and by certified mail to
8 Defendant of the specific provisions of the Labor Code that Defendant violated against Plaintiff
9 and current and former aggrieved employees, including the facts and theories to support the
10 violations. Plaintiff also paid the filing fee.

11 100. The LWDA has not indicated that it intends to investigate Defendant’s Labor Code
12 violations discussed in the notice. Accordingly, Plaintiff may commence a civil action to recover
13 penalties under Labor Code § 2699 pursuant to § 2699.3 for the violations of the Labor Code
14 described in this Complaint. These penalties include, but are not limited to, penalties under
15 California Labor Code §§ 210, 226.3, 1174.5, 1197.1, and 2699.

16 101. Based on the conduct described in this Complaint, Plaintiff is entitled to an award
17 of civil penalties on behalf of himself, the State of California, and similarly Aggrieved Employees
18 of Defendants. The exact amount of the applicable penalties, in all, is in an amount to be shown
19 according to proof at trial. These penalties are in addition to all other remedies permitted by law.

20 ~~99-102.~~ In addition, Plaintiff seeks an award of reasonable attorney’s fees and costs
21 pursuant to California Labor Code § 2699(g)(1), which states, “Any employee who prevails in any

4. That the Court declare, adjudge, and decree that Defendants violated California Labor Code §§ 204 and 1194 and applicable IWC Wage Orders by willfully failing to pay all minimum and straight time wages due;

5. For unpaid wages as may be appropriate;

6. For pre-judgment interest on any unpaid compensation commencing from the date such amounts were due;

7. For liquidated damages;

8. For reasonable attorneys' fees and for costs of suit incurred herein pursuant to California Labor Code § 1194(a); and,

9. For such other and further relief as the Court may deem equitable and appropriate.

As to the Second Cause of Action

10. That the Court declare, adjudge, and decree that Defendants violated California Labor Code §§ 510 and 1198 and applicable IWC Wage Orders by willfully failing to pay all overtime wages due;

11. For unpaid wages at overtime wage rates as may be appropriate;

12. For pre-judgment interest on any unpaid overtime compensation commencing from the date such amounts were due;

13. For reasonable attorneys' fees and for costs of suit incurred herein pursuant to California Labor Code § 1194(a); and,

14. For such other and further relief as the Court may deem equitable and appropriate.

As to the Third Cause of Action

15. That the Court declare, adjudge, and decree that Defendants violated California Labor Code §§ 226.7 and 512, and the IWC Wage Orders;

16. For unpaid meal period premium wages as may be appropriate;

17. For pre-judgment interest on any unpaid compensation commencing from the date

1 such amounts were due;

2 18. For reasonable attorneys' fees under California Code of Civil Procedure § 1021.5,
3 and for costs of suit incurred herein; and,

4 19. For such other and further relief as the Court may deem equitable and appropriate.

5 As to the Fourth Cause of Action

6 20. That the Court declare, adjudge, and decree that Defendants violated California
7 Labor Code §§ 226.7 and 512, and the IWC Wage Orders;

8 21. For unpaid rest period premium wages as may be appropriate;

9 22. For pre-judgment interest on any unpaid compensation commencing from the date
10 such amounts were due;

11 23. For reasonable attorneys' fees under California Code of Civil Procedure § 1021.5,
12 and for costs of suit incurred herein; and,

13 24. For such other and further relief as the Court may deem equitable and appropriate.

14 As to the Fifth Cause of Action

15 25. That the Court declare, adjudge and decree that Defendants violated California
16 Labor Code §§ 201, 202, and 203 by willfully failing to pay all compensation owed at the time of
17 termination of the employment;

18 26. For statutory wage penalties pursuant to California Labor Code § 203 for former
19 employees who have left Defendants' employ;

20 27. For pre-judgment interest on any unpaid wages from the date such amounts were
21 due;

22 28. For reasonable attorneys' fees and for costs of suit incurred herein; and,

23 29. For such other and further relief as the Court may deem equitable and appropriate.

24 As to the Sixth Cause of Action

25 30. That the Court declare, adjudge, and decree that Defendants violated the record
26 keeping provisions of California Labor Code § 226(a) and applicable IWC Wage Orders, and
27 willfully failed to provide accurate itemized wage statements thereto;

28 31. For all actual damages, according to proof;

32. For injunctive relief to ensure compliance with this section, pursuant to California Labor Code § 226(h);

33. For reasonable attorneys' fees and for costs of suit incurred herein; and,

34. For such other and further relief as the Court may deem equitable and appropriate.

As to the Seventh Cause of Action

35. That the Court declare, adjudge, and decree that Defendants violated California Labor Code § 2802 by willfully failing to indemnify employees for expenditures;

36. For unpaid wages or unreimbursed business expenses as may be appropriate;

37. For pre-judgment interest on any unpaid compensation commencing from the date such amounts were due;

38. For reasonable attorneys' fees and for costs of suit incurred herein; and,

39. For such other and further relief as the Court may deem equitable and appropriate.

As to the Eighth Cause of Action

40. That the Court declare, adjudge, and decree that Defendants violated California Business & Professions Code §§ 17200, et seq. by failing to pay for all hours worked (minimum, straight time, and overtime wages), failing to provide meal periods, failing to authorize and permit rest periods, and failing to indemnify employees for expenditures;

41. For restitution of unpaid wages to Plaintiff and all Class Members and prejudgment interest from the day such amounts were due and payable;

42. For the appointment of a receiver to receive, manage and distribute any and all funds disgorged from Defendants and determined to have been wrongfully acquired by Defendants as a result of violations of California Business & Professions Code §§ 17200 et seq.;

43. For reasonable attorneys' fees and costs of suit incurred herein pursuant to California Code of Civil Procedure § 1021.5;

44. For injunctive relief to ensure compliance with this section, pursuant to California Business & Professions Code §§ 17200, et seq.; and,

45. For such other and further relief as the Court may deem equitable and appropriate.

As to the Ninth Cause of Action

46. That the Court declare, adjudge and decree that Defendants violated the California Labor Code by failing to pay wages for all hours worked (including minimum, straight time, and overtime wages), failing to provide meal periods and pay the correct amount of meal period premium wages, failing to authorize and permit rest periods and pay the correct amount of rest period premium wages, failing to pay all final wages to terminated employees, failing to furnish accurate wage statements, and failing to reimburse employees for all necessary business expenses.

47. For all actual, consequential, and incidental losses and damages, according to proof;

48. For all civil penalties pursuant to California Labor Code §§ 2699, *et seq.*, and all other applicable Labor Code provisions;

49. For reasonable attorneys' fees and costs of suit incurred herein pursuant to California Labor Code § 2699; and

~~45.~~50. For such other and further relief as the Court may deem equitable and appropriate.

As to all Causes of Action

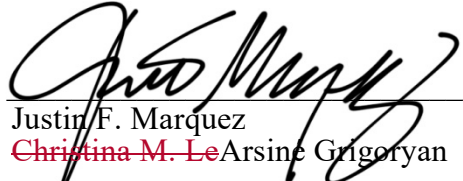

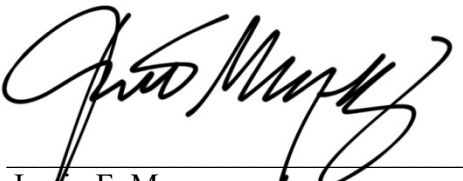
