1 I, Tiffany L. Luu, hereby declare as follows:

2 1. I am an attorney licensed to practice law in the state of California and have been
3 admitted to practice before this Court. I am an attorney with the law firm of Justice for Workers,
4 P.C., counsel of record for Plaintiffs in this action. I am one of the lawyers responsible for
5 representing Plaintiff in this case and I have personal knowledge of the matters stated herein and if
6 called and sworn as a witness, I would and could competently testify under oath thereto.

7 2. My qualifications are as follows: I received my J.D., *cum laude*, along with my
8 Master of Dispute Resolution, from the Pepperdine University Rick J. Caruso School of Law in
9 2020. I was named to the Dean's Honor List in 2019. During law school, I served as the Student
10 Articles Editor of the Pepperdine Dispute Resolution Law Journal where I published the article:
11 *California: A New Golden Hub of International Commercial Arbitration?*, Pepperdine Dispute
12 Resolution Law Journal, Volume 20:2 (May 2020). I also served as the President of the Asian
13 Pacific American Law Student Association. I received two CALI Excellence for the Future Awards
14 for obtaining the highest grade in two law school courses. I also served as a summer law clerk for
15 the Orange County Public Defender's office and for the Law Office of Paul J. Barba, wherein I
16 defended an employer from employment claims brought by the U.S. Equal Employment
17 Opportunity Commission. I also served as a summer law clerk for the Beverly Hills office of
18 Arendsen Cane Molnar LLP and later became a litigation associate after passing the California Bar
19 in January 2021, wherein I served as second-chair trial counsel representing an employee in a wage
20 and hour dispute and represented an employer in a California Private Attorneys General Act
21 ("PAGA") action.

22 3. I practiced as a labor and employment associate for the next 3 years representing
23 employers in wage and hour class and/or PAGA actions, including at Lewis Brisbois Bisgaard &
24 Smith LLP and Fisher & Phillips LLP.

25 4. In January 2024, I joined Justice for Workers, P.C. ("JFW") and as an associate in
26 the Complex Litigation Practice Group, where I focus my practice on representing employees in
27 wage and hour class and PAGA action lawsuits.

1 5. My primary practice has been employment law throughout my entire legal career. I
2 have handled a number of wage and hour matters, including individual actions and class and/or
