DECLARATION OF H. SCOTT LEVIANT

I, H. Scott Leviant, declare as follows:

1. I am admitted, in good standing, to practice as an attorney in the State of California, the United States Supreme Court, the Eighth Circuit Court of Appeals, the Ninth Circuit Court of Appeals, and the United States District Courts for the Central, Eastern, Northern and Southern Districts of California. I have never been subject to discipline by the State Bar of California. I am a fully qualified, adult resident of the State of California, and, if called as a witness herein, I would testify truthfully to the matters set forth herein. All of the matters set forth herein are within my personal knowledge, except those matters that are stated to be upon information and belief. As to such matters, I believe them to be true.

2. I am employed as a Senior Counsel at the law firm of Moon Law Group, PC. My business address is 725 S. Figueroa St., 31st Floor, Los Angeles, California 90017 and my business telephone number is (213) 232-3128. I am counsel for Plaintiff MARYOLIN HERNANDEZ, and I am proposed counsel for the Settlement Class.

3. This Declaration is submitted in support of Plaintiff's Motion for Preliminary Approval of Class and Representative Action Settlement.

BACKGROUND

4. Defendants is a logistics provider that has separate entities in various sects of transportation. On August 10, 2023, Plaintiff commenced this Action by filing a Complaint alleging causes of action against Defendants for failure to pay wages (minimum, overtime, and regular rate), failure to provide meal periods, failure to authorize and provide rest breaks, failure to timely pay final wages at termination, failure to indemnify for necessary business expenses, failure to provide accurate itemized wage statements, and unfair business practices. On September 29, 2023, Defendant removed this action to the United States District Court for the Central District of California.

5. Plaintiff sent a letter to the Labor and Workforce Development Agency ("LWDA"), pursuant to California Labor Code § 2699.3, providing notice of her intent to seek civil penalties under the Private Attorneys General Act, California Labor Code § 2698, *et seq.* The LWDA did not indicate

that it intended to investigate the alleged violations referenced in the letter, and the 65-day time period permitted for the LWDA to provide such a notification expired. On November 1, 2023, Plaintiff filed a First Amended Complaint alleging an additional cause of action against Defendants for civil penalties under the Private Attorneys General Act (“PAGA”). The First Amended Complaint is the operative complaint in the Action (the “Operative Complaint.”). On April 9, 2025, the United States District Court for the Central District of California granted the Parties’ stipulation to remand this action to state court for settlement purposes.

6. The Parties conducted informal and formal discovery and investigation of the facts and law. Investigation included, *inter alia*, the exchange of extensive data and discoverable information in preparation for the mediation session. The Parties have analyzed time clock, pay and other data pertaining to Plaintiff and the Class during the relevant Settlement Period, including but not limited to the numbers of former and current members of the Class, average workweeks and pay periods, and average rate of hourly pay. Time and pay data were used for Plaintiff’s pre-mediation analysis. Sampling was used to reduce costs and increase speed of data collection and review. The margin of error calculation for the sample of the Class in this case is as follows:

$$1.645 \sqrt{\frac{0.5(1-0.5)}{46}} \sqrt{\frac{305-46}{305-1}} = \text{margin of error}^1 = 0.1119 = 11.19\%$$

With a random sample of data for 46 employees, the margin of error, using the population adjustment factor, was no more than 11.19 percent.² In addition, Defendants also provided other data pertaining to

¹ The term “1.645” is derived from a standard deviation table for a 90% confidence interval, known as a “z-table.” It is not affected by sample or population size. The margin of error is an “overestimate” of the margin of error because the variance is presumed to be at its highest value, using 0.5(1-0.5) to represent p*q in the variance equation of (p*q)/n.

² The margin of error formula does not require an adjustment factor for extremely large populations. (*Id.*) A poll of all potential voters in the United States, for example, does not require an adjustment for the population size, since the second radicand in the equation (the fraction in the second radical sign) is effectively equal to 1. (*Id.*) This is because the square root of a fraction that is very close to 1 is even closer to 1. Consider a population of 200 million and a sample of 1,000 individuals from that population. The second radicand is the fraction of 200 million minus 1,000, all divided by 200 million minus 1. (*Id.*) That is equal to 0.999995. (*Id.*) The square root is 0.99999975, which is indistinguishable from 1 when talking about a margin of error percentage even to the nearest tenth of a percent. (*Id.*) But when the population size is much smaller, the population size has a major impact on the margin of error for a given sample size. (*Id.*)

1 Plaintiff and the Class during the relevant Class Period, including but not limited documents reflecting
2 wage and hour policies and practices during the Class Period (*e.g.*, the relevant employee handbook).

3 7. After reviewing documents regarding Defendants' wage and hour policies and practices
4 and other information obtained during the exchange of information, and interviewing Settlement Class
5 Members, Class Counsel were able to evaluate the probability of class certification, success on the
6 merits, and the reasonably obtainable maximum monetary exposure for all claims. Class Counsel
7 prepared a damage analysis prior to mediation. Class Counsel also investigated the applicable law
8 regarding the claims and defenses asserted in the litigation.

9 8. On March 27, 2025, the Parties participated in an all-day mediation presided over by
10 Mike Ludwig, Esq., which led to this Agreement to settle the Action. The Parties discussed at length the
11 burdens and risks of continuing with the litigation as well as the merits of claims and defenses. After the
12 mediation, and the eventual settlement, the Parties then signed a long form settlement agreement (the
13 "Agreement").

14 9. Plaintiff and Class Counsel are aware of the burdens of proof necessary to establish
15 liability for the claims asserted in the Action, both generally and in response to Defendants' defenses
16 thereto. Plaintiff and Class Counsel have also taken into account Defendants' agreement to enter into a
17 Settlement that confers substantial relief upon the Class.

18 10. Based on the foregoing, Plaintiff and Class Counsel have determined that the Settlement
19 set forth in this Agreement is a fair, adequate, and reasonable Settlement and is in the best interests of the
20 Class. Solely for the purpose of settling this case, the parties agree that the requirements for establishing
21 class action certification with respect to this class have been met and are met. If this Settlement is not
22 approved by the Court for any reason, Defendants reserve the right to contest class certification. This
23 Settlement, if approved, will result in the termination of the litigation through the entry of the Judgment
24 and the release of all Released Claims for all Class Members who have not elected to exclude themselves
25 from the Class.

26 27 SUMMARY OF THE SETTLEMENT TERMS

28 11. Key provisions of the proposed settlement include the following:

- (a) Defendants agree not to oppose certification for purposes of Settlement.
(Agreement, ¶ 12.1.)
- (b) Class: All non-exempt employees employed by Horizon Personnel Services, Inc. and placed to work at Defendant in California during the Class Period. (“Class Period” means the period from August 10, 2019, to February 1, 2023).
“Participating Class Member” means a Class Member who does not submit a valid and timely Request for Exclusion from the Class portion of the Settlement.
(Agreement, ¶¶ 1.5, 1.9, 1.12, 1.34.)
- (c) Settlement Amount: Defendants will pay a maximum of **\$200,000.00**, referred to as the Gross Settlement Amount (or GSA herein), resulting in an estimated average **gross** benefit per Class Member of about **\$655.74** (Agreement, ¶¶ 1.21, 3.1; Leviant Decl., ¶ 17.)
- (d) Escalator Clause: If the number of actual Pay Periods at the close of the PAGA Period increases by more than 10% (i.e., 4,400), Defendant may, at its election, opt to (a) increase the Gross Settlement Amount in the exact proportionate amount as to any additional pay periods above 4,400 Pay Periods or (b) end the PAGA Period on the date that the total pay periods equal 4,400 total Pay Periods.
(Agreement, ¶ 8.)
- (e) Funding of Gross Settlement Amount: Defendant shall fully fund the Gross Settlement Amount, and also fund the amounts necessary to fully pay Defendant’s share of payroll taxes by transmitting the funds to the Administrator no later than 5 days after the Effective Date. (Agreement, ¶ 4.1.)
- (f) Class Size: About **305** individuals who worked about 4,135 workweeks.
(Agreement, ¶ 8.)
- (g) PAGA Group Size: About **174** aggrieved employees who worked about 4,000 pay periods during the PAGA Period. (Agreement, ¶ 8.)
- (h) PAGA Period: Period from August 9, 2022 through the date that the Court grants preliminary approval of the Class Settlement (Agreement, ¶ 1.30.)

- (i) Kullar/Munoz Analysis: Plaintiff addresses the claims analysis in the Motion, at Part V.B.3, and below, at Paragraph 18.
- (j) No Reversion: The Settlement is a *non-reversionary* settlement. (Agreement, ¶ 3.1.)
- (k) Certification: Plaintiff addresses certification requisites in the Motion, at Part V.A., and below, at Paragraphs 34-40.
- (l) No Claim Form: No claim form is required. (Agreement, ¶ 3.1.)
- (m) Class Release: All Participating Class Members, on behalf of themselves and their respective former and present representatives, agents, attorneys, heirs, administrators, successors, and assigns, release Released Parties from (i) all claims that were alleged, or reasonably could have been alleged, based on the facts contained in the Operative Complaint and the PAGA Notice and all claims that were, or reasonably could have been alleged based on facts ascertained during the Action including, e.g., all claims for (1) Failure to Pay Minimum Wages; (2) Failure to Pay Overtime Compensation; (3) Failure to Provide Meal Periods; (4) Failure to Authorize and Permit Rest Breaks; (5) Failure to Indemnify Necessary Business Expenses; (6) Failure to Timely Pay Final Wages at Termination; (7) Failure to Provide Accurate Itemized Wage Statements; and (8) Unfair Business Practices (Bus. & Prof. Code § 17200, et seq.). Participating Class Members do not release any other claims, including claims for vested benefits, wrongful termination, violation of the Fair Employment and Housing Act, unemployment insurance, disability, social security, workers' compensation, or claims based on facts occurring outside the Class Period. (Agreement, ¶ 5.2.)
- (n) PAGA Release: The LWDA and all Class Members who are Aggrieved Employees are deemed to release, on behalf of themselves and their respective former and present representatives, agents, attorneys, heirs, administrators, successors, and assigns, the Released Parties from all claims for civil penalties under PAGA, based on the facts and Labor Code sections that were alleged or

1 reasonably could have been alleged, based on the facts contained in the Operative
2 Complaint and the PAGA Notice and all PAGA claims that were, or reasonably
3 could have been alleged based on facts ascertained during the Action.

4 (Agreement, ¶ 5.3.)

5 (o) Net Settlement Amount: The Gross Settlement Amount, less the following
6 payments in the amounts approved by the Court: Individual PAGA Payments, the
7 LWDA PAGA Payment, Class Representative Service Payment, Class Counsel
8 Fees Payment, Class Counsel Litigation Expenses Payment, and the
9 Administration Expenses Payment. The remainder is to be paid to Participating
10 Class Members as Individual Class Payments. The Net Settlement Amount is
11 estimated to be at least **\$78,008.33**, resulting in an average **net** payment per Class
12 Member of at least **\$255.77**, before any tax withholdings. (Leviant Decl., ¶ 17.)

13 (p) Tax Allocation: The Individual Class Payments distributed to Class Members
14 will be characterized as 20% alleged unpaid wages, 80% to interest and penalties.
15 (Agreement, ¶ 3.2.4.1.)

16 (q) Employer's Portion of Payroll Taxes Paid Separately: Defendants' portion of
17 payroll taxes (e.g., FICA, FUTA, etc.) owed on any settlement payments to Class
18 Members that constitute wages will be paid *separate* and apart from the GSA.
19 (Agreement, ¶ 3.1.)

20 (r) Settlement Administrator: The notice portion of the Settlement will be
21 administered by a third-party Administrator, Phoenix Settlement Administrators
22 ("Phoenix"), with the costs of administration at a flat rate of up to \$7,325.00.
23 Phoenix's estimate for settlement administration services in the amount of
24 **\$7,325.00** was selected as the lowest bid from a competitive bidding process.
25 (Agreement, ¶ 3.2.3; Moore Decl., ¶ 16.)

26 (s) Class Data for Administration: Not later than 14 days after the Court grants
27 Preliminary Approval of the Settlement, Defendant will deliver the Class Data to
28 the Administrator. (Agreement, ¶ 7.4.) Because Social Security Numbers

1 (“SSNs”) for some Class Members are not known, the Administrator shall
2 perform a pre-mailing skip trace on all Class Members’ Class Data to identify
3 mailing addresses and SSNs for as many Class Members as possible.
4 (Agreement, ¶ 4.2.1.) For Class Members whose SSNs are located or
5 communicated to the Administrator, their full disbursement of Individual Class
6 Payments and Individual PAGA Payments will proceed as described in
7 Paragraph 4.2.2. (*Id.*) For Class Members whose SSNs are not known, but a
8 mailing address is located, the Administrator will solicit the SSN by the Notice.
9 (*Id.*) The Administrator will distribute any interest or penalty payment portion of
10 the Individual Class Payment and any Individual PAGA Payment, up to an
11 aggregate amount of \$599.00 for those Class Members whose SSN remains
12 unknown. (*Id.*) The balance of any undistributed Individual Class Payment and/or
13 undistributed Individual PAGA Payment will be directed to the California
14 Controller’s Unclaimed Property Fund in the name of the Class Member.
15 (Agreement, ¶¶ 4.2; 4.2.1, 4.2.1.2, 4.2.2.)

16 (t) Notice: The Administrator will mail Notices to all Class Members identified in
17 the Class Data and the pre-mailing skip trace within 14 days of receipt of the
18 Class Data. (Agreement, ¶ 7.5.3.) The Notice describes how to dispute
19 workweeks, submit an objection in writing, in person, or through an attorney, or
20 request exclusion. (Agreement, ¶¶ 7.6 – 7.8.) Prior to mailing the Notice, the
21 Administrator will do a skip trace of all Class Members whose information is
22 incomplete so that the Notice may solicit required information from those Class
23 Members.

24 (u) Notice Language: Notice will issue in English and Spanish. (Agreement, ¶ 1.11;
25 7.5.3.)

26 (v) Objections: Objections can be submitted in person, by attorney, or in writing to
27 the Administrator, with no pre-requisite to being heard. (Agreement, ¶ 7.7.)

28 (w) Exclusion Requests: The procedure for exclusion requests, mailing a request to

the Settlement Administrator, is the same as the procedure for submitting a written objection. (Agreement, ¶ 7.6.)

- (x) PAGA Allocation: From the GSA, **\$20,000.00** will be allocated to settle claims brought pursuant to the California Private Attorneys General Act, Labor Code § 2699 *et seq.* (“PAGA”), and seventy-five percent (75%), or **\$15,000.00**, will be paid to the California Labor & Workforce Development Agency. (Agreement, ¶ 1.33; 3.2.5.)
- (y) Notice to LWDA: Notice was provided prior to the filing of this Motion. Evidence is attached hereto.
- (z) Enhancement/Service Award to Plaintiff: Defendant will not oppose the application for a Class Representative Service Payment of up to **\$10,000.00** to be paid from the GSA. (Agreement, ¶ 3.2.1.)
- (aa) Fees and Costs: Defendant will not oppose Class Counsel’s application for fees of not more than one-third of the GSA (**\$66,666.67**), and actual costs, in an amount not to exceed **\$18,000.00**, to be paid out of the GSA. (Agreement, ¶ 3.2.2.)
- (bb) Check Void Period: Settlement checks will be valid for 180 days. (Agreement, ¶ 4.2.2.)
- (cc) Uncashed Checks: Any settlement checks that are mailed to the Class Members and remain uncashed after 180 days of the date of issuance will be cancelled, and the moneys represented by such checks will be sent to the California Controller’s Unclaimed Property Fund in the name of the Class Member failing to cash the check. (Agreement, ¶ 4.2.4.)
- (dd) Confidentiality Provisions: The Agreement permits Class Counsel to discuss the Settlement with Class Members. (Agreement ¶ 12.2.)

12. A true and correct copy of the CLASS ACTION AND PAGA SETTLEMENT AGREEMENT AND CLASS NOTICE is attached hereto as Exhibit “1.”

THE SETTLEMENT IS FAIR, JUST AND REASONABLE

13. Plaintiff and Class counsel have diligently investigated the claims of the Class Members. Plaintiff and Class Counsel concluded, after taking into account the disputed factual and legal issues involved in this Action, the substantial risks attending further prosecution, including risks related to the outcome of certification and possible summary judgment efforts, and the substantial benefits to be received pursuant to the compromise and settlement of the Action as set forth in the Settlement, that settlement on the terms agreed to are in the best interest of Plaintiff and the putative Class and are fair and reasonable. Plaintiff's counsel brought to bear a great deal of experience with class actions in negotiating the settlement of this case.

14. One fundamental purpose of the class action device is to promote efficiency. Resolution at this time will forestall the need for additional expensive and time-consuming litigation that could very well result in an outcome less satisfactory than that proposed under this settlement. But, before any other consideration, we have agreed to this settlement because it is objectively reasonable. The potential for resolution benefits the class members, since they do not have to wait additional years for a similar recovery. The efficiency of this litigation benefits the Court, the parties and their counsel. A class-wide resolution is the most realistic method for addressing the claims raised in this matter.

15. We have engaged in the necessary investigation in this case that made it possible for us to exercise informed judgment in those aspects of the settlement process in which we were involved. The exchange of time and wage data, wage and hour policy documents, and data about the composition of the Class, were sufficient to permit us counsel to adequately evaluate the settlement. We had more than enough information upon which to evaluate a fair and reasonable settlement amount.

16. In addition to disputing the merits of Plaintiff's claims at trial, Defendants intended to aggressively challenge the case at the certification stage. Defendants contend that Plaintiff could not prevail on a certification motion. We believe that the case was viable through to a trial. However, while Plaintiff asserts a belief that this is a viable case for trial, we realize that there are always very significant risks associated with certification and trials, and those risks cannot be eliminated in this case. Continued litigation of this lawsuit presented Plaintiff and Defendants with substantial legal risks and costs that were (and continue to be) difficult to assess. The risks in this matter include:

- the risk that Plaintiff would be unable to establish liability for allegedly unpaid straight time or overtime wages, *see Duran v. US Bank Nat'l Ass'n*, 59 Cal. 4th 1, 39 & fn. 33 (2014) ("*Duran*"), *citing Dilts v. Penske Logistics, LLC* 2014 WL 205039 (S.D. Cal. 2014) (dismissing certified off-the-clock claims based on proof at trial);
- the risk that Defendants' challenged employment policies might not ultimately support class certification or a class-wide liability finding, *see, Duran*, 59 Cal. 4th at 14 & fn. 28 (citing Court of Appeal decisions favorable on class certification issue without expressing opinion as to ultimate viability of proposition);
- the risk that uncertainties pertaining to the legality of Defendants' policies and practices could preclude class-wide awards of penalties under Labor Code §§ 203 and 226(e);
- the risk that individual differences between Class Members could be construed as pertaining to liability, and not solely to damages, *see, Duran*, 59 Cal. 4th at 19;
- the risk that any civil penalties award under the PAGA could be reduced by the Court in its discretion, *see* Labor Code § 2699(e)(1);
- the risk that lengthy trial or appellate litigation could ensue; and,
- the risk violation rate estimates could prove lower than expected.

These risks are non-exhaustive. While we remain confident that we possess credible strategies for responding to the legal and factual risks facing them, those risks cannot be disregarded. We carefully considered the risks created by all of these uncontrollable factors when evaluating the reasonableness of this proposed settlement. This Settlement provides a benefit to the Class Members that is very reasonable in light of these particular risks.

17. The Settlement is the product of arm's-length negotiations between the Parties occurring throughout the litigation. In light of the uncertainties of protracted litigation and the state of the law regarding the legal positions of the Parties, the settlement amount reflects the best feasible recovery for the Class Members. The settlement amount is, of course, a compromise figure. By necessity it took into account risks related to liability, damages, and the defenses asserted by Defendant. Moreover, each Class Member will be given the opportunity to opt-out of the Settlement, allowing those who feel they have claims that are greater than the benefits they can receive under this Settlement

1 to pursue their own claims For the approximately **305** members of the Class, the average **gross** benefit
2 is **\$655.74** per class member, and the estimated average **net** recovery for each Class Member would be
3 approximately **\$255.77**. Given that Defendant could potentially defeat certification, this is a significant
4 sum to have achieved in settlement. Moreover, a Class Member who worked a greater number of
5 weeks for Defendant will receive a larger share of the Settlement than a Class Member who worked for
6 a shorter amount of time during the class period.

7 18. After analyzing the claims in this matter, Plaintiff has concluded that the value of this
8 Settlement is fair, adequate, and reasonable. The Gross Settlement Amount of **\$200,000.00** is about 93%
9 of the **\$214,395.81** estimate of *risk-adjusted* recovery (excluding interest) at this stage in the litigation.
10 On that basis, it would be unwise to pass up this settlement opportunity. This assessment is based on a
11 carefully constructed model of the current fair value of the case, using estimated risks, average wage
12 rates, numbers of employees, and the amount of time covered by the class period. While Plaintiff would
13 certainly have preferred to recover more (and Defendant would have preferred to pay less), this outcome
14 is in line with a carefully constructed estimate of the current fair value of the case. On that basis, it
15 would be unwise to pass up this settlement opportunity. The risk-adjusted value of each claim, on a
16 claim-by-claim basis, is as follows:

- 17 • A reasonably estimated exposure for unpaid off-the-clock wages was calculated, with the
18 assistance of an expert, to be approximately **\$18,706.00**, based on an assumption of three
19 minutes of off-the-clock work for every shift for every Class Member. However, with the
20 high risk factor discounts for certification and liability proof, the value of that claim is
21 estimated by Plaintiff's counsel to be approximately **\$2,244.72**, assuming certification
22 probability of 30% and merits success at 40%. The off-the-clock time resulted from
23 waiting in line before and after shifts to clock in and out, which was disputed by
24 Defendant. Here, a \$2,244.72 exposure has a value of about 12% of its maximum, given
25 a likelihood of success on both certification and the merits, which is an approximation of
26 the chain probability of certification multiplied by merits chances: $0.4 \times 0.3 = 0.12$. This
27 theory of recovery has a high degree of risk because it depends on Class Member
28 estimates of the frequency and duration and is testimony dependent.
- A reasonably estimated exposure for unpaid wages due to regular rate errors was
calculated, with the assistance of an expert, to be approximately **\$102.00**. However, with
the risk factor discounts for certification and liability proof, the value of that claim is
estimated by Plaintiff's counsel to be approximately **\$49.98**, assuming certification
probability of 70% and merits success at 70%. Defendant's data showed that overtime
and other applicable rates of pay were paid at below the 1.5 times the regular rate for
purposes of calculating overtime rate of pay, sick pay, and break premiums.
- A reasonably estimated exposure for rest break violations over the class period was
calculated at **\$69,769.00**, but with chances of certification and proof of liability (30% and

30% respectively) for a risk-adjusted exposure of **\$6,279.21**. This claim is based on class member testimony of interrupted rest periods and time required to move between work and rest areas which cut into the rest periods, Plaintiff estimated the exposure assuming 25% of all rest periods were missed during the Class Period – an optimistic estimation.

- A reasonably calculated exposure for meal break violations over the class period was calculated at **\$8,721.00**, with chances of certification and liability risks (50% and 40% respectively) resulting in a risk-adjusted exposure of **\$1,744.20**. This exposure is based upon class member testimony that they were required to wait in line to clock back into lunch because of the large number of employees who would clock back in at the same time.
- A calculated exposure for unreimbursed expenses was estimated to be **\$15,250.00**, but with chances of certification and proof of liability (40% and 30% respectively) for a risk-adjusted exposure of **\$1,830.00**. The allegation is that employees used personal cell phones to communicate with Defendant’s supervisors and purchased various items necessary for their jobs such as steel-toed boots. It is disputed that cell phone usage occurred and that purchase of steel-toed boots or other items were actually necessary for Class Members’ duties.
- The risk-adjusted penalty recovery for Labor Code § 203 penalties was estimated to be approximately **\$112,664.70** on a maximum exposure of **\$1,251,830.00** (with certification and merits success chances of 30% and 30% respectively, based on the theory of unpaid wages, adjusted for the additional risk of needing to prove other elements in addition to the underlying wage claim). The need to show a knowing and intentional violation constitutes an additional risk factor.
- The risk-adjusted penalty recovery for wage statement penalties was estimated to be approximately **\$7,825.50**, on a maximum exposure of **\$86,950.00** (with certification and merits success chances of 30% and 30% respectively, based on the theory of unpaid wages, adjusted for the additional risk of needing to prove other elements in addition to the underlying wage claim). The value of this claim was just dealt a severe blow by the recent California Supreme Court decision of *Naranjo v. Spectrum Security Services, Inc.* (May 6, 2024), which significantly strengthened the good faith defense to Section 226 penalties.
- Performing risk-adjusted valuations for all claims yields a total value in the range of **\$132,638.31**, excluding PAGA.³
- For the PAGA Period, the number of PAGA Pay Periods at issue is estimated to be **4,000** for the 174 Aggrieved Employees. Using the most straightforward formulation of applying the “catch-all” \$100 penalty specified in Labor Code § 2699(f)(2) to each PAGA Pay Period, the total penalty exposure is approximately **\$400,000.00**. In addition, with assistance from Plaintiff’s data consultant, and after a thorough review of evidence casting serious doubt on the viability of many of the theories of penalty recover, counsel separately estimated the plausible potential PAGA exposure to be, on a penalty-by-penalty basis, to be **\$545,050.00**, which does include some stacking. But, assuming

³ It is difficult to assign specific percentages to future events, but it does provide a method for attempting to reduce the concept of “very high risk” or “high risk” to a quantifiable amount. Certification of a claim is typically a binary event. One does not obtain a 20% certification; a claim is either certified or it is not. But the current expected value is best quantified by applying a risk reduction, based on the total experience of counsel. The numbers explain with math what can also be described conceptually in words.

1 issues with proof and cooperation of aggrieved employees, along with the Court's power
2 to reduce penalties, the exposure was estimated to be **\$81,757.50.00**, which is 15% of the
calculated exposure assuming an ideal outcome.

3 19. The \$200,000.00 settlement here is fully supportable. Many risks are eliminated through
4 settlement. And, with respect to those risks, certification rates in California are **lower** than conventional
5 wisdom holds. The Judicial Council's Class Certification in California: SECOND INTERIM REPORT
6 FROM THE STUDY OF CALIFORNIA CLASS ACTION LITIGATION - FEBRUARY 2010
7 ("Second Interim Report"), at page 5, states that "less than a quarter of disposed cases in the study
8 sample were certified, either through a litigated motion for certification or as part of a classwide
9 settlement agreement." *See*, Second Interim Report, at 5 (emphasis added).⁴ That "**or**" is significant.
10 The certification rate of less than 25% identified in the study includes **both** contested certifications and
11 settlement certifications, which are the majority of certifications. In other words, one must assume in any
12 wage and hour class action prior to certification that a contested certification motion will have a success
13 rate of well under 25%, and probably closer to 10% as a starting point for risk evaluation. The facts of
14 each case have significant bearing on these percentages. But it cannot be disputed that certification is an
15 exceptionally difficult procedural hurdle to successfully overcome. Thus, it is not unreasonable to start
16 from the proposition that a pre-certification settlement that is 10% to 15% of the maximum plausible
17 exposure is a valid starting point for valuation. If roughly 10% of class actions are certified on a
18 contested basis, then, on average, 90% of the time a class will not be certified and the result for the class
19 is *zero* dollars. Here, the estimated certification probabilities are **above** the average rate at which cases
20 were certified in California over the study years, based upon data available through the California Courts
21 websites. In sum, well *under* 20% of all cases filed as proposed class actions are ultimately certified by
22 way of a *contested* motion. Thus, the recovery falls within the expected outcome under the likelihood of
23 success metric. It would also be appropriate to evaluate the result by examining only the premium wages
24 at issue (approximately \$97,298.00, *with no risk reduction*), excluding penalties and interest.⁵ Because

1 the total Settlement amount and the proportion of the Settlement allocated to PAGA penalties fall within
2 the range of what is reasonable, the Settlement should be approved.

3 20. To the best of my knowledge there are no other like claims asserted or filed by Class
4 Members. To the best of my knowledge, no Class Member has refrained from bringing an action with
5 claims similar to those raised in the Action, whether in reliance on the Action or otherwise, and who
6 thus might be prejudiced by dismissal of the Action.

7 8 THE EXPERIENCE OF CLASS COUNSEL

9 21. Moon Law Group, PC (former named Moon & Yang, APC), has been engaged in the
10 practice of employment and labor law for almost a decade and presently focuses exclusively on
11 plaintiffs' employment law. The firm and its lawyers have handled many hundreds of wage-related
12 class actions between them. The firm and its lawyers have successfully settled more than 500 class
13 action matters during that time span. The firm and its lawyers have also tried both bench and jury trials
14 (representing both plaintiffs and defendants) relating to employment matters. Moon Law Group, PC, is
15 routinely appointed lead or co-lead class counsel (or counsel for representative plaintiffs in FLSA
16 representative actions) in federal and state courts in California and elsewhere, by way of motion for
17 class certification or motion for settlement approval. I personally participated in the litigation of more
18 than 600 class actions since 1999, and more than 90 percent of those cases were wage and hour matters.
19 While I have not maintained a comprehensive list, I have been appointed as lead or co-lead counsel in
20 many hundreds of class actions.

21 22. Mr. Kane Moon received a B.A. in History in 1998 from UCLA. He received his J.D.
22 from Loyola Marymount Law School in 2006. He became an Active Member of the State Bar of
23 California in June 2007 and has been an Active Member in good standing continuously since then. He
24 is a current member of the California Employment Lawyers Association (CELA).

27 amount than the maximum civil penalty amount specified by this part...”), and, second, courts evaluate
28 the strength of a proposed settlement without taking potential penalties or interest into consideration. *See Rodriguez v. West Publishing Corp.*, 563 F.3d 948, 955 (9th Cir. 2000); *see also Miller v. CEVA Logistics U.S.A., Inc.*, 2015 WL 729638, at *7 (E.D. Cal. Feb. 19, 2015).

23. Mr. Moon co-founded Moon & Yang, APC, now Moon Law Group, PC, in March 2010. Since that time, Mr. Moon built his practice to have an emphasis on employment and related civil litigation cases. In fact, the practice is focused almost exclusively on advocating for the rights of employees in wage-and-hour litigation through class and representative actions. Moon Law Group, PC is presently class counsel for many dozens of other putative wage-and-hour class and representative action lawsuits pending in various state and federal jurisdictions throughout California. Moon Law Group, PC has also successfully settled hundreds of wage-and-hour cases; tried both bench and jury trials in employment-related matters, representing both plaintiffs and defendants; and been appointed lead or co-lead class counsel in numerous federal and state courts in California. 24. I received my undergraduate degree from Occidental College. Graduating cum laude, I majored in economics and received a "minor" emphasis in mathematics. Along with my study of economics and mathematics, I also had an emphasis in physics. This combination of scientific and economic education has been of assistance during my litigation of complex civil actions. I received my Juris Doctor degree from the University of Southern California Law Center.

25. My experience relevant to class action litigation includes the following:

(a) I have been involved in the litigation of class actions since 1997, working as a law clerk on a number of class action matters. Since 1999, I have participated as an attorney in the litigation of hundreds of class actions, in California Superior Courts and in federal courts in California, Illinois, and Louisiana. I emphasized litigation of wage and hour class actions beginning in 2005, but I have focused on complex litigation of different types at all times since 1999.

(b) Dating back to 1999, some of the earliest cases in which I contributed to my then-firm's efforts as co-lead/liaison counsel include:

- (c) The 2024-25 Adjusted Laffey Matrix states that an attorney with 20 or more years experience can reasonably charge \$1,141 per hour.
<http://www.laffeymatrix.com/see.html>.⁶ That rate is derived from the Washington, D.C. area and requires a costs of living evaluation for use in Los Angeles. Using federal statistics for average attorney salaries, attorney pay is 4.9% lower in Los Angeles, compared to Washington, D.C., indicating a 4.9% downward adjustment to the Laffey Matrix may be appropriate.
<https://www.bls.gov/oes/current/oes231011.htm>.⁷ However, using federal employee pay tables, federal employee wages are equal when Los Angeles is compared to Washington, D.C., indicating no adjustment to the Laffey Matrix is appropriate. <https://www.opm.gov/policy-data-oversight/pay-leave/salaries-wages/2017/general-schedule/>.⁸ And, using Schedule 9 of 5 U.S.C. § 5332, there is a 3% differential favoring Los Angeles. Thus, something in the range of a 4.4% locality reduction to a 3.0% locality increase appears appropriate here. Thus, applying an adjustment factor of 0.0%, the locality corrected Adjusted Laffey Matrix hourly rate for attorneys with 20 or more years of experience is \$1,141. The complete Adjusted Laffey Matrix is set forth below.
- (d) The full 2024-2025 Adjusted Laffey Matrix provides for the following hourly rates for paralegal/law clerks and attorneys falling into various ranges of years of experience:

(e) I have been selected to Super Lawyers from 2012-2025, achieving that professional recognition for more than a decade. I was selected for the Rising Stars edition of Super Lawyers in 2009.

(f) Based upon my practice area, geographic market, experience, including all of the above information, reputation, and generally accepted hourly rates, my current, hourly billing rate is now \$975.00, which is well below the presumed appropriate hourly rate of \$1,141 for attorneys with 20 or more years of experience.

REASONABLENESS OF THE REQUESTED FEE AWARD

27. When this case was taken on a contingent fee basis, with the firm agreeing to assume responsibility for litigation costs, the ultimate result was far from certain. In the course of this litigation, Moon Law Group, PC, paid filing fees, copy charges, Westlaw fees, and mailing, telephone and express mail charges. There was never a guarantee that Moon Law Group, PC, would recoup those expenditures. The firm took on this case, which necessarily required the firm to forego other opportunities, given finite resources to devote to cases.

28. Because of the uncertainty of the outcome in this and other wage and hour litigation undertaken by Moon Law Group, PC, we took this case with the expectation that a risk enhancement, either in the form of a lodestar multiplier or a percentage of the fund award equivalent thereto, would be available if we prevailed. This expectation stems from the fact that many cases we undertake as putative class actions do not resolve successfully.

29. Class Counsel's experience in employment class actions was integral in evaluating the strengths and weaknesses of the case against Defendant and the reasonableness of the settlement. Practice in the narrow fields of wage and hour litigation requires skill and knowledge concerning the rapidly evolving substantive law (state and federal), as well as the procedural law of class action litigation.

1 30. In the past 5 years, Moon Law Group, PC, has settled hundreds of wage & hour class
2 actions. Just as the Court in *Chavez v. Netflix, Inc.*, 162 Cal. App. 4th 43, 66, n.11 (2008) observed, it
3 has been the experience at Moon Law Group, PC, that attorney fee awards of one-third of a common
4 settlement fund are the rule, rather than the exception. Here, Class Counsel agrees that they will seek no
5 more than one third of the settlement amount in fees. This is consistent with common practice,
6 consistent with Ninth Circuit practice, consistent with California law approving the percentage of the
7 fund method to award fees from a common fund, *Laffitte v. Robert Half Intern. Inc.*, 1 Cal. 5th 480, 503
8 (2016), and not inappropriate in light of the many hours expended by attorneys and paralegals
9 performing work for Plaintiff before and after the filing of this matter. That work includes:

- 10 (a) Numerous interviews with the client, and review of documents provided by
11 Plaintiff;
- 12 (b) Legal research and investigation regarding the Defendants' practices at numerous
13 points in the litigation;
- 14 (c) Preparation of multiple drafts of the original class action complaint and finalization
15 and filing of the original class action complaint;
- 16 (d) Review of the first amended complaint, and finalization of that complaint;
- 17 (e) Extensive "meet and confer" efforts with Defendants' counsel to obtain relevant
18 documents and information through informal discovery;
- 19 (f) Contacting witnesses;
- 20 (g) Review of data and documents produced by Defendants;
- 21 (h) Analysis of the audit results and preparation of a damages model with the aid of a
22 statistics expert;
- 23 (i) Research and preparation of Plaintiff's mediation brief;
- 24 (j) Attendance at mediation;
- 25 (k) Drafting, negotiating, and reviewing multiple drafts of the Settlement and
26 attachments; and
- 27 (l) Preparation of the initial motion for preliminary approval and multiple revisions
28 thereafter.

31. I anticipate that Class Counsel will spend an additional 30 hours on this matter, appearing at the hearing of preliminary approval, answering class member calls, working with the administrator to finalize documents in mailing format, conferring with counsel over any notice issues, drafting the final approval motion and motion for fees and costs, appearing at the final approval hearing, and resolving any post-approval issues that may arise, and appearing at a final accounting hearing. Class Counsel intends to request up to \$66,666.67 in attorneys' fees, as authorized under the Agreement. Class Counsel has also incurred costs in this matter that will be detailed at the time final approval is sought. Class Counsel has agreed to a cap on recoverable costs of \$18,000.00, and if total incurred costs exceed the cap, Class Counsel will request no more than the agreed-upon cap. Costs incurred to date are currently below the cap.

THE CONTRIBUTION OF PLAINTIFF AND THE REASONABLENESS OF THE REQUESTED
INCENTIVE AWARD

32. Here, Plaintiff seeks a Service Payment of up to **\$10,000.00** for the significant result achieved. This amount is very reasonable given the risks undertaken by Plaintiff for involvement in the Action. Taking the risk of filing a lawsuit against an employer deserves recognition, especially in light of the settlement achieved by Plaintiff. Additionally, Plaintiff was actively involved in the litigation and settlement negotiations of this Action, expending considerable effort in advancing the interest of the Class. Plaintiff provided information to counsel before the filing of this matter; assisted with the settlement process (which included conferring with counsel during the preparation of Plaintiff's mediation brief); and, regularly conferred with counsel regarding the case whenever questions arose. Plaintiff's Declaration also confirms that Plaintiff was an active participant in the settlement of this case.

THE THIRD-PARTY ADMINISTRATOR QUALIFICATIONS AND STATEMENT OF NO
CONFLICTS OR AFFILIATION

33. The parties have agreed that administration will be handled by a third-party administrator. In counsel's experience as class counsel in similar wage-and-hour actions with a similar number of employees, Phoenix is fully capable of administering the settlement at a competitive and

1 reasonable cost and should be approved by the Court to administer the settlement notice process.
2 Phoenix was selected because it submitted a low bid in the amount of **\$7,325.00** for administration
3 services. Phoenix has also provided a declaration confirming its experience and its implementation of
4 measures designed to protect Class Member data and Class Settlement funds. Finally, this firm has no
5 relationship with Phoenix, other than as a client retaining a vendor of services via an arms-length
6 transaction. We have no ownership interest in Phoenix.

7 8 CLASS CERTIFICATION

9 34. The class is ascertainable by objective criteria. The class is: All non-exempt employees
10 employed by Horizon Personnel Services, Inc. and placed to work at Defendant in California during the
11 Class Period. ("Class Period" means the period from August 10, 2019, to February 1, 2023).
12 "Participating Class Member" means a Class Member who does not submit a valid and timely Request
13 for Exclusion from the Class portion of the Settlement. (Agreement, ¶¶ 1.5, 1.9, 1.12, 1.34.)

14 35. The class is sufficiently numerous. Based upon Defendant's records and discovery,
15 there are about 305 Class Members. Plaintiff's counsel believe that the data is reliable.

16 36. Plaintiff is typical of the Class. Plaintiff was employed by Defendant. Plaintiff worked
17 during the Class Period. Plaintiff's claims are typical of the claims of the Class proposed in this
18 settlement. Like other class members, Plaintiff experienced work under policies and procedures
19 impacting wage and hour compliance. No unique defenses applicable to Plaintiff have been identified
20 that do not also exist as to other Class Members.

21 37. Common *issues* exist. Here, Class Members have shared a common interest in
22 determining whether Defendant violated wage and hour requirements under state and related federal
23 law, including the following issues: i. Whether or not Defendants paid proper wages to the Class; ii.
24 Whether or not Defendants provided meal periods to the Class; iii. Whether or not Defendants provided
25 rest periods to the Class; iv. Whether or not Defendants paid compensation timely upon separation of
26 employment to former Class Members; v. whether or not Defendants paid compensation timely
27 throughout Class Members' employment; vi. Whether or not Defendants provided accurate itemized
28 wage statements to the Class; and, vii. Whether or not Defendants engaged in unlawful or unfair

1 business practices affecting the Class in violation of California Business and Professions Code §§
2 17200-17208.

3 38. From our review of the documentation provided, we determined that for purposes of
4 these claims, Defendants' policies and practices are either identical, or sufficiently similar, to raise the
5 same questions of liability, and applied to all Class Members. Because Class Members would have to
6 prove the same issues of law and fact to prevail, and because their potential legal remedies are identical,
7 it would be preferable to resolve all Class Members' claims by means of the Settlement than to require
8 each Class Member to litigate his or her individual claims. Therefore, common questions predominate
9 over any questions that may be unique to individual Class Members, and class-wide settlement is
10 superior to any other method of resolution.

11 39. My Declaration, in Paragraphs above, summarizes the firm's experience that establishes
12 its adequacy to represent the Class. We have no known conflicts of interest with absent Class
13 Members. Plaintiff has demonstrated, through participation in this action, a willingness to serve as a
14 representative for the Class. Plaintiff has no known conflicts of interest with absent Class Members
15 and has agreed to place the class's interests above Plaintiff's own. Plaintiff's actions also demonstrate
16 adequacy.

17 40. By consolidating all of these potential individual actions into one proceeding, this
18 Court's use of the class action device enables it to manage this litigation in a manner that serves the
19 economics of time, effort and expense for the litigants and the judicial system. Absent class treatment,
20 similarly-situated employees with small but potentially meritorious claims for damages would, as a
21 practical matter, have no means of redress because of the time, effort and expense required to prosecute
22 individual actions. Moreover, in the context of settlement, superiority concerns are almost non-
23 existent, since case management is controlled and a methodology for trial need not be identified.

CLASS ACTION AND PAGA SETTLEMENT AGREEMENT AND CLASS NOTICE

This Class Action and PAGA Settlement Agreement (“Agreement”) is made by and between plaintiff MARYOLIN HERNANDEZ (“Plaintiff”) and defendant CAL CARTAGE WAREHOUSING & TRANSLOADING, LLC (“Defendant”). The Agreement refers to Plaintiff and Defendant collectively as “Parties,” or individually as “Party.”

1. **DEFINITIONS.**

- 1.1. “Action” means the Plaintiff’s lawsuit alleging wage and hour violations against Defendant captioned *Hernandez v. Cal Cartage Warehousing & Transloading, LLC, et al.*, initiated on August 10, 2023, and pending in the Superior Court of the State of California, County of Los Angeles.
- 1.2. “Administrator” means Phoenix Class Action Administration Solutions, the neutral entity the Parties have agreed to appoint to administer the Settlement.
- 1.3. “Administration Expenses Payment” means the amount the Administrator will be paid from the Gross Settlement Amount to reimburse its reasonable fees and expenses in accordance with the Administrator’s “not to exceed” bid submitted to the Court in connection with Preliminary Approval of the Settlement.
- 1.4. “Aggrieved Employee(s)” means all non-exempt employees employed by Defendant, and all non-exempt employees employed by Horizon Personnel Services, Inc. placed to work at Defendant, in California at any time during the PAGA Period.
- 1.5. “Class” means all non-exempt employees employed by Horizon Personnel Services, Inc. and placed to work at Defendant in California during the Class Period.
- 1.6. “Class Counsel” means MOON LAW GROUP, PC.
- 1.7. “Class Counsel Fees Payment” and “Class Counsel Litigation Expenses Payment” mean the amounts allocated to Class Counsel for reimbursement of reasonable attorneys’ fees and expenses, respectively, incurred to prosecute the Action.
- 1.8. “Class Data” means Class Member identifying information in Defendant’s possession including the Class Member’s name, last-known mailing address, Social Security number, and number of Class Period Workweeks and PAGA Pay Periods.

- 1.9. “Class Member” or “Settlement Class Member” means a member of the Class, as either a Participating Class Member or Non-Participating Class Member (including a Non-Participating Class Member who qualifies as an Aggrieved Employee).
- 1.10. “Class Member Address Search” means the Administrator’s investigation and search for current Class Member mailing addresses using all reasonably available sources, methods and means including, but not limited to, the National Change of Address (“NCOA”) database, skip traces, and direct contact by the Administrator with Class Members.
- 1.11. “Class Notice” means the COURT APPROVED NOTICE OF CLASS ACTION SETTLEMENT AND HEARING DATE FOR FINAL COURT APPROVAL, to be mailed to Class Members in English, with a Spanish translation, in the form, without material variation unless otherwise agreed by the Parties, attached as **Exhibit A** and incorporated by reference into this Agreement. The Parties, through counsel, may agree to modifications to the Class Notice required to correct errors or effectuate changes required by the Court without the need to amend this Agreement, and the revised Class Notice shall be incorporated herein in place of the original **Exhibit A**.
- 1.12. “Class Period” means the period from August 10, 2019, through February 1, 2023
- 1.13. “Class Representative” means the named Plaintiff in the operative complaint in the Action seeking Court approval to serve as the Class Representative.
- 1.14. “Class Representative Service Payment” means the payment to the Class Representative, for initiating the Action and providing services in support of the Action.
- 1.15. “Court” means the Superior Court of California, County of Los Angeles.
- 1.16. “Defendant” means Defendant CAL CARTAGE WAREHOUSING & TRANSLOADING, LLC, the named defendant in the Action.
- 1.17. “Defense Counsel” means LITTLER MENDELSON, PC.
- 1.18. “Effective Date” means the later of: (a) the sixty-fifth (65) day after the Court enters a Judgment on its Order Approving the Class and PAGA Settlement, provided no appeal has been initiated and no motion to vacate has been filed; or (b) if such an appeal or motion to vacate is timely initiated, five (5) business days after the final resolution of that appeal or

1 motion (including any requests for rehearing or appeals, including petitions for certiorari),
2 resulting in final judicial approval of the Settlement.

3 1.19. “Final Approval Order” means the Court’s order granting final approval of the Settlement.

4 1.20. “Final Approval Hearing” means the Court’s hearing on the motion for final approval of
5 the Settlement.

6 1.21. “Gross Settlement Amount” means \$200,000 which is the total amount Defendant agrees
7 to pay under the Settlement except as provided in Paragraphs 3.1 and 8 below. The Gross
8 Settlement Amount will be used to pay Individual Class Payments, Individual PAGA
9 Payments, the LWDA PAGA Payment, Class Counsel Fees Payment, Class Counsel
10 Litigation Expenses Payment, Class Representative Service Payment, and the
11 Administration Expenses Payment.

12 1.22. “Individual Class Payment” means the Participating Class Member’s pro rata share of the
13 Net Settlement Amount calculated according to the number of Workweeks worked during
14 the Class Period.

15 1.23. “Individual PAGA Payment” means the Aggrieved Employee’s pro rata share of 25% of
16 the PAGA Penalties calculated according to the number of PAGA Pay Periods worked
17 during the PAGA Period.

18 1.24. “Judgment” means the judgment entered by the Court based upon the Final Approval.

19 1.25. “LWDA” means the California Labor and Workforce Development Agency, the agency
20 entitled, under Labor Code § 2699(i).

21 1.26. “LWDA PAGA Payment” means the 75% portion of the PAGA Penalties paid to the
22 LWDA under Labor Code § 2699(i).

23 1.27. “Net Settlement Amount” means the Gross Settlement Amount, less the following
24 payments in the amounts approved by the Court: Class Counsel Fees Payment, Class
25 Counsel Litigation Expenses Payment, the LWDA PAGA Payment, Class Representative
26 Service Payment, and the Administration Expenses Payment. The remainder is to be paid
27 to Participating Class Members as Individual Class Payments.

28 1.28. “Non-Participating Class Member” means any Class Member who opts out of the Class

portion of the Settlement by sending the Administrator a valid and timely Request for Exclusion.

1.29. “PAGA Pay Period” means any Pay Period during which an Aggrieved Employee worked for Defendant for at least one day during the PAGA Period.

1.30. “PAGA Period” means the period from August 9, 2022, through the date that the Court grants preliminary approval of the Class settlement.

1.31. “PAGA” means the Private Attorneys General Act (Labor Code §§ 2698. *et seq.*).

1.32. “PAGA Notice” means Plaintiff’s letter to Defendant and the LWDA dated August 9, 2023, providing notice pursuant to Labor Code § 2699.3(a).

1.33. “PAGA Penalties” means the total amount of PAGA civil penalties to be paid from the Gross Settlement Amount, allocated 25% to the Aggrieved Employees and 75% to the LWDA in settlement of PAGA claims.

1.34. “Participating Class Member” means a Class Member who does not submit a valid and timely Request for Exclusion from the Class portion of the Settlement.

1.35. “Plaintiff” means MARYOLIN HERNANDEZ, the named plaintiff in the Action.

1.36. “Preliminary Approval Hearing” means the hearing of the motion requesting preliminary approval of the Class portion of the Settlement.

1.37. “Preliminary Approval Order” means the order granting preliminary approval of the Class portion of the Settlement.

1.38. “Released Class Claims” means the claims being released as described in Paragraph 5.2 below.

1.39. “Released PAGA Claims” means the claims being released as described in Paragraph 5.3 below.

1.40. “Released Parties” means Defendant and any of its past, present and future direct or indirect parents, subsidiaries, predecessors, successors, assigns, and affiliates, joint venturers, as well as its past, present and future owners, officers, directors, employees, associates, partners, shareholders, members, agents, attorneys, insurers, reinsurers, and any individual or entity that could be jointly liable with Defendant including but not limited to

Horizon Personnel Services, Inc. and/or Employer's Outsourcing, Inc.

1.41. "Request for Exclusion" means a Class Member's submission of a written request to be excluded from the Class Settlement.

1.42. "Response Deadline" means forty-five (45) days after the Administrator mails Notice to Class Members and Aggrieved Employees, and shall be the last date on which Class Members may: (a) fax, email, or mail Requests for Exclusion from the Class portion of the Settlement, or (b) fax, email, or mail his or her Objection to the Settlement. The Response Deadline for Class Members to whom Notice Packets are resent after having been returned undeliverable to the Administrator shall be the longer of the original Response Deadline or 14 calendar days from the date of remailing of the Notice Packet.

1.43. "Settlement" means the disposition of the Action effected by this Agreement and the Judgment.

1.44. "Workweek" means any week during which a Class Member worked for Defendant for at least one day, during the Class Period.

2. RECITALS.

2.1. On August 10, 2023, Plaintiff commenced this Action by filing a Complaint alleging causes of action against Defendant for (1) Failure to Pay Minimum Wages (Cal. Lab. Code §§ 204, 1194, 1194.2, and 1197); (2) Failure to Pay Overtime Compensation (Cal. Lab. Code §§ 1194 and 1198); (3) Failure to Provide Meal Periods (Cal. Lab. Code §§ 226.7, 512); (4) Failure to Authorize and Permit Rest Breaks (Cal. Lab. Code §§ 226.7); (5) Failure to Indemnify Necessary Business Expenses (Cal. Lab. Code § 2802); (6) Failure to Timely Pay Final Wages at Termination (Cal. Lab. Code §§ 201-203); (7) Failure to Provide Accurate Itemized Wage Statements (Cal. Lab. Code § 226); and (8) Unfair Business Practices (Cal. Bus. & Prof. Code § 17200, *et. seq.*). On September 29, 2023, Defendant filed a Notice of Removal to remove the Action to federal court. On November 1, 2023, Plaintiff filed a First Amended Complaint alleging a single cause of action against Defendant for civil penalties under the Private Attorneys General Act ("PAGA") (Cal. Lab. Code § 2698, *et seq.*). The First Amended Complaint is the operative complaint in

the Action (the “Operative Complaint.”). Defendant denies the allegations in the Operative Complaint, denies any failure to comply with the laws identified in in the Operative Complaint, and denies any and all liability for the causes of action alleged.

2.2. Pursuant to Labor Code § 2699.3(a), Plaintiff gave timely written notice to Defendant and the LWDA by sending the PAGA Notice.

2.3. On March 27, 2025, the Parties participated in an all-day mediation presided over by Michael Ludwig, Esq., which led to this Agreement to settle the Action.

2.4. Prior to mediation, Plaintiff obtained, through formal discovery requests, policy documents, time clock records, and wage payment records. Plaintiff’s investigation was sufficient to satisfy the criteria for court approval set forth in *Dunk v. Foot Locker Retail, Inc.*, 48 Cal. App. 4th 1794, 1801 (1996) and *Kullar v. Foot Locker Retail, Inc.*, 168 Cal. App. 4th 116, 129-130 (2008) (“*Dunk/Kullar*”).

2.5. The Court has not granted class certification.

2.6. The Parties, Class Counsel and Defense Counsel represent that this settlement will extinguish the PAGA claims alleged against Defendant in *Vasquez v. Cal Cartage Warehousing & Transloading LLC, et al.*, Los Angeles Superior Court Case No. 24STCV10120 (currently stayed pending arbitration of individual claim for PAGA penalties) and the PAGA claims for the PAGA Period as alleged against Defendant in *Alconis v. Cal Cartage Customs Exam Station, LLC, et al.*, Los Angeles Superior Court Case No. 21STCV44364, but they are not aware of any other pending matter or action asserting claims that will be extinguished or affected by the Settlement.

3. MONETARY TERMS.

3.1. Gross Settlement Amount. Except as otherwise provided by Paragraph 8 below, Defendant promises to pay \$200,000 and no more as the Gross Settlement Amount and to separately pay any and all employer payroll taxes owed on the Wage Portions of the Individual Class Payments. Defendant has no obligation to pay the Gross Settlement Amount (or any payroll taxes) prior to the deadline stated in Paragraph 4.3 of this Agreement. The Administrator will disburse the entire Gross Settlement Amount without asking or

1 requiring Participating Class Members or Aggrieved Employees to submit any claim as a
2 condition of payment. None of the Gross Settlement Amount will revert to Defendant.

3 3.2. Payments from the Gross Settlement Amount. The Administrator will make and deduct the
4 following payments from the Gross Settlement Amount, in the amounts specified by the
5 Court in the Final Approval:

6 3.2.1. To Plaintiff: Class Representative Service Payment to the Class Representative of
7 not more than \$10,000.00 (in addition to any Individual Class Payment and any
8 Individual PAGA Payment the Class Representative is entitled to receive as a
9 Participating Class Member and Aggrieved Employee), as approved by the Court.
10 Defendant will not oppose Plaintiff's request for a Class Representative Service
11 Payment that does not exceed this amount. As part of the motion for Class Counsel
12 Fees Payment and Class Litigation Expenses Payment, Plaintiff will seek Court
13 approval for any Class Representative Service Payments no later than 16 court
14 days prior to the Final Approval Hearing. If the Court approves a Class
15 Representative Service Payment less than the amount requested, the Administrator
16 will retain the remainder in the Net Settlement Amount. The Class Representative
17 Service Payment will be reported using IRS Form 1099. Plaintiff assumes full
18 responsibility and liability for any taxes owed on the Class Representative Service
19 Payment(s).

20 3.2.2. To Class Counsel: A Class Counsel Fees Payment of not more than 33 1/3%,
21 which is currently estimated to be \$66,666.67, subject to the escalator clause, and a
22 Class Counsel Litigation Expenses Payment of not more than \$18,000.00.
23 Defendant will not oppose requests for these payments provided that they do not
24 exceed these amounts. Plaintiff and/or Class Counsel will file a motion for Class
25 Counsel Fees Payment and Class Litigation Expenses Payment no later than 16
26 court days prior to the Final Approval Hearing. If the Court approves a Class
27 Counsel Fees Payment and/or a Class Counsel Litigation Expenses Payment less
28 than the amounts requested, the Administrator will allocate the remainder to the

Net Settlement Amount. Released Parties shall have no liability to Class Counsel or any other Plaintiff's Counsel arising from any claim to any portion any Class Counsel Fee Payment and/or Class Counsel Litigation Expenses Payment. The Administrator will pay the Class Counsel Fees Payment and Class Counsel Litigation Expenses Payment using one or more IRS 1099 Forms. Class Counsel assumes full responsibility and liability for taxes owed on the Class Counsel Fees Payment and the Class Counsel Litigation Expenses Payment and holds Defendant harmless, and indemnifies Defendant, from any dispute or controversy regarding any division or sharing of any of these Payments.

3.2.3. To the Administrator: An Administration Expenses Payment not to exceed \$7,325.00 except for a showing of good cause and as approved by the Court. To the extent the Administration expenses are less or the Court approves payment less than \$7,325.00, the Administrator will retain the remainder in the Net Settlement Amount.

3.2.4. To Each Participating Class Member: An Individual Class Payment calculated by (a) dividing the Net Settlement Amount by the total number of Workweeks worked by all Participating Class Members during the Class Period and (b) multiplying the result by each Participating Class Member's Workweeks.

3.2.4.1. Tax Allocation of Individual Class Payments. 20% of each Participating Class Member's Individual Class Payment will be allocated to settlement of wage claims (the "Wage Portion"). The Wage Portions are subject to tax withholding and will be reported on an IRS W-2 Form. 80% of each Participating Class Member's Individual Class Payment will be allocated to settlement of claims for interest and penalties (the "Non-Wage Portion"). The Non-Wage Portions are not subject to wage withholdings and will be reported on IRS 1099 Forms. Participating Class Members assume full responsibility and liability for any employee taxes owed on their Individual Class Payment.

3.2.4.2. Effect of Non-Participating Class Members on Calculation of Individual Class Payments. Non-Participating Class Members will not receive any Individual Class Payments. The Workweeks of Non-Participating Class Members are not included in the calculation of payments to Participating Class Members and therefor have no effect on the calculation of Individual Class Payments paid from the Net Settlement Amount.

3.2.5. To the LWDA and Aggrieved Employees: PAGA Penalties in the amount of \$20,000.00 to be paid from the Gross Settlement Amount, with 75% allocated to the LWDA PAGA Payment and 25% allocated to the Individual PAGA Payments.

3.2.5.1. The Administrator will calculate each Individual PAGA Payment by (a) dividing the amount of the Aggrieved Employees' 25% share of PAGA Penalties by the total number of PAGA Period Pay Periods worked by all Aggrieved Employees during the PAGA Period and (b) multiplying the result by each Aggrieved Employee's PAGA Period Pay Periods. Aggrieved Employees assume full responsibility and liability for any taxes owed on their Individual PAGA Payment.

3.2.5.2. If the Court approves PAGA Penalties of less than the amount requested, the Administrator will allocate the remainder to the Net Settlement Amount. The Administrator will report the Individual PAGA Payments on IRS 1099-MISC Forms.

4. SETTLEMENT FUNDING AND PAYMENTS.

4.1. Funding of Gross Settlement Amount. Defendant shall fully fund the Gross Settlement Amount, and also fund the amounts necessary to fully pay Defendant's share of payroll taxes by transmitting the funds to the Administrator no later than 5 days after the Effective Date.

4.2. Payments from the Gross Settlement Amount. Within 14 days after Defendant funds the Gross Settlement Amount, the Administrator will mail checks for all Individual Class Payments, all Individual PAGA Payments, the LWDA PAGA Payment, the

Administration Expenses Payment, the Class Counsel Fees Payment, the Class Counsel Litigation Expenses Payment, and the Class Representative Service Payment. Disbursement of the Class Counsel Fees Payment, the Class Counsel Litigation Expenses Payment and the Class Representative Service Payment shall not precede disbursement of Individual Class Payments and Individual PAGA Payments.

4.2.1. Because Social Security Numbers (“SSNs”) for some Class Members are not known, the Administrator shall perform a pre-mailing skip trace on all Class Members Class Data is incomplete, in an effort to identify mailing addresses and SSNs for as many Class Members as possible. Class Members for whom addresses are located by SSNs are not known will be advised to communicate their SSN to the Administrator. At the time of distribution, the Administrator will make distributions based on whether SSNs are known as follows:

4.2.1.1. For Class Members whose SSNs are located or communicated to the Administrator, their full disbursement of Individual Class Payments and Individual PAGA Payments shall proceed as described below, beginning at Paragraph 4.2.2.

4.2.1.2. For Class Members whose SSNs are not known, but a mailing address is located, the Administrator will distribute any interest or penalty payment portion of the Individual Class Payment and any Individual PAGA Payment, up to an aggregate amount of \$599.00. The balance of any undistributed Individual Class Payment and/or undistributed Individual PAGA Payment will be directed to the California Controller's Unclaimed Property Fund in the name of the Class Member. The limitation on distributions described in this paragraph shall be applied to the distribution process described below, beginning at Paragraph 4.2.2.

4.2.2. The Administrator will issue checks for the Individual Class Payments and/or Individual PAGA Payments and send them to the Class Members via First Class U.S. Mail, postage prepaid. The face of each check shall prominently state the

1 date (not less than 180 calendar days after the date of mailing) when the check will
2 be voided. The Administrator will cancel all checks not cashed by the void date.
3 The Administrator will send checks for Individual Settlement Payments to all
4 Participating Class Members (including those for whom Class Notice was returned
5 undelivered). The Administrator will send checks for Individual PAGA Payments
6 to all Aggrieved Employees including Non-Participating Class Members who
7 qualify as Aggrieved Employees (including those for whom Class Notice was
8 returned undelivered). The Administrator may send Participating Class Members a
9 single check combining the Individual Class Payment and the Individual PAGA
10 Payment. Before mailing any checks, the Settlement Administrator must update
11 the recipients' mailing addresses using the NCOA database.

12 4.2.3. The Administrator must conduct a Class Member Address Search for all other
13 Class Members whose checks are returned undelivered without a United States
14 Postal Service ("USPS") forwarding address. Within 7 days of receiving a
15 returned check the Administrator must re-mail checks to the USPS forwarding
16 address provided or to an address ascertained through the Class Member Address
17 Search. The Administrator need not take further steps to deliver checks to Class
18 Members whose re-mailed checks are returned as undelivered. The Administrator
19 shall promptly send a replacement check to any Class Member whose original
20 check was lost or misplaced, requested by the Class Member prior to the void date.

21 4.2.4. For any Class Member whose Individual Class Payment check or Individual
22 PAGA Payment check is uncashed and cancelled after the void date, the
23 Administrator shall transmit the funds represented by such checks to the California
24 Controller's Unclaimed Property Fund in the name of the Class Member thereby
25 leaving no "unpaid residue" subject to the requirements of California Code of Civil
26 Procedure § 384(b).

27 4.2.5. The payment of Individual Class Payments and Individual PAGA Payments shall
28 not obligate Defendant to confer any additional benefits or make any additional

1 payments to Class Members (such as 401(k) contributions or bonuses) beyond
2 those specified in this Agreement.

3 **5. RELEASES OF CLAIMS.**

4 Effective on the date when Defendant fully funds the entire Gross Settlement Amount and funds all
5 employer payroll taxes owed on the Wage Portion of the Individual Class Payments, Plaintiff, Class
6 Members, and Class Counsel will release claims against all Released Parties as follows:

7 5.1. Plaintiff's Release.

8 5.1.1. Scope of Plaintiff's Release. In exchange for a Class Representative Service
9 Payment, Plaintiff and his or her respective former and present spouses,
10 representatives, agents, attorneys, heirs, administrators, successors, and assigns
11 generally, release and discharge Released Parties from all claims, transactions, or
12 occurrences, known or unknown, including, but not limited to: (a) all claims that
13 were, or reasonably could have been, alleged, based on the facts contained in the
14 Operative Complaint and the PAGA Notice and all claims that were, or
15 reasonably could have been alleged based on facts ascertained during the Action.
16 ("Plaintiff's Release.") Plaintiff's Release does not extend to any claims or actions
17 to enforce this Agreement, or to any claims for vested benefits, unemployment
18 benefits, disability benefits, social security benefits, workers' compensation
19 benefits that arose at any time, or based on occurrences outside the Class Period.
20 Plaintiff acknowledges that Plaintiff may discover facts or law different from, or in
21 addition to, the facts or law that Plaintiff now knows or believes to be true but
22 agrees, nonetheless, that Plaintiff's Release shall be and remain effective in all
23 respects, notwithstanding such different or additional facts or Plaintiff's discovery
24 of them.

25 5.1.2. Plaintiff's Waiver of Rights Under California Civil Code § 1542. For purposes of
26 Plaintiff's Release, Plaintiff expressly waives and relinquishes the provisions,
27 rights, and benefits, if any, of Section 1542 of the California Civil Code, which
28 reads:

1 **A general release does not extend to claims that the creditor or**
2 **releasing party does not know or suspect to exist in his or her favor**
3 **at the time of executing the release, and that if known by him or her**
 would have materially affected his or her settlement with the debtor
 or Released Party.

4 5.2. Release by Participating Class Members: All Participating Class Members, on behalf of
5 themselves and their respective former and present representatives, agents, attorneys, heirs,
6 administrators, successors, and assigns, release Released Parties from (i) all claims that
7 were alleged, or reasonably could have been alleged, based on the facts contained in the
8 Operative Complaint and the PAGA Notice and all claims that were, or reasonably could
9 have been alleged based on facts ascertained during the Action including, e.g., all claims
10 for (1) Failure to Pay Minimum Wages; (2) Failure to Pay Overtime Compensation; (3)
11 Failure to Provide Meal Periods; (4) Failure to Authorize and Permit Rest Breaks; (5)
12 Failure to Indemnify Necessary Business Expenses; (6) Failure to Timely Pay Final Wages
13 at Termination; (7) Failure to Provide Accurate Itemized Wage Statements; and (8) Unfair
14 Business Practices (Bus. & Prof. Code § 17200, et seq.). Participating Class Members do
15 not release any other claims, including claims for vested benefits, wrongful termination,
16 violation of the Fair Employment and Housing Act, unemployment insurance, disability,
17 social security, workers' compensation, or claims based on facts occurring outside the
18 Class Period.

19 5.3. PAGA Release: The LWDA and all Class Members who are Aggrieved Employees are
20 deemed to release, on behalf of themselves and their respective former and present
21 representatives, agents, attorneys, heirs, administrators, successors, and assigns, the
22 Released Parties from all claims for civil penalties under PAGA, based on the facts and
23 Labor Code sections that were alleged or reasonably could have been alleged, based on the
24 facts contained in the Operative Complaint and the PAGA Notice and all PAGA claims
25 that were, or reasonably could have been alleged based on facts ascertained during the
26 Action.

27 **6. MOTION FOR PRELIMINARY APPROVAL.**

28 Plaintiff shall file a motion for preliminary approval ("Motion for Preliminary Approval") subject to the

review by Defendant, as follows:

6.1. Defendant's Declaration in Support of Preliminary Approval. Within 14 days of the full execution of this Agreement, Defendant will prepare and deliver to Class Counsel a signed declaration from Defendant and/or Defense Counsel disclosing all facts relevant to any actual or potential conflicts of interest with the Administrator, *if any such actual or potential conflicts exist*. Similarly, if any other action is filed that asserts claims that will be extinguished or adversely affected by the Settlement before the Court enters an order preliminarily approving the Settlement, Defendant shall inform Class Counsel of such action(s). If there are no actual or potential conflicts of interest with the Administrator to disclose, or any pending matters to disclose, no declaration from Defendant and/or Defense Counsel is required.

6.2. Plaintiff's Responsibilities. Plaintiff will prepare and deliver to Defense Counsel documents necessary for obtaining a Preliminary Approval Order, including: (i) a draft of the notice, and memorandum in support, of the Motion for Preliminary Approval that includes an analysis of the Settlement under governing case law and a request for approval of the PAGA Settlement under Labor Code § 2699(f)(2)); (ii) a draft Preliminary Approval Order; (iii) a draft proposed Class Notice; (iv) a signed declaration from the Administrator attaching its "not to exceed" bid for administering the Settlement and attesting to its willingness to serve; competency; operative procedures for protecting the security of Class Data; amounts of insurance coverage for any data breach, defalcation of funds or other misfeasance; all facts relevant to any actual or potential conflicts of interest with Class Members; and the nature and extent of any financial relationship with Plaintiff, Class Counsel, Defendant, or Defense Counsel; (v) a signed declaration from Plaintiff confirming willingness and competency to serve and disclosing all facts relevant to any actual or potential conflicts of interest with Class Members or the Administrator, if any; and, (vi) a signed declaration from each Class Counsel firm attesting to its competency to represent the Class Members; its timely transmission to the LWDA of all necessary PAGA documents; and, all facts relevant to any actual or potential conflict of interest with Class

Members or the Administrator. Class Counsel shall aver that they are not aware of any other pending matter or action asserting claims that will be extinguished or adversely affected by the Settlement or disclose the existence of any such pending matters.

Alternatively, if such other actions are filed between the execution of this Agreement and the filing of the Motion for Preliminary Approval and become known to Class Counsel, Class Counsel will advise Defense Counsel.

6.3. Responsibilities of Counsel. Class Counsel are responsible for expeditiously finalizing and filing the Motion for Preliminary Approval no later than 30 days after the full execution of this Agreement (extended in the event that any court processes delay the ability to file the Motion); obtaining a prompt hearing date for the Motion for Preliminary Approval; and for appearing in Court to advocate in favor of the Motion for Preliminary Approval. Class Counsel is responsible for delivering the Court's Preliminary Approval Order to the Administrator.

6.4. Duty to Cooperate. If the Parties disagree on any aspect of the proposed Motion for Preliminary Approval and/or the supporting declarations and documents, Class Counsel and Defense Counsel will expeditiously work together on behalf of the Parties by meeting in person or by telephone, and in good faith, to resolve the disagreement. If the Court does not enter a Preliminary Approval Order or conditions a Preliminary Approval Order on any material change to this Agreement, Class Counsel and Defense Counsel will expeditiously work together on behalf of the Parties by meeting in person or by telephone, and in good faith, to modify the Agreement and otherwise satisfy the Court's concerns.

7. SETTLEMENT ADMINISTRATION.

7.1. Selection of Administrator. The Parties have jointly selected Phoenix Class Action Administration Solutions to serve as the Administrator and verified that, as a condition of appointment, Phoenix Class Action Administration Solutions agrees to be bound by this Agreement and to perform, as a fiduciary, all duties specified in this Agreement in exchange for payment of Administration Expenses. The Parties and their Counsel represent that they have no interest or relationship, financial or otherwise, with the

Administrator other than a professional relationship arising out of prior experiences administering settlements.

7.2. Employer Identification Number. The Administrator shall have and use its own Employer Identification Number for purposes of calculating payroll tax withholdings and providing reports state and federal tax authorities.

7.3. Qualified Settlement Fund. The Administrator shall establish a settlement fund that meets the requirements of a Qualified Settlement Fund (“QSF”) under US Treasury Regulation § 468B-1.

7.4. Class Data. Not later than 14 days after the Court grants Preliminary Approval of the Settlement, Defendant will deliver the Class Data to the Administrator, in the form of a Microsoft Excel spreadsheet or comparable data file. To protect Class Members’ privacy rights, the Administrator must maintain the Class Data in confidence, use the Class Data only for purposes of this Settlement and for no other purpose, and restrict access to the Class Data to Administrator employees who need access to the Class Data to effect and perform under this Agreement. Defendant has a continuing duty to immediately notify Class Counsel if it discovers that the Class Data omitted class member identifying information and to provide corrected or updated Class Data as soon as reasonably feasible. Without any extension of the deadline by which Defendant must send the Class Data to the Administrator, the Parties and their counsel will expeditiously use best efforts, in good faith, to reconstruct or otherwise resolve any issues related to missing or omitted Class Data.

7.5. Notice to Class Members.

7.5.1. No later than 3 business days after receipt of the Class Data, the Administrator shall notify Class Counsel that the list has been received and state the number of Class Members, Aggrieved Employees, Workweeks, and Pay Periods in the Class Data.

7.5.2. Because critical portions of the Class Data, including addresses and SSNs, are not known for some Class Members and are not known to Defendant, the

1 Administrator shall perform a pre-mailing skip trace for any Class Members where
2 essential Class Data is missing, using any available information known about the
3 Class Member, in an effort to identify SSNs and mailing addresses for as many
4 Class Members as possible. At the present time, it is estimated that the Class
5 includes slightly more than 300 Class Members, while more complete Class Data
6 is available for approximately 200 Class Members.

7 7.5.3. Using best efforts to perform as soon as possible, and in no event later than 14 days
8 after receiving the Class Data, the Administrator will send to all Class Members
9 identified in the Class Data, via first-class USPS mail, the Class Notice, with
10 Spanish translation, substantially in the form attached to this Agreement as **Exhibit**
11 **A**. The first page of the Class Notice shall prominently estimate the dollar amounts
12 of each Individual Class Payment and/or Individual PAGA Payment payable to the
13 Class Member and/or Aggrieved Employee, and the number of Workweeks and
14 PAGA Pay Periods (if applicable) used to calculate these amounts. Before mailing
15 Class Notices, the Administrator shall update Class Member addresses using the
16 NCOA database. The first page of the Class Notice will also advise Class
17 Members whether their SSN is believed to be known, or whether their SSN is
18 presently unknown and must be communicated to the Administrator. For Class
19 Members whose SSNs are not know at the time the Notice issues, an IRS w-9
20 Form for providing a SSN to the Administrator will be included with the Notice.

21 7.5.4. Not later than 7 business days after the Administrator's receipt of any Class Notice
22 returned by the USPS as undelivered, the Administrator shall re-mail the Class
23 Notice using any forwarding address provided by the USPS. If the USPS does not
24 provide a forwarding address, the Administrator shall conduct a Class Member
25 Address Search, and re-mail the Class Notice to the most current address obtained.
26 The Administrator has no obligation to make further attempts to locate or send
27 Class Notice to Class Members whose Class Notice is returned by the USPS a
28 second time.

1 7.5.5. The deadlines for Class Members' written objections, challenges to Workweeks
2 and/or pay periods, and Requests for Exclusion will be the longer of the original
3 Response Deadline or 14 days from the date of the remailing of the Notice Packet.
4 The Administrator will inform the Class Member of the extended deadline with the
5 re-mailed Class Notice.

6 7.5.6. If the Administrator, Defendant, or Class Counsel is contacted by or otherwise
7 discovers any persons who believe they should have been included in the Class
8 Data and should have received Class Notice, the Parties will expeditiously meet
9 and confer in person or by telephone, and in good faith, in an effort to agree on
10 whether to include them as Class Members. If the Parties agree, such persons will
11 be Class Members entitled to the same rights as other Class Members, and the
12 Administrator will send, via email or overnight delivery, a Class Notice requiring
13 them to exercise options under this Agreement not later than 14 days after receipt
14 of Class Notice, or the deadline dates in the Class Notice, which ever are later.

15 7.6. Requests for Exclusion (Opt-Outs).

16 7.6.1. Class Members who wish to exclude themselves (opt-out of) the Class portion of
17 the Settlement must send the Administrator, by fax, email, or mail, a signed written
18 Request for Exclusion not later than the Response Deadline. A Request for
19 Exclusion is a letter from a Class Member or his/her representative that reasonably
20 communicates the Class Member's election to be excluded from the Class portion
21 of the Settlement and includes the Class Member's name, address and email
22 address or telephone number. To be valid, a Request for Exclusion must be timely
23 faxed, emailed, or postmarked by the Response Deadline.

24 7.6.2. The Administrator may not reject a Request for Exclusion as invalid because it
25 fails to contain all the information specified in the Class Notice. The Administrator
26 shall accept any Request for Exclusion as valid if the Administrator can reasonably
27 ascertain the identity of the person as a Class Member and the Class Member's
28 desire to be excluded. The Administrator's determination shall be final and not

1 appealable or otherwise susceptible to challenge. If the Administrator has reason to
2 question the authenticity of a Request for Exclusion, the Administrator may
3 demand additional proof of the Class Member's identity. The Administrator's
4 determination of authenticity shall be final as to the Parties, but a Class Member
5 whose Request for Exclusion is rejected by the Administrator may present a
6 challenge to that determination to the Court.

7 7.6.3. Every Class Member who does not submit a timely and valid Request for
8 Exclusion is deemed to be a Participating Class Member under this Agreement,
9 entitled to all benefits and bound by all terms and conditions of the Settlement,
10 including the Participating Class Members' Release under Paragraph 5.2 and 5.3 of
11 this Agreement, regardless whether the Participating Class Member actually
12 receives the Class Notice or objects to the Settlement.

13 7.6.4. Every Class Member who submits a valid and timely Request for Exclusion is a
14 Non-Participating Class Member and shall not receive an Individual Class
15 Payment or have the right to object to the class action components of the
16 Settlement. Because PAGA claims are subject to claim preclusion upon entry of
17 the Judgment, Non-Participating Class Members who are Aggrieved Employees
18 will still receive an Individual PAGA Payment and will be subject to a claim
19 preclusion defense if they attempt to assert any of the Released PAGA Claims
20 identified in Paragraph 5.3 of this Agreement.

21 7.7. Challenges to Calculation of Workweeks. Each Class Member shall have until the
22 expiration of the Response Deadline to challenge the number of Class Workweeks and
23 PAGA Pay Periods (if any) allocated to the Class Member in the Class Notice. The Class
24 Member may challenge the allocation by communicating with the Administrator via fax,
25 email or mail. The Administrator must instruct the challenging Class Member to submit
26 supporting documentation. In the absence of any contrary documentation, the
27 Administrator is entitled to presume that the Workweeks contained in the Class Notice are
28 correct so long as they are consistent with the Class Data. The Administrator's

determination of each Class Member's allocation of Workweeks and/or PAGA Pay Periods shall be final as to the Parties (although Defendant shall retain the right to correct erroneous Class Data if subsequently discovered), but a Class Member whose Workweek and/or Pay Period challenge is rejected by the Administrator may present the same evidence supporting the Workweek and/or Pay Period challenge to the Court for review. The Administrator shall promptly provide copies of any challenges to calculation of Workweeks and/or PAGA Pay Periods to Defense Counsel and Class Counsel, along with the Administrator's determinations regarding any challenges.

7.8. Objections to Settlement.

7.8.1. Only Participating Class Members may object to the class action components of the Settlement and/or this Agreement, including contesting the fairness of the Settlement, and/or amounts requested for the Class Counsel Fees Payment, Class Counsel Litigation Expenses Payment and/or Class Representative Service Payment.

7.8.2. Participating Class Members may send written objections to the Administrator, by fax, email, or mail. In the alternative, Participating Class Members may appear in Court (or hire an attorney to appear in Court) to present verbal objections at the Final Approval Hearing. A Participating Class Member who elects to send a written objection to the Administrator must do so not later than the Response Deadline. The Administrator will provide copies of every written objection to all Counsel.

7.8.3. Non-Participating Class Members have no right to object to any of the class action components of the Settlement.

7.9. Administrator Duties. The Administrator has a duty to perform or observe all tasks to be performed or observed by the Administrator contained in this Agreement or otherwise.

7.9.1. Website, Email Address and Toll-Free Number. The Administrator will establish and maintain and use an internet website to post information of interest to Class Members including the date, time and location for the Final Approval Hearing and

1 copies of the Settlement Agreement, Motion for Preliminary Approval, the
2 Preliminary Approval Order, the Class Notice, the motion for final approval, the
3 Motion for Class Counsel Fees Payment, Class Counsel Litigation Expenses
4 Payment and Class Representative Service Payment, the Final Approval Order and
5 the Judgment. The Administrator will also maintain and monitor an email address
6 and a toll-free telephone number to receive Class Member calls, faxes and emails.

7 7.9.2. Requests for Exclusion (Opt-outs) and Exclusion List. The Administrator will
8 promptly review on a rolling basis Requests for Exclusion to ascertain their
9 validity. Not later than 7 days after the expiration of the deadline for submitting
10 Requests for Exclusion, the Administrator shall email a list to Class Counsel and
11 Defense Counsel containing (a) the names and other identifying information of
12 Class Members who have timely submitted valid Requests for Exclusion
13 (“Exclusion List”); (b) the names and other identifying information of Class
14 Members who have submitted invalid Requests for Exclusion; (c) copies of all
15 Requests for Exclusion from Settlement submitted (whether valid or invalid).

16 7.9.3. Weekly Reports. The Administrator must, on a weekly basis, provide written
17 reports to Class Counsel and Defense Counsel that, among other things, tally the
18 number of: Class Notices mailed or re-mailed, Class Notices returned undelivered,
19 Requests for Exclusion (whether valid or invalid) received, objections received,
20 and challenges to Workweeks and/or PAGA Pay Periods received and/or resolved
21 (“Weekly Report”). The Weekly Reports must include provide the Administrator’s
22 assessment of the validity of Requests for Exclusion and attach copies of all
23 Requests for Exclusion and objections received. In addition to the Weekly Reports,
24 the Administrator shall report to the Parties when it has completed the initial
25 distribution of the Individual Class Payments and Individual PAGA Payments to
26 all individuals with valid addresses.

27 7.9.4. Workweek and/or Pay Period Challenges. The Administrator has the authority to
28 address and make decisions consistent with the terms of this Agreement on all

1 Class Member challenges over the calculation of Workweeks and/or PAGA Pay
2 Periods. The Administrator's determination of each Class Member's allocation of
3 Workweeks and/or PAGA Pay Periods shall be final as to the Parties (although
4 Defendant shall retain the right to correct erroneous Class Data if subsequently
5 discovered), but a Class Member whose Workweek and/or Pay Period challenge is
6 rejected by the Administrator may present the same evidence supporting the
7 Workweek and/or Pay Period challenge to the Court for review.

8 7.9.5. Administrator's Declaration. Not later than 14 days before the date by which
9 Plaintiff is required to file the Motion for Final Approval of the Settlement, the
10 Administrator will provide to Class Counsel and Defense Counsel, a signed
11 declaration suitable for filing in Court attesting to its due diligence and compliance
12 with all of its obligations under this Agreement, including, but not limited to, its
13 mailing of Class Notice, the Class Notices returned as undelivered, the re-mailing
14 of Class Notices, attempts to locate Class Members, the total number of Requests
15 for Exclusion from Settlement it received (both valid or invalid), the number of
16 written objections and attach the Exclusion List or otherwise list the names of each
17 individual submitting a timely Request for Exclusion. The Administrator will
18 supplement its declaration as needed or requested by the Parties and/or the Court.
19 Class Counsel is responsible for filing the Administrator's declaration(s) in Court.

20 7.9.6. Final Report by Settlement Administrator. Within 14 days after the Administrator
21 disburses all funds in the Gross Settlement Amount, the Administrator will provide
22 Class Counsel and Defense Counsel with a final report detailing its disbursements
23 by employee identification number only of all payments made under this
24 Agreement. At least 14 days before any deadline set by the Court, the
25 Administrator will prepare, and submit to Class Counsel and Defense Counsel, a
26 signed declaration suitable for filing in Court attesting to its disbursement of all
27 payments required under this Agreement. Class Counsel is responsible for filing
28 the Administrator's declaration in Court.

1 **8. CLASS SIZE ESTIMATES and ESCALATOR CLAUSE**

2 Based on its records, Defendant estimates that, as of the date of this Settlement Agreement, (1) there are
3 305 Class Members and 4,135 Total Workweeks during the Class Period and (2) there were 174
4 Aggrieved Employees who worked 4,000 Pay Periods from August 9, 2022 to the date of mediation on
5 March 27, 2025. If the number of actual Pay Periods at the close of the PAGA Period increases by more
6 than 10% (i.e., 4,400), Defendant may, at its election, opt to (a) increase the Gross Settlement Amount in
7 the exact proportionate amount as to any additional pay periods above 4,400 Pay Periods or (b) end the
8 PAGA Period on the date that the total pay periods equal 4,400 total Pay Periods.

9 **9. DEFENDANT’S RIGHT TO WITHDRAW.**

10 If the number of valid Requests for Exclusion identified in the Exclusion List exceeds 5% of the total of all
11 Class Members, Defendant may, but is not obligated to, withdraw from the Settlement. The Parties agree
12 that, if Defendant withdraws, the Settlement shall be void ab initio, have no force or effect whatsoever, and
13 that neither Party will have any further obligation to perform under this Agreement; provided, however,
14 Defendant will remain responsible for paying all Settlement administration expenses incurred to that point.
15 Defendant must notify Class Counsel and the Court of its election to withdraw not later than seven days
16 after the Administrator sends the final Exclusion List to Defense Counsel; late elections will have no
17 effect.

18 **10. MOTION FOR FINAL APPROVAL.**

19 Not later than 16 court days before the calendared Final Approval Hearing, Plaintiff will file in Court a
20 motion for final approval of the Settlement that includes a request for approval of the PAGA settlement
21 under Labor Code § 2699(I), a Proposed final approval order and a proposed Judgment (collectively
22 “Motion for Final Approval”). Plaintiff shall provide drafts of these documents to Defense Counsel not
23 later than 7 days prior to filing the Motion for Final Approval. Class Counsel and Defense Counsel will
24 expeditiously meet and confer in person or by telephone, and in good faith, to resolve any disagreements
25 concerning the Motion for Final Approval.

26 10.1. Response to Objections. Each Party retains the right to respond to any objection raised by
27 a Participating Class Member, including the right to file responsive documents in Court no
28 later than 5 court days prior to the Final Approval Hearing, or as otherwise ordered or

accepted by the Court.

10.2. Duty to Cooperate. If the Court does not issue a Final Approval Order or conditions the Final Approval Order on any material change to the Settlement (including, but not limited to, the scope of release to be granted by Class Members), the Parties will expeditiously work together in good faith to address the Court's concerns by revising the Agreement as necessary to obtain Final Approval. The Court's decision to award less than the amounts requested for the Class Representative Service Payment, Class Counsel Fees Payment, Class Counsel Litigation Expenses Payment and/or Administration Expenses Payment shall not constitute a material modification to the Agreement within the meaning of this paragraph.

10.3. Continuing Jurisdiction of the Court. The Parties agree that, after entry of Judgment, the Court will retain jurisdiction over the Parties, Action, and the Settlement solely for purposes of (i) enforcing this Agreement and/or Judgment, (ii) addressing settlement administration matters, and (iii) addressing such post-Judgment matters as are permitted by law.

10.4. Waiver of Right to Appeal. Provided the Judgment is consistent with the terms and conditions of this Agreement, specifically including the Class Counsel Fees Payment and Class Counsel Litigation Expenses Payment reflected set forth in this Settlement, the Parties, their respective counsel, and all Participating Class Members who did not object to the Settlement as provided in this Agreement, waive all rights to appeal from the Judgment, including all rights to post-judgment and appellate proceedings, the right to file motions to vacate judgment, motions for new trial, extraordinary writs, and appeals. The waiver of appeal does not include any waiver of the right to oppose such motions, writs or appeals. If an objector appeals the Judgment, the Parties' obligations to perform under this Agreement will be suspended until such time as the appeal is finally resolved and the Judgment becomes final.

10.5. Appellate Court Orders to Vacate, Reverse, or Materially Modify Judgment. If the reviewing Court vacates, reverses, or modifies the Judgment in a manner that requires a

material modification of this Agreement (including, but not limited to, the scope of release to be granted by Class Members), this Agreement shall be null and void. The Parties shall nevertheless expeditiously work together in good faith to address the appellate court's concerns and to obtain a Final Approval Order and entry of Judgment, sharing, on a 50-50 basis, any additional Administration Expenses reasonably incurred after remittitur. An appellate decision to vacate, reverse, or modify the Court's award of the Class Representative Service Payment or any payments to Class Counsel shall not constitute a material modification of the Judgment within the meaning of this paragraph, as long as the Gross Settlement Amount remains unchanged.

11. AMENDED JUDGMENT.

If any amended judgment is required under California Code of Civil Procedure § 384, the Parties will work together in good faith to jointly submit and a proposed amended judgment.

12. ADDITIONAL PROVISIONS.

12.1. No Admission of Liability, Class Certification or Representative Manageability for Other Purposes. This Agreement represents a compromise and settlement of highly disputed claims. Nothing in this Agreement is intended or should be construed as an admission by Defendant that any of the allegations in the Operative Complaint have merit or that Defendant has any liability for any claims asserted; nor should it be intended or construed as an admission by Plaintiff that Defendant's defenses in the Action have merit. The Parties agree that class certification and representative treatment is for purposes of this Settlement only. If, for any reason, the Court does not issue a Preliminary Approval Order, Final Approval Order, or enter Judgment, Defendant reserves the right to contest certification of any class for any reasons, and Defendant reserves all available defenses to the claims in the Action, and Plaintiff reserves the right to move for class certification on any grounds available and to contest Defendant's defenses. The Settlement, this Agreement and Parties' willingness to settle the Action will have no bearing on, and will not be admissible in connection with, any litigation (except for proceedings to enforce or effectuate the Settlement and this Agreement).

12.2. Confidentiality Prior to Preliminary Approval. Plaintiff, Class Counsel, Defendant, and Defense Counsel separately agree that, until the Motion for Preliminary Approval of Settlement is filed, they and each of them will not disclose, disseminate and/or publicize, or cause or permit another person to disclose, disseminate or publicize, any of the terms of the Agreement directly or indirectly, specifically or generally, to any person, corporation, association, government agency, or other entity except: (1) to the Parties' attorneys, accountants, or spouses, all of whom will be instructed to keep this Agreement confidential; (2) counsel in a related matter; (3) to the extent necessary to report income to appropriate taxing authorities; (4) in response to a court order or subpoena; or (5) in response to an inquiry or subpoena issued by a state or federal government agency. Each Party agrees to immediately notify each other Party of any judicial or agency order, inquiry, or subpoena seeking such information. Plaintiff, Class Counsel, Defendant, and Defense Counsel separately agree not to, directly or indirectly, initiate any conversation or other communication, before the filing of the Motion for Preliminary Approval, with any third party regarding this Agreement or the matters giving rise to this Agreement except to respond only that "the matter was resolved," or words to that effect. This paragraph does not restrict Class Counsel's communications with Class Members in accordance with Class Counsel's ethical obligations owed to Class Members.

12.3. No Solicitation. The Parties separately agree that they and their respective counsel and employees will not solicit any Class Member to opt out of or object to the Settlement, or appeal from the Judgment. Nothing in this paragraph shall be construed to restrict Class Counsel's ability to communicate with Class Members in accordance with Class Counsel's ethical obligations owed to Class Members.

12.4. Integrated Agreement. Upon execution by all Parties and their counsel, this Agreement together with its attached exhibits shall constitute the entire agreement between the Parties relating to the Settlement, superseding any and all oral representations, warranties, covenants, or inducements made to or by any Party.

12.5. Attorney Authorization. Class Counsel and Defense Counsel separately warrant and

1 represent that they are authorized by Plaintiff and Defendant, respectively, to take all
2 appropriate action required or permitted to be taken by such Parties pursuant to this
3 Agreement to effectuate its terms, and to execute any other documents reasonably required
4 to effectuate the terms of this Agreement including any amendments to this Agreement.

5 12.6. Cooperation. The Parties and their counsel will cooperate with each other and use their
6 best efforts, in good faith, to implement the Settlement by, among other things, modifying
7 the Settlement Agreement, submitting supplemental evidence and supplementing points
8 and authorities as requested by the Court. In the event the Parties are unable to agree upon
9 the form or content of any document necessary to implement the Settlement, or on any
10 modification of the Agreement that may become necessary to implement the Settlement,
11 the Parties will seek the assistance of a mediator and/or the Court for resolution.

12 12.7. No Prior Assignments. The Parties separately represent and warrant that they have not
13 directly or indirectly assigned, transferred, encumbered, or purported to assign, transfer, or
14 encumber to any person or entity and portion of any liability, claim, demand, action, cause
15 of action, or right released and discharged by the Party in this Settlement.

16 12.8. No Tax Advice. Neither Plaintiff, Class Counsel, Defendant nor Defense Counsel are
17 providing any advice regarding taxes or taxability, nor shall anything in this Settlement be
18 relied upon as such within the meaning of United States Treasury Department Circular 230
19 (31 CFR Part 10, as amended) or otherwise.

20 12.9. Modification of Agreement. This Agreement, and all parts of it, may be amended,
21 modified, changed, or waived only by an express written instrument signed by all Parties
22 or their representatives, and approved by the Court.

23 12.10. Agreement Binding on Successors. This Agreement will be binding upon, and inure to the
24 benefit of, the successors of each of the Parties.

25 12.11. Applicable Law. All terms and conditions of this Agreement and its exhibits will be
26 governed by and interpreted according to the internal laws of the state of California,
27 without regard to conflict of law principles.

28 12.12. Cooperation in Drafting. The Parties have cooperated in the drafting and preparation of

1 this Agreement. This Agreement will not be construed against any Party on the basis that
2 the Party was the drafter or participated in the drafting.

3 12.13. Confidentiality. To the extent permitted by law, all agreements made, and orders entered
4 during Action and in this Agreement relating to the confidentiality of information shall
5 survive the execution of this Agreement.

6 12.14. Use and Return of Class Data. Information provided to Class Counsel pursuant to
7 Evidence Code § 1152 or comparable laws, and all copies and summaries of the Class Data
8 provided to Class Counsel by Defendant in connection with the mediation, other
9 settlement negotiations, or in connection with the Settlement, may be used only with
10 respect to this Settlement, and no other purpose, and may not be used in any way that
11 violates any existing contractual agreement, statute, or rule of court. Not later than 90 days
12 after the date when the Court discharges the Administrator's obligation to provide a
13 declaration confirming the final pay out of all Settlement funds, Plaintiff shall destroy, all
14 paper and electronic versions of Class Data received from Defendant unless, prior to the
15 Court's discharge of the Administrator's obligation, Defendant makes a written request to
16 Class Counsel for the return, rather than the destruction, of Class Data.

17 12.15. Headings. The descriptive heading of any section or paragraph of this Agreement is
18 inserted for convenience of reference only and does not constitute a part of this
19 Agreement.

20 12.16. Calendar Days. Unless otherwise noted, all reference to "days" in this Agreement shall be
21 to calendar days. In the event any date or deadline set forth in this Agreement falls on a
22 weekend or federal legal holiday, such date or deadline shall be on the first business day
23 thereafter.

24 12.17. Notice. All notices, demands or other communications between the Parties in connection
25 with this Agreement will be in writing and deemed to have been duly given as of the third
26 business day after mailing by United States mail, or the day sent by email or messenger,
27 addressed as follows:

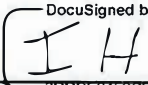

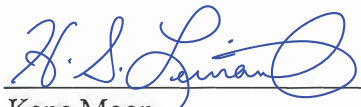

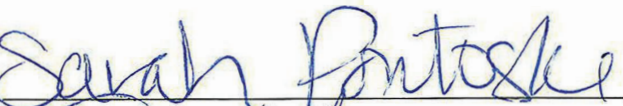

You may be eligible to receive money from an employee class action lawsuit (“Action”) against defendant CAL CARTAGE WAREHOUSING & TRANSLOADING, LLC (“Defendant”)¹ for alleged wage and hour violations. The Action was filed by a former employee, Maryolin Hernandez (“Plaintiff”), and seeks payment of (1) back wages and other relief for a class of hourly non-exempt employees (“Class Members”) who were placed by Horizon Personnel Services, Inc. to work at Defendant during the Class Period (August 10, 2019 to February 1, 2023); and, (2) penalties under the California Labor Code Private Attorneys General Act (“PAGA”) for all hourly non-exempt employees who were employed by Defendant and all non-exempt employees employed by Horizon Personnel Services, Inc. and placed to work at Defendant during the PAGA Period (August 9, 2022 through the date that the Court grants preliminary approval of the Class settlement) (the “Aggrieved Employees”).

The proposed Settlement has two main parts: (1) a Class Settlement requiring Defendant to fund Individual Class Payments, and (2) a PAGA Settlement requiring Defendant to fund Individual PAGA Payments and pay penalties to the California Labor and Workforce Development Agency (“LWDA”).

If you disagree with either of these numbers, you must challenge it by [REDACTED]. See Section 4 of this Notice.

1. WHAT IS THE ACTION ABOUT?

Plaintiff is a former employee of Horizon Personnel Services, Inc., placed to work at Defendant. The Action accuses Defendant of violating California labor laws by failing to pay overtime wages, minimum and straight time wages, wages due upon termination and failing to provide meal periods, rest breaks and accurate itemized wage statements. Plaintiff also claims that this alleged conduct constitutes unfair competition under the Unfair Competition Law (beginning at Business & Professions Code section 17200). Based on the same claims, Plaintiff has also asserted a claim for civil penalties under the California Private Attorneys General Act (beginning at Labor Code section 2698) (“PAGA Claims”). Plaintiff is represented by attorneys in the Action: Moon Law Group, PC (“Class Counsel.”).

Defendant denies all liability arising from the Action and is confident it has strong legal and factual defenses to Plaintiff’s claims. Defendant contends that, at all relevant times, Defendant properly compensated all employees and fully complied with all applicable laws. Defendant also denies that the Action is appropriate to maintain as a class or representative action.

2. WHAT DOES IT MEAN THAT THE ACTION HAS SETTLED?

So far, the Court has made no determination whether Defendant or Plaintiff are correct on the merits. In the meantime, Plaintiff and Defendant hired an experienced, neutral mediator, Michael Ludwig, to resolve the Action by negotiating and to end the case by agreement (settle the case) rather than continuing the expensive and time-consuming process of litigation. The negotiations were successful. Plaintiffs and Defendant have signed a lengthy written settlement agreement (“Agreement”), and jointly asked the Court to enter a judgment ending the Action and enforcing the Agreement. Both sides agree the proposed Settlement is a compromise of disputed claims. By agreeing to settle, Defendant does not admit any violations or concede the merit of any claims.

Plaintiff and Class Counsel strongly believe the Settlement is a good deal for you because they believe that: (1) Defendant has agreed to pay a fair, reasonable and adequate amount considering the strength of the claims and the risks and uncertainties of continued litigation; and (2) Settlement is in the best interests of the Class Members and Aggrieved Employees. The Court preliminarily approved the proposed Settlement as fair, reasonable and adequate, authorized this Notice, and scheduled a hearing to determine Final Approval.

3. WHAT ARE THE IMPORTANT TERMS OF THE PROPOSED SETTLEMENT?

A. Defendant will Pay \$200,000.00 as the Gross Settlement Amount (GSA). Defendant has agreed to deposit the GSA into an account controlled by the Administrator of the Settlement. Following Court approval, the Administrator will use the GSA to pay the Individual Settlement Payments, Individual PAGA Payments, the Class Representative Service Payment, Class Counsel Fees Payment, Class Counsel Litigation Expenses Payment, the Administration Expenses Payment, and penalties to be paid to the California Labor and Workforce Development Agency (“LWDA”). Assuming the Court grants Final Approval, Defendant will fund the GSA not more than 5 days after the Judgment entered by the Court becomes final (the “Effective Date”). The Judgment will be final the day that the Court enters Judgment, or a later date if Participating Class Members object to the proposed Settlement or the Judgment is appealed.

B. Court Approved Deductions from GSA. At the Final Approval Hearing, Plaintiff and/or Class Counsel will ask the Court to approve the following deductions from the GSA, the amounts of which will be decided by the Court at the Final Approval Hearing:

- i. Up to \$66,666.67 (33 and 1/3% of the GSA) to Class Counsel for attorneys’ fees and up to \$18,000.00 for their litigation expenses. To date, Class Counsel has worked and incurred expenses on the Action without payment.
- ii. Up to \$10,000.00 total to the Class Representative for the Class Representative Service Payment for filing the Action, working with Class Counsel and representing the Class.
- iii. Up to \$7,235.00 to the Administrator for services administering the Settlement.

- iv. \$20,000.00 for PAGA Penalties, allocated 75% (\$15,000.00) to the LWDA and 25% (\$5,000.00) to Individual PAGA Payments to the Aggrieved Employees based on their PAGA Pay Periods.

Participating Class Members have the right to object to any of these deductions. The Court will consider all objections.

C. Net Settlement Distributed to Class Members. After making the above deductions in amounts approved by the Court, the Administrator will distribute the rest of the GSA (the “Net Settlement”) by making Individual Settlement Payments to Participating Class Members based on their Workweeks worked.

D. Taxes Owed on Payments to Class Members. Plaintiff and Defendant are asking the Court to approve an allocation of 20% of each Individual Class Payment to taxable wages (“Wage Portion”) and 80% to interest and penalties (“Non-Wage Portion”). The Wage Portion is subject to withholdings and will be reported on IRS W-2 Forms. Defendant will separately pay employer payroll taxes it owes on the Wage portion. The Individual PAGA Payments are counted as penalties rather than wages for tax purposes. The Administrator will report any Individual PAGA Payments and the Non-Wage Portions of the Individual Class Settlement Payments on IRS 1099 Forms.

Although Plaintiff and Defendant have agreed to these allocations, neither side is giving you any advice on whether your Payments are taxable or how much you might owe in taxes. You are responsible for paying all taxes (including penalties and interest on back taxes) on any Payments received from the proposed Settlement. You should consult a tax advisor if you have any questions about the tax consequences of the proposed Settlement.

E. Need to Promptly Cash Payment Checks. The front of every check issued for Individual Class Settlement Payments and Individual PAGA Settlement Payments will show the date when the check expires (the void date). If you don’t cash it by the void date, your check will be automatically cancelled, and the monies will be sent to the California Controller’s Unclaimed Property Fund in the name of the Class Member failing to cash the check.

F. Requests for Exclusion from the Class Settlement (Request for Exclusion). You will be treated as a Participating Class Member, participating fully in the Class Settlement, unless you notify the Administrator in writing, not later than [REDACTED], that you wish to opt-out. The easiest way to notify the Administrator is to send a written and signed Request for Exclusion by the [REDACTED] Response Deadline. The Request for Exclusion should be a letter from a Class Member or his or her authorized representative setting forth a Class Member’s name, address and email address or telephone number, and a simple statement electing to be excluded from the Settlement. Excluded Class Members (i.e., Non-Participating Class Members) will not receive Individual Class Payments but will preserve their rights to personally pursue wage and hour claims against Defendant.

You cannot opt-out of the PAGA portion of the Settlement. Class Members who exclude themselves from the Class (Non-Participating Class Members) remain eligible for an Individual PAGA Payment and are required to give up their right to assert PAGA Claims against Defendant based on the alleged PAGA violations in the Action.

G. The Proposed Settlement Will be Void if the Court Denies Final Approval. It is possible the Court will decline to grant Final Approval of the Settlement or decline to enter a Judgment. It is also possible the Court will enter a Judgment that is reversed on appeal. Plaintiff and Defendant have agreed that, in either case, the Settlement will be void: Defendant will not pay any money and Class Members will not release any claims against Defendant.

H. Administrator. The Court has appointed a neutral company, Phoenix Class Action Administration Solutions (the “Administrator”) to send this Notice, calculate and make payments, and process Class Members’ Request for Exclusion. The Administrator will also evaluate Class Member challenges over Workweeks and/or Pay Periods, mail and re-mail settlement checks and tax forms, and perform other tasks to administer the Settlement. The Administrator’s contact information is in Section 9 below.

I. Participating Class Members’ Release. Effective on the date when Defendant fully funds the entire Gross Settlement Amount and funds all employer payroll taxes owed on the Wage Portion of the Individual Class Payments, Participating Class Members will be legally barred from asserting any of the claims released under the Settlement. This means that unless you opted out by validly excluding yourself from the Class Settlement, you cannot sue, continue

to sue, or be part of another lawsuit against Defendant or related entities for wages based on the Class Period facts and PAGA penalties based on PAGA Period facts, as alleged in the Action and resolved by this Settlement. The Participating Class Members will be bound by the following release:

All Participating Class Members, on behalf of themselves and their respective former and present representatives, agents, attorneys, heirs, administrators, successors, and assigns, release Released Parties from (i) all claims that were alleged, or reasonably could have been alleged, based on the facts contained in the Operative Complaint and the PAGA Notice and all PAGA claims that were, or reasonably could have been alleged based on facts ascertained during the Action including, e.g., all claims for (1) Failure to Pay Minimum Wages; (2) Failure to Pay Overtime Compensation; (3) Failure to Provide Meal Periods; (4) Failure to Authorize and Permit Rest Breaks; (5) Failure to Indemnify Necessary Business Expenses; (6) Failure to Timely Pay Final Wages at Termination; (7) Failure to Provide Accurate Itemized Wage Statements; and (8) Unfair Business Practices (Bus. & Prof. Code § 17200, et seq.). Except as set forth in Section 5.3 of [the] Agreement, Participating Class Members do not release any other claims, including claims for vested benefits, wrongful termination, violation of the Fair Employment and Housing Act, unemployment insurance, disability, social security, workers' compensation, or claims based on facts occurring outside the Class Period.

J. **Aggrieved Employees' PAGA Release.** Effective on the date when Defendant fully funds the entire Gross Settlement Amount and funds all employer payroll taxes owed on the Wage Portion of the Individual Class Payments, all Aggrieved Employees will be barred from asserting PAGA Claims against the Released Parties, including Defendant. Because this Court-approved Settlement of PAGA claims will bind the State of California, other individuals cannot later sue, continue to sue, or participate in any other PAGA claim against Defendant or its related entities based on the PAGA claims alleged in the Action and resolved by this Settlement.

The Aggrieved Employees' Releases for Participating and Non-Participating Class Members are as follows:

The LWDA and all Class Members who are Aggrieved Employees are deemed to release, on behalf of themselves and their respective former and present representatives, agents, attorneys, heirs, administrators, successors, and assigns, the Released Parties from all claims for PAGA penalties that were alleged, or reasonably could have been alleged, based on the facts contained in the Operative Complaint and the PAGA Notice and all PAGA claims that were, or reasonably could have been alleged based on facts ascertained during the Action.

K. **Need to Provide SSN to Administrator.** If this Notice, on Page 1, advises you that your SSN is currently unknown, and if you performed any work for Defendant, you **must** provide the Administrator with your SSN before your Settlement payment can be fully distributed to you. Please use the enclosed IRS w-9 Form for that purpose and see the contact information for the Administrator listed on Page 6, below. Unless you provide your SSN, any payment for penalties and interest in excess of \$599 will not be distributed to you, and **no** money allocated under the Settlement as wages will be distributed to you. If you were never assigned to work for Defendant, please contact the Administrator to report the erroneous receipt of this Notice.

4. HOW WILL THE ADMINISTRATOR CALCULATE MY PAYMENT?

A. **Individual Class Payments.** The Administrator will calculate Individual Class Payments by (a) dividing the Net Settlement Amount by the total number of Workweeks worked by all Participating Class Members, and (b) multiplying the result by the number of Workweeks worked by each individual Participating Class Member.

B. **Individual PAGA Payments.** The Administrator will calculate Individual PAGA Payments by (a) dividing \$5,000.00 by the total number of PAGA Pay Periods worked by all Aggrieved Employees and (b) multiplying the result by the number of PAGA Pay Periods worked by each individual Aggrieved Employee.

C. **Workweek/Pay Period Challenges.** The number of Class Workweeks you worked during the Class Period and the number of PAGA Pay Periods you worked during the PAGA Period, as recorded in Defendant's records, are stated in the first page of this Notice. You have until [REDACTED] to challenge the number of Workweeks and/or Pay Periods credited to you. You can submit your challenge by signing and sending a letter to the Administrator via mail, email or fax. Section 9 of this Notice has the Administrator's contact information.

You need to support your challenge by sending copies of pay stubs or other records. The Administrator will accept Defendant's calculation of Workweeks and/or Pay Periods based on Defendant's records as accurate unless you send copies of records containing contrary information. You should send copies rather than originals because the documents will not be returned to you. The Administrator will resolve Workweek and/or Pay Period challenges based on your submission and on input from Class Counsel (who will advocate on behalf of Class Members) and Defendant's Counsel. If you submit a challenge that is rejected by the Administrator, you may present the same evidence supporting the Workweek and/or Pay Period challenge to the Court for review.

5. HOW WILL I GET PAID?

A. Participating Class Members. The Administrator will send, by U.S. mail, a single check to every Participating Class Member (i.e., Class Members who don't opt-out) and all Class Members who also qualify as Aggrieved Employees. The single check will combine the Individual Class Settlement Payment and the Individual PAGA Payment.

B. Non-Participating Class Members. The Administrator will send, by U.S. mail, a single individual share of the PAGA Payment check to every Aggrieved Employee who opts out of the Class Settlement (i.e., every Non-Participating Class Member who is eligible as an Aggrieved Employee).

Your check will be sent to the same address as this Notice. If you change your address, be sure to notify the Administrator as soon as possible. Section 9 of this Notice has the Administrator's contact information. **The Administrator must have your SSN, or you will not receive your full Individual Class Settlement Payment, and you will not receive any penalty or interest payment that exceeds \$599.**

6. HOW DO I OPT-OUT OF THE CLASS SETTLEMENT?

If you want to opt out, you, or your authorized representative, should submit a Request for Exclusion with your name, address and email address or telephone number, and a simple statement that you do not want to participate in the Settlement. The Administrator will exclude you based on any written statement asking that you be excluded. Be sure to identify the Action in a way that is clear. You must make the Request for Exclusion yourself or through an authorized representative. The Administrator must be sent your Request for Exclusion by [REDACTED], or it will be invalid. Section 9 of the Notice has the Administrator's contact information.

7. HOW DO I OBJECT TO THE SETTLEMENT?

Only Participating Class Members have the right to object to the Settlement. Before deciding whether to object, you may wish to see what Plaintiff and Defendant are asking the Court to approve. At least 16 court days before the [REDACTED] Final Approval Hearing, Class Counsel and/or Plaintiff will file in Court a Motion for Final Approval that includes, among other things, the reasons why the proposed Settlement is fair, and a request for awards of fees, litigation expenses and a service payment to Plaintiff stating (i) the amount Class Counsel is requesting for the Class Counsel Fees Payment and the Class Counsel Litigation Expenses Payment; and (ii) the amount Plaintiff is requesting as a Class Representative Service Payment. Upon reasonable request, Class Counsel (whose contact information is in Section 9 of this Notice) will send you copies of these documents at no cost to you.

A Participating Class Member who disagrees with any aspect of the Agreement, the Motion for Final Approval and for awards of fees, litigation expenses and a service payment to Plaintiff may wish to object, for example, that the proposed Settlement is unfair, or that the amounts requested by Class Counsel or Plaintiff are too high or too low. The deadline for sending written objections to the Administrator is [REDACTED]. Be sure to tell the Administrator what you object to, why you object, and any facts that support your objection. Make sure you identify the Action and include your name, address and email address or telephone number and sign the objection. Section 9 of this Notice has the Administrator's contact information.

Alternatively, a Participating Class Member can object (or personally hire a lawyer to object at your own cost) by attending the Final Approval Hearing. You (or your attorney) should be ready to tell the Court what you object to, why you object, and any facts that support your objection. See Section 8 of this Notice (below) for specifics regarding the Final Approval Hearing.

8. CAN I ATTEND THE FINAL APPROVAL HEARING?

You can, but don't have to, attend the Final Approval hearing on [redacted] at [redacted] in Department 11 of the Los Angeles Superior Court, located at 312 North Spring Street, Los Angeles, CA 90012. At the Hearing, the judge will decide whether to grant Final Approval of the Settlement and how much of the GSA will be paid to Class Counsel, Plaintiff, and the Administrator. The Court will invite comment from objectors, Class Counsel, and Defense Counsel before making a decision. You can attend (or hire a lawyer to attend).

It's possible the Court will reschedule the Final Approval Hearing. You should contact Class Counsel to verify the date and time of the Final Approval Hearing if you are planning to attend the hearing or have your own lawyer attend.

9. HOW CAN I GET MORE INFORMATION?

The Agreement sets forth everything Defendant and Plaintiff have promised to do under the proposed Settlement. The easiest way to read the Agreement, the Judgment or any other Settlement documents is to go to the Administrator's website at [redacted]. You can also telephone or send an email to Class Counsel or the Administrator using the contact information listed below, or consult the Los Angeles Superior Court website.

DO NOT TELEPHONE THE SUPERIOR COURT TO OBTAIN INFORMATION ABOUT THE SETTLEMENT.

10. WHAT IF I LOSE MY SETTLEMENT CHECK?

If you lose or misplace your settlement check before cashing it, the Administrator will replace it as long as you request a replacement before the void date on the face of the original check.

11. WHAT IF I CHANGE MY ADDRESS?

To receive your check, you should immediately notify the Administrator if you move or change your mailing address.

12. WHAT IS A PAGA PENALTY?

The Net Settlement is money paid to settle claims for Participating Class Members. But the PAGA claim is different. PAGA penalties were originally penalties that only the State of California could collect through an enforcement action brought by the State against an employer. In 2004, the State enacted PAGA, a law that allows employees to try to recover those penalties for the State. Under the version of PAGA in effect for this Settlement, the State agrees to share 25% of its penalties with the affected employees (here, the Aggrieved Employees). The PAGA settlement proposed as part of this Settlement is a settlement of the State's PAGA claim.
