20 Following the Award of Arbitration on October 14, 2015, by Arbitrator, Fred Butler of
21 ADR Services, Inc., a Final Judgment being determined and rendered therefrom as follows:

22 JUDGMENT is hereby entered pursuant to the terms of the Award of Arbitration as
23 follows:

24 A. Angelica Mia Tumandao's complaint that San Francisco Health Care and Rehab, Inc.
25 violated the Labor Code by not paying her overtime premiums and failed to provide her
26 with wage statements are denied.

27 B. Angelica Mia Tumandao's complaint that she was terminated in violation of California
28 Law or in violation of San Francisco Health Care and Rehab, Inc.'s progressive discipline
policy is without merit and is denied.

C. Angelica Mia Tumandao is not an aggrieved employee as defined by the Cal. PAGA
Statute.
