## JOINT STIPULATION OF CLASS ACTION AND PAGA SETTLEMENT AND RELEASE

This Joint Stipulation of Class Action and PAGA Settlement and Release (“Settlement” or “Settlement Agreement”) is made and entered into by and between Plaintiffs Rickey Lartigue and Nina Minick (“Plaintiffs” or “Class Representatives”), as individuals and on behalf of all others similarly situated, and Defendants Quik Stop Markets, Inc., EG Retail (America), LLC, and EG America, LLC (“Defendants”) (collectively with Plaintiffs, the “Parties”).

### DEFINITIONS

The following definitions are applicable to this Settlement Agreement. Definitions contained elsewhere in this Settlement Agreement will also be effective:

1. “Action” means *Lartigue v. Quik Stop Markets, Inc.*, No. 23CV422376 (Santa Clara County Superior Court).
2. “Attorneys’ Fees and Costs” means attorneys’ fees agreed upon by the Parties and approved by the Court for Class Counsel’s litigation and resolution of the Action, and all out-of-pocket costs incurred and to be incurred by Class Counsel in the Action, including but not limited to expert/consultant fees, investigation costs, and costs associated with documenting the Settlement, providing any notices required as part of the Settlement or Court order, securing the Court’s approval of the Settlement, administering the Settlement, and obtaining entry of a Judgment terminating the Action. Class Counsel will request attorneys’ fees not in excess of one-third (1/3) of the Gross Settlement Amount, or Five Hundred Thousand Dollars (\$500,000). The Attorneys’ Fees and Costs will also mean and include the additional reimbursement of any costs and expenses associated with Class Counsel’s litigation and settlement of the Action, up to Fifteen Thousand Dollars (\$15,000), subject to the Court’s approval. Defendants have agreed not to oppose Class Counsel’s request for fees and reimbursement of costs as set forth above.
3. “Class Counsel” means Capstone Law APC.
4. “Class List” means a complete list of all Class Members that Defendants will diligently and in good faith compile from their records and provide to the Settlement Administrator and Class Counsel within twenty (20) calendar days after Preliminary Approval of this Settlement. The Class List will be formatted in Microsoft Office Excel and will include each Class Member’s full name; most

recent mailing address and telephone number; Social Security number; dates of employment; the respective number of Workweeks that each Class Member worked during the Class Period and PAGA Period; and any other relevant information needed to calculate settlement payments.

5. “Class Member(s)” or “Settlement Class” means all persons who worked for Defendants as non-exempt, hourly paid employees in the State of California at any time during the Class Period.

6. “Class Notice” means the Notice of Class Action Settlement, substantially in the form attached as Exhibit A.

7. “Class Period” means the period from August 18, 2021 through December 31, 2024.

8. “Class Representative Enhancement Payments” means the amounts to be paid to Plaintiffs in recognition of their effort and work in prosecuting the Action on behalf of Class Members, and for their general release of claims. Subject to the Court granting final approval of this Settlement Agreement and subject to the exhaustion of any and all appeals, Plaintiffs will request Court approval of Class Representative Enhancement Payments of up to Ten Thousand Dollars (\$10,000), each.

9. “Court” means the Santa Clara County Superior Court.

10. “Defendants” means Defendants Quik Stop Markets, Inc., EG Retail (America), LLC, and EG America, LLC.

11. “Effective Date” means the later of: (a) if no timely objections are filed, or are withdrawn prior to Final Approval, then the date of Final Approval; or (b) if a Class Member files an objection to the Settlement, the Effective Date shall be the sixty-first (61st) calendar day after the date of Final Approval, provided no appeal is initiated by an objector; or (c) if a timely appeal is initiated by an objector, then the Effective Date will be the date of final resolution of that appeal (including any requests for rehearing and/or petitions for certiorari), resulting in final judicial approval of the Settlement.

12. “Final Approval” means the date on which the Court enters an order granting final approval of the Settlement Agreement.

13. “Gross Settlement Amount” means the Gross Settlement Amount of One Million Five Hundred Thousand Dollars (\$1,500,000), to be paid by Defendants in full satisfaction of all Released Class Claims and Released PAGA Claims, which includes all Individual Settlement Payments, Attorneys’ Fees and Costs, the Class Representative Enhancement Payments, the PAGA Settlement

1 Amount, and Settlement Administration Costs. This Gross Settlement Amount has been agreed to by  
2 Plaintiffs and Defendants based on the aggregation of the agreed-upon settlement value of individual  
3 claims. In no event will Defendants be liable for more than the Gross Settlement Amount except as  
4 otherwise explicitly set forth herein. There will be no reversion of the Gross Settlement Amount to  
5 Defendants. Defendants will be separately responsible for any employer payroll taxes required by law,  
6 including the employer FICA, FUTA, and SDI contributions, which shall not be paid from the Gross  
7 Settlement Amount.

8 14. "Individual Settlement Payment" means each Participating Class Member's and PAGA  
9 Member's respective shares of the Net Settlement Fund and PAGA Fund.

10 15. "Net Settlement Fund" means the portion of the Gross Settlement Amount remaining  
11 after deducting the Attorneys' Fees and Costs, the Class Representative Enhancement Payments, the  
12 PAGA Settlement Amount, and Settlement Administration Costs. The Net Settlement Fund will be  
13 distributed to Participating Class Members. There will be no reversion of the Net Settlement Fund to  
14 Defendants.

15 16. "Notice of Objection" means a Class Member's valid and timely written objection to the  
16 Settlement Agreement. For the Notice of Objection to be valid, it must include: (a) the objector's full  
17 name, signature, address, and telephone number, (b) a written statement of all grounds for the objection  
18 accompanied by any legal support for such objection; (c) copies of any papers, briefs, or other  
19 documents upon which the objection is based; and (d) a statement whether the objector intends to appear  
20 at the final fairness hearing.

21 17. "PAGA Members" means all persons who worked for Defendants as non-exempt,  
22 hourly paid employees in the State of California at any time during the PAGA Period.

23 18. "PAGA Period" means the period from October 12, 2022 through December 31, 2024.

24 19. "PAGA Settlement Amount" means the amount that the Parties have agreed to pay to  
25 the Labor and Workforce Development Agency ("LWDA") and PAGA Members in connection with  
26 Plaintiffs' claim under the Labor Code Private Attorneys General Act of 2004 (Cal. Lab. Code §§ 2698,  
27 *et seq.*, "PAGA") ("PAGA Settlement"). The Parties have agreed that One Hundred Thousand Dollars  
28 (\$100,000) of the Gross Settlement Amount will be allocated to the PAGA Settlement. Pursuant to

PAGA, Seventy-Five Percent (75%), or Seventy-Five Thousand Dollars (\$75,000), of the PAGA Settlement Amount will be paid to the California Labor and Workforce Development Agency (“Labor and Workforce Development Agency Payment”), and Twenty-Five Percent (25%), or Twenty-Five Thousand Dollars (\$25,000) (“PAGA Fund”), of the PAGA Settlement will be disbursed to PAGA Members, and regardless whether they request to be excluded from the Settlement Class.

20. “Parties” means Plaintiffs and Defendants collectively.

21. “Participating Class Members” means all Class Members who do not submit timely and valid Requests for Exclusion.

22. “Plaintiffs” means Plaintiffs Rickey Lartigue and Nina Minick.

23. “Preliminary Approval” means the date on which the Court enters an order granting preliminary approval of the Settlement Agreement.

24. “Released Class Claims” means all claims that are alleged in the operative Complaint, or which could have been alleged by reason of or in connection with any matter or fact set forth or referred to in the operative Complaint, including claims for violation of: (1) Labor Code §§ 510 and 1198 (unpaid overtime); (2) Labor Code §§ 1182.12, 1194, 1197, 1197.1, and 1198 (unpaid minimum wages); (3) Labor Code §§ 226.7, 512(a), 516, and 1198 (failure to provide meal periods); (4) Labor Code §§ 226.7, 516, and 1198 (failure to authorize and permit rest periods); (5) Labor Code §§ 226(a), 1174(d), and 1198 (non-compliant wage statements and failure to maintain payroll records); (6) Labor Code §§ 201 and 202 (wages not timely paid upon termination); (7) Labor Code § 204 (failure to timely pay wages during employment); (8) Labor Code § 2802 (unreimbursed business expenses); (9) California Business & Professions Code Labor Code §§ 17200, *et seq.* (unlawful business practices); and (10) California Business & Professions Code Labor Code §§ 17200, *et seq.* (unfair business practices).

25. “Released PAGA Claims” means all claims for civil penalties under California Labor Code §§ 2698, *et seq.*, that were brought or could reasonably have been brought based on the same facts alleged in Plaintiffs’ LWDA letters during the PAGA Period.

26. “Released Parties” means Defendants, Quik Stop Markets, Inc., EG Retail (America), LLC, and EG America, LLC and Defendants’ past or present officers, directors, shareholders, agents, principals, heirs, representatives, accountants, auditors, consultants, insurers and reinsurers, and its

respective successors and predecessors in interest, subsidiaries, affiliates, parents and attorneys, if any.

27. “Request for Exclusion” means a timely letter submitted by a Class Member indicating a request to be excluded from the Settlement Class. The Request for Exclusion must: (a) set forth the name, address, telephone number and last four digits of the Social Security Number of the Class Member requesting exclusion; (b) be signed by the Class Member; (c) be returned to the Settlement Administrator; (d) clearly state that the Class Member does not wish to be included in the Settlement; and (e) be faxed or postmarked on or before the Response Deadline.

28. “Response Deadline” means the deadline by which Class Members must postmark or fax to the Settlement Administrator Requests for Exclusion, postmark or fax disputes concerning the calculation of Individual Settlement Payments, or postmark Notices of Objection to the Settlement Administrator. The Response Deadline will be forty-five (45) calendar days from the initial mailing of the Class Notice by the Settlement Administrator, unless the forty-fifth (45th) calendar day falls on a Sunday or State holiday, in which case the Response Deadline will be extended to the next day on which the U.S. Postal Service is open.

29. “Settlement Administration Costs” means the costs payable from the Gross Settlement Amount to the Settlement Administrator for administering this Settlement, including, but not limited to, printing, distributing, and tracking documents for this Settlement, tax reporting, distributing the Gross Settlement Amount, and providing necessary reports and declarations, as requested by the Parties. The Settlement Administration Costs will be paid from the Gross Settlement Amount, including, if necessary, any such costs in excess of the amount represented by the Settlement Administrator as being the maximum costs necessary to administer the Settlement. Settlement Administration Costs are currently estimated to be Fifteen Thousand Dollars (\$15,000).

30. “Settlement Administrator” means CPT Group, Inc., or any other third-party class action settlement administrator agreed to by the Parties and approved by the Court for the purposes of administering this Settlement. The Parties each represent that they do not have any financial interest in the Settlement Administrator or otherwise have a relationship with the Settlement Administrator that could create a conflict of interest.

31. “Workweeks” means the number of days of employment for each Class Member during

1 the Class Period, subtracting days on leave of absence (if any), dividing by seven (7), and rounding up to  
2 the nearest whole number. All Class Members will be credited with at least one Workweek during the  
3 Class Period, and all PAGA Members will be credited with at least one Workweek during the PAGA  
4 Period.

### 5 **TERMS OF AGREEMENT**

6 The Plaintiffs, on behalf of themselves and the Settlement Class, and Defendants agree as  
7 follows:

8 32. Funding of the Gross Settlement Amount. Defendants will make a one-time deposit of  
9 the Gross Settlement Amount of One Million Five Hundred Thousand Dollars (\$1,500,000) into a  
10 Qualified Settlement Account to be established by the Settlement Administrator. Defendants will pay the  
11 employer's share of payroll taxes separately. After the Effective Date, the Gross Settlement Amount will  
12 be used for: (a) Individual Settlement Payments; (b) the Labor and Workforce Development Agency  
13 Payment; (c) the Class Representative Enhancement Payments; (d) Attorneys' Fees and Costs; and (e)  
14 Settlement Administration Costs. Defendants will deposit the Gross Settlement Amount and the  
15 employer's share of payroll taxes within thirty (30) calendar days of the Effective Date ("Funding  
16 Date").

17 33. Attorneys' Fees and Costs. Defendants agree not to oppose or impede any application or  
18 motion for attorneys' fees and costs by Class Counsel for Attorneys' Fees and Costs of not more than  
19 Five Hundred Thousand Dollars (\$500,000), plus the reimbursement of all out-of-pocket costs and  
20 expenses associated with Class Counsel's litigation and settlement of the Action (including  
21 expert/consultant fees, investigations costs, etc.), not to exceed Fifteen Thousand Dollars (\$15,000), both  
22 of which will be paid from the Gross Settlement Amount.

23 34. Class Representative Enhancement Payments. In exchange for a general release, and in  
24 recognition of their effort and work in prosecuting the Action on behalf of Class Members, Defendants  
25 agree not to oppose or impede any application or motion for Class Representative Enhancement  
26 Payments of up to Ten Thousand Dollars (\$10,000) to each Plaintiff. The Class Representative  
27 Enhancement Payments will be paid from the Gross Settlement Amount and will be in addition to  
28 Plaintiffs' Individual Settlement Payment paid pursuant to the Settlement. Plaintiffs will be solely and

legally responsible to pay any and all applicable taxes on the Class Representative Enhancement Payments. Plaintiffs understand and agree that this Settlement Agreement shall remain in full force and effect even if the full amount of Class Representative Enhancement Payments sought by Plaintiffs is not ultimately awarded by the Court.

35. Settlement Administration Costs. The Settlement Administrator will be paid for the reasonable costs of administration of the Settlement and distribution of payments from the Gross Settlement Amount, which is currently estimated to be Fifteen Thousand Dollars (\$15,000). These costs, which will be paid from the Gross Settlement Amount, will include, *inter alia*, the required tax reporting on the Individual Settlement Payments, the issuing of 1099 and W-2 IRS Forms, distributing Class Notices, calculating and distributing the Gross Settlement Amount, and providing necessary reports and declarations.

36. PAGA Settlement Amount. Subject to Court approval, the Parties agree that the amount of One Hundred Thousand Dollars (\$100,000) from the Gross Settlement Amount will be designated for satisfaction of Plaintiffs' PAGA claim. Pursuant to PAGA, Seventy-Five Percent (75%), or Seventy-Five Thousand Dollars (\$75,000), of this sum will be paid to the LWDA and Twenty-Five Percent (25%), or Twenty-Five Thousand Dollars (\$25,000), will be paid to PAGA Members in proportion to the number of Workweeks worked during the PAGA Period.

37. No Right to Exclusion or Objections to the PAGA Settlement. Because this settlement resolves claims and actions brought pursuant to PAGA by Plaintiffs acting as proxies and as Private Attorneys General of, and for, the State of California and the LWDA, the Parties agree that no PAGA Member has the right to exclude himself or herself from the release of the Released PAGA Claims, and all PAGA Members will receive their shares of the PAGA Fund. The Parties also agree that no PAGA Member has the right to object to the PAGA Settlement Amount.

38. Net Settlement Fund. The entire Net Settlement Fund will be distributed to Participating Class Members. No portion of the Net Settlement Fund will revert to or be retained by Defendants.

39. PAGA Fund. The entire PAGA Fund will be distributed to all PAGA Members. No portion of the PAGA Fund will revert to or be retained by Defendants.

40. Individual Settlement Payment Calculations. Individual Settlement Payments will be

1 calculated and apportioned from the Net Settlement Fund and PAGA Fund based on the number of  
2 Workweeks a Class Member worked during the Class Period and PAGA Period. Specific calculations of  
3 Individual Settlement Payments will be made as follows:

4           40(a)     Payments from the Net Settlement Fund. Defendants will calculate the total  
5                             number of Workweeks worked by each Class Member during the Class  
6                             Period and the aggregate total number of Workweeks worked by all Class  
7                             Members during the Class Period. To determine each Class Member's  
8                             estimated "Individual Settlement Payment" from the Net Settlement Fund,  
9                             the Settlement Administrator will use the following formula: The Net  
10                            Settlement Fund will be divided by the aggregate total number of  
11                            Workweeks during the Class Period, resulting in the "Workweek Value."  
12                            Each Class Member's "Individual Settlement Payment" will be calculated  
13                            by multiplying each individual Class Member's total number of Workweeks  
14                            by the Workweek Value. The Individual Settlement Payment will be  
15                            reduced by any required deductions for each Participating Class Member as  
16                            specifically set forth herein, including employee-side tax withholdings or  
17                            deductions. The entire Net Settlement Fund will be disbursed to all Class  
18                            Members who do not submit timely and valid Requests for Exclusion. If  
19                            there are any valid and timely Requests for Exclusion, the Settlement  
20                            Administrator shall proportionately increase the Individual Settlement  
21                            Payment for each Participating Class Member according to the number of  
22                            Workweeks worked, so that the amount actually distributed to the  
23                            Settlement Class equals 100% of the Net Settlement Fund.

24           40(b)     Payments from the PAGA Fund. Defendants will calculate the total number  
25                            of Workweeks worked by each PAGA Member during the PAGA Period  
26                            and the aggregate total number of Workweeks worked by all PAGA  
27                            Members during the PAGA Period. To determine each PAGA Member's  
28                            estimated "Individual Settlement Payment," the Settlement Administrator

will use the following formula: The PAGA Fund will be divided by the aggregate total number of Workweeks during the PAGA Period, resulting in the “PAGA Workweek Value.” Each PAGA Member’s “Individual Settlement Payment” will be calculated by multiplying each individual PAGA Member’s total number of Workweeks by the PAGA Workweek Value. The entire PAGA Fund will be disbursed to all PAGA Members.

41. No Credit Toward Benefit Plans. The Individual Settlement Payments made to Participating Class Members under this Settlement, as well as any other payments made pursuant to this Settlement, will not be utilized to calculate any additional benefits under any benefit plans to which any Class Members may be eligible, including, but not limited to profit-sharing plans, bonus plans, 401(k) plans, stock purchase plans, vacation plans, sick leave plans, PTO plans, and any other benefit plan. Rather, it is the Parties’ intention that this Settlement Agreement will not affect any rights, contributions, or amounts to which any Class Members may be entitled under any benefit plans.

42. Administration Process. The Parties agree to cooperate in the administration of the settlement and to make all reasonable efforts to control and minimize the costs and expenses incurred in administration of the Settlement.

43. Delivery of the Class List. Within twenty (20) calendar days of Preliminary Approval, Defendants will provide the Class List to the Settlement Administrator and to Class Counsel.

44. Notice by First-Class U.S. Mail. Within ten (10) calendar days after receiving the Class List from Defendants, the Settlement Administrator will mail a Class Notice to all Class Members via regular First-Class U.S. Mail, using the most current, known mailing addresses identified in the Class List.

45. Confirmation of Updated Contact Information in the Class Lists. Prior to mailing, the Settlement Administrator will perform a search based on the National Change of Address Database for information to update and correct for any known or identifiable address changes. Any Class Notices returned to the Settlement Administrator as non-deliverable on or before the Response Deadline will, within five (5) business days of receipt, be sent promptly via regular First-Class U.S. Mail to the forwarding address affixed thereto and the Settlement Administrator will indicate the date of such re-

1 mailing on the Class Notice. If no forwarding address is provided, the Settlement Administrator will  
2 promptly attempt to determine the correct address using a skip-trace, or other search using the name,  
3 address and/or Social Security Number of the Class Member involved, and will then perform a single re-  
4 mailing. Those Class Members who receive a re-mailed Class Notice, whether by skip-trace or by  
5 request, will have either (a) an additional fifteen (15) calendar days or (b) until the Response Deadline,  
6 whichever is later, to submit a Request for Exclusion or an objection to the Settlement.

7 46. Class Notices. All Class Members will be mailed a Class Notice. Each Class Notice will  
8 provide: (a) information regarding the nature of the Action; (b) a summary of the Settlement's principal  
9 terms; (c) the Settlement Class and PAGA Member definitions; (d) the total number of Workweeks each  
10 respective Class Member and PAGA Member worked for Defendants during the Class Period and  
11 PAGA Period; (e) each Class Member's and PAGA Member's estimated Individual Settlement Payment  
12 and the formula for calculating Individual Settlement Payments; (f) the dates which comprise the Class  
13 Period and PAGA Period; (g) instructions on how to submit Requests for Exclusion or Notices of  
14 Objection; (h) the deadlines by which the Class Member must postmark or fax Request for Exclusions,  
15 or postmark Notices of Objection to the Settlement; and (i) the claims to be released.

16 47. Disputed Information on Class Notices. Class Members will have an opportunity to  
17 dispute the information provided in their Class Notices. To the extent Class Members dispute their  
18 employment dates or the number of Workweeks on record, Class Members may produce evidence to the  
19 Settlement Administrator showing that such information is inaccurate. Defendants' records will be  
20 presumed correct, but the Settlement Administrator shall contact the Parties regarding the dispute and the  
21 Parties will work in good faith to resolve it. All disputes must be submitted by the Response Deadline,  
22 and will be decided within ten (10) business days after the Response Deadline.

23 48. Defective Submissions. If a Class Member's Request for Exclusion is defective as to the  
24 requirements listed herein, that Class Member will be given an opportunity to cure the defect(s). The  
25 Settlement Administrator will mail the Class Member a cure letter within three (3) business days of  
26 receiving the defective submission to advise the Class Member that his/her/their submission is defective  
27 and that the defect must be cured to render the Request for Exclusion valid. The Class Member will have  
28 until (a) the Response Deadline or (b) fifteen (15) calendar days from the date of the cure letter,

1 whichever date is later, to postmark or fax a revised Request for Exclusion. If the revised Request for  
2 Exclusion is not postmarked or received by fax within that period, it will be deemed untimely.

3 49. Request for Exclusion Procedures. Any Class Member wishing to opt-out from the  
4 Settlement Agreement must sign and fax or postmark a written Request for Exclusion to the Settlement  
5 Administrator within the Response Deadline. In the case of Requests for Exclusion that are mailed to the  
6 Settlement Administrator, the postmark date will be the exclusive means to determine whether a Request  
7 for Exclusion has been timely submitted.

8 50. Escalator Clause. The Gross Settlement Amount was calculated with, and is premised  
9 on, the understanding that Class Members worked 30,517 Workweeks during the Class Period. If the  
10 actual number of Workweeks during the Class Period is greater than 37,375, then Defendants must  
11 either: (a) proportionally increase the Gross Settlement Amount by the proportion above 37,375; or (b)  
12 advance the end date of the Class Period and PAGA Period to a period of time where the Workweek  
13 count during the Class Period did not exceed 37,375.

14 51. Settlement Terms Bind All Class Members Who Do Not Opt-Out. Any Class Member  
15 who does not affirmatively opt-out of the Settlement Agreement by submitting a timely and valid  
16 Request for Exclusion will be bound by all of its terms, including those pertaining to the Released Class  
17 Claims, as well as any Judgment that may be entered by the Court if it grants final approval to the  
18 Settlement.

19 52. Releases by Participating Class Members. Upon the Funding Date, and except as to such  
20 rights or claims as may be created by this Settlement Agreement, each Participating Class Member,  
21 together and individually, on their behalf and on behalf of their respective heirs, executors,  
22 administrators, agents, and attorneys, shall fully and forever release and discharge all of the Released  
23 Parties, or any of them, from each of the Released Class Claims arising during the Class Period.

24 53. Releases by PAGA Members. Upon the Funding Date, and except as to such rights or  
25 claims as may be created by this Settlement Agreement, each PAGA Member, together and individually,  
26 on their behalf and on behalf of their respective heirs, executors, administrators, agents, and attorneys,  
27 shall fully and forever release and discharge all of the Released Parties, or any of them, from each of the  
28 Released PAGA Claims during the PAGA Period.

1           54.     Objection Procedures. To object to the Settlement Agreement, a Class Member may  
2 either postmark a valid Notice of Objection to the Settlement Administrator on or before the Response  
3 Deadline, or appear in person at the Final Approval Hearing. Class Members who fail to object either by  
4 submitting a valid Notice of Objection or appearing in person at the Final Approval Hearing will be  
5 deemed to have waived all objections to the Settlement and will be foreclosed from making any  
6 objections, whether by appeal or otherwise, to the Settlement Agreement. At no time will any of the  
7 Parties or their counsel seek to solicit or otherwise encourage Class Members to submit written  
8 objections to the Settlement Agreement or appeal from the final approval order and judgment. Class  
9 Counsel will not represent any Class Members with respect to any such objections to this Settlement. If a  
10 Class Member timely submits both a Notice of Objection and a Request for Exclusion, the Request for  
11 Exclusion will be given effect and considered valid, the Notice of Objection shall be rejected, and the  
12 Class Member shall not participate in or be bound by the Settlement.

13           55.     Certification Reports Regarding Individual Settlement Payment Calculations. The  
14 Settlement Administrator will provide Defendants' counsel and Class Counsel a weekly report that  
15 certifies the number of Class Members who have submitted valid Requests for Exclusion or objections to  
16 the Settlement, and whether any Class Member has submitted a challenge to any information contained  
17 in their Class Notice, including those received after the Response Deadline. Additionally, the Settlement  
18 Administrator will provide to counsel for both Parties any updated reports regarding the administration  
19 of the Settlement Agreement as needed or requested.

20           56.     Distribution Timing of Individual Settlement Payments. Within ten (10) calendar days  
21 of the Funding Date, the Settlement Administrator will issue payments to: (a) Participating Class  
22 Members and PAGA Members; (b) the Labor and Workforce Development Agency; (c) Plaintiffs; and  
23 (d) Class Counsel. The Settlement Administrator will also issue a payment to itself for Court-approved  
24 services performed in connection with the Settlement.

25           57.     Un-cashed Settlement Checks. Funds represented by Individual Settlement Payment  
26 checks returned as undeliverable and Individual Settlement Payment checks remaining un-cashed for  
27 more than one hundred and eighty (180) calendar days after issuance will be tendered to the State  
28 Controller's Office, Unclaimed Property Division in the name of each Class Member who did not

1 negotiate his or her check, thereby leaving no “unpaid residue” subject to the requirements of California  
2 Code of Civil Procedure Section 384, subd. (b).

3 58. Certification of Completion. Upon completion of administration of the Settlement, the  
4 Settlement Administrator will provide a written declaration under oath to certify such completion to the  
5 Court and counsel for all Parties.

6 59. Treatment of Individual Settlement Payments. All Individual Settlement Payments will  
7 be allocated as follows: (a) Ten Percent (10%) of each Individual Settlement Payment will be allocated  
8 as wages for which IRS Forms W-2 will be issued; and (b) Ninety Percent (90%) will be allocated as  
9 non-wages for which IRS Forms 1099-MISC will be issued. Payments issued to PAGA Members from  
10 the PAGA Fund will be treated as non-wages for which IRS Forms 1099-MISC will be issued.

11 60. Administration of Taxes by the Settlement Administrator. The Settlement Administrator  
12 will be responsible for issuing to Plaintiffs, Participating Class Members, PAGA Members, and Class  
13 Counsel any W-2, 1099, or other tax forms as may be required by law for all amounts paid pursuant to  
14 this Settlement. The Settlement Administrator will also be responsible for forwarding all payroll taxes  
15 and penalties to the appropriate government authorities.

16 61. Tax Liability. The Parties make no representation as to the tax treatment or legal effect  
17 of the payments called for hereunder, and Plaintiffs, Participating Class Members, and PAGA Members  
18 are not relying on any statement, representation, or calculation by Defendants or by the Settlement  
19 Administrator in this regard.

20 62. Circular 230 Disclaimer. EACH PARTY TO THIS AGREEMENT (FOR PURPOSES  
21 OF THIS SECTION, THE “ACKNOWLEDGING PARTY” AND EACH PARTY TO THIS  
22 AGREEMENT OTHER THAN THE ACKNOWLEDGING PARTY, AN “OTHER PARTY”)  
23 ACKNOWLEDGES AND AGREES THAT (1) NO PROVISION OF THIS AGREEMENT, AND  
24 NO WRITTEN COMMUNICATION OR DISCLOSURE BETWEEN OR AMONG THE PARTIES  
25 OR THEIR ATTORNEYS AND OTHER ADVISERS, IS OR WAS INTENDED TO BE, NOR  
26 WILL ANY SUCH COMMUNICATION OR DISCLOSURE CONSTITUTE OR BE CONSTRUED  
27 OR BE RELIED UPON AS, TAX ADVICE WITHIN THE MEANING OF UNITED STATES  
28 TREASURY DEPARTMENT CIRCULAR 230 (31 CFR PART 10, AS AMENDED); (2) THE

19 64. Nullification of Settlement Agreement. In the event that: (a) the Court does not finally  
20 approve the Settlement as provided herein; or (b) the Settlement does not become final for any other  
21 reason, then this Settlement Agreement, and any documents generated to bring it into effect, will be null  
22 and void. Any order or judgment entered by the Court in furtherance of this Settlement Agreement will  
23 likewise be treated as void from the beginning.

24 65. Preliminary Approval Hearing. Plaintiffs will obtain a hearing before the Court to  
25 request the Preliminary Approval of the Settlement Agreement, and the entry of a Preliminary Approval  
26 Order for: (a) conditional certification of the Settlement Class for settlement purposes only, (b)  
27 preliminary approval of the proposed Settlement Agreement, (c) setting a date for a final fairness  
28 hearing. The Preliminary Approval Order will provide for the Class Notice to be sent to all Class

Members as specified herein. In conjunction with the Preliminary Approval hearing, Plaintiffs will submit this Settlement Agreement, which sets forth the terms of this Settlement, and will include the proposed Notice of Class Action Settlement, attached as Exhibit A. Class Counsel will be responsible for drafting all documents necessary to obtain preliminary approval.

66. Final Settlement Approval Hearing and Entry of Judgment. Upon expiration of the deadlines to postmark Requests for Exclusion or objections to the Settlement Agreement, and with the Court's permission, a final fairness hearing will be conducted to determine the Final Approval of the Settlement Agreement along with the amounts properly payable for: (a) Attorneys' Fees and Costs; (b) the Class Representative Enhancement Payments; (c) Individual Settlement Payments; (d) the Labor and Workforce Development Agency Payment; (e) all Settlement Administration Costs. Class Counsel will be responsible for drafting all documents necessary to obtain final approval. Class Counsel will also be responsible for drafting the attorneys' fees and costs application to be heard at the final approval hearing.

67. Judgment and Continued Jurisdiction. Upon final approval of the Settlement by the Court or after the final fairness hearing, the Parties will present the Judgment to the Court for its approval. After entry of the Judgment, the Court will have continuing jurisdiction solely for purposes of addressing: (a) the interpretation and enforcement of the terms of the Settlement, (b) Settlement administration matters, and (c) such post-Judgment matters as may be appropriate under court rules or as set forth in this Settlement Agreement. A copy of the Judgment will be posted to the Settlement Administrator's website.

68. Release by Plaintiffs. Upon the Funding Date, in addition to the claims being released by all Participating Class Members, Plaintiffs will release and forever discharge the Released Parties, to the fullest extent permitted by law, of and from any and all claims, known and unknown, asserted and not asserted, which Plaintiffs have or may have against the Released Parties as of the date of execution of this Settlement Agreement. To the extent the foregoing release is a release to which Section 1542 of the California Civil Code or similar provisions of other applicable law may apply, Plaintiffs expressly waive any and all rights and benefits conferred upon them by the provisions of Section 1542 of the California Civil Code or similar provisions of applicable law which are as follows:

A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS THAT THE

CREDITOR OR RELEASING PARTY DOES NOT KNOW OR SUSPECT TO  
EXIST IN HIS OR HER FAVOR AT THE TIME OF EXECUTING THE RELEASE  
AND THAT, IF KNOWN BY HIM OR HER, WOULD HAVE MATERIALLY  
AFFECTED HIS OR HER SETTLEMENT WITH THE DEBTOR OR RELEASED  
PARTY.

69. Exhibits Incorporated by Reference. The terms of this Settlement Agreement include the  
terms set forth in any attached Exhibits, which are incorporated by this reference as though fully set forth  
herein. Any Exhibits to this Settlement Agreement are an integral part of the Settlement.

70. Entire Agreement. This Settlement Agreement and any attached Exhibits constitute the  
entirety of the Parties' settlement terms. No other prior or contemporaneous written or oral agreements  
may be deemed binding on the Parties. The Parties expressly recognize California Civil Code Section  
1625 and California Code of Civil Procedure Section 1856(a), which provide that a written agreement is  
to be construed according to its terms and may not be varied or contradicted by extrinsic evidence, and  
the Parties agree that no such extrinsic oral or written representations or terms will modify, vary or  
contradict the terms of this Settlement Agreement.

71. Amendment or Modification. No amendment, change, or modification to this Settlement  
Agreement will be valid unless in writing and signed, either by the Parties or their counsel, and approved  
by the Court.

72. Authorization to Enter Into Settlement Agreement. Counsel for all Parties warrant and  
represent they are expressly authorized by the Parties whom they represent to negotiate this Settlement  
Agreement and to take all appropriate action required or permitted to be taken by such Parties pursuant  
to this Settlement Agreement to effectuate its terms and to execute any other documents required to  
effectuate the terms of this Settlement Agreement. The Parties and their counsel will cooperate with each  
other and use their best efforts to effect the implementation of the Settlement. If the Parties are unable to  
reach agreement on the form or content of any document needed to implement the Settlement, or on any  
supplemental provisions that may become necessary to effectuate the terms of this Settlement, the Parties  
may seek the assistance of the Court to resolve such disagreement.

73. Binding on Successors and Assigns. This Settlement Agreement will be binding upon,

1 and inure to the benefit of, the successors or assigns of the Parties hereto, as previously defined.

2 74. California Law Governs. All terms of this Settlement Agreement and Exhibits hereto  
3 will be governed by and interpreted according to the laws of the State of California.

4 75. Execution and Counterparts. This Settlement Agreement is subject only to the execution  
5 of all Parties. However, the Settlement Agreement may be executed in one or more counterparts. All  
6 executed counterparts and each of them, including electronic (e.g., DocuSign), facsimile, and scanned  
7 copies of the signature page, will be deemed to be one and the same instrument.

8 76. Acknowledgement that the Settlement is Fair and Reasonable. The Parties believe this  
9 Settlement Agreement is a fair, adequate and reasonable settlement of the Action and have arrived at this  
10 Settlement after arm's-length negotiations and in the context of adversarial litigation, taking into account  
11 all relevant factors, present and potential. The Parties further acknowledge that they are each represented  
12 by competent counsel and that they have had an opportunity to consult with their counsel regarding the  
13 fairness and reasonableness of this Settlement.

14 77. Invalidity of Any Provision. Before declaring any provision of this Settlement  
15 Agreement invalid, the Court will first attempt to construe the provision as valid to the fullest extent  
16 possible consistent with applicable precedents so as to define all provisions of this Settlement Agreement  
17 valid and enforceable.

18 78. Waiver of Certain Appeals. The Parties agree to waive appeals and to stipulate to class  
19 certification for purposes of this Settlement only; except, however, that Plaintiffs or Class Counsel may  
20 appeal any reduction to the Attorneys' Fees and Costs below the amount they request from the Court,  
21 and either party may appeal any court order that materially alters the Settlement Agreement's terms.

22 79. Class Action Certification for Settlement Purposes Only. The Parties agree to stipulate to  
23 class action certification for purposes of the Settlement only. If, for any reason, the Settlement is not  
24 approved, the stipulation to certification will be void. The Parties further agree that certification for  
25 purposes of the Settlement is not an admission that class action certification is proper under the standards  
26 applied to contested certification motions and that this Settlement Agreement will not be admissible in

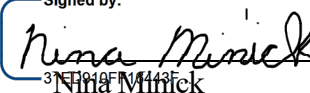

### **Summary of the Litigation**

Plaintiffs Rickey Lartigue and Nina Minick, on their behalf and on behalf of other current and former non-exempt employees, allege that Defendants violated California state labor laws as a result of their alleged failure to, among other things: (1) pay minimum and overtime wages to employees for all hours worked; (2) provide employees with meal and rest breaks; (3) timely pay all wages owed to employees during each pay period and upon termination of their employment; and (4) provide employees with accurate, itemized wage statements.

After the exchange of relevant information and evidence, the parties agreed to enter into settlement negotiations in an attempt to informally resolve the claims in the case. On October 22, 2024, the parties participated in a mediation with Daniel Turner, Esq., an experienced and well-respected class action mediator. With Mr. Turner's guidance, the parties were able to negotiate a complete settlement of Plaintiffs' claims.

Counsel for Plaintiffs, and the attorneys appointed by the Court to represent the class, Capstone Law APC ("Class Counsel"), have investigated and researched the facts and circumstances underlying the issues raised in the case and the applicable law. While Class Counsel believe that the claims alleged in this lawsuit have merit, Class Counsel also recognize that the risk and expense of continued litigation justify settlement. Based on the foregoing, Class Counsel believe the proposed settlement is fair, adequate, reasonable, and in the best interests of Class Members.

Defendants have denied, and continue to deny the factual and legal allegations in the case and believe that they have valid defenses to Plaintiffs' claims. By agreeing to settle, Defendants are not admitting liability on any of the factual allegations or claims in the case or that the case can or should proceed as a class action. Defendants have agreed to settle the case as part of a compromise with Plaintiffs.

### **Summary of The Proposed Settlement Terms**

Plaintiffs and Defendants have agreed to settle the underlying class claims in exchange for a Gross Settlement Amount of \$1,500,000. This amount is inclusive of: (1) individual settlement payments to all Participating Class Members; (2) Class Representative Enhancement Payments of \$10,000 , each, to Rickey Lartigue and Nina Minick for their services on behalf of the class, and for a release of all claims arising out of their employment with Defendants; (3) \$500,000 in attorneys' fees and up to \$ \_ in litigation costs and expenses; (4) a \$100,000 settlement of claims under the Labor Code Private Attorneys General Act of 2004 ("PAGA"), inclusive of a \$75,000 payment to the California Labor and Workforce Development Agency ("LWDA") in connection with the PAGA, and a \$25,000 payment ("PAGA Fund") to all PAGA Members; and (5) reasonable Settlement Administrator's fees and expenses currently estimated at \$ \_ . After deducting the above payments, a total of approximately \$ \_ will be allocated to Class Members who do not opt out of the Settlement Class ("Net Settlement Fund"). Additionally, all PAGA Members will receive a proportional share of the \$25,000 PAGA Fund, regardless whether they opt out of the Settlement Class.

**Payments from Net Settlement Fund.** Defendants will calculate the total number of Workweeks worked by each Class Member from August 18, 2021 through December 31, 2024 ("Class Period") and the aggregate total number of Workweeks worked by all Class Members during the Class Period. To determine each Class Member's estimated share of the Net Settlement Fund, the Settlement Administrator will use the following formula: The Net Settlement Fund will be divided by the aggregate total number of Workweeks during the Class Period, resulting in the "Workweek Value." Each Class Member's share of the Net Settlement Fund will be calculated by multiplying each individual Class Member's total number of Workweeks by the Workweek Value. The Individual Settlement Payment will be reduced by any required deductions for each Class Members as specifically set forth herein, including employee-side tax withholdings or deductions. If there are any valid and timely Requests for Exclusion, the Settlement Administrator shall proportionately increase each Participating Class Member's share of the Net Settlement Fund according to the number of Workweeks worked, so that the amount actually distributed to the Settlement Class equals 100% of the Net Settlement Fund.

A Request for Exclusion does not exclude a PAGA Member from the release of claims under California Labor Code §§ 2698, *et seq.* and the PAGA Member will receive their portion of the PAGA fund even if he/she/they submits a valid Request for Exclusion.

If you dispute the information stated above, Defendants' records will control unless you are able to provide documentation that establishes otherwise.

**Taxes on Settlement Payments.** IRS Forms W-2 and 1099 will be distributed to participating Class Members and the appropriate taxing authorities reflecting the payments they receive under the settlement. Class Members should consult their tax advisors concerning the tax consequences of the payments they receive under the Settlement. For purposes of this settlement, 10% of each settlement payment will be allocated as wages for which IRS Forms W-2 will be issued, and 90% will be allocated as non-wages for which IRS Forms 1099-MISC will be issued. Payments issued to PAGA Members from the PAGA Fund will be treated as non-wages for which IRS Forms 1099-MISC will be issued.

### **Your Options Under the Settlement**

#### ***Option 1 – Automatically Receive a Payment from the Settlement***

If you want to receive your payment from the settlement, then no further action is required on your part. You will automatically receive your settlement payment from the Settlement Administrator if and when the Settlement receives final approval by the Court.

If you choose **Option 1**, and if the Court grants final approval of the settlement, you will be mailed a check for your share of the settlement funds. In addition, on the date on which Defendants fully fund the Gross Settlement Amount, you will be deemed to have released or waived the Released Class Claims, and if you are also a PAGA Member, the Released PAGA Claims:

**Released Class Claims:** All claims that are alleged in the operative Complaint, or which could have been alleged by reason of or in connection with any matter or fact set forth or referred to in the operative Complaint, including claims for violation of: (1) Labor Code §§ 510 and 1198 (unpaid overtime); (2) Labor Code §§ 1182.12, 1194, 1197, 1197.1, and 1198 (unpaid minimum wages); (3) Labor Code §§ 226.7, 512(a), 516, and 1198 (failure to provide meal periods); (4) Labor Code §§ 226.7, 516, and 1198 (failure to authorize and permit rest periods); (5) Labor Code §§ 226(a), 1174(d), and 1198 (non-compliant wage statements and failure to maintain payroll records); (6) Labor Code §§ 201 and 202 (wages not timely paid upon termination); (7) Labor Code § 204 (failure to timely pay wages during employment); (8) Labor Code § 2802 (unreimbursed business expenses); (9) California Business & Professions Code Labor Code §§ 17200, *et seq.* (unlawful business practices); and (10) California Business & Professions Code Labor Code §§ 17200, *et seq.* (unfair business practices).

**Released PAGA Claims:** All claims for civil penalties under California Labor Code §§ 2698, *et seq.*, that were brought or could reasonably have been brought based on the same facts alleged in Plaintiffs' LWDA letters during the PAGA Period.

#### ***Option 2 – Opt Out of the Settlement***

If you do not wish to participate in the settlement, you may exclude yourself from participating by submitting a written request to the Settlement Administrator expressly and clearly indicating that you have received this Notice of Class Action Settlement, decided not to participate in the settlement, and desire to be excluded from the settlement. The written request for exclusion must include your name, signature, address, telephone number, and last four digits of your Social Security Number. Sign, date, and mail the request for exclusion by First Class U.S. Mail or equivalent, to the address below.

If you decide to object to the settlement because you find it unfair or unreasonable, you may submit a written objection stating why you object to the settlement, or you may instead appear at the Final Fairness Hearing to object to the Settlement. Written objections must provide: (1) your full name, signature, address, and telephone number, (2) a written statement of all grounds for the objection accompanied by any legal support for such objection; (3) copies of any papers, briefs, or other documents upon which the objection is based; and (4) a statement about whether you intend to appear at the Fairness Hearing. The objection must be mailed to the administrator at [administrator's address].
