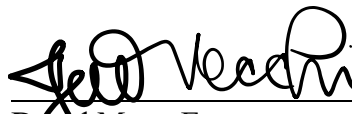
2 **PLEASE TAKE NOTICE** that on August 28, 2026, or as soon thereafter as the matter
