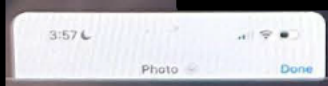
We can't afford to pay overtime for it. If you could do it while the videos are running on any of the webinars that you are facilitating that would be great.

I haven't received my pay increase amount. Also, I received a pay check this Friday and then it was reversed. [redacted] said that I could collect vacation time until I get the disability pay. I believe I also still had those vacation days accumulated due to the 'extra day or two' we were awarded multiple additional vacation days for attendance.

I should be receiving disability pay next month. It's just been a journey to get it due to having to wait for my doctors and we're planning on potentially getting surgery. (edited)

Follow-Up on Reversed Pay and Wage Concerns

I am writing to formally raise concern regarding the reversal of my June 6 paycheck and the continued underpayment of my adjusted salary. As noted in [redacted] prior Slack message, I was instructed to apply for disability and rely on sick and vacation leave during the transition. I followed that directive in good faith and made financial decisions accordingly. Reversing paid wages after they were issued, regardless of an internal miscalculation, violates California Labor Code §221, which prohibits employers from reclaiming paid wages.

Additionally, the failure to apply [redacted] adjustment from \$66,000 to \$69,000

Good afternoon Maria, I apologize for not getting back to you sooner on this matter. The reason why the paycheck was reversed was because I was informed you'd use your sick & vacation time until it ran out. We have been running into several issues with ADP in which they are aware about. After pulling reports, I had noticed that your vacation and sick time had been depleted, but even removing you from payroll, it was still adding you automatically. When I called to ask about this, they showed me how to reverse payment on a payment that was issued but yet not fully processed. I'm not sure if there was a different agreement between you and [REDACTED] regarding your leave, but I was informed you'd use your vacation time and sick time until depleted. Please let me know if you have any questions. [REDACTED]

Hi [REDACTED] thank you. After doing some digging it seems that reversing a check after it was issued (not processing because it was in fact in my account) is a violation of California civil code 221. Additionally in order to properly reverse a check that was already paid- I should have been provided with written notice prior to it being reversed.

You all have yet to address that I have not been paid my increase amount- which may constitute a breach of labor codes. [REDACTED]

Additionally, I have in writing where [REDACTED] said 'to use sick and vacation time until my disability arrives' which is promissory estoppel because I relied on that promise that is now being taken back and has caus
