1 Plaintiff Steven Rivera (“Plaintiff”), on behalf of himself, the State of California, as a private
2 attorney general, and all other similarly situated employees within the State of California, complains
3 and alleges of defendants Island Petroleum Builders, Inc. and Does 1 to 50 (collectively, “Defendants”),
4 and each of them, as follows:

5 **I. INTRODUCTION**

6 1. This is a class action complaint brought pursuant to California Code of Civil Procedure
7 section 382.

8 2. The “Class Period” as used herein, is defined as the period from November 30, 2019,
9 and continuing into the present and ongoing. Defendants’ violations of California’s laws as described
10 more fully below have been ongoing throughout the Class Period and are still ongoing.

11 3. Plaintiff brings this class action on behalf of himself and the following class: *All*
12 *individuals who are or were employed by Defendants as non-exempt employees in California during*
13 *the Class Period* (the “Class Members”). (Code Civ. Proc., § 382.)

14 4. Plaintiff brings this action on behalf of himself and the Class Members, as a class action,
15 against Defendants for:

- 16 A. Failure to pay all minimum wages,
- 17 B. Failure to pay all overtime wages,
- 18 C. Failure to provide rest periods and pay missed rest period premiums,
- 19 D. Failure to provide meal periods and pay missed meal period premiums,
- 20 E. Failure to maintain accurate employment records,
- 21 F. Failure to pay wages timely during employment,
- 22 G. Failure to pay all wages earned and unpaid at separation,
- 23 H. Failure to indemnify all necessary business expenditures,
- 24 I. Failure to furnish accurate itemized wage statements, and
- 25 J. Violations of California’s Unfair Competition Law (“UCL”) (Bus. & Prof.
26 Code, §§ 17200–17210).

1 5. This action is also a representative action brought pursuant to the California Labor Code
2 Private Attorneys General Act of 2004 (“PAGA”), codified at California Labor Code sections 2698
3 through 2699.6.

4 6. The “PAGA Period” as used herein, is defined as the period from November 30, 2022,
5 and continuing into the present and ongoing.

6 7. This PAGA action is brought on behalf of Plaintiff, the State of California as private
7 attorney general, and on behalf of the following aggrieved employees: *All individuals who are or were*
8 *employed by Defendants as non-exempt employees in California during the PAGA Period* (the
9 “Aggrieved Employees”).

10 8. Plaintiff is informed and believes and thereon alleges that the California Industrial
11 Welfare Commission (“IWC”) Wage Order applicable to the facts of this case is IWC Wage Order 16-
12 2001 (the “Applicable Wage Order”) and possibly others that may be applicable. (Cal. Code of Regs.,
13 tit. 8, § 11160.) Plaintiff reserves the right to amend or modify the definition of “Applicable Wage
14 Order” with greater specificity or add additional IWC Wage Orders if additional applicable wage orders
15 are discovered in litigation.

16 **II. JURISDICTION & VENUE**

17 9. This Court has subject matter jurisdiction over all causes of action asserted herein
18 pursuant to Article VI, section 10, of the California Constitution and Code of Civil Procedure section
19 410.10 because this is a civil action in which the matter in controversy, exclusive of interest, exceeds
20 \$25,000, and because each cause of action asserted arises under the laws of the State of California or
21 is subject to adjudication in the courts of the State of California.

22 10. This Court has personal jurisdiction over Defendants because Defendants have caused
23 injuries in the County of San Bernardino and the State of California through their acts, and by their
24 violation of the California Labor Code and California state common law. Defendants transact millions
25 of dollars of business within the State of California. Defendants own, maintain offices, transact
26 business, have an agent or agents within the County of San Bernardino, and/or otherwise are found
27 within the County of San Bernardino, and Defendants are within the jurisdiction of this Court for
28 purposes of service of process.

1 11. Venue as to Defendants is proper in this judicial district, pursuant to section 395 of the
2 Code of Civil Procedure. Defendants operate within California and do business within San Bernardino
3 County, California. The unlawful acts alleged herein have a direct effect on Plaintiff and all of
4 Defendants' employees identified above within San Bernardino County and surrounding counties
5 where Defendants may remotely operate.

6 12. This matter is not appropriate for removal under the Class Action Fairness Act (28
7 U.S.C. § 1332) as the amount in controversy for Plaintiff's and the Class Members' claims, in
8 aggregate, is less than \$5 million. Additionally, all the allegations herein occurred in the State of
9 California. As such, even if the amount in controversy did exceed \$5 million this matter would still not
10 be appropriate for removal under the "local controversy" exception to the Class Action Fairness Act.
11 (28 U.S.C. § 1332, subd. (d)(4)(A).)

12 **III. THE PARTIES**

13 **A. PLAINTIFF**

14 13. At all relevant times, Plaintiff, who is over the age of 18, was and currently is a citizen
15 of California residing in the State of California. Defendants employed Plaintiff as a non-exempt hourly
16 employee in the County of San Bernardino.

17 14. Plaintiff brings this action on behalf of himself and the following class pursuant to
18 section 382 of the Code of Civil Procedure as follows: *All individuals who are or were employed by*
19 *Defendants as non-exempt employees in California during the Class Period* (the "Class Members").

20 15. Plaintiff also brings this action on behalf of himself and the State of California, as a
21 private attorney general, and on behalf of the following group of aggrieved employees: *All individuals*
22 *who are or were employed by Defendants as non-exempt employees in California during the PAGA*
23 *Period* (the "Aggrieved Employees").

24 16. The Class Members and the Aggrieved Employees, at all times pertinent hereto, are or
25 were employees of Defendants during the relevant statutory period.

26 **B. DEFENDANTS**

27 17. Plaintiff is informed and believes and thereon alleges that Defendants were authorized
28 to and doing business in San Bernardino County and is and/or was the legal employer of Plaintiff, the

1 other Aggrieved Employees, and the other Class Members during the applicable statutory periods.
2 Plaintiff, the other Aggrieved Employees, and the other Class Members were, and are, subject to
3 Defendants' policies and/or practices complained of herein and have been deprived of the rights
4 guaranteed to them by: California Labor Code sections 201, 202, 203, 204, 210, 226, 226.3, 226.7, 256,
5 510, 512, 1174, 1185, 1194, 1194.2, 1197, 1197.1, 1198, 1198.5, 1199, 2802, 2804, and others that
6 may be applicable; California Business and Professions Code sections 17200 through 17210 ("UCL");
7 and the Applicable Wage Order (Cal. Code of Regs., tit. 8, § 11160).

8 18. Plaintiff is informed and believes, and based thereon alleges, that during the Class
9 Period and PAGA Period, Defendants did (and continue to do) business in the State of California,
10 County of San Bernardino.

11 19. Plaintiff does not know the true names or capacities, whether individual, partner, or
12 corporate, of the defendants sued herein as Does 1 to 50, inclusive, and for that reason, said defendants
13 are sued under such fictitious names, and Plaintiff will seek leave from this Court to amend this
14 complaint when such true names and capacities are discovered. Plaintiff is informed, and believes, and
15 thereon alleges, that each of said fictitious defendants, whether individual, partners, or corporate, were
16 responsible in some manner for the acts and omissions alleged herein, and proximately caused Plaintiff,
17 the other Aggrieved Employees, and the other Class Members to be subject to the unlawful employment
18 practices, wrongs, injuries, and damages complained of herein.

19 20. Plaintiff is informed, and believes, and thereon alleges, that at all times mentioned
20 herein, Defendants were and/or are the employers of Plaintiff, the other Aggrieved Employees, and the
21 other Class Members. At all times herein mentioned, each of said Defendants participated in the doing
22 of the acts hereinafter alleged to have been done by the named Defendants. Furthermore, the
23 Defendants, and each of them, were the agents, servants, and employees of each and every one of the
24 other Defendants, as well as the agents of all Defendants, and at all times herein mentioned were acting
25 within the course and scope of said agency and employment. Defendants, and each of them, approved
26 of, condoned, or otherwise ratified every one of the acts or omissions complained of herein.

27 21. At all relevant times, Defendants, and each of them, were members of and engaged in a
28 joint venture, partnership, and common enterprise, and acting within the course and scope of and in

1 pursuance of said joint venture, partnership, and common enterprise. Further, Plaintiff is informed, and
2 believes, and thereon alleges, that all Defendants were joint employers for all purposes of Plaintiff, the
3 other Aggrieved Employees, and the other Class Members.

4 **IV. COMMON FACTS & ALLEGATIONS**

5 22. Plaintiff and the other Class Members (collectively, the “Class Members”) are, and were
6 at all relevant times, employed by the Defendants within the State of California.

7 23. Likewise, Plaintiff and the other Aggrieved Employees (collectively, the “Aggrieved
8 Employees”) are, and were at all relevant times, employed by the Defendants within the State of
9 California.

10 24. The Class Members and the Aggrieved Employees are, and were, at all relevant times,
11 non-exempt employees for the purposes of minimum wages, overtime, rest breaks, meal periods, and
12 the other claims alleged in this complaint.

13 25. Specifically, Plaintiff was employed by Defendants within the statutory Class Period
14 and PAGA Period, working as an hourly, non-exempt construction laborer for Defendants. Plaintiff’s
15 duties included general construction duties at multiple job sties throughout California.

16 **A. MINIMUM WAGE VIOLATIONS**

17 26. Labor Code section 1197 requires employees to be paid at least the minimum wage fixed
18 by the IWC, and any payment of less than the minimum wage is unlawful. Similarly, Labor Code
19 section 1194 entitles “any employee receiving less than the legal minimum wage . . . to recover in a
20 civil action the unpaid balance of the full amount of this minimum wage.” Likewise, the Applicable
21 Wage Order also obligates employers to pay each employee minimum wages for all hours worked.
22 (Cal. Code of Regs., tit. 8, § 11160.) Labor Code section 1198 makes unlawful the employment of an
23 employee under conditions that the IWC Wage Orders prohibit.

24 27. These minimum wage standards apply to each hour that employees work. Therefore, an
25 employer’s failure to pay for any particular time worked by an employee is unlawful, even if averaging
26 an employee’s total pay over all hours worked, paid or not, results in an average hourly wage above
27 minimum wage. (*Armenta v. Osmose, Inc.* (2005) 135 Cal.App.4th 314, 324.)
28

1 28. Here, Defendants failed to fully conform their pay practices to the requirements of the
2 law during the relevant statutory periods. The Class Members and the Aggrieved Employees were not
3 compensated for all hours worked including, but not limited to, all hours they were subject to the control
4 of Defendants and/or suffered or permitted to work under the California Labor Code and the Applicable
5 Wage Order. Among other violations, the Class Members and the Aggrieved Employees were subject
6 to the control of Defendants while off-the-clock and did not receive minimum wage for each hour
7 worked.

8 29. Labor Code sections 1194, subdivision (a), and 1194.2, subdivision (a), provide that an
9 employer who has failed to pay its employees the legal minimum wage is liable to pay those employees
10 the unpaid balance of the unpaid wages as well as liquidated damages in an amount equal to the wages
11 due and interest thereon.

12 30. When employees, such as the Class Members, are not paid for all hours worked under
13 Labor Code section 1194, they are entitled to recover minimum wages for the time which they received
14 no compensation. (See *Sillah v. Command International Security Services* (N.D. Cal. 2015) 154
15 F.Supp.3d 891 [employees suing for failure to pay overtime could recover liquidated damages under
16 Labor Code section 1194.2 if they also showed they were paid less than minimum wage].)

17 31. Labor Code section 1197.1 authorizes employees who are paid less than the minimum
18 wage fixed by an applicable state or local law, or by an order of the IWC, a civil penalty, among other
19 damages, as follows:

20 (1) “For any initial violation that is intentionally committed, one hundred
21 dollars (\$100) for each underpaid employee for each pay period for
22 which the employee is underpaid.”

23 (2) “For each subsequent violation for the same specific offense, two
24 hundred fifty dollars (\$250) for each underpaid employee for each pay
25 period for which the employee is underpaid regardless of whether the
26 initial violation is intentionally committed.” (Lab. Code, § 1197.1, subd.
27 (a).)
28

1 32. As set forth above, Defendants failed to fully compensate the Class Members and the
2 Aggrieved Employees for all minimum wages. Accordingly, the Class Members are entitled to recover
3 liquidated damages for violations of Labor Code section 1197.1.

4 33. Based upon these same factual allegations, the Class Members are likewise entitled to
5 penalties under Labor Code sections 1199.

6 **B. OVERTIME VIOLATIONS**

7 34. Labor Code section 510 requires employers to compensate employees who work more
8 than eight hours in one workday, forty hours in a workweek, and for the first eight hours worked on
9 the seventh consecutive day no less than one and one-half times the regular rate of pay for an employee.
10 (Lab. Code, § 510, subd. (a).) Further, Labor Code section 510 obligates employers to compensate
11 employees at no less than twice the regular rate of pay when an employee works more than twelve
12 hours in a day or more than eight hours on the seventh consecutive day of work. (Lab. Code, § 510,
13 subd. (a).) These rules are also reflected in the Applicable Wage Order.

14 35. In accordance with Labor Code section 1194 and the Applicable Wage Order, the Class
15 Members and the Aggrieved Employees could not then agree and cannot now agree to work for a lesser
16 wage than the amount provided by Labor Code sections 510 or the Applicable Wage Order.

17 36. Here, Defendants violated their duty to accurately and completely compensate the Class
18 Members and the Aggrieved Employees for all overtime worked. The Class Members and the
19 Aggrieved Employees periodically worked hours that entitled them to overtime compensation under
20 the law but were not fully compensated for those hours.

21 37. Defendants also had a policy and practice of denying the Class Members and the
22 Aggrieved Employees meal breaks, but nevertheless deducting meal break time from the Class
23 Members' and the Aggrieved Employees' pay. As a result, the Class Members' and the Aggrieved
24 Employees' on-the-clock hours were unlawfully reduced below what was actually worked and, by
25 extension, overtime hours were also reduced below what was actually worked. The Class Members
26 and the Aggrieved Employees were thus periodically shorted the full amount of overtime pay lawfully
27 owed.
28

1 38. These actions were and are in clear violation of California’s overtime laws as set forth
2 in Labor Code sections 510, 1194, 1199, and the Applicable Wage Order. (Cal. Code of Regs., tit. 8, §
3 11160.) As a result of Defendants’ faulty policies and practices, the Class Members and the Aggrieved
4 Employees were not compensated for all hours worked or paid accurate overtime compensation.

5 **C. REST BREAK VIOLATIONS**

6 39. Pursuant to Labor Code section 226.7 and the Applicable Wage Order, Defendants were
7 and are required to provide the Class Members and the Aggrieved Employees with compensated, duty-
8 free rest periods of not less than ten minutes for every major fraction of four hours worked. Under the
9 Applicable Wage Order, an employer must authorize and permit all employees to take ten minute duty
10 free rest periods for every major fraction of four hours worked. (Cal. Code of Regs., tit. 8, § 11160.)

11 40. Likewise, Labor Code section 226.7 provides that “[a]n employer shall not require an
12 employee to work during a meal or rest or recovery period mandated pursuant to an applicable statute,
13 or applicable regulation, standard, or order of the Industrial Welfare Commission” (Lab. Code, §
14 226.7, subd. (b).) Labor Code section 226.7 also provides that employers must pay their employees one
15 additional hour of pay at the employee’s regular rate for each workday that a “meal or rest or recovery
16 period is not provided.” (Lab. Code, § 226.7, subd. (c).) The “regular rate” for these purposes must
17 factor in all nondiscretionary payments for work performed by the employee, including non-
18 discretionary bonuses, commissions, and other forms of wage payments exceeding the employees’ base
19 hourly rate. (*Ferra v. Loews Hollywood Hotel, LLC* (2021) 11 Cal.5th 858, 878.) Thus, the Wage
20 Orders set when and for how long the rest period must take place and the Labor Code establishes that
21 violations of the IWC Wage Orders are unlawful and sets forth the premium pay employer must pay
22 their employees when employers fail to provide rest periods.

23 41. The California Supreme Court has held that, during required rest periods, “employers
24 must relieve their employees of all duties and relinquish any control over how employees spend their
25 break time.” (*Augustus v. ABM Security Services, Inc.* (2016) 2 Cal.5th 257, 260.) Relinquishing
26 control over employees during rest periods requires that employees be “free to leave the employer’s
27 premises” and be “permitted to attend to personal business.” (*Id.* at p. 275.) The *Brinker* Court
28

1 explained in the context of rest breaks that employer liability attaches from adopting an unlawful
2 policy:

3 “An employer is required to authorize and permit the amount of rest break time
4 called for under the wage order for its industry. If it does not—if, for example,
5 it adopts a uniform policy authorizing and permitting only one rest break for
6 employees working a seven-hour shift when two are required—it has violated
7 the wage order and is liable.” (*Brinker Rest. Corp. v. Superior Court* (2012) 53
8 Cal.4th 1004, 1033.)

9 42. Here, Defendants periodically did not permit the Class Members and the Aggrieved
10 Employees to take compliant duty-free rest breaks, free from Defendants’ control as required by Labor
11 Code section 226.7, the Applicable Wage Order, and applicable precedent. (See *Augustus v. ABM*
12 *Security Services, Inc.* (2016) 2 Cal.5th 257, 269 [concluding that “during rest periods employers must
13 relieve employees of all duties and relinquish control over how employees spend their time.”].) At all
14 relevant times, the Class Members and the Aggrieved Employees were periodically not provided with
15 legally-compliant and timely rest periods of at least ten minutes for each four hour work period, or
16 major fraction thereof due to Defendants’ unlawful rest period policies/practices. The Class Members
17 and the Aggrieved Employees were often expected and required to continue working through rest
18 periods to meet the expectations Defendants and finish the workday. In some cases when the Class
19 Members and the Aggrieved Employees worked more than ten hours in a shift, Defendants failed to
20 authorize and/or permit a third mandated rest period. As a result, the Class Members and the Aggrieved
21 Employees were periodically unable to take compliant rest periods.

22 43. In such cases where Defendants did not offer the Class Members and the Aggrieved
23 Employees the opportunity to receive a compliant off-duty rest period, “the court may not conclude
24 employees voluntarily chose to skip those breaks.” (*Alberts v. Aurora Behavioral Health Care* (2015)
25 241 Cal.App.4th 388, 410 (2015) [“If an employer fails to provide legally compliant meal or rest
26 breaks, the court may not conclude employees voluntarily chose to skip those breaks.”]; *Brinker Rest.*
27 *Corp. v. Superior Court, supra*, 53 Cal.4th at p. 1033 [“No issue of waiver ever arises for a rest break
28

1 that was required by law but never authorized; if a break is not authorized, an employee has no
2 opportunity to decline to take it.”].)

3 44. In addition to failing to authorize and permit compliant rest periods, the Class Members
4 and the Aggrieved Employees were not compensated with one hour’s worth of pay at their regular rate
5 of compensation when they were not provided with a compliant rest period in accordance with Labor
6 Code section 226.7, subdivision (c). Thus, Defendants have violated Labor Code section 226.7 and the
7 Applicable Wage Order.

8 45. Based on the foregoing, Plaintiff seeks to recover, on behalf of himself and other non-
9 exempt employees, rest period premiums and penalties.

10 **D. MEAL BREAK VIOLATIONS**

11 46. Labor Code section 512 and the Applicable Wage Order require employers to provide
12 employees with a thirty-minute uninterrupted and duty-free meal period within the first five hours of
13 work. (Lab. Code, § 512, subd. (a) [“An employer shall not employ an employee for a work period of
14 more than five hours per day without providing the employee with a meal period of not less than 30
15 minutes”]; Cal. Code of Regs., tit. 8, § 11160 [“No employer shall employ any person for a work
16 period of more than five (5) hours without a meal period of not less than 30 minutes”].)
17 Additionally, an employee who works more than ten hours per day is entitled to receive a second thirty-
18 minute uninterrupted and duty-free meal period. (Lab. Code, § 512, subd. (a) [“An employer shall not
19 employ an employee for a work period of more than 10 hours per day without providing the employee
20 with a second meal period of not less than 30 minutes”].)

21 47. “An on-duty meal period is permitted only when the nature of the work prevents an
22 employee from being relieved of all duty and the parties agree in writing to an on-duty paid meal
23 break.” (*Lubin v. The Wackenhut Corp.* (2016) 5 Cal.App.5th 926, 932.) The written agreement must
24 include a provision allowing the employee to revoke it at any time. (*Ibid.*) Generally, the California
25 Department of Industrial Relations, Division of Labor Standards Enforcement (“DLSE”) and courts
26 have “found that the nature of the work exception applies: (1) where the work has some particular
27 external force that requires the employee to be on duty at all times, and (2) where the employee is the
28 sole employee of a particular employer.” (*Id.* at p. 945, internal quotation marks omitted; *Abdullah v.*

1 *U.S. Security Associates, Inc.* (9th Cir. 2013) 731 F.3d 952, 958–959.) “[I]t is the employer’s obligation
2 to determine whether the nature of the work prevents an employee from being relieved before requiring
3 an employee to take an on-duty meal period.” (*Lubin v. The Wackenhut Corp.*, *supra*, 5 Cal.App.5th at
4 p. 946.)

5 48. Here, the Class Members and the Aggrieved Employees were never asked to sign any
6 enforceable document agreeing to an on-duty meal period. Moreover, nothing in the nature of their
7 work involved the kind of “external force” that might justify on-duty meal breaks. (*Lubin v. The*
8 *Wackenhut Corp.*, *supra*, 5 Cal.App.5th at p. 945.) Nevertheless, Defendants periodically did not
9 provide compliant off-duty meal periods within the first five hours of work for the Class Members and
10 the Aggrieved Employees.

11 49. As with rest breaks, meal breaks must be duty-free. (*Brinker Restaurant Corp. v.*
12 *Superior Court* (2012) 53 Cal.4th 1004, 1035 [“The IWC’s wage orders have long made a meal period’s
13 duty-free nature its defining characteristic.”].) Relinquishing control over employees during meal
14 periods requires that employees be “free to leave the employer’s premises” and be “permitted to attend
15 to personal business.” (*Augustus v. ABM Security Services, Inc.*, *supra*, 2 Cal.5th at p. 275.) Under
16 Labor Code section 512, if an employer maintains a uniform policy that does not authorize and permit
17 the amount of meal time called for under the law (as specified in the Labor Code and/or applicable
18 IWC Wage Order), “it has violated the wage order and is liable.” (*Brinker Restaurant Corp. v. Superior*
19 *Court*, *supra*, 53 Cal.4th at p. 1033.)

20 50. During the applicable statutory periods here, the Class Members and the Aggrieved
21 Employees were periodically denied legally-compliant and timely off-duty meal periods of at least
22 thirty minutes due to Defendants’ unlawful meal period policy and practices. As a result of Defendants’
23 uniform meal period policies and practices, the Class Members and the Aggrieved Employees were
24 often not permitted to take compliant first meal periods before the end of the fifth hour of work. The
25 Class Members and the Aggrieved Employees were also periodically not permitted to take second meal
26 periods for shifts in excess of ten hours. Defendants thus violated Labor Code section 512 and the
27 Applicable Wage Order by failing to advise, authorize, or permit the Class Members and the Aggrieved
28 Employees to receive thirty-minute, off-duty meal periods within the first five hours of their shifts.

1 51. Labor Code section 226.7 provides that “[a]n employer shall not require an employee
2 to work during a meal or rest or recovery period mandated pursuant to an applicable statute, or
3 applicable regulation, standard, or order of the Industrial Welfare Commission.” (Lab. Code, § 226.7,
4 subd. (b).) Labor Code section 226.7, subdivision (c), and the Applicable Wage Order further obligate
5 employers to pay employees one additional hour of pay at the employee’s regular rate of compensation
6 for each workday that the meal period is not provided. (Lab. Code, § 226.7, subd. (c); Cal. Code of
7 Regs., tit. 8, § 11160 [“If an employer fails to provide an employee a meal period in accordance with
8 the applicable provisions of this order, the employer shall pay the employee one (1) hour of pay at the
9 employee’s regular rate of compensation for each workday that the meal period is not provided.”].)
10 The “regular rate” for these purposes must factor in all nondiscretionary payments for work performed
11 by the employee, including non-discretionary bonuses, commissions, and other forms of wage
12 payments exceeding the employees’ base hourly rate. (*Ferra v. Loews Hollywood Hotel, LLC* (2021)
13 11 Cal.5th 858, 878.)

14 52. Accordingly, for each day that the Class Members and the Aggrieved Employees did
15 not receive compliant meal periods, they were and are entitled to receive meal period premiums
16 pursuant to Labor Code section 226.7 and the Applicable Wage Order. Defendants, however, failed to
17 pay the Class Members and the Aggrieved Employees applicable meal period premiums for many
18 workdays that the employees did not receive a compliant meal period. Thus, Defendants have violated
19 Labor Code section 226.7 and the Applicable Wage Order.

20 53. Based on the foregoing, Plaintiff seeks to recover, on behalf of himself and other non-
21 exempt employees, meal period premiums and penalties.

22 **E. UNTIMELY WAGES DURING EMPLOYMENT**

23 54. Labor Code section 204 expressly requires employers who pay employees on a weekly,
24 biweekly, or semimonthly basis to pay all wages “not more than seven calendar days following the
25 close of the payroll period.” Labor Code section 210, subdivision (a), makes employers who violate
26 Labor Code section 204 subject to a penalty of:

27 “(1) For any initial violation, one hundred dollars (\$100) for each failure to
28 pay each employee.

1 “(2) For each subsequent violation, or any willful or intentional violation, two
2 hundred dollars (\$200) for each failure to pay each employee, plus 25
3 percent of the amount unlawfully withheld.” (Lab. Code, § 210, subd.
4 (a).)

5 55. Notably, the penalty provided by Labor Code section 210 is “[i]n addition to, and
6 entirely independent and apart from, any other penalty provided in this article” (Lab. Code, § 210,
7 subd. (a).)

8 56. Due to Defendants’ failure to pay the Class Members and the Aggrieved Employees the
9 wages described above, along with rest and meal break premiums, Defendants failed to timely pay the
10 Class Members and the Aggrieved Employees within seven calendar days following the close of payroll
11 in accordance with Labor Code section 204 on a regular and consistent basis. (See *Parson v. Golden*
12 *State FC, LLC* (N.D. Cal., May 2, 2016, No. 16-CV-00405-JST) 2016 WL 1734010, at p. *3–5, 2016
13 U.S. Dist. LEXIS 58299 [finding that a failure to pay rest period premiums can support claims under
14 Labor Code sections 203 and 204].)

15 **F. UNTIMELY WAGES AT SEPARATION**

16 57. Labor Code section 203 provides “if an employer willfully fails to pay . . . any wages
17 of an employee who is discharged or who quits, the wages of the employee shall continue as a penalty”
18 for up to thirty days. (Lab. Code § 203; *Mamika v. Barca* (1998) 68 Cal.App.4th 487, 492.) As a result
19 of Defendants’ failure to pay the Class Members and the Aggrieved Employees for the wages described
20 above, along with rest and meal break premiums, Defendants violated and continue to violate Labor
21 Code section 203.

22 58. Due to Defendants’ faulty pay policies, those Class Members and Aggrieved Employees
23 whose employment with Defendants concluded were not compensated for each and every hour worked
24 at the appropriate rate. Defendants have failed to pay formerly-employed Class Members and
25 Aggrieved Employees whose sums were certain at the time of termination within at least seventy-two
26 hours of their resignation and have failed to pay those sums for thirty days thereafter.

27 59. Under Labor Code section 256, “[t]he Labor Commissioner shall impose a civil penalty
28 in an amount not exceeding 30 days pay as waiting time under the terms of Section 203.” (Lab. Code,

1 § 256.) This type of waiting time penalty can be recovered through PAGA because PAGA allows an
2 employee to recover civil penalties on behalf of the state against his or her employer for Labor Code
3 violations. (*Villacres v. ABM Industries Inc.* (2010) 189 Cal.App.4th 562, 579 [recovery of the section
4 256 “civil penalty falls within the PAGA”]); *Iskanian v. CLS Transportation Los Angeles, LLC* (2014)
5 59 Cal.4th 348, 381; *Esparza v. KS Industries, L.P.* (2017) 13 Cal.App.5th 1228, 1242.) Defendants
6 have failed to pay the Aggrieved Employees’ worked wages that were due within at least seventy-two
7 hours of their separation. Thus, the Aggrieved Employees were and are entitled to waiting time
8 penalties as civil penalties under PAGA and Labor Code section 256.

9 **G. FAILURE TO REIMBURSE BUSINESS EXPENSES**

10 60. At all relevant times herein, Defendants were subject to Labor Code section 2802, which
11 states that “an employer shall indemnify his or her employees for all necessary expenditures or losses
12 incurred by the employee in direct consequence of the discharge of his or her duties, or of his or her
13 obedience to the directions of the employer.” The purpose of this section is to “prevent employers from
14 passing along their operating expenses onto their employees.” (*Gattuso v. Harte-Hanks Shoppers, Inc.*
15 (2007) 42 Cal.4th 554, 562.)

16 61. At all relevant times herein, Defendants were subject to Labor Code section 2804, which
17 states that “any contract or agreement, express or implied, made by any employee to waive the benefits
18 of this article or any part thereof, is null and void, and this article shall not deprive any employee or his
19 personal representative of any right or remedy to which he is entitled under the laws of this State.”

20 62. Thus, the Class Members and the Aggrieved Employees were and are entitled to
21 reimbursement for the expenses they incurred during the course of their duties. The duty to reimburse
22 even extends to the use of equipment the employee may already own and would be required to pay for
23 anyway. (*Cochran v. Schwan’s Home Serv., Inc.* (2014) 228 Cal.App.4th 1137, 1144 [“The threshold
24 question in this case is this: Does an employer always have to reimburse an employee for the reasonable
25 expense of the mandatory use of a personal cell phone, or is the reimbursement obligation limited to
26 the situation in which the employee incurred an extra expense that he or she would not have otherwise
27 incurred absent the job? The answer is that reimbursement is always required. Otherwise, the employer
28 would receive a windfall because it would be passing its operating expenses on to the employee.”].)

1 63. Here, Defendants failed to fully reimburse the Class Members and the Aggrieved
2 Employees for necessary expenditures incurred as a direct consequence and requirement of performing
3 their job duties, including the costs associated with their personal cell phone they required to perform
4 their work. Consequently, Defendants failed to comply with Labor Code section 2802.

5 **H. WAGE STATEMENT VIOLATIONS**

6 64. Defendants also failed to provide accurate itemized wage statements in accordance with
7 Labor Code sections 226, subdivisions (a)(1), (2), (5), and (9). Labor Code section 226, subdivision
8 (a), obligates employers, semi-monthly or at the time of each payment to furnish an itemized wage
9 statement in writing showing:

- 10 (1) The gross wages earned;
- 11 (2) The total hours worked by the employee;
- 12 (3) The number of piece-rate units earned and any applicable piece rate if
13 the employee is paid on a piece rate basis;
- 14 (4) All deductions, provided that all deductions made on written orders of
15 the employee may be aggregated and shown as one item;
- 16 (5) The net wages earned;
- 17 (6) The inclusive dates of the period for which the employee is paid;
- 18 (7) The name of the employee and only the last four digits of his or her social
19 security number or an employee identification number other than a social
20 security number;
- 21 (8) The name and address of the legal entity that is the employer; and
- 22 (9) All applicable hourly rates in effect during the pay period and the
23 corresponding number of hours worked at each hourly rate by the
24 employee.

25 65. Due to Defendants' failure to pay the Class Members and the Aggrieved Employees
26 properly as described above, the wage statements issued do not indicate the correct amount of gross
27 wages earned, total hours worked, or the net wages earned, or the applicable hourly rates in effect
28

1 during the pay period and the corresponding number of hours worked at each hourly rate. Thus,
2 Defendants have violated Labor Code section 226, subdivisions (a)(1), (2), (5), and (9).

3 66. In addition to Labor Code section 226, subdivision (a), Defendants also knowingly and
4 intentionally failed to provide the Class Members and the Aggrieved Employees with accurate itemized
5 wage statements in violation of Labor Code section 226, subdivision (e). Defendants knew that they
6 were not providing the Class Members and the Aggrieved Employees with wage statements required
7 by California law but nevertheless failed to correct their unlawful practices and policies. (See *Garnett*
8 *v. ADT LLC* (E.D. Cal. 2015) 139 F.Supp.3d 1121, 1134 [finding the defendant knowingly and
9 intentionally violated Labor Code section 226 because the “[d]efendant knew that it was not providing
10 total hours worked to plaintiff or other employees paid on commission” even though it believed that
11 employees paid solely on commission or commission and salary “are exempt and therefore we do not
12 record hours on a wage statement.”].)

13 I. RECORDKEEPING VIOLATIONS

14 67. Labor Code section 226, subdivision (a), requires employers to keep an accurate record
15 of, among other things, all hours worked by employees. Labor Code section 226.3 provides, in pertinent
16 part, as follows:

17 “Any employer who violates subdivision (a) of Section 226 shall be subject to a
18 civil penalty in the amount of two hundred fifty dollars (\$250) per employee per
19 violation in an initial citation and one thousand dollars (\$1,000) per employee
20 for each violation in a subsequent citation, for which the employer fails to
21 provide the employee a wage deduction statement or fails to keep the records
22 required in subdivision (a) of Section 226. The civil penalties provided for in
23 this section are in addition to any other penalty provided by law.” (Lab. Code, §
24 226.3, emphasis added.)

25 68. Likewise, Labor Code section 1174, subdivision (d), requires every employer, including
26 Defendants, to:

27 “Keep, at a central location in the state or at the plants or establishments at which
28 employees are employed, payroll records showing the hours worked daily by

1 and the wages paid to, and the number of piece-rate units earned by and any
2 applicable piece rate paid to, employees employed at the respective plants or
3 establishments. These records shall be kept in accordance with rules established
4 for this purpose by the commission, but in any case shall be kept on file for not
5 less than three years. An employer shall not prohibit an employee from
6 maintaining a personal record of hours worked, or, if paid on a piece-rate basis,
7 piece-rate units earned.” (Lab. Code, § 1174, subd. (d), emphasis added.)

8 69. As explained in detail above, Defendants failed to provide the Class Members and the
9 Aggrieved Employees with accurate itemized wage statements. Defendants did so, in part, because they
10 failed to accurately track hours worked by the Class Members and the Aggrieved Employees.
11 Defendants have thus failed to keep accurate records of the “total hours worked by the employee[s]”
12 in violation of Labor Code section 226, subdivision (a), and are therefore subject to the penalties
13 provided by Labor Code section 226.3. These penalties are “in addition to any other penalty provided
14 by law.” (Lab. Code, § 226.3.)

15 70. The failure to accurately track hours worked also resulted in a failure of Defendants to
16 keep a record of all “payroll records showing the hours worked daily by” Defendants’ employees,
17 including Plaintiff and the other Class Members, in violation of Labor Code section 1174, subdivision
18 (d).

19 **V. CLASS ACTION ALLEGATIONS**

20 71. As mentioned above, Plaintiff brings this action on behalf of himself and the Class
21 Members pursuant to section 382 of the Code of Civil Procedure.

22 72. **Numerosity/Ascertainability:** The Class Members are so numerous that joinder of all
23 members would be unfeasible and not practicable. The membership of the class is unknown to Plaintiff
24 at this time; however, it is estimated that the number of Class Members is greater than 100 individuals.
25 The identity of such membership is readily ascertainable via inspection of Defendants’ employment
26 records.

27 73. **Common Questions of Law and Fact Predominate/Well Defined Community of**
28 **Interest:** There are common questions of law and fact as to Plaintiff and all other similarly situated

1 non-exempt employees, which predominate over questions affecting only individual members
2 including, without limitation to:

3 A. Whether Defendants' pay policies/practices resulted in a failure to pay the Class
4 Members for all hours worked, including all minimum wages;

5 B. Whether Defendants' pay policies/practices resulted in a failure to pay the Class
6 Members for all required overtime wages at the Class Members' regular rate of pay;

7 C. Whether Defendants' rest period policies and practices afforded legally
8 compliant rest periods or compensation in lieu thereof;

9 D. Whether Defendants' meal period policies and practices afforded legally
10 compliant meal periods or compensation in lieu thereof;

11 E. Whether Defendants maintained accurate employment records;

12 F. Whether Defendants timely paid all wages during employment;

13 G. Whether Defendants timely paid all wages earned and unpaid at separation;

14 H. Whether Defendants indemnified their employees for all necessary business
15 expenditures;

16 I. Whether Defendants furnished legally-compliant wage statements to the Class
17 Members pursuant to Labor Code section 226; and

18 J. Whether Defendants' violations of the Labor Code and the Applicable Wage
19 Order amounted to a violation of California's UCL.

20 **74. Predominance of Common Questions:** Common questions of law and fact
21 predominate over questions that affect only individual Class Members. The common questions of law
22 set forth above are numerous and substantial and stem from Defendants' uniform policies and practices
23 applicable to each individual class member, such as Defendants' uniform policy and practice of failing
24 to pay for all hours worked, Defendants' uniform policies and practices which failed to provide
25 compliant rest periods, Defendants' uniform policies and practices which failed to provide compliant
26 meal periods, Defendants' failure to provide accurate itemized wage statements, and others. As such,
27 the common questions predominate over individual questions concerning each individual class
28 member's showing as to his or her eligibility for recovery or as to the amount of his or her damages.

1 75. **Typicality:** The claims of Plaintiff are typical of the claims of the Class Members
2 because Plaintiff was employed by Defendants as a non-exempt employee in California during the
3 statute(s) of limitation applicable to each cause of action pleaded in this complaint. As alleged herein,
4 Plaintiff, like the other Class Members, was deprived of minimum, regular, and overtime wages
5 because of Defendants' unlawful timekeeping policies and practices, was deprived of rest periods and
6 premium wages in lieu thereof, was deprived of meal periods and premium wages in lieu thereof, was
7 subject to Defendants' uniform rest period policies and practices, was subject to Defendants' uniform
8 meal period policies and practices, was not provided accurate itemized wage statements, was not paid
9 all wages in full and on time, , and was subject to other similar policies and practices to which the Class
10 Members were subject.

11 76. **Adequacy of Representation:** Plaintiff is fully prepared to take all necessary steps to
12 represent fairly and adequately the interests of the Class Members. Moreover, Plaintiff's attorneys are
13 ready, willing, and able to fully and adequately represent the Class Members and Plaintiff. Plaintiff's
14 attorneys have prosecuted numerous wage-and-hour class actions in state and federal court in the past
15 and are committed to vigorously prosecuting this action on behalf of the Class Members.

16 77. **Superiority:** The California Labor Code is broadly remedial in nature and serves an
17 important public interest in establishing minimum working conditions and standards in California.
18 These laws and labor standards protect the average working employee from exploitation by employers
19 who have the responsibility to follow the laws and who may seek to take advantage of superior
20 economic and bargaining power in setting onerous terms and conditions of employment. The nature of
21 this action and the format of laws available to Plaintiff and the Class Members make the class action
22 format a particularly efficient and appropriate procedure to redress the violations alleged herein. If each
23 employee were required to file an individual lawsuit, Defendants would necessarily gain an
24 unconscionable advantage since they would be able to exploit and overwhelm the limited resources of
25 each individual plaintiff with their vastly superior financial and legal resources.

26 78. Moreover, requiring each Class Member to pursue an individual remedy would also
27 discourage the assertion of lawful claims by employees who would be disinclined to file an action
28 against their former or current employer for real and justifiable fear of retaliation and permanent

1 damages to their careers at subsequent employment. Further, the prosecution of separate actions by the
2 individual Class Members, even if possible, would create a substantial risk of inconsistent or varying
3 verdicts or adjudications with respect to the individual Class Members against Defendants herein, and
4 which would establish potentially incompatible standards of conduct for Defendants or legal
5 determinations with respect to individual Class Members which would, as a practical matter, be
6 dispositive of the interest of the other Class Members not parties to adjudications or which would
7 substantially impair or impede the ability of the Class Members to protect their interests.

8 79. Further, the claims of the individual Class Members are not sufficiently large to warrant
9 vigorous individual prosecution considering the concomitant costs and expenses attending thereto. As
10 such, the Class Members identified above are maintainable as a class under section 382 of the Code of
11 Civil Procedure.

12 **VI. EXHAUSTION OF REMEDIES**

13 80. Plaintiff has fully and completely exhausted administrative remedies under PAGA prior
14 to proceeding with the PAGA claims stated in this complaint. Plaintiff filed a PAGA notice online with
15 the Labor Workforce Development Agency (“LWDA”) and sent a letter by certified mail to Defendants
16 setting forth the facts and theories of the violations alleged against Defendants, as prescribed by PAGA.
17 (Lab. Code, §§ 2698–2699.6.)

18 81. As required by PAGA, Plaintiff submitted the \$75.00 filing fee with the LWDA by
19 regular mail. Pursuant to Labor Code section 2699.3, subdivision (a)(2)(A), no notice was received by
20 Plaintiff from the LWDA evidencing its intention to investigate within sixty-five calendar days of the
21 postmark date of the PAGA notice. Plaintiff is therefore entitled to commence and proceed with a civil
22 action pursuant to Labor Code section 2699.

23 **VII. CAUSES OF ACTION**

24 **First Cause of Action**

25 *Failure to Pay All Minimum Wages*

26 *(Against All Defendants)*

27 82. Plaintiff realleges and incorporates by reference all previous paragraphs.
28

1 83. Section 4 of the Applicable Wage Order and Labor Code section 1197 establish the right
2 of employees to be paid minimum wages for all hours worked, in amounts set by state law. (Lab. Code,
3 § 1197; Cal. Code of Regs., tit. 8, § 11160.) Labor Code sections 1194, subdivision (a), and 1194.2,
4 subdivision (a), provide that an employee who has not been paid the legal minimum wage as required
5 by Labor Code section 1197 may recover the unpaid balance, together with attorneys' fees and costs
6 of suit, as well as liquidated damages in an amount equal to the unpaid wages and interest accrued
7 thereon.

8 84. Here, Defendants failed to fully conform their pay practices to the requirements of the
9 law during the relevant statutory periods. Plaintiff and the other Class Members were not compensated
10 for all hours worked including, but not limited to, all hours they were subject to the control of
11 Defendants and/or suffered or permitted to work under the Labor Code and the Applicable Wage Order.

12 85. Labor Code section 1198 makes unlawful the employment of an employee under
13 conditions that the IWC Wage Orders prohibit. Labor Code sections 1194, subdivision (a), and 1194.2,
14 subdivision (a), provide that an employer who has failed to pay its employees the legal minimum wage
15 is liable to pay those employees the unpaid balance of the unpaid wages as well as liquidated damages
16 in an amount equal to the wages due and interest thereon.

17 86. As a direct and proximate result of Defendants' unlawful conduct as alleged herein,
18 Plaintiff and the other Class Members have sustained economic damages, including but not limited to
19 unpaid wages and lost interest, in an amount to be established at trial, and they are entitled to recover
20 economic and statutory damages and penalties and other appropriate relief because of Defendants'
21 violations of the Labor Code and Applicable Wage Order.

22 87. Defendants' practices and policies regarding illegal employee compensation are
23 unlawful and create an entitlement to recovery by Plaintiff and the other Class Members in a civil
24 action for the unpaid amount of minimum wages, liquidated damages, including interest thereon,
25 statutory penalties, attorneys' fees, and costs of suit according to Labor Code sections 204, 218.5, 1194,
26 1194.2, 1197, and 1198, and Code of Civil Procedure section 1021.5.

92. Section 12 of the Applicable Wage Order, and Labor Code section 226.7 establish the right of employees to be provided with a rest period of at least ten minutes for each four hour period worked, or major fraction thereof. (See Cal. Code of Regs., tit. 8, § 11160.)

93. Due to Defendants' unlawful rest period policies and practices described in detail above, Defendants did not authorize and permit Plaintiff and the other Class Members to take all rest periods to which they were legally entitled. Despite Defendants' violations, Defendants have not paid an additional hour of pay to Plaintiff and the other Class Members at their respective regular rates of pay for each violation, in accordance with California Labor Code section 226.7.

94. The foregoing violations create an entitlement to recovery by Plaintiff and the other Class Members in a civil action for the unpaid amount of rest period premiums owing, including interest thereon, statutory penalties, and costs of suit pursuant to the Applicable Wage Order, and California Labor Code section 226.7.

Fourth Cause of Action

Failure to Provide Meal Periods and Pay Missed Meal Period Premiums

(Against All Defendants)

95. Plaintiff realleges and incorporates by reference all previous paragraphs.

96. Plaintiff is informed and believes and thereon alleges, that Defendants failed in their affirmative obligation to provide their hourly non-exempt employees, including Plaintiff and the other Class Members, with all required meal periods in accordance with the mandates of the Labor Code and the Applicable Wage Order, for the reasons set forth herein above. Despite Defendants' violations, Defendants have not paid an additional hour of pay to Plaintiff and the other Class Members at their respective regular rates of pay for each violation, in accordance with California Labor Code section 226.7.

97. As a result, Defendants are responsible for paying premium compensation for meal period violations, including interest thereon, statutory penalties, and costs of suit pursuant to the Applicable Wage Order and Labor Code sections 226.7 and 512, and Civil Code sections 3287, subdivision (b), and 3289. (See Cal. Code of Regs., tit. 8, § 11160.)

1 penalty of \$100 for any initial failure to timely pay each employee's full wages and \$200 for each
2 subsequent violation, plus 25% of the amount unlawfully withheld.

3 104. Labor Code section 216 establishes that it is a misdemeanor for any person, with regards
4 to wages due, to "falsely deny the amount or validity thereof, or that the same is due, with intent to
5 secure himself, his employer or other person, any discount upon such indebtedness, or with intent to
6 annoy, harass, oppress, hinder, delay, or defraud, the person to whom such indebtedness is due."

7 105. Defendants as a matter of established company policy and procedure in the State of
8 California, scheduled, required, suffered, and/or permitted Plaintiff and the other Class Members, to
9 work without full compensation, to work without legally-compliant off-duty meal periods, to work
10 without legally-compliant off-duty rest periods, and thereby failed to fully pay Plaintiff and the other
11 Class Members within seven days of the close of payroll, as required by law.

12 106. Defendants, as a matter of established company policy and procedure in the State of
13 California, falsely deny they owe Plaintiff and the other Class Members these wages, with the intent of
14 securing for itself a discount upon its indebtedness and/or to annoy, harass, oppress, hinder, delay,
15 and/or defraud Plaintiff and the other Class Members.

16 107. Defendants' pattern, practice, and uniform administration of its corporate policy of
17 illegally denying employees compensation, as described herein, is unlawful and entitles Plaintiff and
18 the other Class Members to recover, pursuant to Labor Code section 218, the unpaid balance of the
19 compensation owed to them in a civil action and any applicable penalties, attorney fees, and interest
20 owed to them pursuant to Labor Code sections 210 and 218.5.

21 **Seventh Cause of Action**

22 *Failure to Pay All Wages Earned and Unpaid at Separation*

23 *(Against All Defendants)*

24 108. Plaintiff realleges and incorporates by reference all previous paragraphs.

25 109. The actionable period for this cause of action is three years prior to the filing of this
26 complaint through the present, and ongoing until the violations are corrected or the class is certified.
27 (*Pineda v. Bank of America, N.A.* (2010) 50 Cal.4th 1389, 1395; *Murphy v. Kenneth Cole Productions,*
28 *Inc.* (2007) 40 Cal.4th 1094, 1109; Code Civ. Proc., § 338, subd. (a).) Labor Code sections 201 and

1 202 of the California Labor Code require Defendants to pay all compensation due and owing to its
2 former employees (including the formerly-employed Class Members) during the actionable period for
3 this cause of action at or around the time that their employment is or was terminated, or ended.

4 110. Section 203 of the Labor Code provides that if an employer willfully fails to pay
5 compensation promptly upon discharge or resignation, as required by Sections 201 and 202, then the
6 employer is liable for penalties in the form of continued compensation up to thirty workdays.

7 111. Due to Defendants' faulty pay policies, those Class Members whose employment with
8 Defendants has concluded were not compensated for each and every hour worked at the appropriate
9 rate. Defendants have willfully failed to pay those formerly-employed Class Members whose sums
10 were certain at the time of termination within seventy-two hours of their resignation and have failed to
11 pay those sums for thirty days thereafter as required by Labor Code sections 201 through 203.

12 112. As a result, Defendants are liable to the formerly-employed Class Members for waiting
13 time penalties amounting to thirty days wages for the formerly-employed Class Members pursuant to
14 Labor Code section 203. (See, e.g., DLSE Manual, § 4.3.4 [failure to pay any sort of wages due upon
15 termination entitles an employee to recover waiting time penalties].)

16 **Eighth Cause of Action**

17 *Failure to Indemnify All Necessary Business Expenditures*

18 *(Against All Defendants)*

19 113. Plaintiff realleges and incorporates by reference all previous paragraphs.

20 114. California Labor Code Section 2802 states that employers must "indemnify" an
21 employee for "all necessary expenditures or losses incurred by the employee in direct consequence of
22 the discharge of his or her duties, or of his or her obedience to the directions of the employer." Likewise,
23 Labor Code section 2804 states that "any contract or agreement, express or implied, made by any
24 employee to waive the benefits of this article or any part thereof, is null and void, and this article shall
25 not deprive any employee or his personal representative of any right or remedy to which he is entitled
26 under the laws of this State."

27 115. Here, Plaintiff and the other Class Members paid out of pocket for necessary business
28 expenditures incurred as a direct consequence and requirement of performing their job duties, including

1 the costs associated with their personal cell phone they required to perform their work. Despite knowing
2 that Plaintiff and the other Class Members incurred these necessary business expenses, and requiring
3 Plaintiff and the other Class Members to use such items, Defendants did not reimburse them.

4 116. Thus, Plaintiff and the other Class Members are entitled to recover the cost of such
5 necessary business expenses, plus interest from the date each incurred such business expenses, plus
6 fees and costs. (Lab. Code, § 2802, subds. (b), (c).)

7 **Ninth Cause of Action**

8 *Failure to Furnish Accurate Itemized Wage Statements*

9 *(Against All Defendants)*

10 117. Plaintiff realleges and incorporates by reference all previous paragraphs.

11 118. Labor Code section 226, subdivision (a), obligates employers, semi-monthly or at the
12 time of each payment to furnish an itemized wage statement in writing showing:

- 13 (1) The gross wages earned;
- 14 (2) The total hours worked by the employee;
- 15 (3) The number of piece-rate units earned and any applicable piece rate if
16 the employee is paid on a piece rate basis;
- 17 (4) All deductions, provided that all deductions made on written orders of
18 the employee may be aggregated and shown as one item;
- 19 (5) The net wages earned;
- 20 (6) The inclusive dates of the period for which the employee is paid;
- 21 (7) The name of the employee and only the last four digits of his or her social
22 security number or an employee identification number other than a social
23 security number;
- 24 (8) The name and address of the legal entity that is the employer; and
- 25 (9) All applicable hourly rates in effect during the pay period and the
26 corresponding number of hours worked at each hourly rate by the
27 employee.
28

1 119. As set forth above, Defendants issued and continues to issue wage statements to its non-
2 exempt employees including Plaintiff and the other Class Members that are inadequate under Labor
3 Code section 226, subdivision (a). By failing to pay Plaintiff and the other Class Members properly as
4 described above, Defendants failed to include required information on their wage statements, including,
5 but not limited to, the gross wages earned, the net wages earned in violation of Labor Code section
6 226, subdivision (a).

7 120. Defendants' failure to comply with Labor Code section 226, subdivision (a), of the
8 Labor Code was knowing and intentional. (Lab. Code, § 226, subd. (e)).

9 121. As a result of Defendants' issuance of inaccurate itemized wage statements to Plaintiff
10 and the other Class Members in violation of Labor Code section 226, subdivision (a), Plaintiff and the
11 other Class Members are each entitled to recover an initial penalty of \$50, and subsequent penalties of
12 \$100, up to an amount not exceeding an aggregate penalty of \$4,000 per Plaintiff and per each Class
13 Member from Defendants pursuant to Labor Code section 226, subdivision (e), along with costs and
14 reasonable attorneys' fees.

15 **Tenth Cause of Action**

16 *Violations of California's Unfair Competition Law*

17 *(Against All Defendants)*

18 122. Plaintiff realleges and incorporates by reference all previous paragraphs.

19 123. Defendants have engaged and continue to engage in unfair and/or unlawful business
20 practices in California in violation of California Business and Professions Code section 17200 through
21 17210, by committing the unlawful acts described above. Defendants' utilization of these unfair and
22 unlawful business practices deprived and continue to deprive Plaintiff and the other Class Members of
23 compensation to which they are legally entitled. These practices constitute unfair and unlawful
24 competition and provide an unfair advantage over Defendants' competitors who have been and/or are
25 currently employing workers and attempting to do so in honest compliance with applicable wage and
26 hour laws.

27 124. Because Plaintiff is a victim of Defendants' unfair and unlawful conduct alleged herein,
28 Plaintiff for himself and on behalf of the Class Members, seeks full restitution of monies, as necessary

1 and according to proof, to restore any and all monies withheld, acquired and/or converted by
2 Defendants pursuant to Business and Professions Code sections 17203 and 17208.

3 125. The acts complained of herein occurred within the four years prior to the initiation of
4 this action and are continuing into the present and ongoing.

5 126. Plaintiff was compelled to retain the services of counsel to file this Court action to
6 protect his interests and those of the Class Members, to obtain restitution and injunctive relief on behalf
7 of Defendants' current non-exempt employees and to enforce important rights affecting the public
8 interest. Plaintiff has thereby incurred the financial burden of attorneys' fees and costs, which Plaintiff
9 is entitled to recover under Code of Civil Procedure section 1021.5.

10 **Eleventh Cause of Action**

11 *Penalties Pursuant to PAGA for Violations of California Labor Code Sections 201,*
12 *202, 203, 204, 210, 226, 226.3, 226.7, 256, 510, 512, 1174, 1185, 1194, 1194.2, 1197,*
13 *1197.1, 1198, 1198.5, 1199, 2802, 2804, and Other Provisions of the Labor Code*
14 *(Against All Defendants)*

15 127. Plaintiff realleges and incorporates by reference all previous paragraphs.

16 128. Based on the above allegations incorporated by reference, Defendants violated Labor
17 Code sections 201, 202, 203, 204, 210, 226, 226.3, 226.7, 256, 510, 512, 1174, 1185, 1194, 1194.2,
18 1197, 1197.1, 1198, 1198.5, 1199, 2802, 2804, and others that may be applicable; and the Applicable
19 Wage Order (Cal. Code of Regs., tit. 8, § 11160), and others that may be applicable.

20 129. As a result of the acts alleged above, Plaintiff seeks penalties under Labor Code sections
21 2698 through 2699.6 because of Defendants' violation of Labor Code sections 201, 202, 203, 204, 210,
22 226, 226.3, 226.7, 256, 510, 512, 1174, 1185, 1194, 1194.2, 1197, 1197.1, 1198, 1198.5, 1199, 2802,
23 2804, and others that may be applicable; and the Applicable Wage Order (Cal. Code of Regs., tit. 8, §
24 11160), and others that may be applicable.

25 130. Under Labor Code section 2699, subdivision (f)(2), and 2699.5, for each such violation,
26 Plaintiff and the Aggrieved Employees are entitled to penalties in an amount to be shown at the time
27 of trial subject to the following formula:

28 A. \$100 for the initial violation per employee per pay period; and

1 B. \$200 for each subsequent violation per employee per pay period.

2 131. Moreover, under Labor Code section 256, the Aggrieved Employees are entitled to
3 penalties “in an amount not exceeding 30 days pay as waiting time under the terms of Section 203”
4 through PAGA. (Lab. Code, §§ 256, 2699.)

5 132. These penalties must be allocated seventy-five percent to the Labor and Workforce
6 Development Agency (“LWDA”) and twenty-five percent to the affected employees. These penalties
7 may be stacked separately for each of Defendants violations of the California Labor Code. (*Lopez v.*
8 *Friant & Associates, LLC* (2017) 15 Cal.App.5th 773, 780–781 [citing with approval *Stoddart v.*
9 *Express Services, Inc.* (E.D. Cal., Sept. 16, 2015, No. 2:12-CV-01054-KJM) 2015 WL 5522142, at *9,
10 for the proposition that plaintiff could pursue separate claims for penalties under Labor Code section
11 226, subdivision (e), and penalties for Labor Code section 226, subdivision (a), violations]; see also
12 *Hernandez v. Towne Park, Ltd.* (C.D. Cal., June 22, 2012, No. CV 12-02972 MMM JCGX) 2012 WL
13 2373372, at *17 fn. 70 [noting that federal courts applying California law have found that “PAGA
14 penalties can be stacked, i.e., multiple PAGA penalties can be assessed for the same pay period for
15 different Labor Code violations.”], internal quotation marks omitted).

16 133. In addition, to the extent permitted by law, Defendants failed to provide Plaintiff and all
17 Aggrieved Employees with accurate itemized wage statements in compliance with Labor Code section
18 226, subdivision (a). Plaintiff seeks separate PAGA penalties for Defendants’ violations of Labor Code
19 section 226, subdivisions (a) and (e). (*Lopez v. Friant & Associates, LLC, supra*, 15 Cal.App.5th at pp.
20 780, 788.)

21 134. For violations of Labor Code section 226, subdivision (a), Plaintiff seeks the default
22 penalty provided by Labor Code section 226.3. Labor Code section 226.3 provides that “[a]ny
23 employer who violates subdivision (a) of Section 226 shall be subject to a civil penalty in the amount
24 of two hundred fifty dollars (\$250) per employee per violation in an initial violation and one thousand
25 dollars (\$1,000) per employee for each violation in a subsequent citation, for which the employer fails
26 to provide the employee a wage deduction statement or fails to keep the required in subdivision (a) of
27 Section 226.” Accordingly, through PAGA and to the extent permitted by law Plaintiff and the
28 Aggrieved Employees are entitled to recover penalties for violations of Labor Code section 226.3 and

1 seeks default PAGA penalties for each of Defendants' numerous violations of Labor Code section 226,
2 subdivision (e).

3 135. Labor Code section 210 provides that "in addition to, an entirely independent and apart
4 from, any other penalty provided in this article, every person who fails to pay the wages of each
5 employee as provided in Sections . . . 204 . . . shall be subject to a civil penalty as follows: (1) For any
6 initial violation, one hundred dollars (\$100) for each failure to pay each employee; (2) For each
7 subsequent violation, or any willful or intentional violation, two hundred dollars (\$200) for each failure
8 to pay each employee, plus 25% of the amount unlawfully withheld." As a result of the faulty
9 compensation policies and practices, Plaintiff and the Aggrieved Employees are also entitled to recover
10 penalties under Labor Code section 210 through PAGA.

11 136. Labor Code section 1197.1 authorizes a civil penalty, restitution of wages, and
12 liquidated damages, in the amount of: (1) one hundred dollars (\$100) for any initial violation that is
13 intentionally committed for each underpaid employee for each pay period for which the employee is
14 underpaid, and (2) two hundred fifty dollars (\$250) for each subsequent violation for the same specific
15 offense for each underpaid employee for each pay period for which the employee is underpaid
16 regardless of whether the initial violation is intentionally committed. Accordingly, through PAGA and
17 to the extent permitted by law, Plaintiff and the Aggrieved Employees are entitled to recover pursuant
18 to Labor Code section 1197.1.

19 137. Plaintiff was compelled to retain the services of counsel to file this action to protect his
20 interests and those of the Aggrieved Employees, and to assess and collect the wages and penalties owed
21 by Defendants. Plaintiff has thereby incurred attorneys' fees and costs, which Plaintiff is also entitled
22 to recover under Labor Code section 2699, subdivision (g)(1).

23 **VIII. DEMAND FOR JURY TRIAL**

24 138. Plaintiff hereby demands trial by jury of Plaintiff's and the Class Members' claims
25 against Defendants.

26 **IX. PRAYER FOR RELIEF**

27 Plaintiff prays for judgment for himself and for all others on whose behalf this suit is brought
28 against Defendants, as follows:

- 1 **1.** For an order certifying the proposed class;
- 2 **2.** For an order appointing Plaintiff as representative of the class;
- 3 **3.** For an order appointing Plaintiff's counsel as counsel for the class;
- 4 **4.** For the failure to pay all minimum wages, compensatory, consequential, general, and
5 special damages according to proof pursuant to Labor Code sections 1194, 1194.2,
6 1197, and others as may be applicable;
- 7 **5.** For the failure to pay all overtime wages, compensatory, consequential, general, and
8 special damages according to proof pursuant to Labor Code sections 204, 510, 1194,
9 1198, and others as may be applicable;
- 10 **6.** For the failure to provide rest periods and pay missed rest period premiums,
11 compensatory, consequential, general, and special damages according to proof pursuant
12 to Labor Code section 226.7;
- 13 **7.** For the failure to provide meal periods and pay missed meal period premiums,
14 compensatory, consequential, general, and special damages according to proof pursuant
15 to Labor Code sections 226.7 and 512;
- 16 **8.** For the failure to maintain accurate employment records, penalties pursuant to Labor
17 Code sections 226.3, 1174.5, and others that may be applicable;
- 18 **9.** For the failure to pay wages timely during employment, the unpaid balance of the
19 compensation owed to Plaintiff and the other Class Members and any applicable
20 penalties owed to them pursuant to Labor Code section 210;
- 21 **10.** For the failure to pay all wages earned and unpaid at separation, statutory waiting time
22 penalties pursuant to Labor Code sections 201 through 203, for the Class Members who
23 quit or were fired in an amount equal to their daily wage multiplied by thirty days, as
24 may be proven;
- 25 **11.** For the failure to indemnify all necessary business expenditures, all unreimbursed
26 business expenses, and interest thereon, that are owed, pursuant to Labor Code section
27 2802, and attorney fees, pursuant to Labor Code section 2802, subdivision (c);
28
