[PROPOSED] ORDER

This matter came on for hearing on July 2, 2025 at 11:00 a.m. in Department 11 of the above-entitled Court, the Honorable David S. Cunningham presiding. Based on the pleadings on record, all papers submitted in connection with Plaintiff's Notice of Motion and Motion to Approve Individual PAGA Settlement (the "Motion"), and for good cause appearing, Plaintiff's Motion is GRANTED.

The Court approves the PAGA Settlement Agreement ("Settlement") entered into by Plaintiff Christian Ulessey Molina ("Plaintiff") and Defendant Kayne LLC ("Defendant", and together with Plaintiff, the "Parties"), and hereby ORDERS as follows:

1. Defendant shall pay \$200.00 according to the terms of the Settlement.
2. Of that amount, 75% (\$150.00) is allocated to the California Labor and Workforce Development Agency ("LWDA"); and 25% (\$50.00) is allocated to the Individual PAGA Payment to Plaintiff.
3. "Effective Date" means the date by the Court approves the PAGA settlement.
4. Pursuant to the Settlement, the Court dismisses the class and representative PAGA claims (other than the representative PAGA claim of Plaintiff) without prejudice pursuant to California Rules of Court, Rule 3.770. As the Court has not ruled on class certification and no notice has been sent to putative class members, dismissal of the class claims without prejudice is appropriate.
5. The Court dismisses Plaintiff's individual PAGA claim with prejudice.
6. Under California Code of Civil Procedure section 664.6, the Court retains jurisdiction over the Parties to enforce the Settlement until performance in full of the Settlement's terms.
7. Plaintiff's counsel shall submit a copy of this Order to the LWDA within seven (7) days of the entry of the Order.
8. Plaintiff shall give notice.
