Pursuant to the Order Granting Final Approval of the Class Action Settlement entered on August 11, 2025, which is incorporated herein in its entirety, it is hereby **ORDERED, ADJUDGED AND DECREED** as follows:

1. Judgment in this matter is entered in accordance with the Court's August 11, 2025 Order Granting Plaintiffs Mariela Mendez and Magda Perez's (collectively, "Plaintiffs") Motion for Final Approval of Class Action Settlement ("Final Approval Order") and Plaintiffs' and Defendant Miracle Mile Healthcare Center, LLC's ("Defendant") (collectively, the "Parties") Class Action and PAGA Settlement Agreement and Class Notice ("Settlement Agreement"). All terms used herein shall have the same meaning as defined in the Settlement Agreement.

2. Pursuant to California Code of Civil Procedure Section 664.6 and Rule 3.769(h) of the California Rules of Court, this Court reserves exclusive and continuing jurisdiction over this action, the Plaintiffs, Class Members, and Defendant.

3. This document shall constitute a Judgment for purposes of California Rules of Court, Rule 3.769(h) and is intended to be a final disposition of the Action in its entirety and is intended to be immediately appealable.

IT IS SO ORDERED, ADJUDGED, AND DECREED.

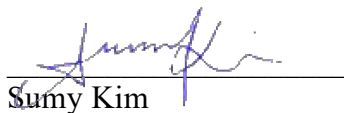
