The Court makes the following findings and orders:

Plaintiff's Motion to approve PAGA Settlement is granted.

The Court grants Plaintiff's unopposed Motion to Approve PAGA Settlement in accordance with Labor Code section 2699(l)(2). The Court finds that the parties entered into the settlement in good faith, and the agreement is fair, adequate, and reasonable and "the relief provided for under the PAGA [is] genuine and meaningful, consistent with the underlying purpose of the statute to benefit the public." (O'Connor v. Uber Techs., Inc. (N.D. Cal. Aug. 18, 2016) 201 F.Supp.3d 1110, 1133.) The Court appoints ILYM Group, Inc. as the third party settlement administrator. The Court further approves the fees and costs requested in the motion. The Court also approves as to form and content the proposed notice to be mailed to the aggrieved employees.
