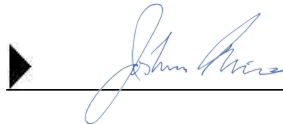

12 Agreement and to disburse the following from the Gross Settlement Amount in
13 accordance with the terms of the Settlement Agreement:
 - 14 a. The PAGA Counsel Fees Payment in the amount of \$225,000.00;
 - 15 b. The PAGA Counsel Litigation Expenses Payment in the amount of \$48,000.00;
 - 16 c. The Administrator Expenses Payment in the amount of \$7,250.00;
 - 17 d. The LWDA Payment to the LWDA in the amount of \$341,062.50;
 - 18 e. The Individual PAGA Payments in the amount of \$113,687.50; and
 - 19 f. The PAGA Representative Service Payment in the amount of \$15,000.00;
- 20 3. The revised proposed Notice of PAGA Settlement and Release of Claims, attached as
21 Exhibit 4 to the Declaration of Joshua R. Mino, is hereby approved.
- 22 4. Judgment in this matter is entered in accordance with the above findings.

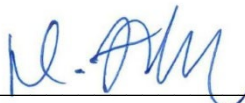
