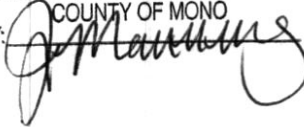

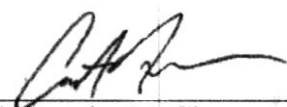

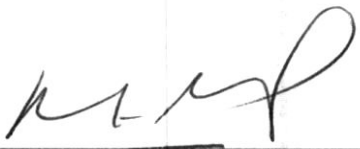
[PROPOSED] ORDER
