1 **[PROPOSED] JUDGMENT**

2 In accordance with, and for the reasons stated in the Order granting Plaintiff's Motion to Approve
3 PAGA Settlement, judgment shall be entered whereby Plaintiff, individually and in her representative
4 capacity on behalf of the State of California and all PAGA Members shall take nothing from Defendant
5 Body Concepts by Orange Twist 1 Corp. except as expressly set forth in the Settlement Agreement and
6 Release of Private Attorneys General Act Claims ("Settlement Agreement"), which was previously filed
7 as part of Plaintiff's Motion to Approve PAGA Settlement, which was granted on December 10, 2025.

8 As stated in the Order granting Plaintiff's Motion to Approve PAGA Settlement, the Gross
9 Settlement Amount is \$200,000 and Defendant shall pay the LWDA, the PAGA Members, PAGA
10 Counsel, Plaintiff and Administrator pursuant to the terms of the Settlement Agreement as follows:

- 11 a. A payment in the amount of \$79,106.25, payable to the LWDA for civil penalties,
12 pursuant to PAGA;
- 13 b. A payment in the amount of \$26,368.75, payable to the Aggrieved Employees in a pro
14 rata basis for civil penalties, pursuant to PAGA;
- 15 c. An award of \$66,667, payable to PAGA Counsel, for reasonable attorneys' fees,
16 pursuant to PAGA;
- 17 d. An award of \$19,008, payable to PAGA Counsel, for reasonable attorneys' costs,
18 pursuant to PAGA;
- 19 e. An award of \$5,000, payable to Plaintiff, for a PAGA Representative Service
20 Payment, pursuant to PAGA; and
- 21 f. A payment of \$3,850, payable to ILYM Group, Inc., for settlement administration
22 costs.

23 2. Pursuant to California Code of Civil Procedure section 664 and Rule 3.769(h) of the
24 California Rules of Court, the Court reserves exclusive and continuing jurisdiction over this Action,
25 Plaintiff, the PAGA Members, and Defendant for purposes of:

- 26 a. supervising the implementation, enforcement, construction, and interpretation of the
27 Settlement Agreement, the plan of allocation, the Order Granting Plaintiff's Motion to
28 Approve PAGA Settlement, and the Judgment; and

1 b. supervising distribution of amounts paid under this Settlement.
